'Positive parenting effective'

SHOROBE - Corporal punishment is not the only form of discipline, as there are other positive ways of building better learners and responsible citizens.

Responding to come comments raised during a kgotla meeting in Shorobe, Minister of Youth and Gender Affairs, Ms Lesego Chombo said parents should teach children about the consequences of their actions, which would foster a sense of responsibility.

Some parents had earlier expressed concern that the abolition of corporal punishment in schools had exacerbated misconduct among learners.

As such, Ms Chombo encouraged parents to play an active role and teach their children moral values, respect and good behaviour from an early age in order to make teachers' role fulfilling.

A child nurtured with values in the family, she said became easier to guide at school.

"As the Setswana idiom says Lore lo ojwa lo sale metsi, I encourage you to instil moral virtues in children at home as a foundation for building an effective and decent society," Ms Chombo said.

A strong family foundation, she said remained most effective way to positively shape the future of the children and encouraged parents to exercise their responsibilities.

Also, she challenged parents to instill moral values amongst their children by being exemplary or being role model.

North West District Council chairperson, Mr Itumeleng Kelebetseng also shared Minister's sentiments that parents should play their role in upbringing of their children as they were under their custody most of the time.

He expressed concern that juvenile delinquency was rampant in the district especially in schools, saying recently about 31 learners were suspended at Moeti Junior Secondary School for drinking alcohol and raping one of their fellow learners.

Jwaneng solar project completion next year

JWANENG - The Jwaneng 100MW Solar Photovoltaic Project, which commenced last month, is scheduled to be completed by July 8, 2026.

Undertaken through a Chinese Consortium, Sinotswana Green Energy, the project is a key development in Botswana's energy transition to diversify the country's energy sources and increase renewable energy generation.

The developer has entered into a 25-year power purchase agreement with government, through the Botswana Power Corporation (BPC).

Addressing Jwaneng full council meeting recently, the project manager, Mr Kenneth Syanjibu noted that in addition to contributing toward the country's aspiration of transitioning to 50 per cent renewable energy by 2030, once operational, the project would also assist in balancing the power network in the Southern region of Botswana.

He noted that to date, the cumulative progress on the designs was at 80 per cent, with most of the basic designs complete.

He also said procurement of major equipment packages, which included PV brackets, inverters, transformers and cables was done, and the installation of solar brackets and substation buildings were 31.4 per cent and 30 per cent complete, respectively.

Additionally, Mr Syanjibu said the project currently employed a total of 260 people, 231 of which were Batswana while the remaining 39 were Chinese. He noted that even though

the number was expected to continue increasing during the construction phase due to the works involved, they would significantly decrease during the operation and maintenance

"We are expecting the current numbers to go up because we are starting to pull the cables inside the plant in the next two months, and this requires a lot of people.

We have also noted that the number of women employed is low, hence we have advised that they should be given more opportunities," he explained.

He noted that part of their agreement was that there should be skills transfer to Batswana, and therefore the contractor had an obligation to train different employees in various areas.

He said that would empower the local people and ensure sustainability for the project and future needs.

He also highlighted that the project was expected to benefit the local communities in various ramifications through social responsibility investment.

The councillors appreciated the economic opportunities created by the project, which they said had both direct and indirect benefits, particularly to the informal sector.

Nominated councillor, Ms Joyce Medupe underscored the need to align the remuneration to the P4 000 minimum living wage that government aspired to achieve.

She also called for sustainable social responsibility investment projects as compared to once-off food hampers donations.

Ngami ward councillor, Mr Bankinyana Montsiemang said he was optimistic that once complete, the plant would significantly augment national energy supply, thereby reducing electricity incurred by consumers.

He also said the project was a key development that would ensure sustainable generation, with less carbon

Raphalane ward councillor, Mr Lebogang Peloyamotho said the skills transfer to Batswana was a good initiative, adding that the contractor should collaborate with Jwaneng Technical College to engage students throughout all the stages of the project.

He noted that such would create a skills base, which would be instrumental for the maintenance of the plans after the lease had lapsed.

He also called for the deployment of highest safety standards to protect the workers.

The mayor, Mr Ronica applauded Ntsimako contractor for opportunities for the local communities in various areas of the project.

He also said their social responsibility investment should consider installing solar panels in the councillors' office containers, which were donated by Red Path towards effective service delivery. BOPA

Centre to offer child offenders break - minister

MOLEPOLOLE - School to offer child offenders break -

The ongoing refurbishment of Ikago School of Industry, which started on July 23, is scheduled to be complete on September 20.

The P4.5 million project awarded to KeboHoldings entails among other things, maintenance of three staff houses as well as renovation of hostels, administration block, guard house, parking area, walk ways and workshops.

Speaking during a tour of the school in Molepolole recently, Minister of Child Welfare and Basic Education, Ms Nono Kgafela-Mokoka said once completed, the centre would play an important role on children with conflict with the law as it would offer them opportunity to pursue their dreams.

The decision to transfer children in conflict with the law from prisons to Ikago Centre was made in line with the Presidential Directive CAB 18 (A)/2025.

This move, Minister Kgafela-Mokoka said came in handy as the children would be attended to by different professionals and addressed underlying conditions, which they were facing.

She therefore said the running of the school required all stakeholders to work together for a common purpose of rebuilding child offenders.

The school she said offered an integrated programme where child offenders could relearn, rebuild and became what they wanted to be.

Even though those children broke the law, she said they deserved an opportunity to a better future as some may have committed offenses due to underlying circumstances that must be addressed.

The Minister said the ministry

had observed that many of such children grew up in violent environments and they also displayed violent behaviours.

Some she said lacked fatherly role model figures, developed anger and resentful attitudes.

Therefore, she said the school would serve to close the gap through different professionals probational among them psychologists, social workers and teachers as the school would have an academic unit, vocational training and other industrial

work in collaboration with that of Justice and Correctional Services, Botswana Police Service and Botswana Defence Force to ensure the children were given an opportunity to learn and pursue their desired dreams.



Delivery of medical supplies continues

TSABONG - Government is committed to acting swiftly to fill gaps in the drug supply chain and support frontline healthcare

This was said by Minister of Health, Dr Stephen Modise in Tsabong on Saturday during a delivery of consignment of medical supplies in the district.

"This is a moment of action, not just words. We are ensuring that our healthcare facilities, particularly those in areas like Tsabong have the necessary tools to care for our citizens during this challenging period," Dr Modise said.

The consignment included a wide range of pharmaceuticals, surgical supplies and other vital medical commodities.

The minister said similar consignments were scheduled to arrive in other districts in the coming days.

The arrival of a crucial shipment of medicines and medical supplies has brought a wave of relief to Tsabong, with hospital staff and residents alike expressing gratitude for the timely intervention.

Tsabong Primary Hospital principal pharmacist, Ms Queen Dada confirmed the arrival of the much-needed supplies, stating it came at a time when the hospital needed them the

Ms Dada detailed the dire situation the facility had been

facing, having ran out of essential medications, including critical antibiotics for children, hypertension medication and drugs for cardiovascular conditions.

"We received what we ordered, which are the essential and most critical medicines," said Ms Dada. She noted that while the hospital had managed to maintain a supply of medication for diabetes, the overall shortage had been a significant concern.

The impact of the shortage was deeply felt by the community, Ms Letso Kainamba, who heaved a sigh of relief upon hearing the

"I have gone for days without my hypertension medication. I was told that medication was not available and I was unable to afford the high costs of a private pharmacy. We are thankful that we would be able to continue with our medication," she said

Mr Thomas Seru from Maubelo echoed the sentiment.

"At least, I will be able to see the doctor with the hope that I will get medication," he stated, looking forward to finally receiving treatment.

Ms Ame Apadile from Tsabong said the arrival of the medication would, 'help most of our parents who have been home without their Non-Communicable Diseases medication'.

She expressed appreciation for government's swift response.

Masuku Parliamentary Counsel

GABORONE - Dr Ame Masuku has been appointed to the position of Parliamentary Counsel of the National Assembly.

A media release from the National Assembly on Friday says her appointment aligns with Section 70 (2) of the Constitution and Standing Order 13 of the Standing Orders of the National Assembly of Botswana.

Dr Masuku, who is a Law Lecturer at the University of Botswana and former State Counsel at the Attorney General's Chamber under the International and Commercial Division, is admitted to practice as an Attorney in the Courts of Botswana and a member of the Law Society of Botswana.

The release says she has also been legal consultant for Modisane Law since its inception.

According to the release, Dr Masuku holds a Doctor of Philosophy (PhD) in Tax Policy from the University of Pretoria, a Master's Degree in International Taxation from the University of Cape Town, a Master's Degree in Trade, Investment and Business Law from the University of Western Cape, a Bachelor of Laws from the University of Botswana, and a Post-Graduate Diploma in Advanced Taxation from the Botswana Accountancy

College.

It further states that she has attended various trainings Advantage's including, Environmental, Social and Governance and Corporate Governance Training World Intellectual Property Organizations' International-CIPA Meister Course.

In addition, the release states that Dr Masuku currently sits on the Radiation Protection Board under the Radiation Protection Inspectorate in the Ministry of Communication and Innovation and is also a member of the Board of Adjudicators (BOA), established under Section 90 of the Income Tax Act.

As a member of the Board of Adjudicators, she adjudicates over tax disputes brought before the BOA and has rendered several judgements in that capacity.

The release states that she has also served as a director to the Botswana Motor Vehicle Accident Fund where she was deputy chairperson and chairperson of the Human Capital Committee.

In addition, the release says she has published in journals, book chapters, conference papers and a monograph currently being used by the University of Botswana Centre for Continuing Education as the prescribed manual for Foundations of Contract Law.

Dr Masuku, the release says has consulted for international institutions, government entities and non-state actors on areas of tax law, company law, international investment law as well as international trade law.

She is a seasoned researcher and Botswana's consultant for the International Bureau for Fiscal Documentation (IBFD) where she reports on all tax developments in Botswana and annually reviews the Botswana Chapter, says the release.

"As a lecturer at the University of Botswana, she facilitated the learning of law in mercantile and commercial law courses such as Tax Law in Botswana, The Law of Business Associations, Contract Law and Legal Research. She has supervised dissertations for both undergraduate and Masters

"This is an indication that parents are not doing enough to reprimand or discipline their children and when discipline is neglected at home, there is no how teachers can win at school," he added noting that parents had a duty to ensure children embraced basic morals.

Sorghum flour to hit shelves

GABORONE - Sorghum flour, a self-raising gluten free product by Golden Grain will soon hit the shelves.

A BUAN graduate's product, the flour is silec and diabetic friendly, with low glycaemic index, which promotes stable blood sugar levels, increased satisfaction, aids weight management and prevents type two diabetes.

Mr Kelelelo Korononeo, who is credited for the idea told BOPA at the recently ended National Agricultural Show in Gaborone that the flour was nutrient rich and loaded with fibre which helped with water retention.

"It's a healthy alternative from

wheat flour," he said. He said the product would be available in 500g packs with plans for other weights to meet the demand.

Mr Korononeo said they were working round the clock to avail the product at the shops but would debut at the BUAN Farm Shop in Gaborone.

Having started with own capital and support from family, Mr Korononeo said he was introduced to sorghum flour by NARDI and realised it made business sense.

We realised it made business sense as sorghum was a local product with the ability to survive local weather conditions and decided it was time to add value to our sorghum grain, he said. **BOPA**

LOROLWANE - The launch the Gasita-Lorolwane Farmers Association marks a pivotal moment for community

Remarks Kgosi Matlho Matlhoakgosi Lorolwane resonated with the broader objective of boosting livestock numbers to five million, reiterating the support for farmers.

He appealed for innovative solutions from farmers, promising a collaborative approach to navigating the myriad challenges they faced. He said the farmers association stands as a beacon of hope for revitalising the agricultural sector in the area.

"The priorities before us are clear -- globally, continentally,

and here at home," she said, outlining three areas under South Africa's G20 presidency: the care economy, women's financial inclusion, and ending genderbased violence and femicide. Chikunga called for "three bold shifts," including financing

> conferences. "Conferences do not change the world -- systems do. That means setting measurable targets, enforcing fair payment norms for women-owned businesses, tracking progress publicly, and embedding zero tolerance for gender-based violence in every workplace," she said.

Balete welcome Mautlwakgosi

RAMOTSWA - Multitudes of Bogwera initiates who gathered at the Gamalete main Kgotla on Saturday have been urged to uphold societal moral values as it is an important component in nation building.

This was revealed by Balete Paramount Chief, Kgosi Mosadi Seboko during a pass out parade for those who had completed the Bogwera initiation rite in Ramotswa.

"Culture is an important component in our efforts to unite our people. It is upon the mophato before me to uphold the call I have made in the past to unite the morafe by upholding basic principles of botho and tlotlo even to the next

rulers after me and to other merafe,' said Kgosi Mosadi.

Kgosi Mosadi said the successful completion of the initiation rite was a true testament that they had transitioned from boyhood into law abiding citizens who were expected to have learnt Setswana culture, history and most importantly Selete customs and values.

The graduates who were named Mautlwakgosi by Kgosi Mosadi were also advised on living to the true testimony of their name and uphold what Kgosi required from adult members of the society.

Kgosi Mosadi said through the guidance of other senior members of the morafe the initiates had completed the necessary training to be considered men within the Balete tribe.

She was highly confident that the rite of passage had instilled the required social values which would make them an important cog in contributing to social cohesion and stability within the tribe.

Multitudes braced the blistering heat on Saturday and thronged the Gamalete main kgotla to witness the colourful ceremony of the procession of the over 200 male initiates.

As early as six o'clock in the morning the kgotla was packed to the rafters and the Ditlhaka tsa Balete led in song as the tribe eagerly awaited the procession of the male initiates.

The initiates finally emerged from their sacred space with Kgosi Mosadi and Deputy Paramount Chief Kgosi Tsimane

to a deafening ululations from the crowd that had packed the kgotla.

According to oral traditions related during the course of the processions the Balete had Bogwera initiates as early as 1890s with the first mophato being Maakathata regiment.

Initiation school for Balete was halted in 1981 and the last regiment to be initiated was

Mokgosi leading the procession called Mafitlhakgosi because the ceremony coincided with the death of Botswana's founding president Sir Seretse Khama in 1980.

> Since then the Bogwera and Bojale were halted and only revived in 2012 with the Matsosangwao regiment passing out.

Tshepiso Masalela and Kethobogile Haingura will represent the country in 800 metres men's category.

The 400 metres hurdles has Kemorena Tisang and Victor Ntweng.

World Athletics Para Championships team consist of Ronald Rich (200m, 400m T37), Edwin Masuge (400m T13), Tumo Masejane (400m T13), Lame Monamati (400m T12).

Bose Mokgwati will represent the country in 400m T13, Katlego Matuto (400m T12) Onkamile Bankaetse and his guide (400m T11) and Gloria Majaga in 400m T13. BOPA
