## MPs express disappointment over project delay

**GUMARE** - The Gumare-Sepopa road cold recycling and asphalt overlay project carried out by Bango Trading Company stands at 72 per cent and 57 per cent progress in package one and package two respectively.

This was said by the Gumare-Sepopa and Sepopa- Mohembo roads, project manager Mr Alec Dennison in response during a virtual special Okavango District Development Committee (DDC) meeting on Tuesday.

The meeting was attended by Members of Parliament from Okavango District with the district leadership.

Mr Dennison reported that the Gumare-Sepopa Road project layers such as prime base, sub base, road bed and cut were completed, adding that they were yet to do cement stabilisation in the first package of the project while they have managed to complete cut, road bed, sub base,

Asphalt is ongoing and we are yet to do emulsion treatment in package two of the project, he told the meeting.

He said for Sepopa-Mohembo Road project, done by Rockefeller Civil Engineer PTY/LTD, the progress was at a total of 25 per cent of completion from both package one of asphalt overlay and package two of shoulder widening.

The Member of Parliament for Okavango West Mr Kenny expressed had dissatisfaction regarding the progress of the ongoing road

Mr Kapinga said he observed the DDC report put the road project progress at 72 per cent and 57 per cent for Gumare-Sepopa package one and package two respectively while the Sepopa-Mohembo was said to be at 25 per cent yet there was less visible progress on the ground.

He therefore emphasised the need for prioritisation of road infrastructure to fast track developments in the Okavango District.

The Member of Parliament for Okavango East Mr Gabatsholwe Disho reiterated that Gumare-Sepopa and Sepopa-Mohembo road progress was inadequate.

Mr Disho further said there was need for frequent grading of the Mohembo-Gudigwa road which was in a terrible state and for Okavango leadership to seek assistance for grading of Nokaneng-Gumare road which posed danger to road users while awaiting a permanent solution.

When presenting the DDC report, Okavango District Council (ODC) principal economic planner Ms Ludo Moloi said the Gumare-Sepopa road project progress was initially delayed by the change of scope that resulted in dividing the project into two packages.

Ms Moloi said the other challenges were unavailability of design drawings at the commencement of the project as well as lack of quality gravel.

Regarding Sepopa-Mohembo road Ms Moloi said the package one of the project of asphalt overlay depended on package two which included shoulder

She therefore said both packages were initially delayed by lack of construction materials

due to delayed approval of mining license for Shadikekete burrow pit and ongoing Environmental Impact Assessment study for the Nxamasere and Sepopa burrow

Ms Moloi further said all dry grading and spot improvement projects in the district have been negatively affected since graders were awaiting maintenance. BOPA

## Company empowers youth to tackle unemployment

**GABORONE** - United Nations Development Programme (UNDP)'s 4th Botswana National Human Development Report released earlier this year, indicates that 38.2 per cent of young people in Botswana remain unemployed.

The report further highlights that 63 per cent of young women lacked marketable skills, compared to 50 per cent of young men, while young people with only a secondary school education face the highest unemployment rates, despite government efforts to diversify the economy.

However, Burban Holdings, a corporate training solutions company, is playing its part in addressing the issue.

Initially offering professional training such as customer service excellence, the company has now ventured into short certified healthcare courses in an attempt to tackle high unemployment rates in Botswana.

Speaking in an interview, Burban Holdings marketing manager, Ms Sahara Mokgweetsi, said the initiative was introduced to give women and youth, even those with only a secondary school education or no formal healthcare background, access to affordable, certified training. She added that the programme equipped graduates employable skills that open doors to both local and international

opportunities. "There is a global need for healthcare workers, Ms Mokgweetsi. "Through this training, creating a pathway for dignified work and sustainable livelihoods while uplifting healthcare the

country." The five-week courses, accredited by Botswana

Qualifications Authority (BQA) the Human Resource Development Council (HRDC), combine theory with practical training. Cover areas such as elderly care, wound nursing, birth delivery assistance, and counselling. The programme has already proven impactful, with more than 50 per cent of graduates securing employment locally or abroad.

According to Ms Mokgweetsi, two graduates had already secured healthcare jobs in Ireland, others were absorbed by Princess Marina Hospital, while some had gone on to open their own healthcare consultancies to serve communities in remote areas, including elders living with

One such graduate is Ms Nonofo Lesolobe, a certified healthcare assistant enrolled with Burban Holdings in October 2023, where she developed a comprehensive understanding of patient care. After earning her certificate, she began working at Karong Clinics.

"After a few months, I decided to open a mobile healthcare consultancy called Compassionate Care with Nonofo Thato Lesolobe," she said.

"Through my consultancy, I offer personal care assistance, companionship, and medication management, making house calls around Gaborone and Mochudi."

# Nyangabgwe hospital receives drug supply

#### **FRANCISTOWN**

Hospital Nyangabgwe in Francistown, a key referral facility for the northern region of Botswana, has received a shipment of various medications, providing some relief from the ongoing drug shortage that has persisted for some time.

Hospital Superintendent Dr Ivan Kgetse reported that the hospital received 20 types of medications, including both oral and injectable forms, on Saturday morning.

However, he stressed that

many critical drugs needed by specialists were yet to arrive saying the hospital anticipated more deliveries in the near future.

Due to the shortage, the hospital had temporarily suspended nonemergency operations, although emergency procedures continued, often requiring patients to procure certain necessary medications themselves.

Dr Kgetse mentioned that this was particularly true in situations where the hospital lacked essential drugs, especially in the operating theatre, where anesthetics to facilitate surgeries were critically low.

While he expressed optimism about additional shipments on the horizon, Dr Kgetse noted that the current supply primarily consisted of medications typically dispensed at clinics, rather than those specifically required for a hospital of Nyangabgwe's capacity.

This,he said included a continued shortage of pain relief medications.

Dr Kgetse remained hopeful that the hospital would receive the necessary specialist drugs soon, emphasising the urgency of the situation across all wards affected by the shortage. **BOPA** 

### Administration of Justice launches Criminal Court

**GABORONE** - The newly established Criminal Court will comprise nine judges; six in Gaborone and three in Francistown.

Chief Justice Gaolapelwe Ketlogetswe said this yesterday during the launch of the High Court Division of the Criminal Court.

Justice Ketlogetswe said management of criminal cases had been a concern hence a decision was taken to have judges who would deal exclusively with criminal cases to speed up the process and promote the quality of judgment.

"Criminal cases are the most publicly visible matters that trial courts have to grapple with on daily basis. And, because of constitutional and other statutory imperatives of speedy-trial requirements, as well as their closeness to the ordinary person's interests, they require special attention and a robust approach to their disposal," he said.

Justice Ketlogetswe said the judiciary was aware of rising crime, particularly violent and intrusive crimes, and the hardships that they visit upon affected individuals, families, and communities.

He further said the court was also conscious of the slow pace at which courts have disposed of 'these particular types of cases.'

"As an antidote to these problems, we have taken a decision to put in place specialised criminal courts with dedicated judges who will do no other cases except for criminal cases," he said, adding that at the top of the pile were murder and manslaughter cases.

He noted that at the end of August 2025, Gaborone and Lobatse divisions of the High Court had between them 1 225 criminal cases, of which 260 were criminal trials, mostly murder, while 88 were criminal appeals.

He said the rest were applications, mainly bail pending appeals, adding that the Francistown division of the

High Court, for the same period, had 462 criminal cases, of which 59 were criminal appeals and the rest were criminal applications.

"These numbers are too many, and criminal trials have remained waiting for trial dates, with the judges' diaries going as far as 2027. This is untenable," he said.

Justice Ketlogetswe said that the sad reality about the statistics was that behind them were human beings who had been killed by fellow human beings, families of the deceased victims who waited years to know what had become of the perpetrators of crimes that had taken their loved ones.

Meanwhile, the Minister of Justice and Correctional Services, Mr Nelson Ramaotwana, said government was committed to the protection of human rights, which included the right to be tried within a reasonable time, therefore commended the establishment of the criminal courts.

He said that the Administration of Justice Annual Report for the year 2025 indicated that the disposal rate of criminal cases at High Courts between December 2024 and January 2025 stood at 35

"This slow disposal of criminal cases is certainly a bad mark on the justice system as a whole, as it often results in denial of justice to the victims of crime," Mr Ramaotwana

He said that during the long period that a case took before

courts, often crucial evidence was lost, as witnesses pass on and the quality of exhibits diminishes.

The minister said 'this can lead to a loss of confidence in the judicial system by members of the public, which affects the country's strength of democracy and good governance.

Giving an overview the criminal courts, Justice Omphemetse Motumise, said Administration of Justice adopted performance standards aimed at enhancing timely disposal of criminal matters.

However, it has become evident that meeting the standards had become extremely difficult and sometimes impossible, noting that majority of criminal trials stretch over three to five days due to various challenges, he said

Justice Motumise said the new creation would improve the efficiency and effectiveness of the judiciary and address the case backlog.

Law Society of Botswana (LSB) Chairperson Mr Lesedi Moahi said specialised courts were long overdue adding that previously attention and resources were directed towards less pressing initiatives. Thus, he said the LSB applause the Chief Justice for the Criminal Courts endeavour to eliminate the criminal matters logjam. BOPA

# **Government selects 200** projects under BETP

**GABORONE** - Government has taken a significant step towards achieving its economic diversification goals and has selected 200 projects for the Botswana Economic Transformation Programme (BETP)'s economic laboratories.

Addressing the BTEP laboratories leadership syndication in Gaborone on Wednesday, the Vice President, Mr Ndaba Gaolathe said the 200 projects were selected from a pool of 6 925 proposals submitted by a diverse group of contributors, including citizens, international partners and innovators.

Mr Gaolathe highlighted that the overwhelming number of submissions reflected the nation's strong desire for a high-income Botswana that was digitallyexport-driven economically diversified.

"This is evidence that the energy for change exists," he said.

He also indicated that the economic laboratories were the third of four phases in the BETP and over four weeks, cross-sector

teams would collaborate to refine the projects for implementation and address any potential obstacles.

He added that the fourth and final phase of the BETP would involve creating a national roadmap for the finalised projects, complete with key performance indicators, timelines and accountability

On one hand, the Vice President acknowledged the disappointment of those whose projects were not selected, explaining that the programme had to make difficult choices.

"We acknowledge that some people have been grieved and have raised concerns that their projects should have been taken further. We understand these frustrations, but the labs required us to make difficult choices, focusing on projects with the highest impact, those that are execution-ready and those that do not place unsustainable pressure on the fiscus," he said.

He also explained that the selected projects were prioritised for their high impact, readiness for

Consequently, the Mr Gaolathe

assured the public that each project would have a clear implementation plan.

further emphasised government's commitment to facilitate and deliver on the initiatives to create lasting impact and new employment opportunities for Batswana.

The Vice President also told the meeting that while the BTEP laboratories were finalised, the National Development Plan (NDP) was also advancing in parallel.

"These two processes are not competing but are complementary. The BETP injects urgency, precision and execution discipline while the NDP provides the longterm vision. Together, they form the twin engines of Botswana's transformation," he said.

Participants were also informed that the selected projects would serve as vehicles to deliver on the government's promise to create jobs for Batswana.

## Church plays major role in fight against social ills

**SEROWE** - Church leaders have been urged to continue praying for HIV/AIDS and other significant social issues impacting Botswana.

Speaking during the official launch of the Month of Prayer in Serowe on Tuesday, Ms Dziidzo Leshiba, a nurse at Serowe district council said September was a special month for all Batswana to pray for HIV/AIDS and other social ills. She said that the 2025 Month of Prayer Against HIV/AIDS and other social ills, under the theme: By His Grace, Generation Now, Our Future Responsibility, End AIDS, underscored the important role that church-led prayers had played in Botswana's tractability against HIV/AIDS.

She called for determination and strength in prayer echoed throughout the community during the launch of the Month of Prayer.

Ms Leshiba noted that alcohol and drug abuse were regarded as the major root cause of social ills such as the now prevalent genderbased violence (GBV).

She also said non-communicable diseases (NCDs) referred to a group

of conditions that were not mainly caused by an acute infection, result in long-term health consequences and often create a need for longterm treatment and care

conditions include cancers, cardiovascular disease, diabetes and chronic lung illnesses.

She also NCDs were the leading cause of death worldwide and present a huge threat to health and development, particularly in lowand middle-income countries.

Letshiba interventions for controlling NCDs included blood glucose through a combination of diet, physical activity and medication if necessary, controlling blood pressure and lipids to reduce cardiovascular risk and other complications, and regular screening for eye, kidney and foot damage to facilitate early

Sergeant Oarabile Tom from Gender and Child Protection unit at Serowe police station said Botswana, like many modern societies, was battling a troubling rise in social ills, substance abuse among the youth, early pregnancies, school dropouts, crime, GVB and a general erosion of respect and

Sgt Tom indicated that social and behaviour change approaches had the potential to address challenges in areas such as health, HIV. education, and child protection by helping in changing attitudes, beliefs and behaviours. He said they were concerned about rape, defilement, murder, threaten to kill, assault and domestic violence He added that GBV cases gave them headache, more especially that some of the victims withdrew cases. # Company restores royal burial site

MAUN - Wilderness Safari has pledged P300,000 towards a project restoring the royal burial ground of Batawana.

The site, located at the main kgotla, is the resting place of former paramount chiefs, including deputy chief, Kgosi Mathiba Moremi, queen mothers (bahumagadi) and other royal family members and had long been in need of renovation.

Kgosi Tawana II had a longstanding desire to see the graves restored and the project is a collaborative effort between Wilderness, bogosi and the Nhabe Museum.

The goal is to restore the deteriorated structures to a state that honoured the royals and preserved the cultural heritage of Batawana.

In an interview, Wilderness Safari's general manager, Mr Joe Matome said the funding was part of the company's annual heritage celebration across all global branches.

He said the project would include upgrading tombstones, creating new walkways, installing a gate and constructing a mural wall that told the history of Batawana.

Mr Matome explained that

while the renovation aimed to attract tourists, it was also a sign of respect for the royal authority and an effort to strengthen community

"We believe our efforts will make a huge difference, especially because the sites hold immense historical and cultural significance for the royal families," he said.

The project steering committee chairperson, Mr Tshematshe Monwela, also Nhabe Museum board chairperson, confirmed that work had already begun and he thanked Wilderness for their support, noting that the project would be done in phases, starting in Maun before expanding to other areas where royals were buried, including Tsau, Toteng and Kachikau in the Chobe region, where Kgosi Sekgoma Letsholathebe and his children had been buried.

Mr Monwela highlighted that the project would require additional funding expanded and had requested that Wilderness encouraged other safari companies to contribute through the Hospitality and Tourism Association of Botswana (HATAB). He also confirmed that all affected families and stakeholders had been consulted and had given their approval.

# Men society gives back to vulnerable

**MAUN** - In a heartening display of compassion, the Matamo Men Society Group recently took a stand against the silent suffering of men by bringing hope to two underprivileged families in Boyei Kgotla.

With a generous donation of toiletries, the group's initiative goes beyond providing much-needed supplies, but restored dignity and sparked a conversation about the challenges men face today.

During the donation ceremony on Monday, Kgosi Moeti Moeti of Boyei Kgotla praised the group for their selfless actions.

"We usually hear of men in connection to abuse and violence, but today, we are witnessing a powerful shift of men giving back to the community," he said.

Kgosi Moeti encouraged the group to continue their impactful work, saying such gestures left lasting impressions on the lives they touched.

Founded in 2019, the Matamo Men Society Group was born from a deep concern for the well-being

The group coordinator, Mr Otukile Nyapetsi said initially, the group focused on helping men navigate destructive lifestyles and health issues.

"We noticed how men were spiralling, where some would recklessly share partners and others living with HIV did not adhere to medication schedules. That is when we decided to create a safe space for men's healing," Mr Nyapetsi said.

He added that over time, the group expanded its mission to address unspoken realities of male abuse and emotional trauma.

"Men too are abused, but most suffer in silence due to societal judgment. We offer them a space to speak freely, without shame or fear," he said.

One community member, Ms Cecilia Aupiti said the reality of men as victims of abuse was often

"Men fear being called weak, so they bottle up pain and when they finally lash out, we punish them without acknowledging that society failed them the first time they asked for help," Ms Aupiti

She thus urged families to listen to and support boys and men and encouraged the society against shaming men for being vulnerable and instead provide them with the necessary support.

The event, which was attended by community leaders like Kgosi Gakemoeng Molaletsi of Seetso Kgotla, served as more than just a donation drive, but a space for open dialogue about men's mental health, healing and community responsibility.

Kgosi Molaletsi emphasised the importance of dismantling deeprooted cultural stereotypes that prevented men from expressing vulnerability, saying men too suffered as they faced abuse, emotional struggles and burdens that often went unspoken.

"It is time we offer them protection too and strive for peace and tranquillity in all our communities," she said.

She thanked that the Matamo Men Society Group, saying their initiative was a powerful reminder that true strength was not about suppressing emotions but creating a supportive and understanding community.

"It is about empowering men to break free from the traditional mould and find the healing and support they deserve," she said.

# Letlhakeng courts investors

**LETLHAKENG** - Letlhakeng District is actively working towards attracting and establishing partnerships aimed at transforming the district's economic landscape.

Of recent, the district has roped in Bolux Group and Pretoria Portland Cement (PPC), as partners in resuscitating and diversifying the local economy.

The commitment was reaffirmed by the Chairperson of the Letlhakeng District Council, Mr Gordon Mokgwathi at a full council meeting on Monday.

Mr Mokgwathi said in its effort to reduce poverty and unemployment, the district had embarked on skills development training in partnership with Bolux Group.

Through the partnership, he said 13 beneficiaries previously funded for bakery projects under Wealth Creation were offered a refresher baking course to improve the quality of their produce.

He was optimistic that the initiative would go a long way in improving their livelihood. Mr Mokgwathi said another stakeholder and partner, Pretoria Portland Cement, had been brought on board.

He said since Village Development Committees (VDCs) in the region had embarked on brick moulding projects as a way of generating income, there was a need to engage experts in the industry to capacitate and offer technical training in brick moulding.

Furthermore, Mr Mokgwathi said that the district was pursuing additional partnerships to further transform its economic landscape.

He encouraged efforts to actively attract and secure long-term partnerships with other stakeholders, particularly in light of the current financial challenges facing both the district and the country.

Furthermore, Mr Mokgwathi said the district had embarked on the leasing of cluster farms to investors as a strategy to rapidly boost the economy.

He said the district recently held a consultation meeting at Malwelwe and Maratswane, where an agreement was made between the Department of Crop Production, the Council's Estate Management office and the Malwelwe cluster farmers on leasing of their land to investors.

He said the initiative had the potential to create jobs for local residents, increase crop production, generate income, and contribute to improving the country's economic situation. *BOPA* 

# SA labour market under strain as mass layoffs loom

**JOHANNESBURG** - South Africa is facing mounting concerns over a looming jobs crisis, after major companies announced plans to shed over 7 000 workers in total, with thousands more indirect jobs at risk, a move government and labor unions warn the country cannot

Successive job cuts have drawn grave concern from Minister of Employment and Labor Nomakhosazana Meth, who warned of the challenges posed by ongoing retrenchments. According to a statement released Tuesday by the department, the closure of South Africa's largest steel producer, ArcelorMittal, was set to result in "an estimated 3 500 job losses and a further 100 000 jobs downstream."

Meanwhile, mining giant Glencore has recently begun a retrenchment process at its ferrochrome and vanadium operations in South Africa, citing power cuts, rising electricity costs, and broader economic pressures.

"This is very concerning. The country cannot afford a job bloodbath. These retrenchments are putting immense pressure on families and local economies. Companies are citing various operational challenges, but the scale of the layoffs is alarming," said Matthew Parks, parliamentary coordinator at the Congress of South African Trade Unions (COSATU), a main labor federation of South Africa.

A similar trend has surfaced in the automotive sector, where Ford Motor's South African unit has announced job cuts and tyre manufacturer Goodyear is shutting down its factory as part of a

"realignment" of production capacity to current and expected market demand. "Although the industries differ, both face severe economic pressure. Rising costs, import competition, and operational inefficiencies are forcing companies to downsize, which is why we are seeing job cuts across multiple sectors," Parks told Xinhua in a phone interview.

Some mining companies have blamed soaring electricity costs. Parks noted that electricity tariffs had risen by about 450 per cent, putting pressure on businesses, and several smelters had already been forced to close. Parks noted that besides workers, the entire supply chain was feeling the pinch of retrenchments.

"The impact is significant. Direct job losses are only part of the problem. Indirect effects on suppliers, contractors, and local communities multiply the impact. Without urgent intervention on electricity costs and other structural challenges, more sectors could follow this trend," Parks added. Independent analyst Sandile Swana told Xinhua that South Africa should focus on providing cheaper and more abundant electricity to support struggling sectors and promote industrialisation.

He added that higher electricity prices were undermining the country's efforts to build an industrial base capable of sustaining smelters.

Sectors such as smelting were initially supported with cheaper electricity to encourage growth, but many are now closing and cutting jobs because they cannot keep up with rising costs, said Swana. *Xinhua*

"Every time he came here and did not find me at home, he would wait and when I finally showed up, as old as he was, he would sit on my lap and start making so much noise, hugging and showering me with affection. The way he was with people on

the streets, that is how he was at home," he said.

Even though A.T.I was a well-known musician, he never acted like he was a household name at home.

"That boy took interest in others, wanted others to be fine and made sure to give more of himself in everything he did, no matter how small it might have been," said Molemogi.

With the arrangements already full steam ahead of A.T.I's funeral service, former president, Kgosi Khama IV, also paid his respects to the Molemogi family Wednesday in Lerala.

He shared how he had wished to grow the creatives during a the time when he was the head of state, the period when he got to know about A.T.I.

"We are saddened by his untimely death and we wish to

pass our deepest condolences to you his family and may his soul rest in eternal peace," said Kgosi Khama

Equally saddened by A.T.I's death was Kgosi Sello Moroka III of Lerala who said Botswana had lost a diamond in the creative sector and it was up to Batswana to give A.T.I a thunderous send off.

"I also want to thank Kgosi Khama IV for coming here and sharing his condolences with us," he said, adding that he had learnt that the Vice President Ndaba Gaolathe and other senior government officials were expected to attend the funeral service

"Lerala is his final resting place and let us unite and bury this young man with dignity, respect and honour," said Kgosi Moroka. *BOPA*

# World Cup first phase of ticket sales starts Wednesday

**WASHINGTON** - FIFA has announced that the first round of ticket sales for the 2026 World Cup in the United States, Canada and Mexico will open September 10, with group-stage tickets starting at US\$60 and final tickets priced as high as US\$ 6,730. For the first time, the tournament will use dynamic pricing

"I think the message is 'Get your tickets early,' especially if you know where you will be, because you live in that city, or you're a fan of the three hosting nations, and then you know already when and where they will play," said Heimo Schirgi, the World Cup's chief operating officer on Wednesday.

"So that's the message: 'Get your tickets early,' because anything could happen," he added. Given the expected high demand, tickets will be released in phases.

The first phase, the "Visa Presale Draw," requires fans to register a FIFA Fan ID on

the official website.

Only Visa cardholders over the age of 18 will be eligible to apply.

The registration window will run from September 10-19, with successful applicants notified by email starting September 29 and assigned purchase time slots beginning October 1.

While tickets for all 104 matches will be put on sale, receiving a time slot does not guarantee availability.

FIFA said the second and third phases of sales would also follow a lottery system, scheduled for October 27-31 and after the final draw on December 5, 2025.

Closer to the tournament, fans will be able to purchase any remaining inventory on a first-come, first-served basis.

The 2026 FIFA World Cup will be held across 16 cities in the United States, Canada and Mexico from June to July 2026, marking the first edition of the tournament to feature 48 teams. *Xinhua*
