

Council, Swedish Municipality reaffirm partnership

LOBATSE - Lobatse Town Council has reaffirmed its commitment to strengthening its international partnership with Swedish, Bollnas Municipality in cultural heritage development.

The partnership started in 2022 aimed at promoting youth inclusivity in preserving culture and reviving heritage monuments with the objective of generating income, reducing youth unemployment and addressing social challenges.

Even though, it came to an end in 2024, it had not yet reached its intended goal of seeing cultural heritage sites refurbished and fully operational thus creating employment opportunities for the youth.

Therefore, the two authorities have taken a decision to extend the partnership.

Welcoming the Swedish delegation in Lobatse on Thursday, Lobatse Town Council Mayor, Mr Aron Ganakgomo said the partnership presented opportunities for the historic town

Mr Ganakgomo said Lobatse was endowed with cultural heritage sites in dire need of resuscitation adding that during Botswana's nascent years, developments included construction of the first tarred road covering 3km, radio station and the Legislative Council buildings.

As such, he said the history of Lobatse must be preserved.

Mayor Ganakgomo further reassured the Swedish delegation of the council's support for the Cultural Heritage project as cultural heritage tourism formed part of Lobatse Town Council development roadmap.

For his part, Bollnas Municipality Mayor, Mr Abdullahi Mohamed said they were pleased to strengthen the partnership between the two councils, which started in 2022.

Initially, he said the partnership was aimed at promoting democracy in developing countries in order to create opportunities for people living in poverty to positively influence their living conditions.

This time, he said, the aim was to deepen corporation between the two councils with the main focus on strengthening capacity with local companies in Lobatse and those in Bollnas, Non-Governmental Organisations as well as the youth.

Lobatse District Commissioner, Mr Mpho Mathe also appreciated the project, which he noted would go a long way in revitalising the first colonial capital of the country, rich with historical sites.

He noted that developing cultural heritage sites was part of government strategic plan to diversify the tourism portfolio through city tourism as well as harnessing cultural tourism.

Mr Mathe noted that the project was opportune, especially now as the country moved to implement the National Development plan 12 as part of the government road map.

"As a country we are quite strong on tourism safari, which was mostly concentrated up north, now we want to move into the space of urban and cultural tourism," he said.

Additionally, he said neighbouring countries such as South Africa and Mozambique had strong historic footprints of heritage in Lobatse. *BOPA*

#CountMeIn initiative to restore hope - minister

GABORONE - In an effort to combat the deteriorating state of schools infrastructure, the Ministry of Child Welfare and Basic Education has launched a nationwide campaign dubbed #CountMeIn.

The campaign is aimed at restoring dilapidated classrooms in flood-affected schools, starting with the most urgent cases, being senior secondary classrooms.

Speaking during the launch on Friday, Minister Nono Kgafela-Mokoka said the idea was conceived in the wake of devastating floods that impacted schools like Mogoditshane Senior Secondary School.

However, the initiative was delayed due to resource constraints.

Acknowledging the ongoing challenges facing the education sector, Ms Kgafela-Mokoka called on communities, businesses, alumni, media and stakeholders to help restore and rehabilitate dilapidated classrooms worsened by damage caused by floods.

"We cannot keep crying, we cannot keep folding our arms, we need to start this initiative and make a plea to the community, businesses, alumni, and stakeholders to participate and help us quickly restore classrooms that are going to be used for examinations," she said.

She said classrooms that would be used for examinations were in dire situation, as walls were spoilt with graffiti, broken windows, collapsing ceilings, and insufficient furniture, raising concerns about the validity

of national examinations and the perception of Botswana's education system locally and abroad.

Ms Kgafela-Mokoka said there was plan to designate weekends for community members, parents, teachers and local residents to come together and clean or repair school infrastructure.

The minister also encouraged maintenance and creativity, saying schools would be ranked based on restoration efforts and cleanliness and that winners would receive public recognition and possible rewards.

Meanwhile, Minsiter Kgafela-Mokoka reignited the vision with personal commitment by donating P20 000 to kick-start the campaign

To participate or make a pledge, she said individuals and organisations were encouraged to contact the ministry and follow updates using the #CountMeIn.

She further pointed out that the ministry would introduce digital classroom tracker; a monitoring system to digitally track the condition of classrooms, allowing the ministry to identify problem areas in real time.

She therefore called on private sector partners to contribute financially or in-kind, saying in the past, partnerships had proven effective and directly impacted on the future of the children. **BOPA**

Town clerk hails strides made in cooperation

GABORONE - The Lobatse Cultural change programme dubbed Youth Inclusiveness in Cultural Heritage is aimed at raising knowledge and awareness about Lobatse heritage sites and their potential to contribute to local economy.

Lobatse Town Clerk, Ms Lenamile Taolo said this during a Sweden, Bollnas Municipality delegation courtesy call to the Minister of Local Government and Traditional Affairs, Mr Ketlalefile Motshegwa on Thursday.

Ms Taolo said the objective of the project was to enhance local governance targeting youth by economically empowering them through local heritage sites in the town. She said cultural heritage was one of the key focus areas in the Lobatse Town Council Mayor's roadmap to place Lobatse as a destination of

cultural heritage. Therefore, she said Lobatse was better placed to advance issues of cultural heritage and diversify the tourism sector as it was more concentrated in flora and fauna tourism.

She said Lobatse Town Council and the Bollnas Municipality have been working together since 2022.

"We have made a significant achievement from 2022. So far there has been an immense exchange of knowledge and skills in running of community cultural heritage project. We had earmarked to train 20 tour guides but only eight graduated. They were mainly youth from Lobatse," she said.

Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa said the ministry was reviewing legislation to give prominence to traditional leadership, elevating them on issue of culture as it was part of heritage and human rights. "By virtue of their proximity to the people, they are in a better position to offer quality services to the people. Our motto for the Ministry is Batho Pele, meaning people first," he said.

He said they were also pioneering community-led development anchored on rural industrialisation to curb rural-urban migration in order to generate village economies.

Mr Motshegwa said he had also engaged local authorities to come up with a model template or prototype of what constituted an impactful and high performance local authority.

For his part, the head of the delegation, Ms Helen Berggren said they had partnered with Lobatse Town Council to learn more on cultural heritage.

She further said they wanted to strengthen capacity of the council to collaborate with the community in a more efficient way. **BOPA**

'Government is keen to hear from the private sector on how we can work together to include our natural capital in our planning and business decisions, as well as harness our natural capital not only to protect biodiversity, but to drive peace, prosperity and resilience," he said.

Mr Mmolotsi said Africa was $confronted \, by \, arapid \, and \, unplanned \,$ urbanisation, unsustainable resource use, illegal wildlife trade, pollution and invasive species, which were all contributing to ecosystem fragmentation and species extinction on an unprecedented scale. Therefore, he expressed concern that the inequitable sharing of benefits and natural resources use further undermined the ability to build resilient communities and economies.

"Current assessments show that Africa is the most affected continent with growing threats to food, water, and energy security," he added.

This, he said posed escalating risks to livelihoods, development and well-being, stressing that 'biodiversity loss, climate change and pollution were now recognised as inextricably linked, crisisthreatening the foundation of life on earth'. Mr Mmolotsi said the unprecedented laws of biodiversity and degradation of eco-systems were also eroding the productivity of vital services that sustained human well-being, food security and economic stability.

'Agriculture sector remains key for economy'

PANDAMATENGA-Agriculture remains one of the most impactful sectors, which can drive Botswana toward the achievement of the Botswana Transformation Economic Programme objectives.

Speaking during a tour of the Pandamatenga silos on Friday, Vice President Ndaba Gaolathe said there was need for urgent action in order to achieve economic transformation and assured the nation that government would invest in proper infrastructure services to ensure that agriculture effectively contributed toward the envisioned transformation of the economy.

Mr Gaolathe said with Pandamatenga rising up as an agronomy hub, government would avail relevant infrastructure to drive agricultural production and enhance output in the area.

He said the governments of Botswana and Zambia were in advanced discussions for the construction of the Mosetse-Kazungula-Livingstone railway line traversing through Pandamatenga aimed enhancing the movement of goods including food stored at the silos to the upper Zambezi region and rest of the continent.

Mr Gaolathe added that the projected Zambezi integrated agro-commercial development project, which incorporated the sourcing of water from the Chobe River basin for irrigation, was also intended to expand the output of the agricultural sector.

The Vice President also said the sourcing of power from Zimbabwe remained a concern Pandamatenga, adding however that embracing and adopting solar energy was a

of bountiful harvests. She said a total of 56 000 hectares was currently productive, and that it was projected that 42 000 more hectares would be added onto the total hectorage after a transfer of land from the Ministry of Lands and Agriculture.

She said the additional hectares would be dedicated to exploring the production of high value crops like hemp, safflower and cactus.

Ms Masie further underscored that SEZA strived to attract investors to set up processing warehouses in Pandamatenga in order to start selling processed and packaged products to the global market.

She added that the 60 000 metric tonnes newly-built silos were fully operational and that they were filled to capacity with grains. She said SEZA was working on phase two of the project, which entailed construction of a grain drier and CCTV camera installation.

GABORONE - The nation have been called to partner with the police and pray for hope, healing and mental strength for officers across the country.

The call was made Minister Assistant tne State President, Ms Maipelo Mophuting during the launch of the Botswana Police Sunday Church Service programme in Gaborone on Sunday.

Ms Mophuting stressed that spiritual welfare mattered just as much as physical welfare, hence the call.

"While they guard us with courage, we must cover them with prayer, while they protect our homes, we must protect their hearts," she said.

Furthermore, she said challenges faced by the country today, such as crime, violence, suicide, broken families, moral decay and youth unemployment, were not merely social issues, but spiritual battles requiring spiritual intervention.

"Prayer is not a passive act, prayer is power, it restores, it unites, it heals and it transforms,"

Ms Mophuting further said the Botswana Police Sunday Church Service sent a clear message to world that Botswana 'anchored not in fear, but in faith: not in division, but in unity'.

"This initiative aims to integrate prayer into Botswana's national identity and creating a culture where every citizen becomes a spiritual support system for the Police Service," she said, adding that 'every time we see a police officer, let it be a moment we whisper a prayer for

Police Commissioner, Ms Dinah Marathe said the new church service initiative was aesigned to strengthen spiritual resilience, offer emotional support and remind officers that they were not alone.

"Our officers encounter trauma almost daily, whether it is scenes of violence, tragic accidents, murders, suicide abused children and confronting armed criminals, or high-stress interventions, it is important that their mental wellbeing remains stable," said Ms Marathe.

She stressed the importance of nurturing the spirit, mind and body of officers so they could continue to serve with strength and dignity.

"Policing is not only about enforcing the law, it is also about serving communities with compassion, that becomes difficult when officers struggling internally," Marathe added.

She said the initiative had objectives of mobilising officers through prayer by encouraging deeper commitment to service regular through spiritual engagement, providing officers with a platform to confront personal and professional challenges through faith.

Also, she said the initiative served as a way of fostering unity through strengthening relationships between officers, religious leaders and communities, as well as promoting spiritual values by raising awareness on how spiritual grounding could combat societal ills.

The Botswana Police Sunday Church Service is expected to be held regularly and has been extended across the country's districts and police stations, reinforcing its purpose as a movement of faith, hope and national unity. **BOPA**

Kgosi Seretse declares ploughing season

SEROWE – Deputy Chief of Ga-Mmangwato, Kgosi Seretse Peter Khama had commissioned the 2025/26 ploughing season at Serowe main Kgotla on Sunday.

Officially launching the ploughing season commonly known as "Letsema" in Setswana, Kgosi Seretse implored Ba-Gammangwato to prioritise farming over other activities to ensure food security and self-sufficiency in the country.

Also, he encouraged the community to prepare for the season well in advance, catch the first and early rains and plough at the right time for optimum output.

Furthermore, he implored Batswana to service tractors, prepare draught power and other farming implements well on time as "the earliest bird catches the fattest worm."

Kgosi Seretse remained optimistic that there would be heavy downpours to enable Batswana to plough more hectares that would lead to a bumper harvest and wished Ba-Gammangwato a fruitful season.

He expressed optimism that God as the rainmaker would provide abundant rain, to enable farmers to contribute significantly to the national grain and food production.

Kgosi Seretse said they were pondering to resuscitate chieftainship ploughing fields dubbed 'Masota' which were in the past used to plough for morafe and store the grains in storage facilities or silos to be used when the need

He said such ploughing fields were idling and therefore utilising them would mean adding an impetus into revitalising the country's economy that was somewhat sluggish.

In an interview following the commissioning of Letsema, MP

for Serowe West, Mr Onalepelo Kedikilwe encouraged fellow citizens to take advantage of the 2025/26 ploughing and cropping season to boost food security in the country and reduce the hefty import bill.

Mr Kedikilwe said in recent years, Botswana experienced poor rains but was optimistic that the coming ploughing season would receive plenty of rain.

He said most farmers in the country were lagging behind in adoption of new technologies, adding these issues resulted in low productivity and profitability thus hindering progress in the agricultural sector.

He said back then, people were using draught power for ploughing which proved to be effective, but nowadays tractors were deployed for ploughing and in some instances people waited for tractors for prolonged times impacting on the ability to till the land at the correct time.

Mr Kedikilwe said it was vital to conduct soil testing as it determined nutrient levels, allowing farmers to add the correct amount of fertilizers which increased yields, improved plant health and resistance to diseases and parasites.

He concurred with Kgosi Seretse that using the appropriate technology would lead to increased productivity and economic viability as well as reducing unnecessary spending habits for farmers.

Ms Mmandu Pitlagano of Mogatsapoo lands in Serowe said she was committed to boosting food security in the country but some bottlenecks within the sector prevented her mission.

She said one of the challenges was that her ploughing field was in an area where soil composition was mostly black cotton soil which was slushy inaccessible during torrential rains due to water logging making ploughing impossible. **BOPA**

He called for the rescusitation of the Adopt-A-School concept, saying it allowed for individuals and community groups to partner with government on issues of education.

GABORONE - Police officers could use prayers from the nation to uplift them spiritually.

Speaking during the launch of the Botswana police church service held in Gaborone on Sunday, Apostolic Faith Mission (AFM) retired pastor Dr Johannes emphasised Kgwarapi importance of prayer in restoring hope, healing the nation's wounds and reinforcing moral values.

Medical practitioner discovers power of acupuncture

DAR ES SALAAM - At the acupuncture therapy unit of Mnazi Mmoja Hospital in Tanzania's Zanzibar, the soft sound of needles being prepared mingles with the calm voices of practitioners, mostly women trained in traditional Chinese medicine.

Among them is Fatma Ally Abdallah, a traditional Chinese practitioner who joined the hospital's acupuncture department in 2021. "I learned acupuncture right here from the Chinese medical team," she said with a proud smile.

"Every year, new Chinese doctors come, teaching us different acupuncture points for conditions like sciatica, stroke, and facial paralysis. Each visit brings us something new."

Abdallah's journey into practice began when she was introduced to acupuncture, cupping, and massage therapy. What started as curiosity soon turned into a calling.

"Since I began, I've treated

many patients, about 90 each month, most of them women," she told Xinhua recently. "People here truly appreciate acupuncture. It's natural, effective, and helps them find relief."

As women around the world prepare to commemorate the 30th anniversary of the Fourth World Conference on Women, often known as the Beijing Women's Conference, through the Global Summit of Women held in Beijing later this month, Abdallah's experience reflects one of the key themes of that landmark conference: empowering women through education, skills, and leadership.

At Mnazi Mmoja Hospital, empowerment is taking shape through acupuncture needles and the spirit of collaboration, with the acupuncture unit standing as a symbol of women's leadership in healthcare, a reminder that empowerment comes not only through policy but through

For Bai Xinyu, a female traditional Chinese medicine doctor stationed at the hospital, the mission went beyond treating patients.

"I believe in health equality," Bai said. "As a woman, I understand the cultural taboos local female patients face. Combining acupuncture with modern medicine respects their customs while ensuring effective treatment."

Her work, she said, was about empathy as much as it is about expertise.

"A doctor's value isn't just in skills, but in understanding people. When I see a local nurse become confident in her work after training, that's the most meaningful result." Zhou Fang, another member of the Chinese medical team, has viewed the practice as a valuable partner in the local healthcare system, noting that acupuncture worked well for chronic conditions like arthritis, back pain, and recovery after a

"I demonstrate, then supervise local practitioners as they perform the procedure themselves. The goal is for them to become independent.

We're not just providing aid; we're building a team that will continue the work long after we're gone." He praised his Tanzanian colleagues for their resilience and dedication.

At Mnazi Mmoja Hospital, the bridge between Chinese and Tanzanian medicine continues to grow, built by steady hands, shared knowledge, and a common belief in the power of healing. Abdallah dreams of going to China one day to further her studies. "I've learned a lot here," she said. "But I want to learn more, to master acupuncture and bring that knowledge back home." Her aspiration echoes the spirit of the 1995 Beijing conference, which called for women's full participation in science, education, and development.. Xinhua

SAMA cuts ties with Israeli counterpart, urges global suspension

CAPE TOWN - The South obligations" in the context of the (SAMA) has announced its decision to "immediately suspend all professional and bilateral relations" with the Israeli Medical Association (IMA), citing grave concerns over the humanitarian crisis in Gaza and alleged breaches of international medical ethics.

In a statement issued on Saturday, SAMA, which represents doctors across South Africa, said it would also press for the IMA's suspension from the World Medical Association (WMA).

SAMA said that these decisions, adopted on October 3 following what it described as "extensive consultations," reflect association's view that the IMA had failed to uphold "international medical ethics and humanitarian shortly after Israel's interception of the Global Sumud Flotilla and the detention of its participants in international waters as they attempted to deliver humanitarian aid to Gaza.

In the statement, SAMA said that its decisions would remain in effect until the IMA took "public and verifiable actions," including demanding the release of detained Palestinian medical personnel, condemning the destruction of Gaza's healthcare system, denouncing the use of starvation as a policy and the blockade of essential medical supplies, and taking active measures to ensure adequate medical care for all individuals under Israeli control. KANYE - President Advocate Duma Boko's recent signing of a Memorandum of Understanding (MOU) with Arton Capital, a leading investment migration consultancy, to launch a Citizenship by Investment (CIP) Programme could transform investor access to Botswana, says Mr Spencer Mogapi.

Botswana, boasting Africa's strongest credit ratings from Moody's and Standard & Poor's, offers a stable financial system and progressive policies for foreign businesses.

Against this backdrop, Mr Mogapi, a former journalist and communications expert at Tsogo Advisory, highlighted prime investment opportunities in the country's growing luxury tourism industry, renewable energy, mining, and financial services sectors.

"The programme will raise funds to address critical needs for Batswana, including investments in housing for immediate impact," Mr Mogapi stated.

The MoU aligns with Botswana's push to diversify its economy beyond the diamond trade.

Drawing parallels with developed nations, Mogapi cited the United States, where immigrants have driven economic success.

"Silicon Valley, a global hub for technology, innovation, and entrepreneurship, is largely built by immigrants," he said, commending the government's open immigration policies.

Mr Mogapi emphasised Botswana's international reputation for political stability, noting that its passport ranks fourth in Africa, as per Arton Capital's Passport Index.

With Arton's guidance, the government aims to secure the continent's top passport ranking by 2027, enabling visa-free access to major global markets for Batswana.

"Nothing should stop Botswana during this time of economic rebuilding," said Mr Mogapi. *BOPA*

'Public input vital for Liquor Act review'

FRANCISTOWN - Minister of Entrepreneurship and Trade, Mr Tiroeaone Ntsima says the concerns regarding alcohol sale and consumption is a cross cutting matter that require collaborative effort, hence ongoing public consultation on Liquor Amendment Bill.

Speaking during the consultative meeting on the review of the Liquor Act in Francistown on Friday, Minister Ntsima said the bill was close to many people therefore important for every Motswana to have an opportunity to present their proposed changes.

Mr Ntsima noted that the

review of the Liquor Act was envisaged to provide guidance on the best possible way to regulate the liquor industry and other matters related to.

In this regard, he said his Ministry consulted various stakeholders and came up with a draft of the Liquor Amendment bill of 2025, which seek to address challenges identified during implementation of the current act.He noted that currently, the Liquor Act prohibits the issuance of new liquor licenses to bars, club, discotheque and night clubs in premises which were less than 500 meters away from schools, highways, major roads and churches.

However, the bill considers the

possibility of reducing the current distance of 500 meters to 250 meters between a liquor outlet and schools, highways, major roads and churches.

As for noise pollution generated by the liquor stores such as bars, clubs and depots, disrupting peace and tranquility, Mr Ntsima said the bill propose to introduce sound proofing as a mandatory requirement in liquor outlets that play music to their patrons.

Mr Ntsima said the other challenge with the current Act, was that there was continuous non-compliance by liquor outlets and consumers, emanating from the existing low penalties, hence the need to increase them.

He said some of the proposed

changes to the act was the introduction of online liquor license, strict measure to those who sell alcohol to underage, advertising alcohol in prohibited areas, commercialising traditional beers, trading hours and places of drinking.

Mr Tera Issac suggested that the bill should be considerate of operating hours, as allowing bars and clubs to operate 24 hours, disadvantage those operating depots.

Mr Fanyana Mapete acknowledged the issue of compelling liquor outlets that play music to be sound proof, adding that the bill must consider hiring of DJs who played loud music in opening space. *BOPA*



Amusement park construction begins

ACCRA - A groundbreaking ceremony for an ultramodern amusement park built by Greenhouse International Development Group, a Chinese company, was held on Saturday at Afienya, near Ghana's port city of Tema.

Upon completion, the Bright Amusement International Park is expected to feature a five-star leisure resort hotel with 160 rooms and 20 independent presidential villas, a 5 000-capacity international conference and exhibition centre, a 160 000-square-meter water park, 500 high-end golf villas, an artificial beach, waterfront restaurants and sightseeing yachts.

Ghana president John Dramani Mahama, who broke ground for the commencement of the project, lauded Chinese investors for their continued confidence in Ghana as an investment destination.

The president noted that once opened, the amusement park would provide an avenue where, on weekends and holidays, Ghanaians of all walks of life and visitors from neighbouring West African countries could go and enjoy leisure time with their families and friends.

Mahama commended Greenhouse International Development Group for its projects since arriving in Ghana in 2011, including the Bright International Industrial Park, with multiple factories producing affordable products for Ghanaians and creating about 10 000 local jobs, as well as its investments in the agriculture and construction

He added that the Bright International Industrial Park and the Bright International Amusement Park become the epicenter of the government's 24-Hour Economy programme.

Zheng Xiangming, chairperson of Greenhouse International Development Group, said the amusement park would stand as another milestone in the friendship between Ghana and China.

"In the future, we will deeply integrate into Ghana's 24-Hour Economy, ensuring that this place is vibrant by day and brilliantly lit by night," Zheng added. Xinhua

whose Chihana, party formed the Blue Alliance with Mutharika's Democratic Progressive Party (DPP) in the election, becomes the second Malawian to hold the position of second vice president in the history of the country, after the position was held by his father, Chakufwa Chihana, who founded AFORD and served as second vice president from 1994 to 1996 and again from 2003 to 2004, both under president Bakili Muluzi.

The constitution of Malawi gives the president the mandate to appoint a second vice president, but other than Bakili Muluzi and Peter Mutharika, no other president had ever appointed a second vice president.

Mutharika also appointed veteran DPP member George Chaponda as foreign minister, and Joseph Mwanamvekha as minister of finance, economic

planning and development.

Chaponda Mwanamvekha had served in the same respective ministerial positions before, during Peter Mutharika's first presidency, from 2014 to 2020.

Former defense deputy commander George was appointed as chief of the Malawi Defence Force, while retired secretary for information Justin Saidi was appointed as chief secretary, with Stuart Ligomeka, a former secretary for local government, as his

The new president also appointed DPP Vice President for the Central Region Alfred Gangata as minister of state, a new ministerial portfolio.

Kiswell Dakamau, who served in a number of different senior positions before, including secretary for education and deputy director for local government, was appointed as director of state residences, another new portfolio.

The Malawian leader also appointed police commissioner Richard Luhanga as police inspector general. Xinhua

Gaolathe said the monument stood as a symbol of the rich cultural heritage of the Basubiya people and shone forth as a celebration of their unique identity. He described the monument as a hallmark of Basubiya's efforts aimed at safeguarding and preserving the cultural heritage and natural resources of the Chobe region.

The Vice President said the landmark would attract tourists from across the globe to come and immerse themselves in the beauty of the region and that of Botswana.

"Celebrate this work of art with a sense of pride and honour it by preserving it for your children,", he said, encouraging the community to jealously guard the monument, which captured the essence of the Chobe region through artistic work showing basketry, arts and crafts, crops, the diverse wildlife species and the towering palm trees.

Gaolathe also said Parakarungu had been an agricultural hub for many decades despite the constant incidents of human-wildlife conflict that the village was facing. He, however, stated that government would restore agriculture in the village and in the rest of the country through the Botswana Economic Transformation Programme.

Kgosi Johane Chika III said the monument showcased their cultural identity and told the story of the Basubiya to the rest of the world.

He remarked that the monument would attract tourists and investors to his village hence government should upgrade the road from Kachikau to Parakarungu to bitumen standard to facilitate ease of movement.

Regarding agriculture in the village, Kgosi Chika highlighted that Parakarungu had cemented itself as a renowned producer of maize since time immemorial and that travellers from afar used

to frequent the village to buy maize.

Chobe MP Simasiku Mapulanga said the monument brought about diversity for rural tourism where visitors would enjoy ecotourism products that allowed for interaction with locals.

Such interaction, he said was necessary for ensuring cultural preservation as it would afford tourists the opportunity to learn from locals and gain insights into the Basubiya culture and practices. He encouraged the people of Parakarungu to market their monument, which he described as a legacy that should be preserved to the world.

The monument was funded by Chobe Enclave Conservation Trust at a tune of P178,000 for design and construction. **BOPA**

GABORONE - President Advocate Duma Boko has applauded Team Botswana for representing the country with distinction at the 2025 World Athletics Championships in Tokyo, Japan.

Speaking at a dinner he hosted for Team Botswana on Thursday, President Boko said the athletes displayed an astonishing performance.

Botswana made history as the first African team to win the 4x400m men's relay at the meet. They also brought home gold and bronze medals in the men's 400 metres courtesy of Collen Kebinatshipi and Bayapo Ndori.

Furthermore, President Boko said as they wrestle with those challenges, the nation expected them to excel, putting a lot of pressure on them.

Minister for State President, Moeti Mohwasa said government remained committed to creating an enabling environment for youth to thrive across all sectors including sport. He therefore urged youth to take a leaf out of Team Botswana's book, adding that the athletes were a demonstration that through discipline and support success could be attained regardless of background.

Furthermore, Mohwasa said the role of coaches, support staff and

technical support during the 2025 World Athletics Championships could not go unnoticed.

He said their consistent work in preparing athletes to internationals standards was appreciated, adding that their professionalism continued to reflect positively on sporting institutions. *BOPA*

Injuries keep athletes off podium

GABORONE - Botswana's performance at the Paralympic Athletics Championships held in New Dehli, India from September 27 to October 5, was significantly hampered by lack of adequate preparation and key athlete injuries, the team's coach has said.

In an interview, coach Nason 'Hadji' Maotwe said their not-sogood performance was because of inadequate training.

Maotwe said they had two groups of athletes which included those that trained in Gaborone and Mochudi and that created a gap in their preparation.

He added that Thuso Baleseng's situation was also dicey because he stayed in Mochudi while his guide in the T11 category stayed in Morwa.

He said the athlete sometimes did not train when his guide was not available. However, he said things became better six weeks before the championships because they were then assisted to both train in Gaborone.

"But looking at performance, had he prepared well he could have won a medal, and a gold for that matter, because with less than two months of proper training he managed to drop a good time," he said.

Maotwe said another thing that cost Team Botswana was Edwin Masuge's injury that he sustained during the warmup, hence he started slow on the block. "But then again, the other challenge was that three weeks before we travelled to India, our office took a decision to change the whole technical team which was to travel with the team and then reversed it. That alone, affected the athletes' performance, because weeks before the competition everything was paused, but they were reinstated, which caused confusion," he said

Meanwhile, the team comprised Ronald Rich (200m, 400m T37), Masuge (400m T13), Tumo Masejane (400m T13) and Lame Monamati (400m T12).

Mokgwathi Bose represented the country in 400m T13 as well as Onkamile Bankaetse and his guide (400m T11) and Gloria Majaga in 400m T13 and 100m T13 while Katlego Matuto competed in 400m T12.

Mokgwathi was the only athlete who managed to salvage a bronze medal in the men's 400m T13 with a Personal Best time of 49.66.

Another medal prospect in the men's 400m T13, Masuge, did not make it to the podium as he finished sixth with 51.65.

Expectations were high that Gloria Majaga would increase the medal tally on Sunday, but she finished fourth in the women's 400m T13 final, with a time of 1:01.30. **BOPA**
