## Weak procurement plans delay project delivery

Botswana's Public Procurement Regulatory Authority (PPRA) has warned that weak planning, limited capacity in procuring entities and the lack of an e procurement system are undermining the country's public procurement framework, two years after the Public Procurement Act of 2021 came into force

Briefing the media in Gaborone recently, PPRA CEO Tumelo Motsumi said the Act, effective from April 14, 2022, expanded the Authority's regulatory mandate but exposed serious compliance gaps across government ministries, councils, land boards and stateowned enterprises.

She stressed that procurement decisions now rest fully with procuring entities' accounting officers, while the PPRA functions solely as a regulator and no longer handles tender awards or asset disposal, the latter now falling under the Public Finance Management framework.

# Francistown-Nata Road: Key transit node for SADC

# Government commits to modernise BDF

Government's commitment to maintaining a robust, modern and professional Botswana Defence Force (BDF) while simultaneously prioritising national development goals was the central theme at the recent BDF Senior Commander and Staff Programme, Class 17 of 2025, graduation ceremony in Gaborone.

Minister for State President, Mr Moeti Mohwasa, said the BDF must evolve its defence capabilities in line with emerging threats, critically maintaining a balance with other vital national priorities, including health, education, infrastructure and social welfare.

Minister Mohwasa emphasised the need for foundational role of a strong security apparatus in achieving national aspirations.

He added that the strength of security institutions was fundamental to the success of the national Vision 2036, Sustainable Development Goals (SDGs) and the Botswana Economic Transformation Programme (BTEP.

He commended the Commanderin-Chief of the Armed Forces for his unwavering support of professional military education, owing to the exceptional quality of officers being produced.

He also highlighted that a modern and responsible defence force necessitated a significant investment in human capital to position it as a cornerstone of military leadership.

Thus, he urged the graduating officers to embody the qualities demanded by their profession, including integrity, accountability, courage, humility, empathy and resilience.

He further stated that their strategic thinking, innovation and problem-solving skills would be essential in environments where prudence and efficiency were not optional, but imperative.

On the graduation, he said the ceremony was a testament to the continent's shared commitment to collective security, with participants from across the region.

Minister Mohwasa highlighted the importance of the continental participation, stating that it demonstrated the strength of continental bonds and played a crucial role of military diplomacy.

For his part, Commandant of the BDF Defence Command and Staff College, Colonel Dumisani Ndzinge, expressed gratitude to the staff for their commitment to excellence and for creating a conducive learning environment.

Col. Ndzinge said the curriculum ensured that graduates were prepared for the complex modern threat landscape.

He said the Strategic Studies curriculum, delivered by the University of Botswana's Department of Political and Administrative Studies, alongside the core Military Curriculum, was key to such effort.

He explained that such collaboration ensured that they produced robust war fighters who were also academically skilled with deep understanding

of the geopolitical and strategic environment within which the military operated.

A key highlight of the event was the presentation of the best research paper award to Major Kehumile Modimoosi, whose work focused on the assessment of psychological stress on officers returning from war zones.

Inspired by her role as a mother, Major Modimoosi's research shed light on how post-deployment challenges can significantly affect an officer's cognitive mentality and prevent them from executing their duties effectively.

She emphasised that there was critical need for the organisation to formally address traumas, noting her focus on the issue of

extended separation from families and the subsequent difficulty of reintegration due to changed family dynamics. Major Modimoosi acknowledged the BDF's proactive measures, including established programmes to assist remaining families and conducting orientations prior to deployment.

Meanwhile, the graduating cohort comprised 60 officers, a group that included civil servants from local institutions like the Ministry of International Relations, Botswana Police Service and the Directorate on Corruption and Economic Crime.

The cohort included military officers from Lesotho, Kenya, Malawi, Nigeria, Rwanda, Zambia and Zimbabwe. **BOPA** 

## Water project offers glimmer of hope

When the Maun Water Supply and Sanitation Phase II started in 2021, Maun residents celebrated with high hopes that it would offer a long-awaited solution to inconsistent water

They pinned their hopes on the project, envisaging that it would improve economic opportunities, health and livelihoods, among other benefits, after years of experiencing persistent water shortages despite the area having water sources such as rivers. The situation forced the Water Utilities Corporation (WUC) to undertake measures like rationing. However, that was not satisfactory, as many residents believed that water was a fundamental right and everyone had the right to sufficient, safe and accessible water for personal and domestic use.

However, government's implementation of the multi-billion Pula project, intended to provide reliable access to clean, quality water and improve sanitation services in Maun and surrounding areas, brought hope to residents and fostered resilience against water scarcity.

The project was originally planned to be completed in 2023, but this was not the case as it is still ongoing due to several challenges encountered by contractors. It was unbundled into four components and awarded to four different contractors. Recently, the Ministry of Water and Human Settlement took the district leadership

and other stakeholders on a tour to review the project's progress and the challenges that had caused the delay.

Deputy director from the Department of Technical Services, Mr Vincent Kinnear, recently admitted that the project had experienced delays but noted that some components were almost complete. Updating the gathering on the progress of the components implemented by Contractor I and 2, he highlighted that they intended to secure water sources, treat and distribute water to Maun and satellite villages to meet their water demand and improve sanitation infrastructure.

The gathering learned that the delay in the extension of power to nine boreholes in the Gogomoga-Chuchubega wellfields by the Botswana Power Corporation (BPC) was one of the major challenges causing water shortages in Maun and surrounding villages.

Mr Kinnear informed them that they had engaged BPC to provide adequate power for the operation of the aeration or filtration process, but were experiencing some delays. He said once the boreholes were electrified, shortage of water would be a thing of the past, as there would be water security and residents would enjoy reliable supply of quality potable water. He also acknowledged other challenges that contributed to the project delays, which he said were, however, beyond their control. He cited the COVID-19 outbreak, the contractor's difficulty in accessing boreholes due to high water levels in the river channel, change in borehole

water quality as well as poor condition of borehole casings and screens, which compromised the integrity of the boreholes to the design horizon.

To mitigate the situation, he said works were reprogrammed to take cognisance of the water levels, and the contractor had to drill 13 additional boreholes to ensure that water supply can be secured to the 2038 design horizon.

"The project is almost complete and the actual progress stood at 99.7 per cent. We had anticipated it to be complete by the end of November this year, but we now anticipate an extension to February 28, 2026, pending the completion of works by BPC," he added.

Mr Kinnear further explained that Contractor I was responsible for water distribution and sanitation networks in Maun, while Contractor 2 focused on water source development, treatment and storage, including supply to Nxaraga, Komana and Somelo villages. Earlier, Kgosi Tawana Moremi thanked officials from the Ministry of Water and Human Settlement for the update, noting that two years ago, there were many complaints from community members as they experienced severe water shortages, but with time, the situation had improved.

Moreover, Kgosi Tawana said he wished contractors could accelerate their efforts to complete the project, and was optimistic that it would help alleviate the village's persistent water shortage. He emphasised the urgency of the project, urging authorities to avoid any more delays. **BOPA** 

## Germany lauds Botswana for climate action efforts

The German government has lauded Botswana through the Ministry of Environment and Tourism for committing funds into sustainable projects that championed conser-

Speaking during a recent visit at the Department of Environment and Wildlife in Kasane, the German Ambassador to Botswana, Ms Gabriela Bennemann said it was imperative for them as the funders of SADC Transfrontier Conservation Areas to appreciate the projects they had invested in.

Ms Bennemann said Botswana was an important partner in fighting climate change and preserving the flora and fauna. She added that Botswana was a model of conservation of natural resources which she attributed to the human wildlife coexistence frameworks that were crafted by the government.

She stated that the German government had injected over €200 million financing Kavango Zambezi Transfrontier (KAZA) Conservation Areas for wildlife management and biodiversity management projects.

She said she was happy that German tourists were benefactors of the riverfront road maintenance inside the Chobe National Park which was funded by German government. For his part, Department of Wildlife and National Parks regional director-Chobe, Mr Batshani Nduchwa stated that Chobe was endowed with diverse and rich wildlife species which attracted an influx of tourists to the region.

However, Mr Nduchwa said due to communal land sitting between Chobe river and the national park, there was a plight of human wildlife conflict caused by wildlife traversing through farms and cattleposts.

He said the funding from the German government impacted positively in mitigating human wildlife conflict. He said Germany funded his department through KAZA to build three solar powered boreholes Kazuma-Chobe wildlife dispersal area to safeguard communities and de-concentrate wildlife from communal areas. Also, he said the German government had funded maintenance of Chobe riverfront roads and purchased a grader that was dedicated to maintaining roads inside the park.

Furthermore, he indicated that they were funded for construction of eight staff houses at Chobe National Park and Pandamatenga staff houses. He thanked the German government for addressing the critical needs for conservation to attain biodiversity. **BOPA** 

# BOB maintains 3.5 per cent monetary policy rate

Monetary Policy Rate remains at 3.5 per cent to help manage inflation and safeguard economic stability, says Governor Lesego Moseki at MPC meeting

Speaking during a Monetary Policy Committee (MPC) media briefing Governor Moseki said the MPC met at a time when the global economy continued to face shifting trading patterns and heightened geopolitical tensions.

Despite these challenges, he noted that the global economy had shown stronger-than-expected resilience in 2025.

"Domestically, increased uncertainty and continued weakness in the diamond market have put pressure on Botswana's fiscal and external buffers," he said.

Looking ahead, Mr Moseki stressed that accelerating growthenhancing initiatives and economic diversification efforts, as outlined in the Botswana Economic Transformation Programme (BTEP) and National Development Plan 12, was essential for supporting a sustainable recovery in 2026.

He added that Botswana's strong institutions and sound macroeconomic policy framework provided an opportunity to attract investments capable of driving economic transformation.

The Governor also revealed that Botswana's real Gross Domestic Product (GDP) contracted by three per cent in the 12 months to June 2025,a sharper decline compared to the 0.6 per cent contraction reported at the end of 2024.

'The weak performance was mainly due to the continued contraction in mining output and subdued non-mining sector activity," he explained.

On inflation, Mr Moseki said headline inflation rose slightly from 3.7 per cent in September to 3.9 per cent in October 2025, remaining within the mediumterm objective range of three to six percent.

"The marginal increase in

inflation was attributable to higher price increases for alcoholic beverages, tobacco and transport, mainly due to price pressures stemming from the July 2025 adjustment of exchange rate

parameters," he noted.

The MPC forecasts inflation to increase into medium term averaging 2.7 per cent in 2025 and 5.3 per cent in 2026. However, Mr Moseki cautioned that the overall risk of inflation exceeding current projections remains elevated.

He added that the economy is

expected to continue operating below full capacity in the short to medium term, which should limit demand-driven inflationary pressures. The Governor announced that the MPC has also directed that the seven-day Bank of Botswana Certificates, repos and reverse repos will be conducted at the policy rate of 3.5 per cent. The standing deposit facility (SDF) rate will remain at 2.5 percent with 100 basis points below the policy rate. Commercial banks have been instructed not to increase their prime lending rates. BOPA

Ms Motsumi emphasised that the Act places full responsibility for procurement decisions on procuring entities, represented by accounting officers, while the PPRA serves strictly as a regulator.

Despite its national oversight mandate, the Authority is currently operating with only five staff members. As a result, Ms Motsumi said the PPRA was unable to conduct regular audits, investigations and monitoring.

We do not have an e-procurement system. Everything is manual. This makes oversight difficult and increases the cost of monitoring," she added.

She further noted that poor procurement planning remained one of the biggest contributors to delays and wastage. Many entities either failed to submit procurement plans on time or disregarded them entirely, resulting in emergency purchasing and in some cases, directed appointments that bypass competitive bidding.

She described most of these emergencies as "man-made, created by internal inefficiencies rather than unavoidable circumstances.

According to PPRA statistics, 78 800 procurement processes were

recorded across public entities in the 2023/24 financial year. While 74 per cent of tenders were awarded to citizen-owned companies, these accounted for only 38 per cent of the total contract value.

"Citizen companies continue to dominate in low-value contracts, while high-value projects are mostly awarded to foreign contractors due to capacity gaps,' Ms Motsumi said.

She also raised concern about the increasing reliance on microprocurement, which accounted for 25 per cent of all awards, amounting to P8 billion. This trend, she warned, may point to tender splitting and poor planning, both of which undermine transparency and competition.

Addressing recurring public allegations of interference by the Directorate of Intelligence and Security (DIS), Ms Motsumi clarified that the agency has no legal authority in procurement.

The DIS is not a procuring entity. It does not award or cancel tenders. Its role is limited to offering intelligence advice where security or fraud risks are identified," she stated.

In the last financial year, PPRA investigated 23 complaints, many involving alleged irregularities, delays and non-compliance. The Authority subsequently suspended 43 contractors for fraudulent practices and blacklisted eight companies.

To strengthen the system, Ms Motsumi said the PPRA had developed a new procurement audit manual, conducted more than 60 capacity-building workshops and issued 24 price guides to help government entities with standardised cost estimations. The Authority is also working with the Ministry of Finance to develop a national e-procurement system that will enable real-time tracking of tenders and reduce manual

The PPRA's long-term goal, she added, is to professionalise the procurement function across the public service through clear career pathways, standard qualifications and accreditation for procurement

Ms Motsumi warned that procurement failures continue to affect service delivery, noting that weak supervision and contract management contribute to stalled projects, cost overruns and poor workmanship.

"Procurement is central to government performance. Where it fails, service delivery suffers," she said. BOPA

## Collective action crucial to peace restoration

University of Botswana Vice Chancellor, Professor David Norris, has called for collective action to restore the country's cherished peace amid growing social challenges.

Delivering welcome remarks at a two-day Peace Conference and Festival, Professor Norris noted that Botswana is grappling with rising gender-based violence, increasing divorce rates, and the proliferation of illicit drugs, issues that are deeply affecting families, communities, and the nation at large.

He said the troubling realities of child-headed households, high unemployment, and the rising incidence of white-collar crime, corruption, and organised criminal activity serve as reminders that peace is more than the absence of conflict; it is the presence of justice, compassion, and shared responsibility.

Emphasising the conference theme: Let Us Heal; We Owe It to Ourselves, Professor Norris described it as a rallying call for self-reflection and unified effort. He said the gathering offers an invaluable platform for learning, dialogue, and reflection on fostering peace within relationships, institutions, and the broader national fabric.

Expressing concern, he noted that Botswana's long-held pride as a peaceful and vibrant nation appears to be fading, citing recent incidents of violence and social unrest as troubling signs of a society in need of moral renewal. He urged participants to serve as catalysts for change, stressing that ordinary citizens hold the power to help rebuild trust and social cohesion.

He condemned recent divisions and violent acts, saying they are uncharacteristic of Batswana and contrary to the country's core values. Moral renewal, social justice, and collective responsibility, he said, are essential ingredients for lasting peace and stability.

Little Eden's Justice and Peace Centre board chairperson, Rev Dr Enole Ditsheko, shared how a 2013 encounter between his family and five boys commonly referred to as bo bashi (street children)led to the establishment of the centre. He recounted how the boys spoke of dropping out of school, illness, and substance

While some dismissed them as delinquents, Rev. Dr Ditsheko said they were children in need of love, care, and guidance. He urged society to reflect on where things went wrong, noting that the breakdown of modern family support systems had worsened vulnerabilities among young people.**BOPA**

## Serowe District registers 89 teenage pregnancies

Serowe District Development Committee (DDC) reports that the district documented 89 cases of teenage pregnancies.

Speaking during Serowe District Council Full session recently, Principal District Officer-Development, Mr Mmoloki Batlang said they discovered that Swaneng Hill Senior Secondary School was topping the list for registered pregnancies in schools.

He shared that a significant number of pregnancies stemmed from younger girls being exploited by older men, primarily from the working class, like taxi drivers, who enticed the girls into sexual encounters by promising them money, electronic devices, and various material possessions.

Furthermore, he said in many instances, parents knew about the defilement but decide to ignore it in return for the culprit purchasing groceries and other necessities, as well as sending money to the victim's family.

In addition, he said such actions undermined justice in the process of protecting the offender.

'Many parents do not report instances of defilement, much less underage pregnancies stemming from defilement; they prefer to accept the offender as their child's partner. They just require the offender to support their family's maintenance," said Mr Batlang.

Mr Batlang said the district was pleased with the increase in HIV testing, noting that in the last quarter, 1 702 individuals were tested, while the current quarter recored 2 470 individuals.

He also mentioned that out of the 2 470 individuals who tested, 39 were found to be HIV positive; 26 women and 13 men.

Over and above, he disclosed that there were currently 15 794 HIV positive individuals actively receiving Antiretroviral Therapy.

Mr Batlang shared that at present, there were 110 children under 12 on Highly Active Antiretroviral Therapy (HAART).

He also disclosed that 35 patients began Antiretroviral Therapy this quarter, emphasising that, regrettably, a total of 12 patients (including adults and children) had passed away while receiving HAART.

Regarding drug availability, Mr

Batlang mentioned that there had been a decline, pointing out that last quarter the district recorded 68 per cent drug availability, while this quarter they noted 65 per cent drug availability.

He mentioned that the availability of essential drugs stood at 78 per cent, nonessential drugs at 59 per cent, and vital drugs at 68 per cent.

He remarked that despite shortage of antiretroviral, the outlook appeared to improve as additional medications had been secured, allowing some patients to receive a month's supply.

However, he pointed out that they continued to face a shortage of antiretroviral drugs. particularly for clients with renal issues, but remained hopeful that the situation would improve in the near future. BOPA

# Boago finds purpose to live

Twenty-eight-year-old Mr Boago Tsietsi was raised by his loving grandmother, Ms Obabaletse Malema in Ramokgonami after the demise of his mother.

He was one-year-old at the time. Fast forward, Mr Tsietsi is currently a guidance and counseling teacher and lives openly about his HIV-positive status. He recently took to social media platforms to disclose his health status.

This comes at the backdrop of a prolonged battle with emotions, self-rejection, and sometimes suicidal thoughts that made it difficult to accept his HIV status. Mr Tsietsi relays that ever since going public and posting about his HIV status on Instagram, many people, especially those within the age bracket of 20 to 35 year have started reaching out to him about their HIV status.

"The fact that some people did not believe what I narrated concerning my HIV status led me to ask my Mama to make a full reference video to cater for the doubtful," he said.

The video is a testimony of how Mr Tsietsi 's life has evolved over the years. It is a rare journey that many caregivers and few individuals born with HIV have not embarked on yet, to acknowledge and live openly with their positive status for fear of victimisation. "I started my antiretroviral (ART) medication at standard six," he said adding that he only started learning about HIV/AIDS years later during school lessons.

According to him, the lessons were delivered in a manner that instilled fear. "Obviously when taught about something as deadly and scary as it was purported, it sticks to your mind as a kid," he said.

Mr Tsietsi recalls one time he and his 'Mama' visited the doctor in one of the regular checkups and was asked by the latter if he knew why he was taking HIV treatment.

HIV was news to him, let alone his HIV status. His 'Mama' had never mentioned anything about this condition to him. "I told the doctor that I was not aware why I took the medication. "Ke ne ke itse gore, Olady ga a ise a mpolelele

le fa e le sepe", he said, literally translating, I knew that my mother had never mentioned anything to me.

After the disclosure, the young Mr Tsietsi started looking at himself differently from the rest of his fellow classmates and friends. He wanted to quit taking the medication so that he could die quickly and save himself from

the shame of the condition.
In fact, while doing Form One, he fell sick to a point he could not even walk because he defaulted on the medication, a secret he

The Ministry of Health has initiated measures to address the unuasual rise of Tuberculosis (TB) treatment failure.

In a press release, the ministry **⊥** notes that the specific batch of the TB drugs with the poor outcomes were quarantined and taken for testing.

The results shows that the concerned Fixed Dose Combination (FDC) drugs are deficient of two critical anti-TB molecules: Rifampicin and Ethambutol.

Although it is possible for some patients not to respond to treatment for various reasons, investigations discovered that the 40 patients affected are nearly double the 22 patients reported with similar issues at the same time last year.

MOH also reveals that all

patients who are exposed to the concerned drugs are currently being clinically re-assessed and managed with alternative drugs according to their stage of treatment.

"In addition, clinical guidelines have been developed to guide clinicians and health care workers across the country on the appropriate steps to take, including psychosocial support," states the release.
The press release further

notes that contact tracing

and routine community TB screening continue as part of the Ministry's prevention efforts, hence advice to the public not to panic, but to take precautions to reduce TB transmission by avoiding congregated settings, staying in well-ventilated spaces and practicing cough etiquette.

It says anyone experiencing signs and symptoms of TB like cough, unintentional weight loss, fever and night sweats, is advised to report to the nearest

health facility so that they can be screened and or tested for

about their status.

# Mukuru fuels women-led businesses

In the small village of Tatisiding 📘 near Francistown, a quiet revolution is taking place. Women like Ms Goitse Monyatsi are breaking down barriers and seizing economic opportunities, thanks to Mukuru's Gazang

As an agent of Mukuru, a nonbanking financial institution operating in the Southern African Development Community (SADC) region, Ms Monyatsi has transformed her life and the lives of many women in her community.

Before joining the Mukuru, Ms Monyatsi and 10 other women from Tatisiding and Shashe Bridge were running a community-based savings group called Motshelo Financial Scheme, largely run by women in Botswana.

For the last five years, she has dedicated herself to fostering financial inclusion and economic empowerment within her community, inspired by a model she learned from a friend in Zimbabwe, where Mukuru was born in 2004.

"The Gazang initiative of Mukuru has transformed not just my life but those of many women in our community," said Ms Monyatsi. From humble beginnings, she has witnessed first-hand how this innovative financial solution has facilitated cross-border transactions and promoted regional trade, creating opportunities for women to save, invest, and support one another financially.

The Mukuru's Gazang initiative has rapidly spread its wings across different countries, cementing its positions as a significant force among non-banking financial institutions (NBFIs) in the SADC region allowing members to access financial services and conduct business across borders.

Ms Monyatsi explained that with the Gazang's trans-border transaction capabilities, women in business could now purchase goods and services from suppliers in other countries, and receive payments from customers in different currencies.

"It has been incredible to see our members' businesses grow and expand into new markets," Ms Monyatsi said.

Shedding more light into how Mukuru operates, she said a member from Botswana could now buy crops from a farmer in Zimbabwe, and pay for them in Botswana Pula.

The Mukuru's non-banking financial institution model has also provided women with access to financial services that were previously out of reach.

"Many of our members were previously excluded from traditional banking services, but the Mukuru business initiative has given them a secure and reliable way to manage their finances," she explained.

Ms Monyatsi added that Mukuru's impact went beyond just facilitating transactions as it also served as a beacon for collective empowerment.

"It is also about empowering women to take control of their finances and make informed decisions about their businesses. We have been seeing women become more confident and independent, and that is the greatest reward for us," she said. Another woman using

Mukuru's Gazang initiative from Francistown, Ms Nyaladzani Maluke of Sekokwe near Matshelagabedi, said most of her clients were Zambians and Zimbahweans.

She explained that on a good day, she can have 20 clients transacting huge sums of money to their respective countries.

Ms Maluke stated that Mukuru appeared to be the cheapest and easiest method of money transfer, and was particularly convenient.

"Many people prefer Mukuru because it is convenient and accessible, their outlets are scattered everywhere," said Ms

Ms Maluke further praised Mukuru as a game-changer for cross-border transactions, offering a remarkably swift and user-friendly experience that had significantly simplified remittances for clients.

"With the Gazang's transborder transaction capabilities, women in business could now purchase goods and services from suppliers in other countries, and receive payments from customers in different currencies."

She spoke highly of Mukuru's impact, noting that its simplicity and speed had revolutionised how her clients handled international money transfers. She added that the extensive network of Mukuru outlets across the region made it an indispensable service for her customers, offering them unmatched convenience and reliability.

The narrative of local financial initiatives like Mukuru is intertwined with the historical journey of regional integration that SADC has embarked upon since its inception in 1981.

Former leaders such as Botswana' Sir Seretse Khama and Angola's Eduardo Dos Santos, King Sobhuza II of eSwatini, Moshoeshoe II of Lesotho, convened in Lusaka, Zambia for a pivotal meeting that laid the groundwork for what would evolve into SADC, which today encompasses 16 member states, each represented by its own NBFI, such as Botswana's NBFIRA.

At an Annual General Meeting (AGM) held in Maun in October, chairperson of the Committee of Insurance, Securities and Non-Banking Financial Authorities (CISNA) Mr Kenneth Matomola, emphasised the importance of building on the foundation laid by the founding fathers.

"We are enjoying the fruits of our founding presidents who are no longer with us. Today, let us honour their legacy by putting into practice the foundation they have laid so that our region becomes prosperous; where economic growth can thrive with an inclusive financial system," he added.

Mr Matomola explained that as the region looked to the future, it was clear that the power of regional integration would be a key driver of growth and prosperity. Each nation, represented by its own NBFI, contributes to this collective vision, which Mr Matomola emphasised as crucial for economic growth and integration. The impact of NBFIs on regional economies cannot be overstated. Their footprints in emerging economies like Egypt, South Africa, and Nigeria clearly show that NBFIs can drive growth through offering innovative financial solutions.

In Zambia, for example, mobile-based financial services similar in nature to Mukuru, have enhanced credit access for small businesses and underserved populations, promoting inclusive

economic growth.

Botswana's Vice President, Mr Ndaba Gaolathe highlighted this importance at the same CISNA AGM that was held in Maun.

He reiterated that regional integration was pivotal for economic advancement and that NBFIs played a vital role in Botswana's Economic Transformation Programme (BETP).

"Through BETP, the nation aims to move beyond its dependency on diamonds, striving for diverse, export-driven growth and financial innovation," he said.

Mr Gaolathe underscored the impressive growth of NBFIs in Botswana, with total assets increasing from approximately P35 billion in 2013 to P185 billion in 2024. Nevertheless, he acknowledged the challenges, including outdated regulatory frameworks and limited product offerings. "Addressing these obstacles is essential for creating a more dynamic financial environment," said the Vice President.

He explained that it was time for SADC countries to embrace

the potential of NBFIs as a means of fostering economic growth and regional integration.

He called for a collective effort to close the gap between the world of high finance and community trust, ensuring that financial inclusion became a lived experience for every citizen.

Mr Gaolathe stated that the journey toward regional integration and economic prosperity was one of progress, innovation, and community spirit. "By continuing to build on the foundations laid by pioneering leaders and fostering home-grown solutions, SADC can unlock its true potential for growth and prosperity," he said. He explained that the road

He explained that the road ahead was illuminated by the remarkable stories of local champions rising to meet the challenges of the future.

challenges of the future.

"Together, we can harness the spirit of community and innovation, paving the way toward a bright and financially inclusive future for the entire SADC region," he said.

Mr Gaolathe identified the

Mr Gaolathe identified the non-banking sector as a key contributor to Botswana's economic turnaround, through BETP). "The BETP aims to diversify Botswana's economy beyond diamond dependency, with a focus on export-driven growth, technology-enabled innovation, and financial inclusion. NBFIs are expected to play a vital role in driving this transformation," said the Vice President.

The board chairperson of Botswana's NBFIRA, Mr Thabo Gaadingwe, has admitted that the global financial ecosystem was undergoing a period of rapid and profound transformation.

"The rise of digital assets, decentralised finance, and other innovations continuously

challenges our regulatory agility. Yet, within this challenge lies our greatest opportunity, to collaborate more deeply, harmonise our standards, and ensure that the citizens of the SADC region are not only protected, but are active participants in this new financial era," he said. Mr Gaadingwe emphasised the critical role that NBFIs played in facilitating cross-border transactions and driving economic growth in the

region.

"NBFIs, such as microfinance institutions, insurance companies, and pension funds, are becoming increasingly important players in the financial sector, providing essential services to underserved populations and driving economic growth," he said.

To fully harness the potential of NBFIs in regional trade, Mr Gaadingwe also called for the development of harmonised regulatory frameworks, investment in digital infrastructure, and greater collaboration between NBFIs, governments, and other stakeholders. Some of the specific solutions that can be implemented include streamlining crossborder payment systems where NBFIs can work with governments and private sector companies to develop efficient and secure cross-border payment systems, reducing transaction costs and increasing the speed of remittances.

For example, this can be achieved through the implementation of block chainbased payment systems, which can increase transparency and reduce costs. However, Mr Gaadingwe also indicated that there was need in developing trade finance solutions so that NBFIs could provide trade finance solutions, such as letters of credit, guarantees, and factoring, to support small and medium-sized enterprises engaged in cross-border trade.

This, he said could be achieved through partnerships with international trade finance institutions and the development of specialised trade finance products.

In addition, he said there was need to enhance financial literacy so that NBFIs could invest in financial literacy programmes to educate citizens on the benefits and risks of crossborder transactions, as well as the services offered by NBFIs.

"The future of finance is digital, and we must work together to ensure that our regulatory frameworks, infrastructure and financial institutions are equipped to harness the benefits of this new era."

"This can be achieved through the development of online educational resources and community outreach programmes. The SADC region has significant potential for crossborder trade, with intra-regional trade accounting for over 50 per cent of the region's total trade," he said. However, the region faces significant challenges in facilitating cross-border transactions, including regulatory hurdles. Differences in regulatory frameworks and standards across countries can create challenges for NBFIs and other financial institutions seeking to operate across borders.

By addressing these challenges and harnessing the potential of digital assets and cross-border trade, the SADC region can unlock significant economic growth and development opportunities.

"The future of finance is digital, and we must work together to ensure that our regulatory frameworks, infrastructure, and financial institutions are equipped to harness the benefits of this new era, "said Mr Gaadingwe.

He explained further that nonbanking financial institutions had stood as a beacon of regional cooperation for years.

The challenge ahead is clear - to bridge the world of high finance with the world of community trust and to make financial inclusion a lived reality for every citizen across the region.

For NBFI users, the future is indeed bright. With the support of governments and regulatory bodies, Ms Monyatsi, Ms Maluke and their fellows are poised to unlock the full potential of NBFIs, driving economic growth and prosperity for generations to come. **BOPA**

# No legal framework for expungement of fingerprints

The Assistant Minister for State President, Ms Maipelo Mophuting says there is no established legal framework for the expungement of fingerprints or records to minor offences, though government is aware that reformed and rehabilitated ex-offenders continue to experience persistent stigma and discrimination. The ex-offenders experience stigma particularly in accessing employment and other opportunities, she said. These challenges, Ms Mphuting said undermined ex-offenders reintegration into society and might in some cases reverse the progress made through rehabilitation initiatives. However, she said there was presidential pardon where individuals might apply for pardon to the President and depending on the gravity of the matter, such pardon might be granted allowing employment of the said individual. In the light of these concerns Ms Mophuting said the proposal to develop legal framework for the expungement of records for minor offences was worthy of careful consideration. In addition, she the government was committed to exploring the matter with a view to Determining an appropriate and comprehensive policy approach that safeguarded public interest and supported the restoration of dignity for rehabilitated individuals. Kgatleng Central MP, Mr Mpho Morolong, inquired if the minister would consider the development of a legal framework that allowed for individuals with minor or civil convictions to apply for expungement of finger prints after a period of demonstrated

# Allocation based on land tenure type

The type of land tenure in areas under the Chobe and Tawana land boards determines which authority is responsible for land allocation, Minister of Lands and Agriculture, Dr Edwin Dikoloti, has told Parliament. Responding to a question from Chobe MP, Mr Simasiku Mapulanga, on Thursday, Dr Dikoloti said some allocations in the Chobe District fall under state land as they lie within the Chobe National Park, while others in the North West District were administered by the Tawana Land Board. He said the Chobe Land Board made allocations only on portions that are designated as tribal land. "The Savuti and Linyanti are river channels that cut across two districts, being the North West and Chobe," he said, adding that this geographical reality explains the dual jurisdiction. Dr Dikoloti said Chobe Land Board holds one lease for CHI, which is between the board and the Chobe Enclave Conservation Trust. Tawana Land Board, he added, also holds one lease in the area, for NG15, which is leased to Linyanti Investments trading as Wilderness Safaris. In addition, there are 11 leases in the area under the jurisdiction of the Department of Lands. The minister explained that Tawana Land board did not allocate Iand that fell within the Chobe Land board area of jurisdiction. Chobe MP, Mr Simasiku Mapulanga had asked the minister to state who between Chobe and Tawana land board was responsible for allocating land in the Savuti and Linyanti areas, the number of leases held by each authority; and why Tawana Land board allocated land in areas that fell within the Chobe jurisdiction.

# Ramogapi outlines five-pronged strategy

The Ministry of Water and Human Settlement is pursuing a five-fold strategy to deliver 100 000 houses in five years, Minister Onneetse Ramogapi has told Parliament.

Minister Onneetse Ramogapi has told Parliament recently when responding to a question from Molepolole North MP, Mr Arafat Khan.

He said the strategy comprised Botswana Housing Corporation (BHC) commercial projects, social housing schemes including the Bonno turnkey programme, a D4 salary scale and below housing scheme, private sector-led initiatives and donated houses.

He said the social housing scheme targeted individuals earning between P4 400 and P95 000 per annum. Under this category, beneficiaries paid P90 000 while government covered any cost above that threshold.

For the D4 salary scale and below, or equivalent housing scheme, aimed at those earning between P95 001 and P282 120 annually, beneficiaries were required to meet the full cost of the house.

The minister said government had rebranded and revamped the existing low-income housing programme into the Bonno National Housing Programme. Under the Bonno turnkey scheme, 353 housing units were planned for construction across all constituencies in the current financial year.

"Fifty-eight houses are under construction and are on course to be completed by the end of December," said Minister Ramogapi, saying that the remaining 295 units would start this month due to late approval of funding.

He said 61 houses under D4 and below or equivalent housing scheme would commence this month owing to late approval of funds as well, while a total of 924 units were under construction and 11 494 at preconstruction stage, making a total of 12 418 units.

Under the private sector led investment, Minister Ramogapi said 19 344 housing units had been allocated to 154 investors across 52 constituencies, and implementation was at contracting

stage.

Additionally, he said four houses had been donated by Morupule Coal Mine, Choppies and Obakeng Construction.

Mr Ramogapi also informed the House that government purchased 1 226 units of former BCL and Tati Nickel mines.

Regarding the number allocated to Molepolole, Mr Ramogapi said 1 288 housing units were allocated for construction in the said village through the different housing schemes; mostly by the private sector led investment at 1 200 houses, followed by 80 under the BHC commercial, and eight under Bonno turnkey.

Molepolole North MP, Mr Arafat Khan, had asked the minister to share with the House, the status of the pledge to deliver 100 000 houses within five years as stated in the Umbrella for Democratic Change 2024 manifesto, progress made towards the commitment as well as the number of houses allocated to Molepolole. **BOPA**

# NCQF facilitates learner mobility - Maele

The National Credit and Qualifications Framework (NCQF) developed and maintained by the Botswana Qualification Authority (BQA), exists to ensure that all qualifications offered in Botswana are quality assured and standardised to other qualification frameworks in the region and globally.

"It provides clear levels and criteria for learning, making it easier to understand and compare qualifications across the fields of learning and the three subsystems of education and training: General Education, Higher Education and Technical and Vocational Education and Training (TVET)," said the Minister of Higher learning, Mr Prince Maele in Parliament.

He said it also facilitated learner mobility and ensured that Botswana's qualifications were competitive, recognised locally and regionally, as well as being comparable with international qualifications.

BQA has been implementing the NCQF since 2017, as such, 2025 marks its eighth year of implementation and since inception the authority has received 1 745 application for registration of qualifications, Mr Maele said.

Out of the number, he said 1146 qualifications had been registered, 373 rejected and 226 were being processed.

The figures translate to 66 per cent of qualifications aligned to the Human Resource sector skills and registered on the NCOF.

Mr Maele said that to date, there had not been a full-scale, comprehensive evaluation of the NCQF since its inception however, periodic monitoring and stakeholder consultations had been ongoing to assess progress and identify areas for improvement.

He said among the monitoring activities undertaken were the Graduate Tracer Studies and

Learner Enrolment Surveys.

The minister further explained that the NCQF system's maturity level was still in its infancy and the first cohort graduated in 2021 for

qualifications registered in 2017. This stage he said did not warrant a compressive evaluation, more so that the institutions, professionals bodies and the relevant stakeholders were still undergoing capacitation and transition to the NCQF.

Mr Maele said BQA had commenced plans to conduct a study on the implementation and impact of the NCQF with an estimated budget requirement of P2 million, and the evaluation was scheduled to commence in the

2026/27 subject to availability of funds.

The sturdy will focus on the effectiveness, relevance and impact of the framework on education quality and employability.

Maun west MP, Mr Caterpillar Hikuama had asked the minister to provide a comprehensive account on the current status of the implementation of the NCQF and state the percentage of all national qualifications that were now aligned and registered on the framework.

He also wanted to know if there had been any comprehensive evaluation of the NCQF since it was established and if not, plans to evaluate it. **BOPA** 

# BEC to issue new BGCSE certificate

The Botswana Examinations Council (BEC) is in the process of developing a new Botswana General Certificate of Secondary Education (BGCSE) certificate, as the education parastatal will no longer be offering joint certification with Cambridge University Press and Assessment (CUPA).

The Botswana Examinations Council (BEC) is in the process of developing a new Botswana General Certificate of Secondary Education (BGCSE) certificate, as the education parastatal will no longer be offering joint certification with Cambridge University Press and Assessment (CUPA).

This was revealed by Minister of Child Welfare and Basic Education, Ms Nono Kgafela-Mokoka while delivering a statement in Parliament on Thursday.

Ms Kgafela-Mokoka said subsequent to a BEC board resolution of August 2024 to approve a strategy to gradually withdraw from the CUPA Accreditation with Certification contract, a decision endorsed by Cabinet in October, BEC entered into a new contract with the British institution.

"BEC entered a three-year Accreditation without Certification contract. This was done to ensure that BEC continues to receive independent quality assurance of the assessment operations for the delivery of credible qualifications. This is a scaled down contract, which will cost about £562 000 (Pl0 million) annually compared to the previous contract, which cost P27 million annually," said Ms Kgafela-Mokoka.

She clarified that the amendment of the contract meant that from the 2025 examination series, BEC and Cambridge would no longer issue a joint certificate to BGCSE candidates and that BEC would independently design and issue a new certificate under their own

authority.

Ms Kgafela-Mokoka said the BEC board had approved the new design of the 2025 BGCSE certificate at their sitting in August, and that the current Accreditation without Certification CUPA contract would run until the 2027 examination cycle

"While the down scaled quality assurance contract is running, BEC has begun the process of identifying a local partner with capacity to assume the role of external quality assurance to the BEC qualifications starting 2028 examination cycle," said Ms Kgafela-Mokoka.

She said external quality assurance of assessment processes was critical as it ensureed that standards for both the assessment and its associated curriculum did not drift over time as well as instilling the confidence stakeholders had in the qualification.

Ms Kgafela-Mokoka said BEC, a parastatal under her ministry, was mandated to manage and conduct examinations and assessments in general education, technical vocational education and training and to award certificates in respect of the said examinations and assessments.

She further said the BEC and CUPA partnership dated back to the time BEC functions were operated by the Examinations, Research & Testing Division division of the then ministry of education.

Over the years, CUPA assisted the Botswana government to replace the then Cambridge Overseas School Certificate by developing a localised qualification that would be recognised internationally and also equivalent to International General Certificate of Secondary Education as recommended in the Revised National Policy on Education of 1994.

This led to the establishment of BGCSE.

Further to developing BGCSE, CUPA was to monitor the application of assessment standards across all examination processes on yearly basis, to ensure that the BGCSE qualification maintains international recognition and global competitiveness.

global competitiveness.

From 1999 to 2011, the ERTD, and later BEC, worked in collaboration with CUPA across all examination processes.

As from 2012 to 2025, the

As from 2012 to 2025, the relationship between BEC and CUPA developed into a three-year and lately two-year contract cycles that were down scaled in scope.

"Since inception of the relationship, BEC pays an annual fee that is currently around £1 400 000, (about P27 million), subject

to exchange rate at the point of payment.

The main cost driver in this agreement is certifying at individual candidate level. The cost has escalated to a level that is unsustainable to BEC.

Further to that, BEC has matured overtime and now has the capacity to conduct some of the examination processes without support from CUPA. It is on the basis of the forgoing that the council found it prudent to scale down further and gradually withdraw from the accreditation agreement," said Ms Kgafela-Mokoka.

She stressed that other than the engagement of local external quality assurance, BEC would participate in the regional quality assurance processes of the Southern Africa Association for Educational Assessment, a network of Southern African

examination bodies.

While legislators appreciated the move, Meanwhile, Molepolole South MP, Mr Shima Monageng said learners should be paying less examination fees since BEC would be paying less to CUPA.

For his part, Kanye East legislator, Mr Prince Mosasana raised concern of BEC engaging teachers to assist with the invigilation and marking of examinations yet their payments were occasionally being processed late.

Kgatleng East legislator, Mr Mabuse Pule said the move was satisfactory as long as BGCSE certificates would still be recognised internationally.

Tswapong South legislator, Dr Kesitegile Gotswang also had no qualms with the development but stressed the importance of peer review, saying it should continue.

## Bill overhauls pharmaceutical laws

In a move to transform the country's healthcare landscape, Botswana is on the cusp of overhauling its pharmaceutical laws, with a new bill set to revamp the nation's medicine regulatory system. The proposed law, Medicines and

The proposed law, Medicines and Related Substances Bill 2025, which received unequivocal backing from parliamentarians on Thursday, has been passed to the Committee Stage, where members will scrutinise its clauses before Parliament votes for its passage.

Presenting the bill, Assistant Minister of Health, Mr Lawrence Ookeditse, said it would adequately address shortfalls identified in the existing act and achieve World Health Organisation maturity level three regulatory standards, align with the African Union (AU) model law on medical products regulatory and address local regulatory environment challenges.

He said it represented a comprehensive modernisation of Botswana's pharmaceutical regulatory framework.

He noted that the current act lacked legal framework required for World Health Organisation Global Benchmarking Tool (GBT), crosscutting quality and risk management systems. It is also insufficient in terms of legal provisions for risk-based legislative approaches across all regulatory functions, Mr Ookeditse stated, adding that there was also an absence of mandatory quality management systems provisions for the national regulatory authority as well as limited legal authority for comprehensive post-market surveillance and vigilance systems.

Thus, he said government was looking at alignment with the AU model law, which necessitated integration of harmonised regulatory standards to facilitate regional trade, implementation of mutual recognition frameworks for pharmaceutical products, establishment of risk-based classification systems consistent with AU standards, and legal provisions enabling participation in continental regulatory initiatives.

In terms of local environment

adaptation, he said the bill would address Botswana's unique market characteristics and public health priorities, strengthen local pharmaceutical manufacturing capabilities, enhance regulatory capacity for emerging product categories such as cannabis-derived products and biologics.

The proposed law will address systematic gaps in the current legislation that exhibits critical limitations that restrict effective regulation, as regulation is currently fragmented.

Mr Ookeditse said the law treated medicines, medical devices, and cosmetics as separate domains, thus creating enforcement challenges. He said currently, the authority

He said currently, the authority lacked explicit authority to mandate recourse or impose graduated penalties, a deficiency that would be addressed.

There are currently outdated technical standards, where quality control provisions do not reflect modern international organisation standardisation.

Mr Ookeditse stated that reforms in the bill directly supported Vision 2036 goals for health system strengthening, economic diversification through pharmaceutical sector development, and African Continental Free Trade Area implementation by meeting regional harmonisation requirements.

The bill includes a sanctions framework that will create a deterrence against pharmaceutical crimes in the country, adding that there shall be a national quality control laboratory that ensured that reliance on foreign laboratories was a thing of the past.

The proposed law will also bring about cosmetics regulation, adding that currently, the environment of cosmetic markets posed public health risks; with studies showing that up to 22 per cent of sample products contain prohibited substances.

Mr Ookeditse said the current inadequate law had failed to address this and added that the bill also brought about innovative approaches, including risk-based classification.

Meanwhile, Tswapong South MP, Dr Kesitegile Gobotswang

welcomed the bill, commending the ministry for adequate consultations and engagements and terming it, forward-looking.

He said the proposed law leveraged on the Pan-African Parliament

on the Pan-African Parliament models and embraced African medicines in the mainstream health sector. Most countries, such as China,

he said were advanced in promoting and benefiting from their traditional and indigenous medicines.

However, he said there was a need to build trust for use of indigenous medicine, as it was predominantly associated with witchcraft.

Dr Gobotswang said collaborations between medical schools and traditional medicine could help dispel the stigma through research.

MP Onnetse Ramogapi of Palapye, who is also Minister of Water and Human Settlement, supported the bill, saying it would take the country forward.

He said through the implementation of the proposed law, government would also create employment opportunities for Batswana, aligning with the ruling Umbrella for Democratic Change manifesto.

Mr Ramogapi said the bill would ensure the safety and protection of Batswana through testing and quality control measures, adding that it came at the right time and would ensure the enjoyment of a quality life.

MP Mabuse Pule of Kgatleng East also supported the bill, for the good of the country.

He stressed the need to promote traditional medicine and called for research to enhance the acceptability and credibility of indigenous medicine.

He said some traditional herbs could prove important in preventing non-communicable diseases, thus the need for further research.

He spoke of the need to promote recognition of herbs and traditional healers in the health sector, adding that some people came to the country for indigenous healing.

Mr Pule indicated that the country had many resources on indigenous knowledge and medicine and needed to dispel the evil connotation associated with traditional healers. **BOPA**

- Retail partnerships
- Government procurement (schools, hospitals, prisons, army) Private sector contracts No farmer should be left with unsold produce.
- 5. Prioritise Processing, Packaging, Distribution and Export Botswana must shift from raw production to full value chains. Produce must be:
- Processed
- Packaged
- Distributed nationwide
- •Exported when surplus exists This is where wealth and sustainable jobs are created.
- 6. Commercialise Indigenous Products Your vision must also extend to our own heritage crops:
- Morama
- Indigenous beans
- LerotseWild fruits
- Medicinal plants
- Traditional grains and vegetables

# AU condemns attempted military coup in Benin

ADDIS ABABA

Chairperson of the African Union (AU) Commission Mahmoud Ali Youssouf has condemned an attempted military coup in Benin.

"Any form of military interference in political processes constitutes a grave violation of the fundamental principles and values of the African Union," the chairperson stressed in a press statement on Sunday.

Youssouf called on all actors involved in the coup attempt to immediately cease all unlawful actions, to fully respect the country's

constitution, and to return without delay to their legitimate barracks and professional obligations.

He further encouraged all national stakeholders in Benin to prioritise unity, dialogue, and the preservation of national peace. Meanwhile, the AUC chief expressed concern over the troubling proliferation of military coups and coup attempts across parts of the region.

He underscored that such actions continued to undermine continental stability, threatened democratic gains, and embolden military actors to act outside constitutional

mandates

He emphasised that the pan-African bloc remained firm and consistent in defending democratic governance, the rule of law, and the sovereign will of the African people.

Benin's armed forces have foiled an attempted mutiny aimed at destabilising the state and its institutions, Minister of Interior and Public Security Alassane Seidou said in a statement.

Seidou made the remarks after a group of soldiers announced earlier in the day on state broadcaster that President Patrice Talon had been "removed from office." *Xinhua*

# Russia maintains solidarity with Venezuela

MOSCOW

Russia stands with Venezuela's leadership and calls on the US government to refrain from "sliding" into a full-scale conflict with Caracas, Russian Deputy Foreign Minister Sergei Ryabkov said on Sunday.

Moscow views recent developments in Venezuela with deep concern, and tensions remain high and continue to grow.

"This is primarily linked to Washington's desire to assert unquestioned dominance in the region, a trademark of the Trump administration," Ryabkov was quoted by TASS news agency as saying.

Ryabkov stressed that Russia maintains strong solidarity with Venezuela, referring to the recently concluded agreement on strategic partnership and cooperation between the two countries.

"We support Venezuela, just as it supports us ... In this trying time, we stand with Caracas and its leadership shoulder to shoulder," Ryabkov said. The US has increased its

The US has increased its military presence in the Caribbean Sea.

The Pentagon has carried out at least 22 known strikes on alleged drug vessels in the Caribbean and eastern Pacific Ocean since Sept. 2, killing more than 87 people aboard. *Xinhua* 

# Police investigate shooting incident

#### **JOHANNESBURG**

At least 11 people were killed and 14 others wounded in a shooting early Saturday at a hostel in South Africa's administrative capital Pretoria.

Spokesperson for South African Police Service (SAPS), Brigadier Athlenda Mathe said 10 victims died at the scene in Saulsville, Atteridgeville, and another succumbed to gunshot wounds later in a hospital, while 14 others were receiving medical treatment.

The victims included a three-year-old child and two adolescents aged 12 and 16, she added. According to the SAPS, the shooting occurred at around 4:15am, when three unidentified gunmen stormed the building and opened fire indiscriminately.

Authorities have not yet confirmed a motive for the attack. The SAPS urged residents to remain vigilant as police continue efforts to apprehend the perpetrators. *Xinhua*

Botswana's digital landscape reached a defining moment this past week when Botswana Fibre Networks (BoFiNet) unveiled the Digital Delta Data Centre (DDDC), the country's first Tier III-certified carrier-neutral facility of its scale. The launch, graced by the Minister of Communications and Innovation, Honourable David Tshere, and attended by cabinet ministers, dignitaries and regional industry players, signalled a new era for Botswana's digital ambitions and its place within the global technology ecosystem.

The DDDC did not emerge overnight. Its story began in 2016, when BoFiNet recognised that Botswana's growing digital ecosystem required a modern, resilient and future-ready data infrastructure. Nearly a decade later, the vision materialised into a world-class data centre built entirely through revenue generated from BoFiNet's own operations, an achievement that Acting Chief Executive Officer, Mr. Keabetswe Segole, described as a defining moment for the organisation.

Reflecting on the journey, Mr. Segole said the milestone represented more than the completion of a technical project. It was, in his words, "a demonstration of the capability, dedication and perseverance of our teams, who worked tirelessly to deliver an asset worthy of national pride." He noted that the DDDC had been designed not only to support Botswana's digital future, but to anchor the country's position as a regional hub for high-reliability data hosting and digital innovation.

The facility earned its **Tier III Certification of** Constructed Facility (TCCF) from the Uptime Institute on 23 October 2025, an endorsement that placed Botswana in a select class of countries offering infrastructure capable of running uninterrupted even during planned maintenance. For enterprises and Government alike, this meant improved resilience, predictable uptime and the confidence to scale digital operations securely.

In his address, Minister Tshere emphasised that the DDDC aligned with Botswana's national agenda to expand digital access and modernise public service delivery. He highlighted that the migration of key Government systems to the DDDC would strengthen service availability, enhance data protection and accelerate the shift toward a fully digital State. He noted that the data centre enhances Botswana's attractiveness to global digital investors and reaffirmed the Board's commitment to supporting infrastructure that drives national transformation.

Beyond government systems, the DDDC has set the stage for private-sector innovation. As a vendor-neutral, high-security and energy-efficient environment, it offers businesses the opportunity to expand cloud capabilities, reduce capital expenditure on in-house data centres, and improve customer experience with lower latency and elevated reliability. For emerging sectors such as fintech, health tech, Al and IoT, the DDDC presents an enabling foundation for growth.

Guests were welcomed with an Amuse Bouche with venison carpaccio thinly sliced and marinated in olive oil, lemon juice, and micro herbs offering delicate flavours that set the tone for the feast ahead.

A beef biltong starter, featuring shredded dried beef, followed, while an alternative goat cheese bruschetta offered a creamy blend of goat cheese seasoned with salt, pepper, and herbs, topped with a drizzle of honey.

The Clemen Gold sorbet, served in elegant glassware with fresh mint, lime, and a hint of honey, offered a refreshing, smooth texture and effectively reset the palate for the main course.

The main dishes harmoniously blend local flavours with international culinary techniques.

A standout is the Tswana chicken roulade, chicken breast stuffed with crushed fillet, paired with bogobe jwa lerotse and morogo wa dinawa. Another culturally inspired but globally appealing dish is the wildebeest seswaa steak, crusted with avocado, coriander, and chilli, and served with traditional zengwe (lebelebele) and morogo.

Currently, Dube said they did not have a title sponsor and called on potential sponsors to come forward and partner with them.
