Mothibe calls for cooperatives revival

GABORONE - Cooperative societies are an ideal model to diversify the rural economy and improve livelihoods.

Commenting on Minister of Finance, Mr Gaolathe Ndaba's budget proposals presentation in Gaborone on Monday, Customary Court of Appeal president, Kgosi Mothibe Linchwe said it was important to resuscitate the spirit of self-reliance, encourage communities to come together to engage in upliftment of groups.

Even though there was a challenge for members of the community to work in groups, he said it was important for them to establish cooperative

societies such as Savings and Credit Cooperative Societies (SACCOS).

Kgosi Mothibe highlighted that public officers who organised themselves and formed SACCOS such as Motswedi, Thuto and many others in local authorities were now enjoying the benefits of such cooperatives.

"Members were offered loans at affordable interest rates and therefore many of them were able to improve their lives and their growth was in the desired direction," he said.

He said the model of running cooperative societies was benchmarked in countries such as Kenya where SACCOS was doing well and contributing more

to the livelihoods of people in rural areas.

"I encourage our people to follow such a model and do more to improve their lives rather than relying solely on government who was already burden by financial and resource constraints. There is a SACCOS named Hope which is doing well in Mochudi and that is why I am positive about these ideas of engaging in cooperatives," he said

On the upliftment of vulnerable groups such as people with disabilities, Kgosi Mothibe said they required diverse interventions as they had different needs.

He said financial institutions and other support structures

must have packages aimed at supporting vulnerable groups.

Also, he said it important to identify and protect heritage sites and other cultural monuments.

He said the Bakgatla who were the custodians of bogwera and bojale much protect sites where such cultural practices were held for the benefit of the tribe.

He said it would be amiss for such heritage locations to only benefit a few, being the leadership of a tribe or a community.

Kgosi Mothibe also appreciated that Mr Gaolathe touched on infrastructural development at dikgotla.

He said the Department of

Tribal Administration was in dire need for its human resource to be empowered to improve the quality of service that was rendered to the people.

He said it was worth noting that the tribes were solely losing confidence in the leadership of dikgosi and therefore it was important for the traditional leaders through support of government to as a matter of urgency work on regaining the trust and confidence of the tribe and ensure that the bogosi was given the respect that it deserved.

"We must work on developing ourselves and demonstrate quality service," he said. **BOPA**

Ministry, UNDP join efforts on biogas promotion

MASUNGA - Ministry of Environment and Tourism and United Nations Development Programme (UNDP) have embarked on a biogas production and promotion project.

Briefing the North East District administration management team on Monday, Principal Energy Engineer, Mr Edwin Khethiwe, said the project which started, from 2017 to 2021, was funded at the tune of P35 million.

He said the principal objective of the use of biogas development in Botswana was to promote the production and utilisation of biogas as a clean, renewable energy source derived from agricultural waste (cow dung).

Mr Khethiwe noted that the project was primarily aimed to provide a sustainable fuel for rural communities while simultaneously reducing greenhouse gas emissions that affected the ozone layer.

"The technology uses cow dung and it assists farmers by reducing piling of cow dung in their kraals. The cow dung would be collected while fresh before methane gas escapes into the atmosphere to pollute the environment. The gas could be used for cooking, space heating in poultry houses during winter time and lighting," he said, adding that people who had started the use of the technology had since stopped cutting down trees for firewood.

This, he said, contributed to the country's climate change mitigation efforts while aligning with the National Development Plan (NDP11) to improve energy access and security of supply.

"This is typically implemented through projects focused on capacity building, biogas plant establishment, and knowledge sharing platforms to facilitate widespread adoption of biogas technology across the country, particularly in the southeastern regions where agro-waste is readily available," he noted.

Already, he said 77 graduates from brigades had been trained and were also given 31 digesters to construct as part of their practicals.

He said more training would be conducted in selected brigades so that digester constructors would be within reach.

He further said during the NDP11, the ministry received around P20 million for the expansion of the project, capacity building, awareness creation and conducting biogas study and training of additional 200 youth in the district who did not receive training.

The other target was that during training, trainees should build about 190 digesters in the northern part. In the northern part, they were started in Serowe, Mahalapye, Kasane, Maun, Ghanzi, Nata, Palapye, Letlhakane and Selebi Phikwe and currently the training is ongoing for Zwenshambe Brigade graduates," he said, adding that another training was conducted in Hukuntsi.

"For trainees to be qualified, they should be exposed to three digesters," he said, adding that they provide protective clothing like overalls, boots, goggles, camping equipment as they will be staying at the farm and an allowance of around P2 900.

Responding to questions from the team, the ministry's energy engineer, Mr Jimmy Gabatshwane said they prefer engaging famers on the biogas project as they already had access to cow dung.

However, he said they were not leaving others out as some could have the potential to collect sludge at the slaughterhouses and feed their digesters.

For her part, North East District Commissioner, Ms Wame Samapipi, acknowledged the importance of the project.

She said there was value chain in the production of biogas as one could use the gas for enhancing their businesses such as catering. **BOPA**

Red Cross aids North West District flood victims

MAUN - The Botswana Red Cross Society (BRCS) has started distributing disaster response packages to the floods victims in the North West District.

A number of households in Maun, Ngaraga, Tsau and Semboyo collapsed due to flooding while some yards were not easily accessible to following torrential rains in the area recently.

The BRCS head of operations and business development, Ms Boitumelo Cornelius-Moloi, confirmed that the team was

on the ground providing crucial relief to families affected by the floods.

She said they were distributing 100 relief items consisting mattresses, blankets and hygiene packs. She said 20 families benefited in Ngaraga, Tsau and Semboyo while 35 packages were distributed in Maun and Morutsha settlement respectively.

She said the response efforts were carried out in accordance with guidance from the District Disaster Response Committee.

In addition, Ms Cornelius-Moloi said BRCS provided cash support to enable families to

get basic supplies such as food, school supplies for children and other needs that may arise.

"This support will be for two months with each family benefiting P1 000," she said.

Also, she said BRCS had extended relief distribution to affected areas in Boteti such as Mokoboxane adding that more relief efforts were planned for Serowe, Mahalapye, Tonota districts as well as Francistown.

This, Ms Cornelius-Moloi said highlighted BRCS's continued commitment to ensuring that assistance reached the most affected communities across the country. **BOPA**

BPS to host crime prevention conference

GABORONE - The Botswana Police Service will hold a National Crime Prevention Conference from March 19 to 20.

Updating the nation on the state of public safety, crime situation and measures in place to address crime and criminality in the country during a press conference yesterday, Minister for State President, Mr Moeti Mohwasa said various experts were expected to share insights and interventions on crime prevention.

Also, Minister Mohwasa, who was accompanied by the Police

Commissioner, Ms Dinha Marathe said the BPS would train 1 068 police officers comprising floor managers and frontline officers on customer handling.

In its continuous efforts to fight crime in the country, Minister Mohwasa said BPS had put in place several special operations, such as the Rapid Response Teams, which were strategically positioned to respond promptly on a 24/7 basis, to deal with prevailing crime incidents.

Special operation, he said included, City Police, Air Support Services for aerial patrols and KgomoKhumo Anti-Stock Theft operation, among others.

Through regional cooperation and collaboration, he said BPS continued to cooperate and collaborate with neighbouring countries to fight transnational organised crime through bi-lateral cooperation, joint investigations and joint border patrols.

Furthermore, he said the police service had leveraged on utilising science and technology, as a force multiplier, in its various law enforcement interventions, such as Automated Fingerprints Technology, Deoxyribonucleic acid (DNA) technology, Cyber Forensics services and others.

Despite efforts put in place to fight crime, the minister said the BPS was faced with shortage of staff. However, he said government was expediting the absorption of all Special Constables into regular police officers and to also improve their general condition of service and welfare.

To improve police officers' welfare issues, he said plans were also at advanced stage to implement a comprehensive psycho-social support programme for police officers.

Meanwhile, Minister Mohwasa said a joint operation by BPS and Botswana Defence Force (BDF), code named Operation Pabalesego, which took place from December 19, 2024 to January 5, resulted in a decrease of 9.8 per cent in overall crime compared to the same period during the previous year.

However, he expressed displeasure that incidents of crime were still a public concern.

Preliminary findings, he said indicated an 8 per cent decrease of total crime (146 526) recorded in the year 2024 compared to 159 680 cases, around the same period in the year 2023.

"In general, all prevalent offences recorded a decrease of 15 per cent in 2024 compared to 2023 from 17 054 in 2023 to 14 560 in 2024 save for murder cases which recorded a 5 per cent increase," he added.

All offences, the minister said recorded a decrease in numbers, except murder, illicit drugs and defilement of persons under 18 years.

Whilst some of the cases were still under investigations, he said since January 1 to date, more than 364 suspects were arrested and some had already appeared before courts of law.

He also pointed out that there had been a modest reduction in gender based violence (GBV) related offences from 331 cases recorded in January 2024 to 317 in January 2025.

Whilst most GBV cases, such as threat to kill and rape have reduced, the minister was concerned on the increase in murder and defilement of children under 18 years.

"In some instances, these defilements are preceded by reports of missing persons who upon return turn out to have been harbored by adults for sexual exploitation. It is important to note that as a result of the police and partnering agencies' robust community outreach programmes, communities are starting to understand many of these crimes, hence the reports," he added.

Given that GBV cut across various sectors of society, Mr

Mohwasa said there was need for multi-sectoral approach to address the scourge.

One such approach, he said was the establishment of One-Stop-Service Centres across the country. **BOPA**

"It provides member countries with training, research, consultancy and advisory services to help improve their labour practices," says the release.

It further explains that the governing council is the highest decision-making body within ARLAC, with meetings held biannually to discuss key labour and employment matters.

He is accompanied by senior government officials and the team is expected back home on Friday. **BOPA**

VP promises fair, prosperous Botswana

HUKUNTSI - The Vice President has assured Hukuntsi residents that government is resolute on positioning Botswana as the best managed country and a model of unity, fairness and prosperity across the African continent.

Addressing the residents in a kgotla meeting yesterday, Mr Ndaba Gaolathe, who is also Minister of Finance, therefore called on all to take part in resuscitating the economy and bringing the nation together.

"We need to understand that Rome was not built in one day. We will attain all our aspirations gradually," he said.

He acknowledged that the new administration inherited government that was plagued with systematic inefficiencies, which hindered progress. Also, he said government was determined to resuscitate the Botswana Meat Commission through putting in place a strong management team, which would be able to secure partnerships to lead in the revitalisation of the commission.

Mr Gaolathe promised the residents that government would do everything in its power to nip corruption in the bud.

On issues bedeviling people with disabilities (PWDs), Mr Gaolathe said government was committed to

reviewing and enacting disability specific legislation aimed at addressing challenges faced by PWDs.

He said there was a need for a holistic approach to addressing all their grievances and challenges.

"I have to admit that PWDs face challenges on their daily lives, which includes inaccessibility to public buildings and public transport, lack of financial assistance and lack of adequate health care which is an impediment to their lives," he said.

He said current policies were outdated and out of sync with global trends on people with disabilities issues.

"This reduces PWDs into objects of pity and recipients of charity hence the need to focus more on their human rights not discretionary rights," he said.

He said government was therefore on the process of creating laws premised on the principles of universality, equality and non-discriminatory, which were embodied mainly on human rights.

Meanwhile, the Vice President commended the district for the Zutshwa Salt Mine project, adding that the new government was keen on opening market for businesses in Botswana, adding that focus would also be aimed at seeking export market for the project.

For his part, Member of

Parliament for Kgalagadi North, Mr Reason Lekhutlane thanked government for increasing the old age pension allowance from P830 to P1 400.

Though government had promised to increase the allowance to P1 800, he said he was optimistic that it would fulfill its promise once funds permit.

He also pleaded with government to assist in the expansion of Zutshwa Salt Mine project so that it became fully functional.

He said the mine had the potential to create more jobs for Batswana.

In his welcome remarks, Kgosi Merapelo Tshweneyagae decried shortage of water supply and implored government to expedite the plan in availing water in the district.

"We need this project to succeed in order to address the increasing water demand in our constituency, the current water bowing plans are inefficient and unreliable," he said.

On the poor state of access roads from Hukuntsi to settlements surrounding the village, he pleaded with government to construct the Ncojane-Hukuntsi road, saying it would connect Hukuntsi with other villages such as Hunhukwe, Ukhwi, Maake, among others.

Kgosi Tshweneyagae also decried poor state of infrastructure at Hukuntsi Primary Hospital and clinic. **BOPA**

Government identifies priority areas

GABORONE - Government has identified key strategic priorities for the financial year 2025/2026 to aid in fulfilling the commitments of the new Botswana geared towards a rapid and inclusive economic growth and achieving a social equitable development that benefits all Batswana.

Presenting budget proposals for the financial year 2025/26 in Gaborone on Monday, Minister of Finance, Mr Ndaba Gaolathe said the areas included Modernising and Transforming Infrastructure; Improving Quality of Life; Innovation and Digital Transformation; and Supporting a Private Sector Export Led Growth.

Modernising and Transforming Infrastructure

Minister Gaolathe said under this priority area, critical areas such as schools, healthcare facilities and housing were underdeveloped in many areas, particularly in rural and remote areas, calling for a need to upgrade and expand infrastructure ecosystem to unlock economic opportunities and in doing so, enhanced the quality of life for a greater number of citizens.

He also said the state of road networks, rail, power, water and sewage infrastructure was not adequate to facilitate the vision of building a deep and inclusive economy.

In addition, he said the absence of adequate infrastructure to support modern agriculture coupled with the lack of world-class airports, presented a significant barrier to government's ambition of becoming a regional logistics hub.

Mr Gaolathe said a development budget of P11.54 billion was proposed to fund infrastructure development projects however, indicated that modernising and transforming infrastructure could not be achieved in one financial year as it was a process that needed time and money.

In that regard, he said that leveraging Public-Private partnerships (PPPs) would play a vital role in mobilising resources needed to accelerate the agenda and deliver projects effectively.

He further said government was advanced on creating a legal framework for better management of PPP projects, the draft bill of which was expected to be finalised and presented for consideration by Parliament during the 2025/2026 financial year.

He said once it came to effect, it would foster a strong private sector partnership and provide a platform for domestic and international consortia to optimise the full benefit of the PPP delivery model thereby, reducing the fiscal strain on the government budget and improve the growth-investment nexus.

Minister Gaolathe said other key infrastructure development projects under Modernising and Transforming Infrastructure included completion of water supply, network and sanitation

projects at Molepolole, Kanye, Sowa Town, construction of primary hospitals with at least 50 beds in Tsabong, Tonota and Shoshong.

He said solar energy presented a remarkable opportunity for the nation with abundant sunshine throughout the year and Botswana was ideally suited to harness the clean and sustainable resource to power households, industries and communities.

Improving Quality of Life

He said a development budget of P9.81 billion was proposed for this priority which included strengthening human capital development, modernising education and healthcare systems, supporting vulnerable groups as well as availing economic opportunities to ensure long-term prosperity and equality for all.

One of the areas he touched on under this priority was the need to increase excellence in Technical and Vocational Education and Training institutions by leveraging on tried and tested Vocational Technical Education Training (TVET) models in countries such as South Korea, Germany and Finland.

He said government was developing a robust TVET Policy with an agenda anchored on various pursuits such as agriculture, jewelry, multimedia, Artificial Intelligence, sports and manufacturing.

Innovation and Digital Transformation

Zooming in on this priority, Minister Gaolathe said a development budget of P1.47 billion was proposed to support this area.

He said the budget would fast track the delivery of the national digital transformation strategy known as SmartBots with a view to accelerate digital transformation across government, the economy and the society.

In order to achieve this initiative, he said government aimed to close the connectivity gap across the country through the implementation of the village connectivity program.

To this end, he said Phases two, three and four of the village connectivity programme connecting over 1 000 public facilities across different villages would be completed during the 2025-2026 financial year.

He also said during the 2025-2026 financial year, government would connect over 500 schools to the internet, expand connectivity of private research and education institutions through the Botswana Research and Education Network and roll out the Digital Competency Framework aimed at building digital literacy.

Supporting Private Sector Export Led Growth

This priority highlights government commitment to advance an export led growth model with a development budget of P0.93 billion proposed to support the agenda.

He said government would

support SMEs by addressing existing bottlenecks such as lack of access to finance and markets.

Mr Gaolathe said government would continue to promote entrepreneurial development through implementation of free trade agreements such as the Southern Africa Development Community - Economic

Partnership Agreement (SADC-EPA) and African Continental Free Trade Area (AfCFTA).

He further said that they were determined to attract quality investments and government had completed the feasibility study on the establishment of commercial dispute resolution framework.

Currently, he said Botswana had no court dedicated to resolving commercial disputes and it took an average of 660 days to resolve a commercial case hence would establish commercial courts to reduce turnaround time to resolve commercial cases in 2025/2026 financial year. **BOPA**

Public resources to be managed with responsibility, integrity

GABORONE - In pursuit of good governance, ensuring transparency, fairness and accountability in public sector operations, the government is taking decisive steps to guarantee that public resources are managed with the utmost responsibility and integrity.

In his Budget Speech on Monday, Vice President and Minister of Finance, Mr Ndaba Gaolathe, emphasised that the new Botswana vision recognised that good governance was not only about policy implementation, but also about establishing accountable and transparent institutions that were capable of fulfilling their mandates effectively.

Mr Gaolathe said the Public Procurement Regulatory Authority (PPRA) recent evaluations had revealed that the authority had not been able to fully execute its essential role in ensuring fairness and transparency in the procurement system, which led to concerns regarding the integrity of public procurement, often marred by inefficiencies, lack of transparency and potential misuse of public funds.

He said in response to the

challenge, government had prioritised strengthening oversight institutions, with particular emphasis on the revitalisation of PPRA.

“Recognising the importance of PPRA as a strategic State-Owned Enterprise (SOE), the government is taking significant steps to enhance its capacity to oversee procurement processes more effectively.”

Mr Gaolathe highlighted that one of the cornerstones of government's plan to strengthen oversight was the introduction of comprehensive audits to evaluate the effectiveness of public procurement.

“These audits will focus on key projects, including those under the Development Manager model, the Central Medical Store and infrastructure projects at key SOEs,” explained Mr Gaolathe, highlighting that the audits would be conducted in two phases to ensure a thorough examination of procurement practices.

He said the first phase would focus on evaluating the value, procurement processes and procedures in place, along with ensuring legal compliance.

This phase will assess if the procurement processes followed

by government agencies aligned with established laws and regulations.

He said the second phase would take a deeper dive into financial irregularities and potential signs of fraud, necessitating specialised forensic audits to uncover any financial discrepancies or corrupt practices.

Mr Gaolathe emphasised that those audits would be an integral part of the new oversight framework, establishing a culture of accountability within government institutions, adding that the audits would not be confined to the PPRA alone, but would also involve other oversight bodies such as the Directorate on Corruption and Economic Crime, the Office of the Auditor General, the Public Enterprises Evaluation and Privatisation Agency, and the Botswana Accountancy Oversight Authority.

He said the collective approach would create a robust governance framework, ensuring that public resources were safeguarded and used for their intended purposes, underlining the importance of a unified effort in ensuring accountability and preventing misuse of public funds. **BOPA**

Labour ministry facilitates ex-miners payout

MOLEPOLOLE - The Ministry of Labour and Home Affairs has successfully facilitated payment of over P19 million to former Batswana miners who worked in South African mines.

This was disclosed by the minister, Maj. Gen. Pius Mokgware during the Mmualebe National Listening Tour programme on Botswana Television on Friday, emphasising government's role in assisting ex-miners to secure their long-awaited financial settlements.

Minister Mokgware elaborated that a total of 179 ex-miners have received their dues thus far, with close to 500 still awaiting medical examinations to qualify for assistance.

The minister also praised the efforts of his government, which had secured the payments for former miners in a short period.

Therefore, Maj. Gen. Mokgware urged those who had not yet received their dues or relatives of deceased miners to reach out to his ministry for assistance.

He further announced that his ministry had passed legislation barring foreign nationals from obtaining work permits to teach in Botswana except for specific qualifications which might be needed for teaching and were not available locally.

The move, he said, were part of government's wider effort to tackle unemployment and prioritise job opportunities for citizens.

Similarly, work permits for heavy duty drivers are no longer being issued due to the availability

of skilled local Batswana drivers.

Maj. Gen. Mokgware underlined that the ministry's efforts were focused on creating job opportunities for citizens and boosting the local economy.

Further, the Minister announced that the ministry was in the process of reviewing various other sectors to develop legislation that would prioritise job opportunities for Batswana.

In addition to enacting the changes to the teaching and heavy duty driving sectors, he shared that they were also looking into overhauling the internship programme to ensure that interns were provided with permanent employment upon completion of the programme. Furthermore, they aim to extend the initiative to the private sector.

The minister's presentation drew various reactions from citizens, who proposed additional initiatives to further enhance the ministry's service delivery.

Many expressed frustrations at unfair labour practices in the private sector, particularly with regards to some employers' reluctance to allow unionisation.

Some also suggested reducing the frequency of national identity card renewals for convenience.

Notably, several citizens praised the minister's efforts in protecting job opportunities for Batswana, which they believe will significantly reduce unemployment.

However, an issue that seemed to resonate with many in the audience was the new government's campaign promise to increase social benefit allowances such as old-age pension and student allowances.

Maj. Gen. Mokgware assured the public that the UDC government remained committed to fulfilling all campaign promises, emphasising that some required legislative amendments which would be addressed in upcoming Parliament sessions.

He also underscored that no employee should be prevented from unionising, highlighting the importance of fair labour practices.

Minister Mokgware further explained that the ministry's role extends beyond labour issues, covering all aspects of human life, including births, marriages, deaths and national registration.

Old age pensioners celebrate increment

He said recent reports from government had shown that the economy had declined with

government coffers running at a deficit. He was however confident that with time, Botswana would be prosperous resulting in every Motswana being well taken care of. Muchenje born Ms Diketso Gabaitumele welcomed the good news with a beaming smile saying this was expected from the new government having promised them a better living during their political campaigns.

She stated that the move gave the elderly hope in the new Botswana, adding that it was possible that with time the country would generate revenue that could cushion the youth.

SPEDU to retain its independence status

SELEBI PHIKWE - Minister of Trade and Entrepreneurship, Mr Tiroeaone Ntsima, has confirmed that SPEDU will remain in its present form amid a wave of proposed mergers of other State Owned Enterprises.

Mr Ntsima said this during a meeting with SPEDU officials and its clients.

Mr Ntsima explained that the strategic decision was to allow SPEDU to continue to diversify and revitalise the economy for growth and stability.

He said this would continue to enable and enhance creation of sustainable job opportunities in the Selebi Phikwe region.

“The decision is to allow SPEDU to continue its mandate of job creation, economic diversification and revitalisation particularly in the unfavourable effects, which came along due to the closure of the BCL mine among other factors,” he said.

Mr Ntsima highlighted that SPEDU played a pivotal role effort to assist in the establishment

of various business entities, job creation, and attracting new investors.

He said the rationalisation exercise that was put in place led to the suspension of some activities within the SPEDU which, he said, crippled the some of the daily business of the entity.

Mr Ntsima shared that currently the government is on an exercise to re-tool SPEDU, and the exercise will include hiring a chief executive officer.

He said the decision to review acts of SOE is to ensure that each operates under specific legal framework tailored to its unique mandate, thereby minimising conflict of interests, enhance accountability, transparency, effective customer service and good governance.

Currently SPEDU has 179 projects of which 152 are privately owned, five are government funded and 21 are community based. The projects are in varying stages of implementation.

The projects’ total value is P2.5 billion, and have created 7 185 jobs. **BOPA**

Govt commits to economy with opportunities

GABORONE - The dominance of few players in some industries exposes inefficiencies that stifle competition and innovation, Vice President and Minister of Finance, Mr Ndaba Gaolathe says.

Presenting budget estimates on

Monday, he said the budget was determined to build an economy in which every citizen enjoys fair access to opportunities.

Mr Gaolathe said preliminary evidence indicated that citizens were encountering artificial barriers impeding their access to

lucrative sectors such as poultry, automobile, retail, franchising and distribution among others.

“As a government rooted in the principle of fairness, we are going to strengthen institutions responsible for licensing and regulatory oversight to address structural and market barriers,” he said.

Mr Gaolathe said one of the challenges hindering effective execution for change in the country was the speed and alignment at which laws were amended to pave way for effective execution of measures pronounced by government.

He said the new administration had set itself a bold objective of facilitating international investment in mega, transformational projects with the potential to create economic value and to dilute the country’s over dependence on diamonds.

Mr Gaolathe stated that a landmark achievement was the successful conclusion of negotiations with DeBeers Group, resulting in an enhanced rough diamonds sales agreement and the extension of mining licenses beyond 2029.

“This agreement ensures greater value retention for Botswana and strengthens our position as a global leader in the diamond industry,” he said. **BOPA**

SOEs to become engines of wealth creation

GABORONE - Budget allocated to State Owned Enterprises (SOE) will transform them into high performance organisations that deliver on their mandate, Vice President and Minister of Finance, Mr Ndaba Gaolathe says.

Delivering his maiden budget speech yesterday, he said government was focused on paying delicate and special attention to SOEs with a view to bring out the best in them and use them as a lever to significantly reduce costs of doing business.

“We are also determined to transform our SOEs into engines of wealth creation for the larger population by re-configuring and up-scaling some of them into becoming truly global players,” he said.

He said the intention was also to curtail gross wastage and

duplication that takes place at some of the enterprises.

Mr Gaolathe said the neglect and sometimes outright callous mismanagement of the enterprises by political principals cultivated a culture of wastage and stagnation.

“We are determined to fan the embers for a new progressive culture of good governance, integrity, efficiency, effectiveness and excellence,” he said.

Mr Gaolathe said government was in the process to overhaul the power sector’s legislative framework to separate power generation from power transmission, and repurpose Botswana Power Corporation.

In relation to Botswana Agricultural Marketing Board (BAMB), he said farmers had come up with proposals to re-

imagine, refocus and reposition BAMB in order to drive an effective, enabling model and facilitate equitable and fair market access for all farmers.

He pointed out that government was determined to stabilise Botswana Meat Commission by putting in place strong management and securing investment partners to revitalise the company to become a global player.

Mr Gaolathe said Botswana Vaccine Institute in partnership with Meryl of France mastered the art of research and development of vaccines.

He said the manner in which public sector funds enterprises or funds victims of road accidents of medical aids among others was both inefficient and ineffective.

“We are probing and

considering options for an overhaul of our funding model towards a comprehensive system for national health insurance and targeted social interventions,” he said.

He said the new model will re-imagine the current arrangement of Citizen Entrepreneurial Agency, Motor Vehicle Accident Fund and other institutions.

Mr Gaolathe said government had started a process facilitate Botswana Unified Revenue Services, to unlock its revenue collection potential, aiming to surpass the annual average of P26 billion collection in non-mineral and non-SACU revenue achieved over the past five years.

He said a well managed and efficient BURS could boost revenue collection efficiency by at least 30 to 40 per cent in the next five years. **BOPA**

BDP leadership urges party unity

MOLEPOLOLE - Botswana Democratic Party (BDP) leadership has urged discipline among members, acknowledging that internal disunity was a significant factor in its historic electoral defeat last year.

Speaking during a regional consultation tour of the Kweneng West region in Molepolole on Saturday, BDP President Dr Mokgweetsi Masisi emphasised the importance of unity within the party, particularly in light of their recent loss.

Although Dr Masisi conceded that he accepts responsibility for the party's loss, he implored fellow party members to reconsider their approach, stating, "I may be to blame for our defeat, but does that mean we should abandon the party rather than defend it?"

The former President urged party members to unify behind the BDP, emphasising that internal disunity only weakened their collective strength.

Emphasising the importance of discipline, Dr Masisi remarked, "If you are not disciplined, you cannot go far."

He went on to acknowledge the concerns raised by party members regarding the previous primary election process, including the late primary election date, limited opportunities for appeal, and

delayed issuance of campaign materials and membership cards.

Dr Masisi explained the cause of these issues, stating that the party leadership had made a decision to upgrade its voting system to a new software in order to strengthen its security features to deter infiltration, which inadvertently resulted in missing names on the voter rolls during the migration process.

He stressed the importance of learning from the challenges to avoid similar problems in future elections.

Despite acknowledging these challenges and many others, Dr Masisi remained firm in his belief that party unity was crucial for the its future success, emphasising that focusing on internal disagreements would only distract BDP from the larger goal of winning back the support of the electorate.

The BDP chairperson, Mr Slumber Tsogwane echoed the importance of party discipline and unity.

He emphasised the need for party members to unite and build the party within its structures, warning against using WhatsApp groups as a platform for spreading divisive or disrespectful messages about the party and its leadership.

Mr Tsogwane highlighted that the party's election loss had been gradually mounting

over the years, which suggests that internal disunity had been an issue for some time.

Acting secretary general, Mr Ngaka Ngaka warned that "even if we win back the government,

if we don't forgive each other, our party will not move forward". **BOPA**

Disinformation triggers economic uncertainty

JOHANNESBURG - South African and U.S. business communities should intervene and correct the disinformation that has resulted in the diplomatic spat between both countries, a South African expert said Monday.

Raymond Parsons, an economist from the North-West University's Business School, urged companies in both countries to mobilise their suppliers and customers to correct the disinformation.

"Disinformation about the situation in South Africa and negative U.S. statements about South African policies have triggered a worrying spike in

economic uncertainty, which is not only bad for business but also for the country more broadly," he said.

The row between the two countries began last week when U.S. President Donald Trump threatened to withdraw funding for South Africa due to the recently signed Expropriation Act, which allows public institutions to expropriate land in the public interest.

South African President Cyril Ramaphosa dismissed claims that the Expropriation Act was aimed at seizing land, expressing willingness to engage with the Trump administration on land reform policies and other

bilateral issues.

"We should not underestimate what may ultimately be at stake for the South African economy and business in the face of the current sharp breach in bilateral political and diplomatic relations between the U.S. and South Africa," noted Parsons. He explained that the business community should contribute their efforts to the ongoing political and diplomatic initiatives.

The business community has to be united in mounting its case to the Trump administration and other stakeholders, said Parsons, urging affected companies in both countries to enlarge their spheres of influence.

"Intervention by business should be conducted in a calm and focused manner which proposes better ways supported by facts to manage and preserve U.S-South Africa economic relations in the short and longer terms," he said.

Parsons further noted the spat had put the renewal of African Growth and Opportunity

Act (AGOA), set to expire in September 2025, in jeopardy. AGOA allows African products to the U.S. markets with no tariffs.

Trump signed an executive order on Friday to cut financial assistance to South Africa and offered refugee status to Afrikaners in South Africa, which they turned down. *Xinhua*

Ivorian artist seeks funds to help children with cancer

ABIDJAN - In a bid to raise funds for children with cancers, Ivorian artist Mylene Francoise Amon is seeking a Guinness World Record by creating 130 portraits in 120 hours, Abidjan. net has reported recently.

Using a similar technique involving optical illusions on paper in creation, Amon aimed to surpass the previous record of 100 portraits.

The artist fell short of her initial goal of 150 works within the allotted time as the progress was impeded by adverse weather conditions, but with an extension granted, she was able to continue her challenge.

Her efforts of intense creation during the period from February 5-to-10, an event taking place at the BAE stadium in Yopougon, the largest commune in the Abidjan district, drew attention and support from the public and media across Cote d'Ivoire as well as the artistic community and political figures, said the report. Amon's portrait works depicting

political leaders, well-known entrepreneurs and cultural icons in the western African country have been known for vividness. The report says proceeds from the sale of the portraits created in her Guinness record challenge will be donated to children suffering from cancers, in a move in partnership with the Ivorian Ministry of Health. *Xinhua*

Biya targets over 10 000 jobs

YAOUNDE - Cameroonian President Paul Biya has unveiled a series of measures aimed at reforming the nation's employment system, with a goal of improving job access for young people.

The government will establish a regulatory framework to support the recruitment of first-time jobseekers, Biya said in a televised message on Monday evening. He said the framework would help consolidate, analyse and disseminate information on available job opportunities.

To preserve the environment and combat climate change, the government has created the Green Jobs Promotion Program, which will "ultimately help to create over 10,000 jobs through income-generating activities in areas such as sanitation, waste recycling and organic farming," said the president.

The government is also working to employ more health workers and ensure that training opportunities mirror actual labor market needs, he added. According to data from the National Institute of Statistics in Cameroon, the unemployment rate in the country in 2024 was 3.6 percent.

Biya's speech was televised on National Youth Day, celebrated annually on February 11 in the Central African country. *Xinhua*

Angola opens new fuel storage terminal

LUANDA - Angola has opened a fuel storage terminal in northern province of Bengo on Monday which is expected to increase the country's onshore storage capacity for diesel, gasoline and other refined petroleum products by more than

80 per cent.

The Barra do Dande Ocean Terminal, a strategic infrastructure project owned by the state-run oil company Sonangol, has an initial storage capacity of 580,000 cubic meters.

Built at a cost of US\$642 million the facility was constructed by the Brazilian company Odebrecht Engineering and Construction.

Before the new terminal became operational, Angola's onshore fuel storage capacity

stood at 676,968 cubic meters, according to an October 2024 report by the Angola Petroleum Derivatives Regulatory Institute.

Despite being one of Africa's major crude oil producers, Angola still imports about 70 percent of its fuel supply. *Xinhua*

Power struggle engulfs karate association

GABORONE - Botswana Karate Association (BOKA) is embroiled in power struggles, which saw some members of the association convening a special general meeting on Saturday at Yarona Lodge in Mogoditshane.

The meeting was said to deliberate on what was considered serious concerns with regard to the current BOKA executive committee led by Sensei Mpho Bakwadi.

Conveners of the meeting alleged that the leadership disregarded the principle of good governance and violated the constitution on several occasions, hence they passed a motion of no confidence against the committee.

This led to the election of a new committee, which is expected to stay at the helm until June before the annual general assembly.

Keorapetse Mogopodi was elected as president, assisted by Moemedi Mpebe as vice president technical, while Veronica Tshube was elected the vice president administration.

Boitumelo Koone is was elected as the secretary general and will be assisted by Etellang Serumola, Moses Hirschfield is the treasurer, while Moses Tubego is entrusted with the role of publicity secretary.

However, Bakwadi took no notice of the new developments on the basis that the special general assembly was unconstitutional, and it was a circle of friends whose aim was to destabilise karate.

“What I can tell you is that I am still BOKA president and nothing has changed. If people are aggrieved they have to follow the constitution,” said Bakwadi in an interview.

Asked why he was adamant that he was still BOKA president despite a motion of no confidence against his committee, Bakwadi said prior to the unconstitutional special general meeting, he received letters from six out of eight affiliates disassociating themselves from the special general assembly.

Bakwadi said all was well at BOKA and were busy with national team selection in the northern and southern parts of the country.

Meanwhile, concerns raised against Bakwadi and his team were that they had over time violated the constitution by failing to appoint BOKA commission, and failed to hold regular meetings as stipulated in the constitution.

Those disgruntled also

complained of lack of financial transparency, arbitrary termination of members, unlawful appointments of coaches without following the prescribed procedures.

Botswana National Sport Commission (BNSC), director for Sport Development, Peaceful Seleka said at the moment it was early for them to comment because there was nothing on their table from both parties.

“Also you must remember that karate is governing itself and we cannot jump to conclusion that the motion of no confidence was constitutional or not. As BNSC, in the event they both approach us, the role that we can play is that of mediation,” said Seleka.
