

Bank of Botswana addresses liquidity challenges

 $B^{\rm ank\ of\ Botswana\ has\ introduced\ measures\ to}_{\rm respond\ to\ low\ excess\ liquidity\ challenges.}$

One of the measures include reducing the primary reserve requirement to zero, extending the maturity of repurchase agreements (repo) to 30 days and adjusting foreign currency trading margins.

"These interventions have helped to stabilise liquidity conditions, evidenced by increased uptake of longer-term repos, improved interbank activity and a pause in prime lending rate hikes," the Bank notes

According to the central bank's Financial Stability Report, the country has experienced a historically low excess liquidity in the banking sector at P764 million in March 2025, while average daily market liquidity increased to P1.557 billion in the second quarter of 2025, driven by mainly by government expenditure financed by Southern African Customs Union (SACU) receipts.

Traditional Affairs Tribunal to resolve Bogosi disputes

Government is planning to establish a Traditional Affairs Tribunal via the reviewed Bogosi Act to bring greater clarity and stability to the Bogosi institution.

The Traditional Affairs Tribunal is expected to resolve chieftainship disputes and other relevant traditional matters.

Speaking at a kgotla meeting in Mochudi on Thursday, Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa said the legislative review was necessary because the Bogosi institution had been marred by disputes, often stemming from lack of proper consultation between communities and royal houses.

Mr Motshegwa said the review of the Bogosi and Customary Law Acts followed countrywide consultations, with most amendments based on the recommendations received.

He indicated that the review aimed to profile the roles of Dikgosi and grade them to ensure that the structures were clearly defined and formally incorporated and defined the role of the royal house within

the Bogosi Act as well as establish a defined structure for Dikgosi, complete with official titles.

He added that government's goal was to create well-defined structures that minimised ambiguity and friction within the traditional leadership framework.

Furthermore, the Minister commended the Bakgatla community for continuing to uphold their culture and encouraged them to keep instilling discipline through traditional institutions like initiation schools.

Minister Motshegwa also

informed the Bakgatla that government had officially dropped all charges previously levelled against their paramount chief, Kgosi Kgafela II.

The landmark decision, he explained, followed key engagements between the ministry and the Bakgatla Deputy Chief, Kgosi Bana Sekai, regarding the circumstances surrounding Kgosi Kgafela II's prolonged absence from the country.

Mr Motshegwa also shared that during a recent meeting with Kgosi Kgafela II, he informed him that a Constitutional Review was underway and extended an invitation for him to participate in the national process.

For his part, Minister of Justice and Correctional Services, Mr Nelson Ramaotwana, assured Bakgatla that government was committed to peaceful relations with the tribe.

Mr Ramaotwana said their Kgosi was free to come back home following the engagements and consultations that ultimately led to his flight. "This has been a long journey, but it has finally been resolved," he said.

Members of the community expressed their delight over the news and welcomed the decision.

However, they stressed that they still required assurance that their Kgosi would not be troubled upon his arrival back home, which they deemed a significant step toward healing historical rifts. **BOPA**

Residents welcome proposed National Health Insurance

Hukuntsi residents have welcomed government's proposal to establish the National Health Insurance (NHI), describing it as a long-term and sustainable solution to persistent challenges facing the country's health sector.

Community members said the initiative would significantly improve access to timely and quality healthcare services for all citizens.

They shared their views during a stakeholder consultative kgotla meeting convened by the Ministry of Health, where officials engaged residents to solicit input on the structure of the envisaged insurance scheme.

They expressed optimism that the NHI would expand access to private health facilities, particularly private clinics, which could help ease congestion in public hospitals and address recurring shortages of essential medicines.

The residents proposed that the scheme should allow patients to collect prescribed medication from private providers during stockouts at government facilities.

On funding, residents recommended that government be the primary contributor to the NHI provident fund, with allocations made directly to the fund rather than channelled through the ministry to enhance efficiency and accountability.

Kgosing Ward resident, Mr Oarabile Ratlou suggested that additional revenue be raised through levies on tobacco and alcohol, given their contribution to lifestyle-related illnesses. He also proposed levies on festivals, noting that emergency cases often arose from accidents and assaults associated with such events. Mr Ratlou further recommended levies on certain high-risk foods to boost the fund.

He emphasised the importance of integrating the informal sector, NGOs, pensioners and the unemployed into the scheme, calling for equitable contribution models that accommodated varying financial capacities.

Mr Ratlou also urged the ministry to introduce robust security systems to prevent fraudulent claims and to adopt modern technologies, including the use of drones for medicine delivery to remote areas.

Hukuntsi South Councillor, Mr

Kerapetse Jane raised concerns about the absence of a referral hospital in the area, saying long travel distances to Princess Marina Hospital for specialised care often compounded by transport costs.

He called for policy provisions to support referred patients who lacked the means to travel and for improved access to specialist consultations, citing prolonged waiting times.

Another resident, Mr Mooketsi Radira, said a well-designed and effectively implemented NHI could benefit all Batswana, including those in remote settlements. Addressing the meeting, Ministry of Health's Public Health Physician, Ms Leungo Reigner said the ministry had intensified stakeholder consultations as part of efforts to develop Botswana's NHI scheme. She underscored the importance of district and community participation in shaping the country's future health financing system.

Ms Reigner explained that the consultations were critical for gathering ideas and insights from citizens, which would inform an NHI model reflecting the needs, expectations and lived experiences of Batswana. She added that the NHI represented a major step toward strengthening health financing and advancing Universal Health Coverage.

"The NHI seeks to ensure universal health coverage and equitable access to affordable, high-quality healthcare for all, built on principles of equity, solidarity and sustainability," she said.

She encouraged residents to continue participating in the consultations, stressing that their contributions would be central to shaping a resilient and inclusive health system for Botswana. **BOPA**

Botswana and China relations flourish

Since the establishment of Botswana and China diplomatic relations in 1975, the two have expanded cooperation in agriculture, health care, education, infrastructure, digital construction and other fields with the total trade volume between the two countries increasing by 15.7 percent with an optimised trade structure in 2023.

Of significance, is the fact that diplomatic relations between China and Botswana have grown significantly in recent years, with Botswana becoming the 46th country on the continent to sign a Memorandum of Understanding on the China-proposed Belt and Road Initiative in 2021.

In the face of complex economic challenges besieging the nation, cooperative programmes are emerging as inspiring examples of an alternative future, one where solidarity enterprises place workers and societal welfare before profit.

The influence of the cooperative movement in Botswana is a remarkable story and its contribution to financial inclusion for communities cannot be overstated.

Central to this success is a philosophy rooted in trust, fairness, inclusion, collective empowerment and long-term financial wellbeing.

As the nation continues to chart its path toward financial strength and economic stability, the cooperative movement is expected to remain pivotal to that growth.

To support this journey,

government through the Banking Act of 2023 has placed all Savings and Credit Cooperative Organisations (SACCOs) under the oversight of the Bank of Botswana.

"Under BOSCCA, more than 27 SACCOs have mobilised over P2 billion in savings, issued more than Pl.9 billion in credit to their members, and now serve a membership exceeding 60 000 people nationwide truly impressive figures," he said.

He said government would

continue working with BOSCCA and all stakeholders to ensure cooperative financing played a central role in employment creation and poverty reduction uniting over 200 000 members across diverse sectors, from farming to finance, while evolving with modern economic goals such as social enterprise.

Mr Gaolathe emphasised that financial inclusion remained one of the clearest expressions of an equitable economy, with SACCOs continuing to be among the most effective vehicles for achieving it.

He added that government was committed to supporting Botswana's leverage of the SACCOs model to advance financial inclusion, citizen empowerment and broader economic participation.

"We recognise that no single financial player, public or private, can close the inclusion gap alone. SACCOs are key partners in expanding access to credit, mobilising household savings, supporting micro and small enterprises, and fostering financial literacy and resilience," he said.

'Transitioning of special constables notable milestone'

The enlistment of special constables into the regular police establishment marks a significant milestone that will enhance police visibility, boost officer morale and build a resilient and reputable police service committed to serving the nation with diligence and enthusiasm.

President Advocate Duma Boko made these remarks at the pass-out parade of 873 graduate recruits of the Botswana Police Service (BPS) held at the Police College near Otse on Friday. Of the graduates, 845 are former special constables.

"Their elevation to the status of full-time police officers is not a mere manpower expansion effort, it is a milestone that is in alignment with government's pathway to a new Botswana; a Botswana defined by peace, security and stability," said President Boko.

He explained that the engagement of special constables was introduced in September 2004 as a temporary measure to augment police manpower and

enhance visibility as a key crimeprevention strategy.

Over the years, he noted, government prioritised the incremental enlistment of special constables who met standard employment requirements, resulting in the absorption of some into the regular police service.

"It has now become necessary to discontinue the special constable programme altogether, while retaining the accumulated expertise. As such, all serving special constables have now been absorbed into the regular police establishment," he said.

President Boko noted that the absorption of the graduates came at a pivotal moment in the BPS's transformative journey, which focused on re-engineering and modernising the service to make it more effective, dynamic, innovative and technology-driven, while strengthening partnerships and collaboration.

He highlighted notable initiatives such as the introduction of air support services, cyber

forensics, safer city solutions, drone technology, the gender and child protection branch, the police-public partnership directorate and the human rights

Emphasising that the fight against crime could not be won by police alone, President Boko urged the graduates to embrace community-oriented policing as the cornerstone of effective law enforcement.

He said they should build trust and cultivate the spirit of policecommunity cooperation with the

people they served in order to make crime management effective and impactful.

"Our country is currently wrestling with new and emerging public security threats and mounting social challenges. The scourge of illicit drugs and substance abuse is threatening to tear families and communities apart. It is an existential threat that we must fight and win," he said.

He also described gender-based violence (GBV) as a dark stain on the nation's collective conscience and a betrayal of the national ethos of Botho, posing a grave threat to the moral fabric and social stability

"In 2024 alone, the BPS recorded 14 020 GBV cases, including 4 468 cases involving children. As you graduate today, go out not to perpetuate the problem, but to contribute meaningfully to finding solutions. You are not just enforcers of the law; you are the first line of defence for the vulnerable, the hope for every victim, and the living embodiment of justice, peace, and security," he

The bank further states that banks continue to meet minimum liquidity requirements, with a ratio of 17.8 per cent in June 2025, although structural vulnerabilities such as high deposit concentration and elevated funding costs persist.

It says that the foreign exchange risk exposure remains minimal, and exchange rate volatility has declined, contributing to overall financial system stability

"However, the underlying structural features of the economy and market, such as asset and funding concentration and deep interconnections, pose contagion risk that could be triggered by liquidity, leverage or external sector shocks," notes the Bank.

The report notes that the financial

banks, non-banking financial institutions and financial market infrastructures remain resilient and robust.

The banking sector remains healthy, characterised by strong capital adequacy position, stable liquidity buffers, and low levels of non-performing loans (NPLs), the report notes.

The report further states that the bank's profitability has improved, underpinned by several drivers such as non-interest income or service fees and cost containment measures. It further says the pension funds, insurance firms and asset managers, continue to grow in scale and influence, though they face operational and market risks linked to digital transformation, product concentration, and

Interconnectedness across sectors has increased, underscoring the need for enhanced supervisory coordination. Financial Market Infrastructures (FMIs) continue to be robust and ably support large volumes of electronic payments and clearing, says the report.

The central bank however warns that despite the prevailing resilience, the financial system faces a constellation of risks that warrant close and continuous monitoring.

The bank says financial institutions remain vulnerable to weak economic growth, constrained fiscal space, and low export revenues due to low sales of diamonds and persistent structural bottlenecks that could dampen investment and worsen the external position. "Financial

pertain to funding risk driven by tightening liquidity conditions and elevated refinancing pressures among financial institutions, as well as elevated contagion risk, considering concentrated exposures and interlinkages across banking, non-bank financial institutions, and public sector entities," reads the report. The report further says although household credit risk is contained, it remains sensitive to shifts in employment dynamics and debt servicing capacity.

"Risks from crypto assets, climate-related exposures, and cybersecurity threats are currently assessed as low-impact and lowlikelihood, though their latent potential to escalate remains nonnegligible," states the Financial Stability Report. **BOPA**

For many motshelo members, the end of the year is a moment of great anticipation, the long-awaited sharing of dividends after months of faithfully contributing to the communal pot.

Traditionally, these year-end gatherings are grand occasions. Members mostly women, arrive dressed to impress, ready for a celebratory lunch where profits or food packages are shared. After a year of disciplined contributions, the payout serves not only as financial relief but as a boost of pride ahead of Christmas festivities and the journey home to the village, where spending power often translates into status.

But there have always been the occasional spoilers: the treasurer who disappears, the member who vanishes with outstanding contributions, the mysteriously switched-off phone and the now famous line, "Buka ya motshelo e jelwe ke dipeba" (the rats have eaten the motshelo accounting book).

Such festive-season tales have circulated on social media for years, recounting members who go missing well into the New Year.

Increasingly, however, those mishaps are becoming rare as motshelo groups tighten their governance.

"The motshelo I am part of is very organised," says Serowe-born, Gaborone-based multimedia designer Tswelelo Kgakge. "We have a committee with a chairperson, secretary and

treasurer, and we use a mobile money group savings account where every withdrawal must be approved by all members."

She says her team of women

runs like a well-oiled machine, with checks and balances that build trust.

"Beginning of the year, we make our contributions. As the year continues, members can borrow from the common pool and repay with interest. At yearend, we share the dividends. One member hosts us for a lunch where everything is distributed — all very orderly."

Motshelo functions as a

Motshelo functions as a voluntary financial cooperative, where members contribute agreed amounts into a shared fund. The money may then be released to individuals on a rotational basis, often generating income through interest before a collective payout at year-end. It also doubles as a rotating savings and credit association (ROSCA) for major expenses — funerals, school fees, groceries or even construction projects.

Modelled closely on South Africa's communal stokvel system, motshelo has historically relied on trust and solidarity. Over time, however, it has modernised through digital applications, formal banking products and clearer accounting procedures.

Award-winning sports journalist Ms Anastasia Sibanda agrees that modern structures have reduced disputes.

"Commercial banks now offer fixed deposit motshelo accounts, and mobile money providers have group savings solutions. This improves accountability and ensures a clear paper trail," she says.

Sibanda has belonged to a tenmember motshelo since 2011. The group charges a joining fee, makes regular contributions, allows members to borrow at 20 percent interest, and divides the earnings once members reach their agreed threshold. "We are well structured — chairperson and treasurer as signatories to the account, a secretary, and a disciplinary coordinator who handles disputes. Everything is transparent. A spreadsheet is published monthly in the WhatsApp group, and members must approve any release of funds," she explains.

Such measures ensure that members are now far less vulnerable to "the rats" — real or metaphorical — that once threatened to spoil the festive cheer by devouring the money or the accounting book. **BOPA**

Public participation central to constitution review - Dingake



litizens are entitled to participate in the public affairs, including the process of designing the country's constitution, says Professor of Constitutional Theory, Justice Key

Speaking at a public lecture hosted by the Botswana Council of Non-Governmental Organisations (BOCONGO) in Gaborone on Thursday, Prof Dingake said there was a need to strengthen the country's democratic culture, embolden rights, evolve power relations, and reform public administration.

He emphasised the importance of dialogue among key stakeholders and citizens, describing what he termed 'conversational constitutionalism'.

'The process must be inclusive, transparent, participatory and peopledriven. In modern constitution-making, the process is as important as the content," he said. Prof Dingake added

that the design of the constitution must engender national ownership by being participatory, inclusive, transparent and accountable. Such an approach, he said,

enhanced legitimacy, educated the public on democratic governance, and built a shared political identity.

He noted that in the past, constitutions were often imposed by departing colonial authorities or political elites, a practice no longer considered appropriate. He pointed to international legal instruments such as the International Covenant on Civil and Political Rights, which affirm citizens' right to participate in public affairs, including constitution-making.

"Public engagement can take many forms and may occur at different stages of the constitutional process," he said.

Prof Dingake said Botswana could draw lessons from South Africa's CODESA process, noting that Botswana's review would take place many years later and should reflect its own history, values and circumstances.

In his remarks, BOCONGO board member, Mr Fredrick Kololo said the constitutional review process could not be left to any single institution. He said it required the participation, vigilance and wisdom of the nation, adding that BOCONGO and its partners had played a central role throughout the

"During the previous review attempt, we consistently advocated for a process grounded in transparency, participation and genuine public consultation," he said.

Although that process did not yield the desired outcome, Mr Kololo said it strengthened their resolve and highlighted critical

He added that an informed nation was an empowered nation, noting that civil education demystified the process and enabled Batswana to contribute from a place of

He also said that a truly peoplecentred constitutional review must place citizens at the heart of the process, adding that democracy was strongest when citizens were active participants rather than passive observers. BOPA

Minister urges Batswana to learn own rights

Minister of Justice and Correctional Services, Mr Nelson Ramaotwana, has urged Batswana to understand and appreciate the importance of their rights.

Delivering a message on Human Rights commemorations day recently, Mr Ramaotwana said government continued to reaffirm the values of human rights and promote public participation in shaping daily life. He said all Batswana and all inhabitants of Botswana had a role to play in the country's development and prosperity.

"This is the new Botswana which we are currently building together, and every person living in Botswana and every organization should hold hands with government to achieve this reality," Mr Ramaotwana said. This year's Human Rights

Day is commemorated under the theme: Our Everyday Essentials, which focuses on bridging the gap between human rights principles and day-to-day experiences. The theme aims to increase awareness, inspire confidence and encourage collective action.

The minister said government, as a human-rights-centred administration, remained committed to improving the lives of all people living in Botswana. He highlighted initiatives such as the Bonno Housing Project, access to education, food and water, as well as ensuring a safe and peaceful environment. He emphasised that the wellbeing of every person was central to the national development agenda.

Mr Ramaotwana, however noted that challenges such as unemployment, drug abuse, strains in the health sector and rising delinquency continued to hinder the enjoyment of human rights. Human Rights Day, he said, served as a call to all citizens, residents, public officials, the private sector and civil society to recognise their importance in Botswana's development journey and to speak with one voice in moving the country forward.

Investment competition grows

The 2025 BSE–Stanbic Bank Senior Secondary Schools Finance and Investment Competition aims to plant a seed by raising a financially literate generation.

Any vision, no matter how small, requires a dedicated partner to become a reality.

This sentiment was shared by Botswana Stock Exchange (BSE) Head of Market Development, Ms Thapelo Moribame, while welcoming guests at the 2025 BSE—Stanbic Bank Botswana Senior Secondary Schools Finance and Investment Competition National Awards Ceremony, held recently at the BSE Training Room in Gaborone.

Ms Moribane said the competition, launched in 2013 as a physical initiative, had evolved into a digitally driven programme. She explained that this year's edition was delivered through a Stock Market Simulator a user-friendly, risk-free virtual trading platform designed to enhance financial literacy and broaden access to stock market education.

"For the 2025 edition, all participating schools began competing at regional level. Each school was allocated virtual funds to build and manage investment portfolios. We then identified the top three schools in each region and awarded them share vouchers," she said. Regional winners advanced to the national finals, where they competed for the final prize. Ms Moribane noted a substantial increase in participation, with schools rising from 15 in 2024 to 28 in 2025.

She described the growth as evidence of the competition's relevance among students and a reaffirmation of BSE and Stanbic Bank Botswana's commitment to widening access to capital markets.

Ms Moribane revealed that a total

Ms Moribane revealed that a total of Pl15, 000 in share vouchers had been awarded to 55 participants, alongside P30, 000 in cash prizes to the top three schools.

She applauded Stanbic Bank Botswana for its sponsorship and partnership, describing the collaboration as strategic and anchored in a shared belief that empowering young people was critical to Botswana's economic growth.

The Deputy Permanent Secretary in the Ministry of Child Welfare and Basic Education, Mr Steve Bothasitse, congratulated the winning schools, Al Nur School, Swaneng Hill School and Pioneer Academy for their outstanding performance.

"You have demonstrated exceptional resilience throughout this competition. The stock market is often viewed as complex, yet you embraced the challenge with determination and confidence," he said.

Mr Bothasitse told learners that their participation sent a clear message that Botswana's youth were ready to play an active role in shaping the country's economy. He also praised the BSE–Stanbic Bank partnership, noting that the initiative reflected a deep commitment to youth empowerment, financial inclusion and national development.

He acknowledged that one of the ministry's major challenges was that financial literacy was not yet strongly embedded in the mainstream curriculum, leaving many students unprepared for reallife financial decisions. Competitions such as this, he said, helped bridge the gap between education and industry, and between theory and practice.

"Financial literacy is no longer optional; it is an essential life skill," Mr Bothasitse said, adding that government alone could not deliver every skill learners needed.

Partnerships with industry, he noted, were vital in cultivating a culture of shared responsibility and investment in education.

He emphasised that child development was a national project requiring collective effort, and reaffirmed the Ministry's commitment to nurturing and expanding collaborations for the benefit of every child. **BOPA**

NARDI, RESADE focus on advancing agricultural development

The declining agricultural produce and low yields per hectorage has prompted the National Agricultural Research and Development Institute (NARDI) to come up with initiatives to enhance production. With the help of international partners, the International Centre for Biosaline Agriculture (ICBA), the Arab Bank for Economic Development in Africa (BADEA) and the International Fund for Agricultural Development (IFAD), NARDI has been able to set up best practice hubs in Kweneng District where the farmers were taught best practices in agriculture for high production.

Speaking during the site visit of the Kweneng village best practice hub on Wednesday, Chief Executive Officer (CEO) of NARDI, Professor Julius Atlhopheng said the sixth Steering Committee members for Improving Agricultural Resilience to Salinity through Development and Promotion of Pro-poor Technologies (RESADE) project were accorded an opportunity to

visit one of the projects, where some members of the local community were undergoing training.

He said the practice hub gave locals an opportunity to be taught and learn how best to enhance production and value added chain of their produce especially in areas where ground water has high concentration of salinity.

Prof Atlhopheng said Kweneng practice hub was a piece of land measuring a hectare designed for research with irrigation system. He said crops that were used for research included lab-lab, varied varieties of beans and the traditional Kalahari early pearl variety of sorghum.

He added the Kalahari early pearl sorghum grows fast when irrigated adding that another variety of sorghum; Kanye standard also does well under such conditions.

Prof Atlhopheng said more than 700 farmers in Kweneng District have been trained, covering villages such as Mahetlwe, Gakuto, Lentsweletau and Tsetseng.

He further said the farmers were engaged in courses relating to exploring value chain of the

different crops by making food item such jam, sauce and other value adding products to improve their livelihoods by starting small businesses

Prof Atlhopheng said the Kweneng practice hub has a seed bank where farmers will be able to source traditional seeds, which were facing extinction.

He added that research showed that a hectare of a field given the necessary care, would produce a harvest of between 2.8 tons to 3.5 tons.

Prof Atlhopheng encouraged small holder farmers to source quality seeds from NARDI and be in a position to produce better yields.

Prof Atlhopheng said since its inception, the RESADE project which would run for three years, ending December 2026 had produced some positive results.

produced some positive results. He added that NARDI wouldcontinue working closely with other government agriculture programmes, such as the new Lemang Dijo programme, identify areas of collaboration toward increased production. **BOPA**

South Africa engages G20 members over exclusion

South Africa has engaged with the embassies of the Group of 20 (G20) countries following its exclusion from G20-related activities by the United States, according to South African International Relations and Cooperation Minister Ronald Lamola.

In an interview with the South African Broadcasting Corporation on Saturday, Lamola said South Africa would not attend next year's G20 summit in Miami, the United States, unless it receives a formal invitation from Washington. He stressed, however, that Pretoria will not call for a boycott of the summit even if it was excluded.

The minister said the United States had taken unilateral decisions this year on a range of issues, including trade, and had withdrawn from several multilateral platforms. *Xinhua*

Sudan, South Sudan to boost cooperation in energy and oil trade

Sudan and South Sudan have agreed to strengthen bilateral relations and expand cooperation, particularly in energy, oil, trade, investment and political affairs.

The agreement was reached during a meeting between Chairperson Sudan's Sovereign Transitional Council Abdel Fattah Al-Burhan and a high-level South Sudanese delegation led by Tut Gatluak, presidential adviser on national security, who delivered a written message from South Sudanese President Salva Kiir Mayardit on enhancing bilateral ties. Sudan's Foreign Ministry Undersecretary Muawiya Osman Khalid said Alinstructed Burhan had relevant state institutions at ministerial and technical levels to engage with their South Sudanese counterparts to discuss issues of mutual interest. *Xinhua*

Laying The Foundation For Safer Deposits

What is the Deposit Insurance Scheme of Botswana?

Deposit Insurance Scheme of Botswana (DISB/ Scheme) is a public scheme set up for purposes of compensating depositors'money when a bank or deposit taking institution has failed. The Scheme is established under the Bank of Botswana (Amendment) Act 2022 and operationalised through the Bank of Botswana (Deposit Insurance Scheme) Regulations 2023, that came into effect on July 21, 2023. The Scheme is administered by staff seconded from the Bank of Botswana. It operates from the Bank of Botswana Head Office.

What are the functions of DISB?

Premium Collection

DISB is responsible for regular collection of insurance premiums from member institutions in order to build a fund to meet its future financial commitments.

Public Awareness

DISB is responsible for regular collection of insurance premiums from member institutions in order to build a fund to meet its future financial commitments.

Payout and Liquidator

DISB is responsible for depositor payout in the event ofthe failure of a member institution. Additionally, DISB may act as a liquidator (an official person or organisation that is given the job of closing a bank/ deposit taking institution by selling its assets so that its debts could be repaid) of a failed member institution if appointed by the Bank of Botswana.

Data Collection, Risk Analysis and Surveillance

DISB is responsible for the collection and analysis of data on member institution customer deposits. The analysis of the data helps the DISB determine, among others, risk exposure to the Deposit Insurance Fund (Fund), coverage limit, estimated insured deposits and amounts to be paid to depositors in the unlikely event of failure of a member institution. The DISB also carries out surveillance and continuous monitoring of member institution performance to enable early identification of possible risks that could lead to member institutions failure. Further, the DISB collaborates with other safety net participants (i.e. Financial Stability Council member institutions) on policy formulation, financial crisis preparedness and in the determination of the most appropriate resolution method of a failing or failed member institution.

Administration of the Fund

The DISB has opened a Fund account with the Bank of Botswana for purposes of depositing premiums contributed by member institutions. The DISB is required to invest monies paid into the Fund in low-risk liquid assets, such as, Government treasury bills and bonds to preserve the Fund capital and for maintenance of liquidity. The monies in the Fund may also be invested in other securities, as may be determined by the Deposit Insurance Committee.

Who are the member institutions of DISB?

All commercial banks licensed by Bank of Botswana are member institutions of DISB, as well as the Botswana Savings Bank. The membership is compulsory by law. Any newly licensed commercial banks and deposit taking institutions automatically become members of DISB.

How are member institutions identified?

Member institutions of DISB can primarily be identified by a membership certificate that is visibly displayed in all their respective head offices, branches

Sample of the membership certificate is shown below:



In addition, member institutions will indicate their membership to DISB in their ATM screensavers, and when making website, radio, television or podcast advertisements.

As soon as a member institution fails, and is unable to repay its depositors, DISB steps in to payeligible customers of the failed memberinstitution.

DISB will announce how and when compensation of insured deposits will be made, and the copensation will be based on the record of depositors obtained from member institutions. Therefore, it is very important for the depositors to keep their records updated at their banks or keep their records updated at their banks or deposit taking institutions.

How much is coverage limit?

DISB insures up to a maximum of P250 000 per depositor per member institution in the event that a member institution fails (see examples below).

It insures deposits held by member institutions for natural persons as well as legal entities, whether they are from Botswana or from any other country.

Funds deposited in separate branches of the same member institution are not insured separately but are added and insured up to a maximum of P250 000

If someone is a depositor in more than one member institution, how does coverage limit apply?

Deposits in each member institution are insured up to the maximum limit of P250 000 per depositor. A depositor is therefore entitled to compensation by DISB whenever one or more member institutions that hold his/her deposits fails.

Which types of deposits are eligible for insurance by DISB?

All ownership categories (i.e. individual, corprate, trust, etc) of deposit accounts are eligible for compensation by DISB, except the following:

- · Deposits of the Government or institution wholly or partly owned by the Government.
- · Deposits of banks and non-bank financial institutions.
- · Deposits of owners, directors and senior management of a failed member institution
- Deposits of a subsidiary or associate company of a member institution.
- · Deposits held by International Financial Service Centre licensed banks.
- · Negotiable certificates of deposits or any other tradable debt funding instrument.
- · Deposits arising from transactions that are linked to financial crime.

Where does DISB get funds for its operations?


DISB maintains a Deposit Insurance Fund that consists of seed capital from Government, membership fees from each member institution, as well as annual insurance premiums paid by member institutions. DISB also invests the money it collects in government treasury bills and government bonds to earn interest. In addition, DISB has powers to borrow for emergency liquidity needs.

The cover is free for all eligible depositors. Only member institutions pay contributions in the form of insurance premiums to DISB.

Second water debt amnesty campaign opens

Water Utilities Corporation (WUC) customers have until February 28, 2026 to settle their outstanding bills under the second phase of the water amnesty campaign that targets residential homes and businesses.

Delivering a statement in Parliament on Friday, the Minister of Water and Human Settlements, Mr Onneetse Ramogapi, said through the campaign that started December 8, customers would qualify to be connected to the new Smart Prepaid Meters once their bills were settled.

He further noted that the corporation would also take the opportunity to educate customers about the importance of paying their water bills, as water was a source of life.

Also the second addition campaign would target residential homes and businesses that pay P2 000 or less for water bills, as well as churches and non-governmental organisations. Mr Ramogapi said government departments, councils, and state-owned enterprises were excluded, as well as banks.

All WUC customers who previously registered under the programme's first phase but failed to pay will be given an opportunity to do so, Mr Ramogapi explained.

To be eligible for debt amnesty, business and domestic customers would be expected to pay the balance of the Resultant Balance in full, or a minimum of 50 per cent deposit at application.

They would also be expected to complete payment plan forms, where payment plans are applicable, and customers would only benefit from the debt amnesty if they apply and pay the requisite

amounts within the agreed periods. Minister Ramogapi said disconnected accounts would be reconnected upon payment of the initial 50 per cent of the discounted balance, plus 50 per cent of the requisite new debt balance.

He explained that customers on Debt Amnesty Campaign payment plans would be expected to pay the agreed monthly payment plan amount, plus monthly bills during the campaign period.

Kanye East MP, Mr Prince Mosanana, appreciated the project's second phase of the amnesty, noting that most of the water bills were a result of backyard gardens during the previous administration.

Shashe West MP, Mr Jeremiah Frenzel, also thanked the minister for the water amnesty phase two programme, saying it showed that the government cared about its people.

Letsweletau-Lephephe MP, Mr Tshenolo Bogatsu, requested the minister to have a temporary office for areas such as Kopong, where there was nowhere to pay for the water bills under the amnesty.

On smart meters, he said the government had not yet expanded the programme to other areas, adding that it started in Ramotswa, Gaborone, Tloweng, and Mogoditshane, where over 90 per cent of households were already connected.BOPA

Gaborone Station upgrade necessary - Motshegwa

The upgrade of Gaborone Bus and Taxi terminal is essential for urban renewal and efficiency to improve safety and security, streamline transport operational efficiency, and contribute to the broader Greater Gaborone development as a modern, vibrant economic hub.

The development works being **⊥** undertaken at the Gaborone Bus and Taxi terminal is vital for greater public transport efficiency beneficial to the capital, and the temporary displacement of traders who operate at the station is a short term necessity.

This was said by the Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa, on Friday at the National Assembly in response to a question without notice from Mogoditshane East, Member of Parliament, Mr Letlhogonolo Barongwang.

Mr Motshegwa said the ongoing development works were necessary to modernise the public transport infrastructure in Gaborone, enhancing safety, efficiency and urban vibrancy saying temporary displacement of informal traders was unavoidable to construct the new, multi-level, and safer

He added that the displacement had been necessitated by the need to clear the site for the construction of a new and larger modern facility, which would include new underground services and structured commercial spaces, with a long-term goal of formalising the informal sector into better facilities.

"Consultation is ongoing and structured through dedicated communication channels to ensure continuous stakeholder engagement. This includes the formation of dedicated committees comprising representatives from traders, the Gaborone City Council (GCC), and the project team to facilitate consistent feedback," said Mr Motshegwa.

He added that regular meetings were being held to provide timely updates, address any concerns, and to explain the temporary relocation process and the future stall allocation procedures.

"A mandatory verification process is also in place to accurately identify and register all legitimate traders, ensuring they receive critical communications and are prioritized for re-allocation within the new terminal," said Mr Motshegwa.

He further revealed that as a means of minimising disruption, there were designated areas adjacent to the operational hub prepared with basic amenities, in particular shelter, sanitation and lighting, maintaining proximity to commuters.

"In addition, there is provision

for waiving market or vending fees for the temporary sites to reduce operating costs. Furthermore, collaboration with agencies like Citizen Entrepreneural Development Agency (CEDA) to explore offering temporary, low-interest micro-loans to help traders meet financial obligations during the transition period," said Mr Motshegwa.

Also, the upgrade offers substantial long-term benefits across key stakeholder groups, Mr Motshegwa said.

These would include traders receiving an allocation of formal, modern stalls featuring better security, reliable electricity, and improved sanitation, which is expected to cultivate a more professional business image and significantly increase customer volume, the minister stated.

Commuters would also enjoy an improved user experience within a safer, cleaner, and covered terminal, benefiting from efficient transport services and clear organisation.

He further revealed that tender awards were made to two companies, Silverpark and MADCO in September 2024 and July 2025 respectively and that the first phase was expected to be complete by end of 2026.

Mr Barongwang had asked the minister to clarify to Parliament the rationale behind the ongoing development works at the Gaborone Bus and Taxi Terminal, particularly in relation to the temporary displacement of informal traders, and further outline. BOPA

Parliament defers motion on MPs tenure

The National Assembly on Friday decided to defer a motion by Maun East Member of Parliament (MP), Mr Goretetse Kegonegile that sought to align the term of office of MPs with that of Cabinet and councilors.

Mr Kekgonegile had proposed in his motion "that this honourable House resolves to request government to reconcile the tenure of Members of Parliament with that of members of Cabinet and councilors to 60 months as per constitutional term of contract."But after a short debate. Mr Kekgonegile formally requested for his motion to be deferred to a later date, after being asked by fellow legislators

In tabling his motion earlier

constitution of Botswana was clear of a five year parliamentary that the term of office for MPs was five years, or 60 months, but the constitution also provided for the dissolution of Parliament further stipulated in the Electoral Act.

The dissolution of Parliament by the President, who also issues writ of elections and election instruments before the general election is held, means MPs do not get to serve a full five year term, Mr Kekgonegile argued. He lamented that it created a vacuum where there were no area MPs in the two months leading up to a general election and also created a discrepancy between MPs and their colleagues who serve in Cabinet, as the executive served until election day.

'The purpose of this motion is to align the term of office of Cabinet ministers, MPs local councilors and also to bring to fruition the

on, Mr Kekgonegile said the spirit of the letter of the constitution representative term of office," said Mr Kekgonegile.

He added that constituents continued to need the assistance of their parliamentary representatives but in the two months leading up to national polls, people struggled to get assistance from the vacant constituency office.

Mr Kekgonegile said the changes his motion would bring about included avoiding the uncertainty of the past such as when Parliament was dissolved then reconvened under a State of Emergency ahead of the 1999 general elections during the tenure of former President Dr Festus Mogae.

Minister of Tourism and Environment, Mr Wynter

Mmolotsi, said he found the overall intent of the motion to be in order. But the third time legislator said he recalled that a similar motion had been passed by Parliament before, but a legal impediment that prevented it from being signed into law.Mr Mmolotsi thus pleaded with Mr Kekgonegile to defer the motion while research and legal advice could be pursued to clear any potential impediment to its passing.

Minister of Higher Education, Mr Prince Maele, then clarified that the similar motion had been brought to Parliament on March 2014 by former Lobatse, MP Mr Nehemiah Modubule, who then sought an amendment to Section 68 (1) of the constitution, which stipulated the tenure of office of MPs.

He said during the debate that ensued at the time, it was advised that such amendment would have an effect on two other sections of the constitution- 91 (Prorogation and Dissolution of Parliament) and 93 (Sittings of the National Assembly).

While the motion was passed by Parliament at the time, it still faced legal hurdles impending ratification, Mr Maele said.

Kgatleng West legislator, Dr Unity Dow, called for the motion to be taken to the parliamentary general assembly for further interrogation with legal advice from the parliamentary counsel and any other advisor deemed necessary.

She said the constitution did not stipulate the tenure of MP terms to be five years, but rather that it should not exceed a five-year period.Mr Kekgonegile acceded to the request from MPs that the debate on the motion be curtailed pending further legal advice; and while the motion was not withdrawn, it was deferred to a later date. Legislators approve health loan bill

Parliament has voted in favour of the approximately P584 million loan for the Health Emergency Response and Resilience Project.

The loan facility, comprising US\$40 million from the International Bank for Reconstruction and Development (IBRD) and a grant of US\$3 million from the Liveable Planet Fund, was passed by Parliament on Thursday with only one out of 29 present members voting against the bill.

The Emergency Preparedness Response and Resilience Project, International Bank for Reconstruction and Development (IBRD) Loan Authorisation Bill, 2025 (Bill No. 34 of 2025), authorises the government to raise a loan from IBRD for the Health Emergency Preparedness Response and Resilience (HEPRR) project.

Before its passing, Vice President and Minister of Finance, Mr Ndaba Gaolathe, thanked Members of Parliament for the overwhelming support of the bill during their deliberations.

He explained that the loan would

Parliament has given thumbs up to the loan facility, comprising US\$40 million from the International Bank for Reconstruction and Development (IBRD) and a grant of US\$3 million from the Liveable Planet Fund, was on Thursday.

aid in laying a solid foundation in closing gaps in the health sector, which had contributed to the current challenges.

Thus, he said the loan would ensure that future generations enjoyed better healthcare.

The money would, among other things, help to address supply chain digitalisation, and the impact of the facility would be felt throughout the country, Mr Gaolathe said, further explaining that the grant would go towards establishing the project office, to ensure that expenditure was on the intended purpose.

Mr Gaolathe said the loan would be used for addressing health emergencies in the health sector, noting that the country was unprepared for emergencies, just as it was during the outbreak of the COVID-19 pandemic.

As a result, the country cannot afford to traverse the same route of unpreparedness, and fail to

protect its people, Mr Gaolathe said, further stating that the loan facility came with better terms of payment, a lower interest rate, and payment terms.

When Parliament passed the country's budget earlier this year, Mr Gaolathe said, it did so with a deficit, which the government had to address, and it could only raise the money through its own sources or through borrowing, which he assured that was within set borrowing limit range of less than 40 per cent of its Gross Domestic Products (GDP).

Maun North MP and Leader of Opposition, Mr Dumelang Saleshando, supported the bill but warned that the country should be cautious as its credit rating had been downgraded, and that affected its creditworthiness.

He said such came at a time when it was approaching its set legal borrowing limits of 40 per cent of GDP, explaining that such could signal tough times.

Through the loan, Mr Saleshando said the country could be setting a debt trap for future generations, thus calling for fiscal discipline from the government and pleading that the money be used for the betterment of the health sector.

Kanye West MP, Mr Victor Phologolo, said the loan should be for shaping the country's health sector which currently was broken down, by building a resilient health system.

Human capital is the most valuable resource to build the economy of any country, and therefore, a healthy workforce is important to grow the economy, Mr Phologolo said.

Mr Phologolo said it was the responsibility of the government to provide healthcare to its citizens, and that such could be done through borrowing since it was one of the modalities used for funding in the world.

Thamaga-Kumakwane MP, Mr Palelo Motaosane, also supported the bill but said his only worry was bringing it on a certificate of emergency, something that was a trend with the previous administration.

That he said he did not support. However, his reason for supporting the bill he said was because the budget was passed with a deficit, and so, borrowing was a method used for financing the budget.

He said his constituency's health facilities improvements were not included in the National Development Plan 12, yet Thamaga Primary Hospital needed attention.

Also, he said the country should learn from previous misfortune and prepare, giving an example with COVID-19 and how it exposed the health sector's weaknesses.

Preparedness should include issues of staffing, he said.

Mr Motaosane observed that the Ministry of Health had many doctors doing administrative duties, instead of what they were trained for.

That should be revised and doctors be deployed to their professional duties, Mr Motaosane advised

The legislator cautioned the government against direct appointment, saying it bred corruption. **BOPA**

Bill seeks to breathe life into health sector

The International Bank for Reconstruction and Development (IBRD) amounting to approximately P582 million loan will breathe life into the health sector.

This was the general observation by Members of Parliament as they rallied behind the loan facility presented to Parliament by Vice President and Minister of Finance, Mr Ndaba Gaolathe, on Wednesday.

The Palapye legislator, Mr Onneetse Ramogapi, supported the bill, Botswana Emergency Preparedness, Response and Resilience Project, International Bank for Reconstruction and Development Loan Authorisation Bill, No. 34 of 2025, arguing that it would provide crucial funding aimed at bolstering the country's emergency preparedness and response capabilities.

In the past, the country was caught unprepared for health emergencies such as the COVID-19 pandemic, which exposed its preparedness weaknesses, resulting in many deaths, Mr Ramogapi said, stressing the importance of preparing for health emergencies.

Maun East MP, Mr Goretetse Kekgonegile, said the loan facility was for strengthening the health sector across the country and bolstering preparedness, however, pointed out that health sector was besieged by crisis across the

He said the loan could be going towards addressing immediate health challenges on the ground that included shortages of medicines, improving health facilities, paying private facilities owned by the government, and paying owed employees, among others.

Thus, he opined that the government had its priorities wrong in the health sector.

He opposed to the bill presented under emergency certificates, since it is not about a life and death matter, but lack of planning, Mr Kekgonegile said.

Minister of Communication and Innovation, and Mahalapye West MP, Mr David Tshere, supported the bill, as it was intended to support and strengthen the health sector's resilience. He said the country was in a dire financial situation, which had impacted the health sector, and the loan came with a grant facility for the sector as preparatory assistance.

Given the expensive nature of the health sector, Mr Tshere reckoned the loan would finance already planned programmes in the budget.

He said the loan preparedness facility was in line with the World Health Organisation, adding that recently, SADC countries launched one disease surveillance in the region, targeting pandemics.

In that regard, Mr Tshere thought it important for the country to be prepared for its own disease surveillance.

Minister of Environment and Tourism, and Francistown South MP, Mr Wynter Mmolotsi, saw the loan as being in the well-being of the community, and that the government was responding to the crisis faced by the country.

Health is in its nature an emergency, Mr Mmolotsi said and appreciated that not every country qualified for such dispensation.

Since Botswana has set its borrowing limit at 40 per cent of the GDP, Mr Mmolotsi said all was in order because the country was within the set range at 33.05 per cent after the disbursement of the new loan. **BOPA**

Mmamashia-Modipane Road maintenance starts January

The Ministry of Transport and Infrastructure has planned for the maintenance of the Mmamashia-Modipane road through an asphalt overlay during the current financial year, says the portfolio Assistant Minister.

Mr Keoagile Atamelang however, said due to budgetary constraints to outsource maintenance works as well as shortage of in-house earth moving plant, the ministry had been unable to carry out the required maintenance interventions on gravel roads between Malolwane-Ramotlabaki, Matebeleng-Morwa, and Dikwididi-Mochudi, to make them usable.

He explained to Parliament that currently, the ministry was only

limited to carrying out dry grading and would continue to explore ways to undertake spot improvement.

The plan is to commence the procurement process for the asphalt overlay on the Mmamashia-Modipane road January next year and actual construction was expected to take approximately 15 months to complete, Mr Atamelang stated.

He said the dry grading of the Malolwane-Ramotlabaki road was undertaken in April, with additional partial grading carried out in October while the Matebeleng-Morwa road was also graded in June and the next grading cycle was scheduled for January next year.

The Dikwididi-Mochudi Road the minister said was graded in

October as well adding that due to shortage of resources, gravel roads were maintained through quarterly grading at the minimum.

Kgatleng East MP, Mr Mabuse Pule had asked the minister if he was aware of poor and deteriorating state of roads in the Kgatleng East constituency among them, Mmamashia-Modipane, Malolwane - Ramotlabaki, Matebeleng - Morwa and Dikwidid-Mochudi.

Mr Pule further requested to know the immediate measures the ministry intended to implement, to make the roads usable and safe for motorists, public transport operators and residents, as well as commencement of such measures and projected timeframe for completion. *BOPA*

Moshupa hospital 98 per cent complete

The new Moshupa Primary Hospital is on the verge of full operation, with physical progress now at 98 per cent and key facilities already handed over for use.

Presenting the District Development Committee (DDC) report to Moshupa District full council meeting on Wednesday, Principal District Development Officer, Mr Tebogo Mekwe confirmed substantial progress on the long-awaited health facility since the previous update on August 5.

According to Mr Mekwe, the P494 million hospital and civil works package, awarded to Zhengtai Group Botswana in joint venture with Whitacon (Pty) Ltd, was in its final phase.

Mr Mekwe explained that, to counter delays caused by outstanding payments, a phased hand-over strategy had been implemented.

The administration block, main stores, reception, public toilets, laundry, and kitchen have already been issued occupation permits and are ready for immediate use by the Ministry of Health. Guard houses, the general ward, engineering workshop, and wastemanagement zone are currently being de-snagged and will be handed over soon.

Only landscaping, external works, the Out-Patient Department (OPD), maternity wing, main theatre, TB ward, and mortuary remain before the revised completion date of December 18.

Expenditure on the hospital package stood at P402.1 million, leaving a balance of P66.4 million. Mr Mekwe reiterated that delayed payments remained the primary risk to meeting the December deadline and disclosed that the Ministry of Health had been formally requested to expedite the release of final funds urgently.

On the associated staff-housing project valued at P77.7 million and executed by Classic Clean (Pty) Ltd, Mr Mekwe reported that the units had been at 100 per cent complete since June 2023. Final closure was pending with only the rectification of minor defects

including damaged landscaping equipment and pressure testing of the fire line, which the contractor must complete at its own cost. Only P320,548 remain unspent.

Mr Mekwe further informed councillors that Phase One of the refurbishment of academic facilities at Moshupa Senior Secondary School was now 100 per cent complete across all four packages (Administration Block, Library Block, Old Administration Block, and covered walkways).

"Defects Liability Periods have either concluded or were in the final retention-payment stage, while Phase Two remains shelved due to funding constraints," he said.

Presenting employment statistics, Mr Mekwe stated that the hospital construction had created lll jobs, 98 of which were filled by Batswana citizens. The workforce comprised 70 youth (18–35 years), 41 older workers, 86 males and 25 females, with 44 skilled, 30 semi-skilled, and 37 unskilled workers. Regrettably,

he noted that no persons living with disabilities were employed on the project.

"Residents of Moshupa and surrounding villages are now poised to access modern primary-hospital services before yearend, marking a major milestone in upgrading healthcare infrastructure in the Southern district," he said. **BOPA**

Fight against GBV should continue beyond 16 Days of Activism

The 16 days of Activism against Gender-Based Violence may have concluded, but the fight must continue. It is essential for everyone to unite in combating the scourge that has become a pervasive threat. From November 25 to December 10, a period marking the days of activism, more was highlighted through different forums on the need to effect real change, and make an impact in reducing violence against women and children.

However, as the curtain closed, statistics painted a grim picture. Headlines announced either murder or rape involving children or women, bringing with them the sharp pain and reminder of the ongoing crisis our country faces.

The World Population Review 2023 has cited Botswana as the country with the highest number of rape and gender-based violence cases in the world.

These are not just statistics. It is a call for action, as the nation seems to be loosing the battle to this relentless epidemic.

The incidents are not only emerging now and cannot be treated in isolation.

They are a reflection of a society that needs to introspect on what could have gone wrong and what is it that is being done wrong!

The 2018 National Relationship Study revealed that Botswana has long been facing a gender-based violence crisis, with 1 in 3 women having experienced abuse in their lifetime.

It is evident that the crisis has been here for a while and if it not nipped in the bud, the nation might find itself at stand still.

GBV challenges all to embark in a rigorous battle that will trigger the much-needed urgent response.

The renewed fight should be such that role-players provide safer spaces where all can unlearn the harmful gender stereotypes that have now become entrenched in our society and drive GBV.

Khwai plot allocation on hold

A llocation of land is still on hold in Khwai pending the completion of a study on Strategic Environmental Assessment (SEA) in the area. Tawana Land Board chairperson, Ms Reamogetswe Yakenge, explained when responding to some reports that some officials abused their power by allocating plots despite suspension of the exercise.

Some councillors decried lack of transparency, accountability and mushrooming of illegal tourism operations in the Okavango Delta noting that the unlawful activities were fueled by illicit allocation by some landboard officials calling for action to be taken on perpetrators.

However, Ms Yakenge dismissed reports as misleading and baseless stating that land allocation at the tourism prime area situated in the heart of the

delta was suspended around 2016, to allow for proper environmental assessment and planning due to the area's ecological sensitivity.

She explained that in 2021, a decision was taken to lift the suspension and start allocation to people who had long applied but that did not happen up until some applicants in the same year were allocated plots, resulting in conflicts among members of the community.

The allocation, she said was indefinitely suspended and an investigation team was assigned to get to the bottom of the issue while on the other hand, a decision was taken to address the community as they were divided on the matter.

Ms Yakenge complained about the mushrooming of squatters in the district, explaining that there was illegal self-demarcation of residential plots activities in some areas such as Polokabatho.

The land board compensated individuals whose land was

acquired for Maun expansion project in Polokabatho.

Ms Yankge said those allocated plots and chose to sell would not be given self-allocated land.

She appealed to village leaders to work with them and fight squatting since it undermined efforts toward effective land administration.

Councilors were accusing the landboard of poor service delivery saying the board failed to consult stakeholders so that they could appreciate their challenges.

Nominated councillor, Mr Kebareeditse Ntsogotlho said corruption was rampant and that some officials were abusing their power as there were incidents of favouritism in land allocation.

Khwai-Mababe-Sankoyo ward councillor, Ms Tshabang Paul also expressed concern about the rising illicit allocation of plots at Khwai yet they had been informed that allocation was suspended.

 It also includes all other access roads to Kgotlas and villages within a radial distance of 10km to the main road which includes, Mmathethe, Metlobo, Lorolwana, Tswaaneng, Kanngwe, Bray and Werda. The road is approximately 250km in length

b) The location of the activity
The road traverses the Goodhope, Tsabong and Kanye Districts through the villages of Mmathethe, Kanngwe, Metlobo, Tswaaneng, Lorolwane, Bray and Werda villages.

c) The anticipated environmental impacts of the project and the proposed mitigation measures to respond to both negative and positive environmental impacts.

The University of Botswana (UB) and the Mafikeng Innovation Hub have signed a Memorandum of Understanding (MoU) aimed at empowering young people to

create jobs and drive innovation.

Speaking at the signing ceremony in Gaborone recently, UniPod Botswana Director, Professor Richie Moalosi, said the shrinking job market called for innovative ways to equip young people with skills to create employment opportunities for themselves and others.

Prof. Moalosi said UniPod was open to both to the public, in line with UB's founding 'one-man-one-beast' principle.

He noted that although many innovators were youth, UniPod also supported older innovators.

"We are not a specialist hub like yours is more digital. We are in all the area because when they opened people from outside would come up with innovative ideas but we cannot say, this is in tech," he

Prof. Moalosi said UniPod was established to nurture innovative ideas within and beyond the university. Half of its innovators come from outside UB, while the remaining 50 per cent are staff and students.



In one of his many hit songs, No Suffer, featuring King David, Odirile Sento, popularly known as Vee Mampeezy, cuts through the rhythm with a defiant vow in Nigerian Pidgin English: 'I no go suffer, I no go beg for bread-o!' meaning, 'I will not suffer, I will not beg for bread!'

It is a line that sounds almost prophetic, as though the artiste was speaking prosperity over his own life.

The lyric is derived from the popular Nigerian gospel-inspired prosperity song, Me I No Go Suffer by Lara George, a track that has, over the years, been reinterpreted by various artistes.

It has since become a prayerlike mantra within Christian communities, symbolising faith in God's promises and a resolute pursuit of success.

Perhaps for Vee Mampeezy, the words rang true. More than a decade after the song's release, he has steadily risen to the top of his craft, delivering charttopping hits such as Dumalana, securing collaborations with leading African artistes including Makhadzi, and winning numerous awards along the Beyond music,

Kylian Mbappe and Rodrygo scored to give Real Madrid a 2-1 win away to Alaves on Sunday, trimming the gap to La Liga leader FC Barcelona to four points.

Horse racing in Botswana has grown at an extraordinary pace. What began as a community pastime, deeply rooted in rural culture and tradition has evolved into a sport of national appeal, attracting competitors and supporters from across the country and even beyond

Acting Minister of Sport and Arts, Lesego Chombo made the remarks during the official launch of the country's first ever professional horse racing starting gates and the opening of the 8th edition of the Premier Champion Cup that took place at Masa Racing Park in Samedupi over the weekend.

The event was staged by

TT Horse Racing Events and attracted horses across the country, Namibia and South Africa, to compete.

The government through the ministry allocated P450,000 to the Botswana Horse Race Association (BHRA) for the procurement of the starting gates, marking the beginning of a new era defined by improved safety, fair competition and greater professional integrity.

Minister Chombo described the race as far more than a sport activity, but a celebration of progress, innovation and the growing spirit of excellence within Botswana's horse racing community.

"This marks the significant milestone in the national sporting journey as the horse racing starting gates is an achievement that brings our beloved sport closer to international standards and affirms collective commitment to professionalise the sector,"

The government, she said had observed the development of horse racing with great interest and the ministry remained committed to ensuring that emerging sports such as horse racing grow within a safe, structured and modern environment.

Chombo further highlighted that the government through the National Development Plan 12 had already committed to including a dedicated horse racing facility in the national development pipeline and consultations for the process were said to be ongoing.

She stated that its growth would attract corporate sponsorship as companies put their money where there was structure, professionalism and

The introduction of the professional gates, should serve as a foundation upon which the association builds a compelling case for investment, locally and internationally.

"Let this milestone be the beginning of stronger partnerships that propel the sport to a level where it contributes meaningfully to economic diversification, tourism development, youth empowerment and rural upliftment," said Chombo. The gathering also learnt that the ministry was reviewing the Botswana National Sport Commission Act to ensure that emerging issues in the sporting sector were properly addressed.

Chombo strongly warned against illegal gambling practices which if left unchecked, could harm the integrity and reputation of horse racing hence urged BHRA and all organisers of events to collaborate closely with the Gambling Authority, to guarantee that all betting related to horse racing was regulated, safe and compliant with the country's laws, thereby protecting athletes, bettors and the credibility of the sport.

BHRA was also advised to uphold a zero-tolerance policy towards doping as anything less undermines fairness and the spirit of competition. To private sector and the broader business community, the minister revealed that their partnership could accelerate the professionalism of the sport and unlock economic opportunities particularly in rural communities where horse racing was deeply woven into the cultural fabric.

Together, she said they could nurture future champions and transform horse racing into a sustainable, competitive and economically impactful industry. North West District

commissioner, Thabang Waloka appreciated the launch of the starting gates as an indication that the sport was growing in leaps and bounds. Infrastructure development, he said was critical for local economy. **BOPA**
