BIUST launches STEAM centre

The Botswana International University of Science and Technology (BIUST) has launched a STEAM (Science, Technology, Engineering, Arts, Mathematics) centre for use by the community.

Equipped with state-of-the-art virtual computer laboratory; 30 desktop access points as well as a fully equipped electronics laboratory, the centre was launched at the university campus recently.

It showcases the university's collective dedication to education, innovation and sustainable development.

"What renders this initiative particularly effective is its inclusive character. STEAM enrichment initiatives aid in closing gaps related to gender, ethnicity, and social backgrounds, thus fostering togetherness, creativity and progress within and between communities," said BIUST vice chancellor, Professor Ologetswwe Totolo during the launch.

He explained that the birth of the centre stemmed from a partnership with STEMpower Corporation (based in the United States), which had been supporting African nations in enhancing STEM education for the last decade.

The centre serves as a specialised learning space that offers hands-on engineering and science lab experiences, and it provided free, suitable programmes for local students who opted in willingly within a secure and nurturing environment, where experienced lab mentors assist students while they engaged with contemporary scientific and engineering tools.

"The BIUST STEAM Centre is not merely a lab.

It signifies an investment in human capability, creativity, and national progress. It showcases the potential outcomes when international collaborators join forces with local organisations to equip the upcoming generation of scientists, engineers and innovators," said Prof. Totolo.

The university's Outreach and Engagement director, Dr Haniso Motlhabane, expressed the pleasure of being a key participant in the project because for him, witnessing significant potential materialise in real time was both rewarding and inspiring.

"Botswana is rich in talent, collaborating with pre-university students has demonstrated our significant potential in technology, Mathematics, programming, Science, and the Arts," he said.

Dr Motlhabane regarded STEAM education as being essential for driving national development forward, indicating that establishing a strong STEAM foundation in youth would significantly influence the cultivation of solution-oriented thinking and ignite enthusiasm for manufacturing and production.

His plea was that the school administration and educators helped ensure that students could access the centre, because it was meant for them.

Mabogo Junior Secondary School, Science teacher, Ms Keorapetse Kelebele, commended BIUST and STEM power for creating a centre that would help to enhance learning experience and stimulate students' interest in pursuing careers in Mathematics and Science.

It is a bridge between textbooks or theoretical solutions and practical applications in a secure environment, Ms Kelebele said.

GCC and Swedish municipality partner to boost waste management

GABORONE

Gaborone City Council (GCC) has entered into a collaboration with the Swedish city of Västerås in a move aimed at improving waste management systems in the capital while also supporting humanitarian efforts through the Botswana Red Cross.

The partnership, facilitated through the International Centre for Local Democracy (ICLD), seeks to introduce innovative waste management practices and strengthen community participation in environmental sustainability.

The collaboration was officially marked by a charity event held at the Gaborone City Council Civic Centre, which was attended by senior council officials, ICLD representatives and delegates from the city of Västerås.

Opening the proceedings, GCC Chief Environmental Health Officer Mr Patrick Oleseng highlighted stark differences in waste management between Botswana and Sweden, noting that approximately 98 per cent of waste in Botswana's landfills was

recyclable, compared to only about 10 per cent in Sweden.

Mr Oleseng said the alarming statistic underscored the need for the partnership, adding that community involvement played a major role in Sweden's success.

He further said in Sweden, waste management was not only a municipal responsibility but also a community-driven effort, including financial participation, therefore urging Batswana to support waste management initiatives.

He expressed hope that with collective effort, landfill waste could be reduced from 98 per cent to 50 per cent by the end of the year.

He also said the involvement of ICLD would not only improve waste management but also help preserve and reinvigorate Botswana's natural environment, which the country is well known for.

Mr Oleseng also acknowledged donations made by the city of Västerås to the Botswana Red Cross.

Deputy Town Clerk Ms Mosidi Batsalelwang, emphasised the importance of educating both current and future generations

on the consequences of improper waste disposal.

She reiterated the need for effective waste management schemes and highlighted the role of community awareness in achieving long-term environmental sustainability.

She also stressed the importance of donations, noting that many vulnerable people could benefit from items such as warm clothing and blankets.

Ms Batalelwang also said there were people who could benefit greatly from what others could afford to give away and encouraged members of the public to donate.

Botswana Red Cross Disaster Management Officer, Mr Mompoloki Nawa, expressed gratitude on behalf of the organisation for the donations. He said the contributions would go a long way in assisting disaster-affected communities.

He further revealed that the donations would also be used to support victims of recent natural disasters in Mozambique, expressing sympathy for those affected and appreciation to all collaborating partners for their continued support. **BOPA**

Tumasera residents hail decision to restore village name

Residents of Tumasera have expressed gratitude to the Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa, for uniting the community through the restoration of the village's name and the official opening of the customary court offices.

The residents thanked Minister Motshegwa during a kgotla meeting where the latter apprised them of the decision to officially open the customary court last Thursday.

The jubilant residents ululated at the decision taken by the

government, saying it will bring about lasting peace and harmony.

Minister Motshegwa informed residents that Tumasera customary court would continue to provide the services it offered before its closure in 2023, such as presiding over both criminal and civil matters and hosting kgotla meetings to facilitate community consultation.

He informed the residents that following his meeting with the headmen of arbitration from Tupa, Malete, and Rasesa, it was agreed that the trio would continue to lead their respective wards and work in unison.

In addition, residents learned that, going forward, traditional leaders would alternate leadership

responsibilities within Tumasera, which comprises the three wards of Tupa, Malete and Rasesa.

The three wards, according to Minister Motshegwa would be afforded the opportunity to establish their own Village Development Committees (VDCs).

Tumasera customary court was closed in 2023 after the then-Minister of Local Government and Rural Development, Mr Kgotla Autlwetse, called a kgotla meeting at Tumasera and informed the residents that their villages, which had been merged, were now being separated to stand independently.

This was after a court case that ruled in favour of the residents of Seleka village wanted to own

identities from the three other villages namely; Tupa, Malete and Rasesa.

Tumasera is an acronym created by combining the first two letters of four villages: Tupa, Malete, Seleka, and Rasesa.

Based on the 1995 court ruling, Seleka residents argued therefore, that including them as part of Tumasera (Tupa, Malete, Seleka and Rasesa) conglomerate of villages was invalid.

However, residents of Tupa, Malete and Rasesa were not pleased with the decision, pointing out the merger was meant to ease service delivery within the four villages.

In August 2025, Minister

Motshegwa held a consultative meeting with residents of Tupa, Malete, and Rasesa to listen to their plight.

In December 2025, the government reached a conclusion after considering the reasons presented by residents, along with the guidelines set out in the 2024 National Settlement Policy, that reaffirmed Tumasera as the official village, although comprising the wards of Tupa, Malete, and Rasesa this time around.

He further confirmed at the time that the headmen of Tupa, Malete, and Rasesa would continue to lead their respective wards as before, maintaining continuity in local governance. **BOPA**

Government expands radio broadcasting coverage

Government is working to close private radio broadcasting gaps in various areas, Minister of Communications and Innovation, Mr David Tshere said at the World Radio Day commemoration.

Speaking under the theme: Radio and Artificial Intelligence, Mr Tshere said 19 FM transmitters have been installed, covering areas in Kgalagadi North, Kweneng, Southern, and North West districts, benefiting over 157 717 people at a cost of P14.4 million.

In the North East, three FM transmitters were commissioned in Tutume, Sekakangwe and Tshesebe, covering over 85 000 people.

Mr Tshere said government aimed to quadruple listenership, giving every Motswana a choice to listen to any station, promoting diversity and plurality.

He said to date, there were 10 non-commercial radio licenses that had been issued, commonly referred to as community radio stations while the Botswana Communication Regulatory Authority (BOCRA) is still in the process of licensing additional non-commercial radio stations.

Mr Tshere emphasised that government was deliberate in transforming the broadcasting landscape in Botswana, evidenced by the recent introduction of 10 languages to be used in broadcasting, including radio broadcasting.

He stated that, at a minimum, people must listen to news and current affairs in languages they understand because access to news was not a luxury but a necessity.

Mr Tshere has emphasised the importance of clear communication, especially during critical times like the current Foot and Mouth Disease outbreak. He challenged private radio stations to explore Artificial Intelligence solutions to translate programmes into local languages.

The minister launched FM extension signals for Yarona FM, Gabs FM, and Duma FM, and announced plans to roll out the project in Bobirwa district, covering Molalatau, Semolale, and Tsetsebye villages.

The P6 million project would benefit 114 461 people in 55

villages and be completed by the end of the 2026/27 financial year.

The ministry plans to extend commercial FM radio station signals to Kgalagadi South next financial year.

"We are going to connect both radio and internet services in the 101 km stretch between Charles Hill and Nxojane, therefore connecting everyone on the way, including the people of Makunda to Kuke to Nxojane with these FM broadcasting signals," he said.

The initiative, he added would provide coverage in most of the Ghanzi South areas, which have historically relied on Namibian Broadcasting Services for news and current affairs.

The Ministry of Communications and Innovation is currently carrying out a needs assessment in the region to establish existing gaps, particularly along the border villages.



Minister of Communications and Innovation, Mr David Tshere said to date, a total of 19 FM transmitters had been installed, augmenting commercial broadcasting across the country at a cost of P14. 4 million.

Mr Tshere affirmed that radio was one of the most influential media of communication, and it was therefore conceivable that it could be vulnerable to cyber-attacks.

He thus recognised and acknowledged the loud call from the private sector of his ministry to bring about the legislative framework that would govern AI, stating that Parliament had passed the Digital Services Bill.

He said the focus of his ministry regarding the AI policy was to ensure ethical AI, while they continue to improve access to radio broadcasting in the country, AI solutions should be developed for radio broadcasting.

"Digital solutions have been found to improve productivity and efficiency across different industries because they lower production costs while improving the quality of service, leading to an improved listener experience," he said. **BOPA**

Botswana to attend Côte d'Ivoire SIREXE

Botswana will attend second edition of the International Exhibition of Extractive and Energy Resources (SIREXE), scheduled for later this year in Abidjan, Côte d'Ivoire, as a country of honour. SIREXE is a biennial event focusing on mining, oil and energy, providing a platform for African and international partnerships. The two countries are considering signing a Memorandum of Understanding with clear deliverables to strengthen cooperation

agriculture and energy sectors.

The two countries with Botswana, known for its expertise in diamond mining, and Côte d'Ivoire, whose economy is largely driven by cocoa production, aim to diversify their economies by leveraging each other's strengths and experiences.

"It is not just about diamonds and cocoa; we are both looking to diversify, and our diversification is based on shared experiences," Ms Kenewendo said in an interview.

She noted that Botswana's experience in diamond mining, mining governance, beneficiation, mineral development and negotiations could complement Côte d'Ivoire's strong agricultural base, particularly in cocoa production.

"We do hope that beyond the mineral space in Botswana, we can learn something from the agricultural space, which is the mainstay of Côte d'Ivoire," she told the media.

Looking ahead, Ms Kenewendo expressed optimism about opportunities for collaboration in capacity building, mining exploration and development, that encouraged private sector engagement between the two countries.

For his part, Mr Sangafowa-Coulibaly welcomed Botswana's

engagement and praised efforts to deepen friendship between the two nations.

He said Côte d'Ivoire was keen to host Botswana as country of honour at this year's SIREXE and stressed the importance of expanding cooperation in the minerals and energy sectors.

Mr Sangafowa-Coulibaly added

that his country was interested in benchmarking Botswana's diversification initiatives, particularly in mining, as it sought to expand its own sector.

He said Côte d'Ivoire viewed Botswana's experience in mining governance, beneficiation and mineral development as a model of good practice. **BOPA**

Company to revitalise mining sector

An analysis of Botswana's current and long-term economic performance shows that, despite rich mineral endowment, the mining sector's contribution to the economy has declined in recent years and is currently at historically low levels.

Responding to a question in Parliament recently on behalf of the Minister of Minerals and Energy, Minister of Environment and Tourism, Mr Wynter Mmolotsi, stated that key challenges included limited mineral diversification, low levels of beneficiation and a weak conversion rate from early-stage exploration to active mining operations.

As a result, Mr Mmolotsi said government had identified systematic and targeted mineral exploration as a critical driver of economic transformation and established Exploration Investment Company Botswana (EICB).

"The company was registered to address chronic under investment in exploration and to unlock the country's mineral potential. It will do so by consolidating extensive historical geological data and undertaking new exploration, particularly for critical minerals such as copper and manganese, with a strategic focus on the Kalahari Copper Belt," he said.

He added that EICB was an independent entity operating under the Companies Act, with its own governance structures, budget and board of directors.

"The exploration company will operate in partnership with the private sector to de-risk early-stage exploration and secure investment through partnerships, driving the mining sector and exploitation diversification," he added.

He further indicated that the establishment of EICB represented a timely and strategic intervention by government to reverse the decline in the mining sector, strengthen mineral discovery and unlock new growth opportunities.

Chobe MP, Mr Simasiku Mapulanga, had asked the minister to clarify if there was a state-owned enterprise or indigenous company dealing with mineral exploration and prospecting. He further requested an update on the operations of such an enterprise or, if none existed, whether it would be prudent to create one. **BOPA**

Mmoniemang Motsamai

Bobirwa MP, Mr Taolo Lucas, has implored government to channel more resources toward fighting Foot and Mouth Disease (FMD).

Contributing to the debate on proposed 2026/27 budget recently, Mr Lucas argued that the P97 million allocated to the cause was far below par given the vastness of the country and the severity of the disease.

He stated that agricultural demonstrators should be visible and alert across the nation, warning that FMD had the potential to paralyse the economy if surveillance remained lax.

"To me, beef is one of the mainstays of this economy and we need to be shrewd in dealing with FMD," he said.

He further noted that most veterinary cordon fences and their associated control gates or pickets, had collapsed.

He urged for their immediate repair because they were crucial infrastructure for combating the disease.

Additionally, he highlighted that many pickets had been abandoned by officers who once monitored cattle movement.

"An all-party conference should be called for FMD so that we can lock horns on this matter of public interest," he said.

Mr Lucas dismissed the budget as short-sighted, empty and lacking direction and timelines.

He said he was surprised that the budget did not align with the Umbrella for Democratic Change (UDC)'s manifesto, presidential policy pronouncements, the State of the Nation Address, Vision 2036 or National Development Plan 12 (NDP 12).

"This budget does not resonate with the UDC promises and assurances made to Batswana, instead, it is just a motivational speech without any coordination," he added.

In contrast, Jwaneng/Mabutsane MP, Mr Omphemetse Kwapa, argued that the budget had ticked the right boxes given the fiscal challenges facing the country.

Mr Kwapa stated that the UDC had laid its roadmap and was

implementing it accordingly.

He commended the finance minister for introducing measures for fiscal prudence, noting that expenditure controls, particularly the suspension of Government Purchase Orders (GPOs), had resulted in significant savings.

However, he suggested that the Ministry of Local Government and Traditional Affairs should have received a larger share, as it was central to supporting rural communities.

He also advocated for increased funding for education ministries, noting that many school buildings were dilapidated and that learners in his constituency still travelled long distances to attend classes.

Mogoditshane East MP, Mr Letlhogonolo Barongwang, supported the 2026/27 budget for its thoroughness, arguing that government was on the right track despite the economic challenges the country continued to face.

While acknowledging that the economy had not fully recovered, he said there was a clear resolve to move forward.

Mr Taolo Lucas said most veterinary cordon fences, including control gates and pickets, had fallen into disrepair.

He called for immediate repairs, saying the structures were vital in the fight against FMD.

He noted that while GPO enforcement had successfully controlled expenditure, it should be loosened in the future for small service-based businesses that has been negatively impacted.

He praised the 2026 budget for its shift away from diamond dependence, prioritising enterprise through the Botswana Economic Transformation Programme (BETP) and private sector-led growth.

He further suggested that government should strengthen measures to prevent financial haemorrhaging by implementing sound governance and utilising Public-Private Partnerships (PPPs).

MP for Shoshong, Mr Moneedi Bagaisamang, also supported the budget, describing it as well-packaged.

Mr Bagaisamang explained the rationale for continuing some Development Manager (DM) projects, clarifying that those currently underway were initiated before the programme was suspended. He also commended government for initiatives aimed at revitalising rural economies. **BOPA**

Okavango river crocodile population low

Minister of Environment and Tourism, Mr Wynter Mmolotsi, has apprised Parliament that current scientific assessments of the crocodile population in the Okavango system indicate it cannot presently able to sustain additional offtake.

Responding to a question from Okavango East MP, Mr Gabatsholwe Dishes, Minister Mmolotsi said the decision came despite reported crocodile-related incidents

involving people accessing rivers for water collection, fishing, bathing and other domestic uses.

"There have also been numerous cases of livestock predation, which frequently lead

to retaliatory killings," he said.

He explained that research indicated that population recruitment remained low, primarily as a result of human disturbance and historical over-exploitation.

"This includes, among others, habitat loss due to the deliberate burning of papyrus beds during nesting season, leading to nest abandonment," the minister stated.

He added that in light of the findings, the ministry continued to prioritise non-lethal management approaches, public safety awareness campaigns as well as conflict mitigation measures.

These efforts aim to ensure the long-term conservation of the species in accordance with national legislation

and international commitments," he said.

Parliament also heard that the crocodile population in the Panhandle region of the Okavango Delta was estimated at approximately 2 570, encompassing all size classes.

However, Mr Mmolotsi noted that it had been some time since the last comprehensive survey, meaning such figures may have shifted. He noted that future decisions regarding crocodile management quotas for the Okavango and other regions in Botswana would be informed by updated data to help mitigate human-wildlife conflict.

MP Dishes had asked the minister to specify when the ministry would consider releasing management quotas, citing the crocodiles' contribution to human fatalities and ongoing conflict within the region.

He also sought clarity on the total number of crocodiles currently inhabiting the Botswana side of the Okavango River basin. **BOPA**

Pilane project requires 417 000 litres of water daily

The 200 new Botswana Housing Corporation (BHC) units currently under construction in Pilane will require an additional 417 000 litres of water every day.

This was said by Assistant Minister of Transport and Infrastructure, Mr Keoagile Atamelang, on behalf of the Minister of Water and Human Settlement in response to a parliamentary question recently.

Mr Atamelang acknowledged the

existing water supply challenges in the Mochudi cluster, which encompassed Mochudi, Morwa, Pilane, Bokaa and Rasesa, and assured Parliament that measures were in place to prevent the new BHC project from exacerbating the

crisis.

"The ministry is aware of the water supply challenges and has put in place short-term and long-term plans to ensure that water shortage is not exacerbated," he said.

He added that in the short term,

the Water Utilities Corporation (WUC) had resorted to water bowsing to service high-lying areas in Morwa, Pilane, Bokaa and Rasesa North where infrastructure was currently limited.

Furthermore, he said residents in Rasesa were facing daily water rationing, adding that supply in the village was managed, with water available from 5am to 12 midnight daily, as the corporation struggled to balance demand across the cluster.

As a long-term plan, he said government was looking toward the National Development Plan 12 (NDP 12) for a major Network Rehabilitation and Extension Project, with an addition of the construction of a proposed 3.5Mega Litres concrete tank under the Kgaleng Land Servicing Project.

Kgaleng West MP, Dr Unity Dow had asked the minister to state the number of extra litres of water that would be required to service the additional 200 BHC houses currently being constructed in Kgaleng District and the plans to ensure that the current water shortage in the Morwa, Pilane and Rasesa area was not exacerbated. **BOPA**

Botswana Oil Limited strategic intervention to petroleum industry challenges

Parliament has heard that the establishment of Botswana Oil Limited (BOL) in 2013 was a strategic intervention by government to address persistent challenges in the petroleum industry.

Answering a question in Parliament recently on behalf of the Minister of Minerals and Energy, Minister of Environment and Tourism, Mr Wynter Mmolotsi said the challenges included limited citizen participation, high dependence on International Oil Companies (IOCs) and the urgent need for a coordinated framework to ensure the security of the nation's fuel supply.

Mr Mmolotsi explained that Botswana Oil was mandated to ensure reliable supply and distribution of petroleum products in Botswana, manage government-owned strategic facilities and fuel reserves as well as facilitate meaningful participation for Batswana in the oil industry.

He added that Botswana Oil

currently had no Citizen Economic Empowerment (CEE) fuel suppliers operating under such mandate, as the organisation and most citizen-owned companies acted primarily as importers.

However, he said the regulatory framework remained open and citizen-owned companies had seen significant growth, rising from a 10 per cent import quota in April 2024 to 40 per cent of current market volumes.

Regarding logistics, he said Botswana Oil had on board 34 citizen-owned fuel transporters managing over 200 trucks across routes in South Africa, Namibia and Mozambique.

"While four transporters hold long-term contracts through a partnership with Debswana, 30 others remain on short-term adhoc contracts of one to three months," he said.

The minister explained that while a tender for long-term contracts had been evaluated and awarded,

finalisation was on hold.

"This delay is due to an ongoing review of the import quota process, which will directly impact Botswana Oil volume allocations.

Tati East MP, Mr Tlhabologo Furniture had asked the minister to state what the company was created to do, account for the actual number of local fuel suppliers and transporters currently doing business with Botswana Oil and justify why the majority of local transporters were stuck on precarious, month-to-month adhoc arrangements

rather than the stable and long-term contracts they were promised.

Mr Address Administrative Delays: Explain why there has been a six-month silence following a completed tender process for regional routes, leaving successful local bidders in a state of financial uncertainty.

Mr Furniture also wanted clarity whether Botswana Oil intended to sign contracts and, if not, why they had not been honest with local business owners who needed to make critical investment decisions. **BOPA**

No need to change land policy for 18-year-olds

GABORONE

There is no need to review current land policies, as 18-year-old citizens legally are already eligible to apply for land, acting Minister of Lands and Agriculture, Dr Edwin Dikoloti, has said.

Responding to a parliamentary question recently, Dr Dikoloti explained that since the legal age of majority was lowered from 21 to 18 in 2010, young adults had possessed full legal competence.

"Due to the legislative

amendment, everyone who is 18 years of age or older has the complete legal competence to engage into contracts and make choices on their own. This includes applying for land and engaging in any transactions involving immovable property," he said.

Currently, he said, the waiting list had over 88 719 applicants who were between the ages of 18 and 21 at the time of their application.

The Minister was responding to questions raised by Boteti West MP, Mr Sam Digwa, who challenged

the exclusion of 18-year-olds from economic empowerment opportunities.


Mr Digwa argued that since turning 18 confers full civic responsibilities, including the right to vote, denying access to land applications would undermine the constitutional rights and dignity of young adults.

He thus urged the ministry to align its land allocation policies with the legal age of majority to ensure housing and economic security for the youth. **BOPA**

ConCourt to ensure justice for all - Moswaane

The establishment of Constitutional Court will ensure equal justice for all, Assistant Minister of Local Government and Traditional Affairs, Mr Ignatius Moswaane has said.

Speaking during a consultative meeting in Seronga recently, Mr Moswaane said ConCourt's existence before a comprehensive Constitutional review would provide Batswana a platform for redress where the Constitutional review recommendations were unfavourable.

However, Seronga residents expressed mixed reactions regarding the establishment of the court. Some suggested that the most critical issues that required immediate interventions in Seronga and the Eastern part of the Okavango District as a whole, were

construction of the Mohembo-Gudigwa road and addressing education and health challenges.

A resident, Mr Ene Maeze said the Mohembo-Gudigwa road current state put people's lives at risk and disadvantaged the area.

He said, therefore, the constitutional court establishment should be deferred for now.

Another resident, Mr Ntshepang Johane said the government should do a holistic review of the Constitution first, that would include all the tribal groups, before establishing the court.

Kgosi Diverse Ndando of Gudigwa supported the idea with the hope that it would help in expediting developments in the Eastern part of the Okavango.

Another resident, Mr Ndorobaki Tsietso, also welcomed the establishment of the court since it was premised on protecting human rights, regardless of social status or tribe. **BOPA**

Motshegwa addresses concerns over death penalty

The Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa says the establishment of a Constitutional Court would not abolish the death penalty.

Speaking during a kgotla meeting in Mmadinare recently, Mr Motshegwa emphasised protections afforded by existing laws and affirmed that the court lacked authority to eliminate the death penalty from the legal framework.

Furthermore, he explained that the current constitutional provisions explicitly protected the death penalty, which remained a legal form of punishment for heinous crimes.

"There is a legal framework that

supports the existence of the death penalty within our judicial system. The proposed Constitutional Court will not abolish the death penalty, as it is already entrenched in the Constitution," he said. He recognised the range of opinions concerning the death penalty and the creation of the Constitutional Court.

Minister Motshegwa emphasised that any changes to the laws regarding capital punishment would need a thorough legal process that involved discussions in Parliament and input from the public, rather than being decided unilaterally by the judiciary.

Meanwhile, a resident, Mr Goitsemang Mokwaledi, expressed skepticism about the Constitutional Court as a solution to the country's urgent challenges, warning it could lead to increased financial strain.


Mr Mokwaledi said he feared

that the court might abolish the death penalty and in that case, it might encourage people to commit heinous crimes, knowing they could walk free.

In addition, he also raised concerns about how some perpetrators were protected, saying gaps within some of the existing laws should be addressed.

Another resident, Mr Tokisi Kebalepile noted that neighbouring countries with operational Constitutional Courts still faced instability and human rights issues, highlighting the need to benchmark against those countries.

Mr Kebalepile remarked that while establishing the Constitutional Court seemed promising, necessary and safety measures should also be in place to prevent it from benefiting only a few select and exploitation for personal gain. **BOPA**

Economic climate presents opportunities - Mohwasa

The 2026/27 National Budget recently presented by Vice President and Minister of Finance, Mr Ndaba Gaolathe, was delivered in the current economic climate that presents both opportunities and challenges. Minister for State President, Defence and Security, Mr Moeti Mohwasa has said.

Giving an address to commence the Botswana Institute for Development Policy Analysis (BIDPA) Budget Breakfast Seminar held in Gaborone, Mr Mohwasa said government was committed to not only navigating the current circumstances but executing long term reform.

“We are addressing the realities with discipline and resolve. Government has taken a responsible path. The budget seeks to restore stability to our public finances while safeguarding strategic investments that drive long term growth infrastructure, human capital development and economic diversification. It is a careful balance between prudence and progress,” said Mr Mohwasa.

He added that state commitment to accountability and ensuring public finances deliver tangible benefit to citizens would be realised through strengthening public financial management, tightening expenditure controls and improving procurement processes.

“At the same time, transformation must be inclusive. Youth unemployment remains a serious concern. Economic reform must therefore translate into real opportunities in agriculture, manufacturing, tourism, digital services and other priority areas of the twelfth National Development Plan (NDP 12),” said Mr Mohwasa.

Additionally, Mr Mohwasa said institutions such as BIDPA are vital partners and urged them to strengthen their role of research and development, as well as analysis to assist with policy choice and accountability.

Govt reaffirms commitment to private-led economy and rejects mandatory CSR

Minister of Trade and Industry, Mr Tiroyaone Ntsima, has reiterated the government’s commitment to building a private-sector-led economy, citing this strategy as the primary reason for rejecting a motion to make Corporate Social Responsibility (CSR) a statutory requirement.

Speaking in response to the motion tabled by Tswapong South MP, Dr Kesitegile Gobotswang,

Minister Ntsima explained that while government valued the role of CSR, it opposed making it a legal obligation.

He emphasised that government’s role was to create an enabling environment for businesses to thrive, rather than imposing further regulatory hurdles. “Let us not craft policies that will impact the very Motswana we are trying to empower,” the minister stated.

He argued that CSR should complement government efforts

rather than replace them, noting that many companies had already successfully integrated social obligations into their business models voluntarily.

The minister, supported by some MPs, outlined why a statutory mandate would be detrimental to Botswana’s economic health. Minister Ntsima argued that mandatory CSR was essentially a hidden tax, adding that companies were already significant contributors through corporate tax, withholding tax and

Pay As You Earn (PAYE) deducted from employees, alongside various licensing fees.

He added that within the Southern African Development Community (SADC) region, mandatory CSR was not a standard practice.

More foreign firms to invest in Hong Kong

China believes more American and other foreign companies will invest in Hong Kong and benefit from the Chinese modernisation and the “one country, two systems” policy. Lin Jian, Chinese foreign ministry spokesperson said when commenting on the American Chamber of Commerce in Hong Kong’s 2026 Business Sentiment Survey Findings Report, which showed that 86 percent of surveyed U.S. firms see Hong Kong as a competitive international business hub, 92 percent have no plans to relocate their headquarters. The statistics demonstrate American companies’ growing confidence in Hong Kong. **Xinhua**

China removal of visa requirements spikes Russian tourists

The number of outbound trips by Russian tourists increased 16 per cent in 2025, with trips to China climbing 33.6 per cent, Russian Gazette reported Sunday, citing the Association of Tour Operators of Russia. Experts attribute this surge in trips to China to the removal of visa requirements, expanded flight options, and new charter services. A significant portion of the growth came from residents of Russia’s Far East, particularly those living in border regions, according to the report. **Xinhua**

Budget 2026/2027: Turning point in economic transformation

The managing director of Access Bank Botswana, Mr Sheperd Aisman has hailed the 2026/2027 national budget as a structural turning point for the country's economic transformation, saying it allocates risks rather than resources.

"The budget does not simply allocate resources, but risks, which is the structural turning point Batswana have waited for," said Mr Aisman when speaking at the second edition of the bank's budget review in Francistown last Friday.

He said that through the budget, the government is shifting the responsibility and risk of driving economic growth from the public sector to the private sector.

Mr Aisman stated that the budget is a call for the private sector and investors to take the lead, invest in the economy and reap the rewards of their investment rather than relying on government spending and support.

However, he expressed optimism about the 2026/2027 national budget, stating it provided a strategic mandate for the financial sector and aligns with the bank's core pillars. The managing director said the budget focuses on private sector-led growth, SMME financing, export-led trade finance and digital transformation.

He stated that the budget, presented by the Vice President and Minister of Finance, Mr Ndaba Gaolathe, aimed to reduce the country's reliance on diamond revenue and promote economic diversification.

Mr Aisman highlighted the

budget's emphasis on fiscal realignment, with the government stepping back to allow private capital to drive growth.

He said that when the government steps into its proper role as an architect, private capital finally does what it does best: convert policy certainty into productive investment.

He explained that the Botswana Economic Transformation Programme (BETP), is expected to play a key role in diversifying projects, with P514 billion positioned for private financing.

He also indicated that the budget prioritises SMME financing, with P1.31 billion allocated to support SMMEs and export-led trade finance, with 26 agriculture and 22 manufacturing projects underway.

Infrastructure development and digital transformation are also key focus areas, with P23.38 billion allocated for development projects and efforts to expand fiber connectivity and implement a National Digital ID.

He said that though allocated on risk rather than resources, the budget addresses critical issues driving economic development, aiming to elevate the country from a middle-income to a high-income status.

He stated that for Access Bank, the budget opens multiple points of entry where the bank is structurally positioned to deliver.

Mr Aisman further indicated that the bank's role is clearest in SMME financing, trade facilitation, and partnership-driven intermediation.

In addition, the managing director indicated that the national budget is more than a fiscal

instrument but rather a strategic mandate for the financial sector.

Themed "A new era of economic transformation and fiscal prudence," Mr Aisman stated that the budget validates the financial sector's core strategic pillars.

"The alignment between the government's execution strategy and our banking model is both deliberate and striking. I am optimistic. Not despite the constraints, but because of them," he added.

He said that when necessity sharpens policy, when fiscal discipline is no longer a choice but a condition of survival, the private sector will finally inherit its proper role. **BOPA**

He warned that introducing it would make Botswana less attractive to Foreign Direct Investment compared to its neighbours.

He further indicated that because business profits were never guaranteed, a forced CSR mandate could cause local companies to struggle or fail during difficult financial periods. "Government believes that voluntary CSR encourages genuine innovation and additional investment, whereas a mandatory one may reduce these efforts to a mere compliance exercise," Mr Ntsima said. Mmadinare MP, Mr Kethlalefile Motshegwa and Mogoditshane West MP Galenawabo Lekau echoed the minister's concerns.

Mr Motshegwa suggested that tax rebates and incentives, similar to those currently offered for sports sponsorship, were far more effective tools than over-regulation. Mr Lekau added that the motion was risky, particularly at a time when government was already considering an increase in corporate tax.

Supporters of the motion argued

that a law was necessary to ensure equitable wealth distribution. MP Mabuse Pule of Kgatleng East argued that CSR was a matter of human rights.

MP for Maun East, Mr Goretetse Kekgongile proposed that a statutory model would allow royalties to be paid directly to local communities.

He targeted large multinationals, arguing that some had reaped significant profits without ploughing back into the country. Similarly, Shashe West MP Jeremiah Frenzel argued that a law would ensure more equitable distribution, citing Lucara Diamond as an example of a company outperforming established giants like Debswana in community engagement despite fewer years in the country. **BOPA**

During the post-budget analysis debates, the Botswana Stock Exchange (BSE) chief executive officer, Mr Aupa Monyatsi said there was a need for "creating the right risk capital" and training for small medium and micro enterprises (SMME) as well as self-financing mechanisms for local government authorities in order to assist transform the economy.

BVI ready to support the region

Botswana Vaccine Institute (BVI) Head of Quality Management, Dr Keabetswe Moagabo says the institute is ready to support the region with Foot and Mouth Disease (FMD) vaccines.

Speaking at the tour of the National Emergency Operations Centre in Gaborone on Thursday, Dr Moagabo said they were ready to support the region because their focus was not only in Botswana.

"If the region is healthy, Botswana will be healthy. We have declared a state of emergency at the BVI and reviewed our processes to become more efficient. We are also constantly engaging with customers to meet their needs," he said.

He said that BVI is ready and has enough vaccines to administer in Botswana and is making inroads into the SADC region as well.

BVI's top-notch approach, he further stated, was that it collected animal samples whenever there was an outbreak to identify the virus to ascertain if it could be deterred by available vaccines or will need another vaccine.

As part of the practice, BVI does not make a vaccine without first checking the strain, except in instances where the customer has not been able to bring the right samples.

The only time BVI missed the target was when they delivered vaccines to South Africa, who had not furnished BVI with samples.

He disclosed that currently BVI had delivered 150 000 doses of FMD vaccines to Eswatini.

For his part, Acting Director of Veterinary Services, Dr Kobedi Segale said to date, 83 cattle and 13 goats had been killed in various regions in Botswana.

Dr Segale stated that the animals that crossed to Ngamiland were also killed since the area is declared a red zone.

He said they were also monitoring and reviewing to see if the compensation was adding value so that the reparation would be revised. **BOPA**

Ramontshonyana aims to uproot drug abuse

Kaone Ramontshonyana, commonly known as K-one from Big Brother Africa, recently embarked on a 30-day cycle tour against drug, substance and alcohol abuse, gender-based violence and irresponsible gambling.

Ramontshonyana and his team were welcomed in Kanye on Thursday.

The team left Kanye on January 12 and traversed to Maun with the sole purpose of sensitising the youth and the public at large about the dangers of indulging in drugs, substance and alcohol abuse, GBV as well as irresponsible gambling.

As they traveled throughout the villages, Ramontshonyana said the goal was to leave behind a committee in every village that would continue tackling drug and substance issues and come up with solutions that are homegrown.

The team has engaged five primary schools, junior schools, seven senior secondary schools and two brigades.

Ramontshonyana, who has partnered with the Drug Enforcement Agency (DEA), said the aim was to build rehabilitation centres

across the country.

"We are looking at a seven-year project and believe that by the fifth year, we will have the first facility," he said.

The focus, he said, is currently to establish strategies for raising revenue to support the project.

Another cyclist, Lereo Mokwena, said the challenges they encountered were tyre punctures and sun exposure, as well as a lack of sponsors for their meals.

Mr Motshereganyi Sefanyetso from DEA said he supported Kaone's initiative, stating that their core mandate is to fight illicit drugs in Botswana.

Most of the challenged individuals, he said, were young people, adding that the drugs that present a challenge in Botswana were cannabis, methcathinone and synthetic drugs.

A new act, he said, has been enacted to allow them to search people's homesteads without a warrant.

The government, he said, has embarked on a process to set up rehabilitation centers in Botswana, indicating that there will be one in Maun and Lobatse.

Meanwhile, Kgosi Motswakgakala Sealetsa of Goo-Motebejana ward said drug and substance abuse have afflicted people's lives countrywide.

Drugs, he said, influenced people to make poor decisions and display unbecoming behaviour, adding that Ramontshonyana, who publicly shared his challenge, is much better placed than those masking their issues . **BOPA**

Grey hair: Another natural variation of human story

The first time I noticed grey hair on a teenager, I was stunned. At the time, greying was something I associated with old age but not school corridors and teenage friendships. Yet, for some young people, silver strands arrive far earlier than expected...

According to the National Institutes of Health (NIH), hair turns grey when melanocytes, the stem cells responsible for producing melanin, the pigment that gives hair its colour are depleted or stop functioning properly. While this is a natural part of ageing, premature greying challenges long-held assumptions about when and why hair loses its colour.

In Botswana's traditional beliefs, early greying has not always been viewed negatively. An elderly woman, who requested anonymity, recalled that in earlier times, grey hair in young people was sometimes interpreted as a sign of future prosperity and good fortune, much like the white spots once believed to appear on children's nails as omens of luck. She added that families also recognised that premature greying often ran in families.

On the other hand, modern medicine offers a more detailed explanation. Lifestyle medicine practitioner Dr Lebogang Sebekedi explained that premature greying, medically known as premature canities, could appear as early as 20 to 25 years among Caucasians, 25 to 30 years in people of Asian descent, and between 30 and 35 years among Africans. In rare cases, even teenagers may experience early greying, depending on their genetic background.

Dr Sebekedi attributed premature greying to several lifestyle-related factors, including chronic psychological stress. He explained that when the body is under stress, it releases norepinephrine, a chemical that could travel to hair follicles and interfere with melanin-producing cells, accelerating the greying process.

He also said nutrition also played a critical role as deficiencies in vitamins and minerals such as vitamin B3, B12, ferritin, copper, biotin and folate had been linked to premature greying. These nutrients are essential for maintaining healthy, pigmented hair and are found in foods such as beef liver, poultry, fish, nuts, leafy green

vegetables, milk and eggs.

Urban living brings additional risks. Dr Sebekedi pointed to environmental oxidative stress from air pollution and excessive exposure to ultraviolet (UV) rays as factors that may damage pigment-producing cells. He also raised concern over lifestyle trends among young people, including vaping and smoking, noting that smoking reduced blood flow to hair follicles, depriving them of oxygen and nutrients needed for healthy hair growth.

For some, the cause lies deep within their DNA through genetic mutations that affect melanin

production and can result in visible grey hairs even in adolescence. One rare example is autosomal dominant premature greying syndrome, an inherited condition in which hair turns grey unusually early and may be triggered by oxidative stress.

Everyday habits may also be quietly contributing including crash dieting, chronic sleep deprivation, and frequent use of hair bleaches, very hot water and harsh shampoos that strip the scalp of natural oils can weaken hair health and speed up pigment loss.

While currently, greying linked to ageing and genetics was irreversible, Dr Sebekedi said greying caused

by nutritional deficiencies may, in some cases, be reversed, with deficiencies such as vitamin B3, B12 and copper, some reports show repigmentation within six months to a year once levels were corrected.

Beyond medicine, attitudes toward grey hair are also changing. Once widely seen as something to hide, grey hair has become a symbol of confidence and individuality. K-pop idols and Hollywood stars such as Halle Berry, Salma Hayek and Tracee Ellis Ross have embraced their natural silver strands, helping to redefine grey hair as fashionable rather than flawed.

For those tempted to pluck out

unwanted grey hairs, Dr Sebekedi offered a word of caution. "If that is not convincing though, I highly discourage against pulling out grey hair because if you do, it will damage follicles and can lead to scarring and distorted regrowth," he said adding, that pulling out grey hair does not make seven more grow back.

For many young people, premature greying can be a source of anxiety or embarrassment. Yet as science continues to uncover its causes and as society grows more accepting of silver strands early greying may increasingly be seen not as a flaw, but as another natural variation of the human story. BOPA

Farmers' committees complement government efforts

Farmers committees in the border villages of Sikwane and Mabalane have joined forces with government to fight the Foot and Mouth Disease (FMD). Farmers have teamed up to repair the borderline fence to deter any cross-border movement of animals between the Botswana and South Africa.

A team led by Mmathubudukwane Police Station Commander in collaboration with other government departments has also been established to carry out patrols on Mondays, Wednesdays and Fridays.

In an interview, Sikwane farmer's committee chairperson Mr Jeffrey Tlhewe said they were compelled to act swiftly and complement government efforts to stop FMD spillover into Botswana.

"The objective is to safeguard the borderline and make sure Botswana animals do not cross into the FMD red zone in South Africa," he said.

He commended farmers for joining efforts with the government

to fight the Foot and Mouth Disease, which he reiterated, had the potential to destroy the livelihoods of the farming community if due care and containment measures were not taken.

For his part, the youthful Emmanuel Kgaswe from Mabalane said the borderline was not in a good shape to control Foot and Mouth Disease. As such, together with the Department of Veterinary Services, farmers have collaborated to identify and fix certain areas that needed attention along the Botswana/South Africa border.

"Initially we started on the side of the Sikwane border and made some improvements through fence erection but we were stopped by the increase of water in the river," he said adding that a decision was then taken to focus on the Mabalane borderline.

The Chief Technical Officer with the veterinary service, Mr Moagi Teseletso, lauded farmers and communities of the river villages for their positive response.

Mr Teseletso said a physical borderline was available from

Sikwane to Tlokweng while from Sikwane to Palla Camp near Ramotlabaki and in the absence of a physical border line, the river which was currently flowing helped hinder animals from crossing to and from South Africa.

He said government had taken a decision that animals that cross the border from South Africa into Botswana would be immediately slaughtered, burned and buried, and farmers would be compensated P700 for a cow, and P200 for a goat. Mr Teseletso further said last week Thursday, they received a report from Palla Camp that four cows entered into Botswana and the department moved with speed to destroy the said animals.

However, he was concerned that certain farmers do not adhere to the strict interventions by the government to curb disease spread, something he said could have negative rippling effects on the cattle industry if left unabated.

For instance, he said one farmer recently slaughtered an animal for domestic use against established protocols and fortunately, the

officials received a tip-off from concerned citizens and the meat of the animal was immediately disposed as per procedure.

To date, the department of veterinary services has not recorded a single case of FMD and it is Mr Teseletso's prayer that the situation remains so for the sake of the farmer and the economy of the country.

He appeals to Botswana, especially the farming community, to adhere to the restrictions put in place by the government to ensure the country triumphs in the fight against Foot and Mouth Disease.

Since the report of cases of FMD in South Africa, the government has put measures in place to curb the spread of the disease into Botswana.

Stoppage of the movement of cloven-hoofed animals and prohibition of their slaughter was among the foremost decisions taken to immediately curb disease spread. In order to further reinforce efforts towards containment of the disease, farmers converged in Mabalane village last Thursday to repair the border fence between Botswana and South Africa. BOPA

Zimbabweans top work permit list in Botswana

Zimbabweans continue to dominate Botswana's work permit landscape, accounting for over half of the country's total permits issued, according to the latest Statistics Botswana figures.

The numbers, which reflect a gradual recovery from COVID-19 lows, highlight a continued reliance on foreign labour, particularly in the agriculture, forestry and fishing sectors, as well as education, wholesale and retail, and human health and social work.

Statistics Botswana's February report indicates that, from a total of 5 314 permits recorded at the end of 2023, there were 2 921 Zimbabwean work permit holders,

more than half of all permit holders in the country.

The new figures released this month further show that work permit numbers have been gradually increasing since the COVID-19 period, when permits declined to 3 409 in 2021 from 5 766 recorded in 2017, with Zimbabweans maintaining their dominance.

The report also indicates that the majority of work permit holders were employees, accounting for 4 462 of the total.

Apart from Zimbabwe, other work permit holders were from African countries including South Africa, Zambia, Malawi and Ghana, with figures ranging from less than one per cent to seven per cent.

From outside the African

continent, the majority were from the Indian sub-continent at 9.6 per cent, while other Asian countries were also represented.

Both British and other European nationals contributed less than one per cent.

As for the distribution of employee work permit holders by training, at the end of 2023, employees with no formal training accounted for 54.3 per cent.

Degree holders followed at 31 per cent, while diploma holders accounted for 11.1 per cent, followed by employees with basic training programmes.

In analysing work permit trends, Statistics Botswana notes that total permits have generally been declining, which it attributes to skills transfer policies aimed at empowering citizens. BOPA

African leaders wrap up summit and map out priorities

ADDIS ABABA

The 39th Ordinary Session of the Assembly of the African Union (AU) concluded on Sunday, outlining Africa's priorities for 2026 and beyond.

The two-day meeting, which brought together leaders from AU member states at the AU headquarters in Addis Ababa, the capital of Ethiopia, was held under the AU's 2026 theme: "Assuring Sustainable Water Availability and Safe Sanitation Systems to Achieve the Goals of Agenda 2063."

As the African continent, under the umbrella of the 55-member organization, focuses on continental water security in 2026, the summit deliberated on enhancing sustainable water management to power Africa's socio-economic development ambitions.

African leaders at the summit also discussed a range of issues related to progress, challenges, and prospects of Africa's development and stability, as well as fostering continental unity to augment Africa's role in the wider global multilateral context.

As the AU's highest decision-making body, the assembly, among other things, reflected on the achievements and gaps marked under the second 10-year implementation plan of the

AU's 50-year continental development blueprint, Agenda 2063, which runs from 2024 to 2033.

The summit also witnessed the election of Evariste Ndayishimiye, President of Burundi, as the chairperson of the AU for 2026, taking over the chairmanship from Angolan President Joao Lourenco.

In his comprehensive report on the achievements and activities undertaken during his chairmanship of the AU over the course of 2025, Lourenco highlighted progress in advancing Agenda 2063, mobilizing investment

for infrastructure, strengthening continental integration through the African Continental Free Trade Area (AfCFTA), and enhancing the AU's institutional efficiency.

He also underscored the need to silence the guns across Africa as a critical imperative for a better continental future.

Ndayishimiye, for his part, emphasized his commitment, as the incoming AU chairperson, to strengthening Africa's global positioning toward building a fairer, more balanced, and inclusive world at a time of

"unrelenting" security challenges, rising unilateralism, growing economic tensions, and the adverse effects of climate change.

AU Commission Chairperson Mahmoud Ali Youssouf underscored some critical concerns currently facing Africa. These include the continent's inability to address peace and security perils across different regions, geopolitical uncertainties and global polarisation with the rise of unilateralism and protectionism, the resurfacing of unconstitutional changes of government, financial

and governance deficits, and climate change.

To address Africa's current challenges and realise the continent's development ambitions, Youssouf pointed out a number of priorities. These include accelerating Africa's industrialisation, transforming the agriculture sector as the backbone of economies and livelihoods, harnessing Africa's energy potential, and developing high-performing infrastructure.

"These are the sine qua non conditions for the anticipated economic growth," he said. *Xinhua*

South Africa classifies FMD outbreak as national disaster

CAPETOWN

South African President Cyril Ramaphosa announced Thursday that the ongoing outbreak of foot-and-mouth disease (FMD) across the country has been classified as a national disaster.

The president made the announcement in the annual State of the Nation Address (SONA) before a joint sitting of the two houses of Parliament at Cape Town City Hall. "While the rest of our agriculture sector is thriving, the cattle industry is today facing one of the worst outbreaks of foot-and-mouth disease our country has experienced," said Ramaphosa.

He warned that the disease "is damaging our economy, resulting in export bans, trade restrictions and devastation of herds."

"We have classified foot-and-mouth disease as a national disaster and will be mobilizing all necessary capabilities within the state to deal with this crisis," Ramaphosa said.

The government has decided to vaccinate the national herd of 14 million cattle, which will require 28 million vaccine doses over the next 12 months, he said. "The state will facilitate the acquisition of the vaccines centrally to ensure that we get the right vaccine for the particular strain of the virus in South Africa," Ramaphosa said.

"We will work closely with the private sector to enable an efficient rollout, and most importantly, we will ensure that commercial, private and communal farmers have

immediate access to vaccines." The president said that a task team made up of farmer organisations and experts would report to him every month on progress made in tackling what he described as a pandemic.

It is not the first time that South Africa has taken such a step this year. According to Ramaphosa, just a few weeks ago, catastrophic flooding in Limpopo and Mpumalanga was declared a national disaster, which claimed at least 45 lives and caused widespread destruction of homes, schools, clinics and other infrastructure.

FMD is a highly contagious viral disease that affects cattle, sheep, goats, pigs, and other cloven-hoofed animals. According to a recent report released by the Bureau for Food and Agricultural Policy, a total of 24 400 FMD cases were reported in domestic livestock in South Africa in 2025, significantly surpassing the previous 20-year-high of 7 700 FMD cases in 2022.

The ongoing outbreak spread to eight of the country's nine provinces excluding only the Northern Cape in 2025 for the first time on record, with nearly 21 600 cases reported in the second half of the year.

In January 2026, Minister of Agriculture John Steenhuisen outlined a 10-year national strategy on FMD containment, announcing the launch of a nationwide vaccination campaign and plans to seek a declaration of the outbreak as a national disaster. **Xinhua**

Namibia receives China-aided satellite ground station to boost space capabilities

Namibia on Thursday marked the official handover of a China-aided Satellite Ground Data Receiving Station, a milestone project aimed at strengthening the country's space science capacity, disaster response and innovation-driven development.

The facility, located at the Telecom Earth Station outside the capital, Windhoek, is expected to enable Namibia to directly receive and process remote-sensing data from satellites, including the

Egypt announces new gas and oil discoveries

CAIRO

Egypt's Petroleum Ministry on Thursday announced new gas and oil discoveries in the Western Desert, with an expected daily output of about 34 million standard cubic feet, alongside over 5 200 barrels of crude oil and condensates.

The discoveries, made by four petroleum sector companies, are part of the ministry's ongoing efforts to offset natural production declines in older wells, reduce import bills, and boost domestic energy output.

Khaldha Petroleum Company, a major operator in Egypt's energy sector, discovered two new gas wells. The first exploratory well, the North Opera-2, located in the Matrouh Development area, is expected to produce 21.15 million standard cubic feet of natural gas and 3 274 barrels of condensate per day.

The well is set to begin production by mid-February. The second well, West El Dabaa-2x in the West El Dabaa concession, is testing at 4.15 million standard cubic feet of natural gas and 336 barrels of condensate per day.

Another well, GPD-1X, was discovered by General Petroleum Company (GPC), an Egyptian national company, in the Sinan development area. It has already been tied into production with an expected daily output of 625 barrels of oil.

Meanwhile, PetroFarah, in collaboration with its partner United Energy Egypt, and Agiba Petroleum Company have made additional discoveries. Egypt has been trying to boost its oil and gas production amid a decline in natural gas output in recent years.

In August 2025, Prime Minister Mostafa Madbouly said Egypt's current natural gas production stands at 4.1 billion cubic feet per day and is expected to rise to 6.6 billion cubic feet per day by 2027. **Xinhua**

China-Brazil Earth Resources Satellite (CBERS-4). Speaking at the ceremony on behalf of President Netumbo Nandi-Ndaitwah, Prime Minister Elijah Ngurare expressed appreciation to China for its support.

"On behalf of the Namibian government and the people of Namibia, I express gratitude to the People's Republic of China for the generous support provided through the construction of this satellite ground data receiving station," Ngurare said. "This remarkable gesture solidifies the enduring friendship and strong bilateral relations between our nations and people," he added. Ngurare said China's financial resources and technical expertise had enabled Namibia to join a select group of African countries with modern ground stations capable of receiving real-time satellite data.

"This data will enhance evidence-based decision-making across key economic sectors," he said. Namibia's Minister of Education, Innovation, Youth, Sports, Arts and Culture Sanet Steenkamp described the station as a major step in implementing the country's National Space Science and Technology Policy of 2021.

"The establishment of the satellite ground data receiving station comes at an opportune time and complements Namibia's national efforts to build capacity in the space science and technology sector," she said. Steenkamp noted that the facility would serve as a strategic national asset, providing indepen-

dent, high-resolution imagery to strengthen border and maritime monitoring, environmental protection and disaster management.

She said real-time access to satellite data would improve responses to natural disasters such as floods and wildfires, without delays linked to international data-sharing restrictions. The minister also highlighted the project's capacity-building component, saying 14 Namibians have been receiving training to operate the station, with some already managing the facility and receiving satellite data.

Chinese Ambassador to Namibia Zhao Weiping said the project demonstrated China's commitment to support Africa's scientific and technological advancement. "The satellite ground data receiving station is the first high-technology development assistance project undertaken by China in Namibia," Zhao said. "It vividly demonstrates China's strong commitment to supporting African countries in advancing science and technology development."

He said the completion of the project provided Namibia with the foundational capability to receive and process remote-sensing satellite data, adding that a second phase would soon be implemented in close cooperation with Namibian partners. Zhao emphasised that the station will be fully owned and operated by Namibia, noting that Chinese experts trained local technicians for independent operation and would continue to provide technical support. **Xinhua**

Tanzania calls for African cooperation in fight against cancer

Tanzanian Prime Minister Mwigulu Nchomba on Thursday called for stronger regional and continental cooperation to combat cancer.

Speaking at the 30th anniversary of the Ocean Road Cancer Institute (ORCI) in Dar es Salaam, she said progress in cancer control required joint efforts in research, specialist training, and the sharing of technology and expertise.

The prime minister stressed that collaboration was essential to address Africa's growing cancer burden, adding that Tanzania was

ready to serve as a regional hub for the fight against the disease through the ORCI.

Nchomba directed the Ministry of Health to develop a strategy to reduce new cases and mitigate the economic and national well-being impacts. The government has expanded early screening services for various cancers to primary healthcare facilities, Nchomba said.

According to Ministry of Health statistics, around 44 900 people were newly diagnosed with cancer in Tanzania in 2022, while approximately 29 700 died from the disease that year. **Xinhua**

BanT celebrates 29th birthday with album drop

While many light up candles for their birthdays, Baanthata Mokgwathi, popularly known as BanT, is lighting up the charts with the release of his new album, Twenty9, for his 29th birthday on Friday.

For the *Naomi* hit maker, the eight track album, which features tracks such as, *Twenty9*, *OMG* featuring Veezo View as well as *Yebo* featuring Jackalass Onetym, is a tribute moment to 10 years in the music industry and celebration of his final year in his 20s.

A decade of grinding in Botswana’s ever evolving hip-hop industry and even launching his youth agency, Unmuted267 along the way, is no small feat, yet at some point, BanT shared, he almost gave up under the weight of public scrutiny.

“But I learned to block out the noise and trust my journey. That mindset shift brought me here.”

On collaborations with Veezo View, Jackalass Onetym and Shaba Stele on such a monumental album of his music career, BanT lauded the artistes for their incredible talent and highlighted the partnership with Veezo View as a powerful addition to the project. He described his and View’s music working relationship throughout the years as a work of art centered on pushing one another to their creative limits.

BanT shared that a conversation with his 19-year-old self would go this way.

“I would tell him: don’t be too hard on yourself. Take time to look back and appreciate how far you’ve come. You are who you believe you are. Never doubt that.”

As for the biggest lesson the industry has taught him in his twenties, the hip-hop star said,

“Diversify or you won’t survive. Music is passion, but understanding the business and your environment is power.” **BOPA**

Bayani creates safe space for teens with WhatsApp initiative

Boniswa Bayani, an educator with over a decade of experience working with learners aged nine to 21 across rural, semi-urban and urban areas, has become a trusted guide.

Her role has long been one of mentorship, listening, early intervention, and knowing when to refer young people to trained professionals.

Drawing on years of conversations with teen boys and girls, Bayani recently launched a WhatsApp channel called

Mind Over Matters y2k Teens, designed to help teenagers navigate the hurdles life places before them.

“The initiative grew organically,” she explained, “building on discussions I have had with learners over the past 10 years of teaching and mentorship.”

The channel itself was created as a structured response to recurring challenges raised by both teens and parents.

On average, the group engages about 133 participants; teens and parents alike. Membership fluctuates as new people join and others observe quietly, but interaction remains steady through daily discussions, private check-ins, and shared reflections.

Bayani believes that today’s parents and children often find themselves at odds.

“Rapidly changing trends, the influence of social media, Gen Z culture, and exposure to positive

and negative influences have reshaped adolescence,” she said.

“While access to information has grown, so too has the emotional burden placed on young people,” Bayani added. Across Botswana, she has observed a rise in mental health challenges among teenagers. Too often, these struggles go undiagnosed or are misinterpreted as indiscipline.

“In classrooms, corridors, and quiet one-on-one moments, young people have spoken openly about anxiety, pressure, confusion, loneliness, peer influence, family conflict, and the overwhelming need to ‘keep up.’ Many lack the language, tools, or safe spaces to process these emotions in healthy ways,” she noted.

Affectionately known as Teacher B, Bayani emphasises that resilience is not innate but learned.

“The earlier children are taught essential life skills; how to cope

with disappointment, manage unfair circumstances, navigate peer pressure, and respond to challenges, the more resilient, self-aware, and emotionally grounded they become,” she said.

Her WhatsApp channel serves as a daily point of reference: a space for teens to pause, reflect, reset, and grow.

It offers gentle reminders that emotions can be acknowledged without dictating behavior, and that progress is built through small, consistent choices.

Still, Bayani acknowledges the limits of her role. “As an educator, I recognise that some challenges require specialised, professional intervention,” she explained.

Teens are encouraged to seek support with their parents or guardians when deeper emotional or personal challenges arise.

“Professional care is not a sign of weakness, it is a courageous step toward healing and growth,”

she said.

Bayani stresses that her initiative is not meant to replace professional services but to complement them by raising awareness, encouraging early intervention, and normalising conversations around mental and emotional wellbeing.

“It is my hope that as more young people engage with these messages, they will aspire to live by the principle of mind over matter; remaining grounded, focused, and resilient regardless of what life throws their way. The wellbeing of our children is a shared responsibility. Awareness, empathy, and early support can make all the difference,” she said.

Her work extends beyond the WhatsApp platform. Teacher B also engages face-to-face through schools, educational programmes, and community-based interactions, often engaging parents when the need arises. **BOPA**

Morupule edge out Lions


Jwaneng Young Stars edged Notwane SC 1-0 to remain fourth with 26 points.
