Bomaid leverages technology for better access

GABORONE - Bomaid a medical aid entity, is set to introduce a virtual health service to cater for people in remote areas, including the Okavango Delta, where access to healthcare is limited due to distance and lack of GPS connectivity.

Addressing members stakeholders during the 54th annual general meeting in Gaborone recently, the Bomaid chief executive officer, Mr Moraki Mokgosana, explained that the service would enable clients to consult with a healthcare practitioner virtually.

Mr Mokgosana also revealed that they had plans to launch a wellness application, through which they would engage with stakeholders.

He welcomed the developments surrounding the National Health Insurance (NHI), noting that Bomaid has had initial

discussions with government.

"We believe that Bomaid's administrative capabilities could be leveraged to support some of the government's goals for NHI, as continue to actively position ourselves to play a role in its implementation," he said.

He indicated that the traditional form of medical aid was evolving and losing relevance, as younger generations were increasingly drawn to health insurance for protection against specific risks.

"They are not necessarily looking for the whole package as far as medical aid is concerned. So we have set up an entity that will allow us to pivot into that opportunity when it becomes available and that is what we call South View Insurance," explained. He further said through their strategic investment, they aimed to slow down cost escalation, particularly with MRI, which handled many services within the Bomaid value

chain, including the call centre, emergency medical services, Prime Health Capri Medical, pharmaceutical distribution and training.

Bomaid board chairperson, Dr Refeletswe Lebelonyane, highlighted that in 2024, the customer satisfaction index increased to 71 per cent.

Dr Lebelonyane also reported a significant uptake in screenings, with over 40 000 conducted, representing a 47 per cent increase.

"We are excited that the screening uptake is high, but this does not mean anything at the end of the day if you are not going to do anything about the results.

So, it is important for us to screen, identify those who are outside the normal range, lead them to care and make sure that they are on treatment and receiving the care they are supposed to," she said.

She also shared that the MRI investment was a major milestone, with Bomaid's stake in MRI reduced from 95 to 38 per cent.

"This makes Bomaid a minor shareholder, allowing MRI to operate more competitively while addressing regulatory concerns' she said.

She added that in 2024, Bomaid recorded a surplus of over P34 million, which improved their solvency ratio from 34 to 36 per cent, well above the 25 per cent regulatory requirement.

"So, your fund is not broke. We are not broke and we are far from it. I know that in 2024 there was a lot of talk on the street that Bomaid was broke, because we were strengthening our processes and dealing with fraud. We had to make sure that people were not becoming millionaires overnight because of the money that you have entrusted us with," she said.

Meanwhile, by embracing technology and new business models, Bomaid aims to continue providing essential services while expanding its reach and preparing for a future that includes a National Health Insurance. BOPA

In addition, he said boot camps aimed at building discipline, teamwork, resilience and creating values that would serve students outside school.



He commended teachers for the being the backbone of the county's education system, dedication and going an extra mile by mentoring learners.

Batanani JSS School Head, Mr Teedzani Mkandla said the school has enrolled a total 391 students.

He said since 2020 to date the school has been experiencing a declining performance. The school managed 40.1 per cent quality pass (merit, A, B, C), followed by 50.3 per cent in 2021, dropping to 37.3 per cent and in 2022, followed by a further slump of 33.8 per cent in 2023. He said 2024 was equally challenging as the school registered quality pass of 38.5 per cent. **BOPA**

Rising wildfire incidents alarming

ZUTSHWA - The Department of Forestry and Range Resources has raised concern over the increasing cases of wildfires in Kgalagadi North, warning that the situation poses a serious threat to both livelihoods and the national economy.

Speaking at a three-day fire management and handling workshop, organised by Mabapi Training Institute in collaboration with Botswana Tribal Administration Service Association (BOTASA) which was held in Zutshwa recently. Forestry Superintendent Mr Obonye Matsiara stressed the importance of educating communities on fire prevention.

He stressed that wildfires not only destroyed property and farmland but also had effects on the environment.

"Uncontrolled fires damage the earth's surface and, if they persist, they will negatively impact tourism, which is one of Botswana's key revenue drivers,"

He noted that tourism relied

heavily on wildlife, adding that when animals flee burnt areas, it weakens the tourism economy in those regions.

Matsiara further cautioned that farmers were also among the hardest hit, as wildfires burn fields, grazing land, and equipment, causing major setbacks to agricultural production.

This, he said undermined the national target to increase Botswana's cattle herd from two million to five million, a target which had been set by President Advocate Duma Boko.

also expressed disappointment that perpetrators of wildfires often go unidentified, pleading with communities to assist in reporting cases.

"Government alone cannot manage this problem. There is a strong need for public education and sensitisation so that together we can prevent these fires," he said. Mr Matsiara commended the Zutshwa community for their cooperation in extinguishing fires in the past and urged them to remain vigilant.

advised that He when communities need to clear land through burning, citing an example of control plant diseases, that they should request assistance from the department instead of starting uncontrolled

"The department is always available to guide and provide alternatives. Fire should never be the first option," he said.

Mabapi Training Institute Mafhoko, who facilitated the programme, said the prevalence of wildfires in Zutshwa made it essential for the community to be trained on fire management.

He stressed that the workshop, which enrolled more than 40 participants, was designed to equip locals with the knowledge and skills necessary to prevent and respond to wildfires.

Mr Mafhoko highlighted the importance of sensitising the community to the dangers that wildfires pose to both farming and wildlife.

He further appealed to local stakeholders to assist by providing firefighting equipment, which would empower participants to put their training into practice and extend awareness campaigns to the rest of the community.

For his part, Mr Ezhekhiel Phologolo of BOTASA said he partnered with Mabapi Training Institute as part of his social responsibility, having recognised the serious challenge that wildfires pose to the village.

He expressed gratitude to the Zutshwa Salt Mine for their Director, Mr Maitumelo generous support of the initiative and said he was hopeful that the participants would continue to raise awareness in the community while also playing an active role in managing wildfires in and around the village.

> Meanwhile, cases of wildfire outbreaks were reported in Zutshwa and Monong over the past weekend.

> According to the Hukuntsi District Commissioner, Ms Veronica Rabakane, response teams were deployed to the affected villages and successfully managed to suppress the fires.

Founded in 1974, the RTC was temporarily closed in 2020 while undergoing accreditation renewal with the Botswana Qualification Authority (BQA).

It was accredited as an Education Training Provider in 2023 and successfully accredited qualifications included Diploma in Highway Engineering, Certificate V in Road Construction and Maintenance as well as a Certificate III in Heavy Plant Operations.

With 29 students enrolled, the centre reopened today starting with the legacy programme and the Highway Engineering Technician Diploma Course (HETDC).

Furthermore, Mr Maele said the enrollment process for National Credit Qualification Framework (NCQF) programmes would take place in the next academic year (2026-27).

He said the ministry was currently working on accreditation

Govt sets up team to fight illegal mining

THAMAGA -Government has set up a technical team to address illegal sand mining along Metsimotlhabe River.

Addressing a kgotla meeting in Thamaga recently, Minister for State President, Mr Moeti Mohwasa said the task team would comprise officers from the Ministry of Local Government and Traditonal Affairs, Botswana Defence Force, Botswana Police Service, Directorate of Intelligence

Services, Departments of mines, environment as well as land board.

Mr Mohwasa said the formation of the task team was a response to a long standing issue of illegal sand mining in Metsimotlhabe River.

Mr Mohwasa said illegal sand mining had developed into a cartel involving some members of the public, the business community and illegal immigrants.

However, Mr Mohwasa assured Thamaga residents that goverment would address the matter through the establishment of technical team.

said some residents haboured illegal sand miners by renting out their premises to be used as brick moulding sites

He urged residents to report perpetrators to relevant authorities to help in combating illegal sand mining.

"We want order and respect of the law. Illegal sand mining is a serious concern," he said.

Following the meeting, Mr Mohwasa said the task team would further engage with the community to come up with strategies to address the challenge.

"Those engaged in illegal sand mining must desist from the practice. If they do not stop, we will act. It is not a threat," he said.

He said Thamaga and other villages along Metsimotlhabe River should enjoy beauty of the river, hence the need to guard against illegal sand mining.

"We will be an irresponsible government if we are to ignore plea from the people, allow them to live in fear of criminals he said."

Earlier on, Mogoditshane/ Thamaga Council Chairperson and councillor of Thamaga West, Mr Molatedi Selala said the community had complained about illegal sand miners, welcomed government's thus intervention.

He said he was optimistic that the task team, together with residents would come up with a permanent solution to end illegal sand mining.

Thamaga/Kumakwane Member of Parliament, Mr Palelo Motaosane also thanked government for its agility in handling the issue.

"It was beyond me, therefore, I pleaded with Minister Mohwasa to intervene, I appeal to you to desist from being part of the illegal act as action that will be taken will target all the perpetrators."

Mr Motaosane said residents responsibility take to protect their resource. Unfortunately, MP Motaosane said some residents connived illegal miners cartel.

"Some of us are partners in the crime as we are working with the illegal sand miners.

Some of you also act as their informants when police engage in raids," he said. **BOPA**



Two lives lost in aviation tragedies

GABORONE - Parliament has been told that two students lost their lives in aviation tragedies.

Responding to a question from Kgatleng Central MP, Mr Mpho Morolong, the Minister of Higher Education, Mr Prince Maele said one student lost his life in Johannesburg, South Africa in 2006 while the other, under the International Aviation solutions (IAS) lost his life in 2017.

He noted that, unfortunately, families were not compensated, as there was no policy guidance on the matter.

On the status of life cover insurance for the trainees, Minister Maele noted that the two aviation training institutions in the country had insurance cover.

He said for New Generations Aviation Professional Academy, all learners and staff were covered under the mandatory insurance policy taken for each aircraft.

"This insurance policy covers for all occupants including students and instructors hurt or injured while undergoing training in the aircraft and also include third party liability," he said.

He said for FM-Amess, life insurance cover for training students had been taken through Dynamic Insurance Brokers.

Regarding the number of operational flying aviation schools in Botswana, Minister Maele noted the two operational flying aviation schools, which had been registered and accredited Botswana Qualification Authority(BQA).

He said the New Generations Aviation Professional Academy was registered and accredited on December 22, 2022 while FM-Amess was registered and accredited on August 24, 2021.

"There are in total 246 learners enrolled at FM-Ames and the students are enrolled on a Diploma in Mechanical Engineering learning programme," he added.

He said the programme was registered under legacy and Engineering Registration Board registers graduates.

"New Generation Aviation Profession Academy has one accredited learning programme while Diploma in Airline and Transport Pilot Learning has no learners enrolled," he said.

Mr Maele further noted that there were no applications for flying aviation school pending registration by BQA.

Mr Morolong had wanted to know the number of trainees who lost their lives in aviation tragedies, how their families were compensated, and availability of any life cover insurance for trainees.

He also enquired about the total number of students enrolled in these schools as well as the number of pending applications for schools registrations. BOPA

'No reasons compel govt to return land'

GABORONE - There are no compelling reasons for government to return the acquired piece of land to Tawana Land Board after thorough considerations of the potential economic contributions of the envisaged resort in the Okavango Delta and the community having no direct land rights.

The Minister for State President Mr Moeti Mohwasa told Parliament that the acquired land conformed to all the authenticities of Tribal Land Act, the North West District Council and the Tawana Land Board who were duly served with a notice of acquisition on April 2, 2021.

Thereafter, he said the council

was given an opportunity to raise any descending opinions for consideration by the land board.

He said in the same manner, Batawana Regent was also consulted on May 25, 2021 in the presence of tribal leader and then upon extensive consultations, the land board considered the application on June 22, 2021 and resolved to grant the required land to the State as per the provision of the Tribal Land Act,

"The Act empowers the land board to independently make its decisions" he said.

He, however, condemned the deliberations that the land was taken from Tawana Land Board but emphasised that, the land board did not decline to grant the land to the State having acquainted itself of the reasons for acquisition against the issues raised by the aforementioned critical stakeholders.

Mohwasa further highlighted that government was at an advanced stage in finding a partner to establish a Presidential resort in the mentioned area.

He said the envisaged facility would enable high profile personalities and dignitaries to visit the areas and contribute significantly to the tourism offerings provided by its prime flora and fauna as well as its scenic view.

Mr Mohwasa said since government was already at an advanced stage to set up a facility on the site, it would be a regressive move to return the land.

He emphasised that the intended purpose of the land was for both partnerships between government and the private sector.

Mr Mohwasa said that the facility would play a pivotal role, as it would relieve government of the financial burden of hosting State dignitaries in private

Moreover, he said the move would also affect the confidence of investors with whom the government would like to partner.

Meanwhile, Mr Mohwasa pointed out that, there was once a matter before the Maun Land Tribunal, which was intended to oppose the grant of the land to the State, lodged by Mr Lekopanye Mokobela and others.

He said the judgement was delivered on March 22, 2022, which pronounced that they had no sufficient connection with the land to establish real and substantive interests in the matter.

The minister added that where government considered it expedient and in the public interest to reverse a decision of the acquisition of the tribal land, it would duly be undertaken based on the advanced reasons.

government He said demonstrated that in January, when it was resolved that they abandon an ongoing acquisition process of about 10 000 hectares land in Kgagodi, Moremi/ Lesenepole and Tamasane.

Mr Mohwasa said the communities had voiced their concerns and further demonstrated how the acquisition would impact on their livelihoods, as they used the land for arable and pastoral farming.

He was responding to a question by Maun North MP and also the Leader of Opposition, Mr Dumelang Saleshando who had asked if government would return a piece of land that was taken from the Tawana Land Board within the Okavango Delta by the previous administration.

Mr Saleshando also requested the minister to state the full reasons for the position, in the event government does not plan to return the land. BOPA

Budgetary constraints delay Tonota Primary Hospital project

MPs agree to rescue health services

GABORONE - Parliament wrapped up its business on Friday by adopting a motion calling on government to urgently prioritise resolving the country's worsening health crisis.

The motion, brought as a definite matter of urgent public importance, by Kgalagadi North MP, Mr Reason Lekutlane urged government to mobilise funds in all possible ways and forms to purchase essential medication, settle outstanding health bills, and restore medical operations across public health facilities.

MP Lekutlane painted a grim picture of the country's public healthcare system, citing severe shortages of medication, halted medical procedures and shortage of doctors.

He highlighted critical shortages in essential supplies, including medical dressings and syringes, which have forced patients to purchase those items themselves.

"We must act before the medicine even reaches our people, ensure it is there and accessible," he said, adding that there was also a growing public concern about the deteriorating state of public healthcare facilities, where reports of stock outs and delays have become increasingly common.

He said Princess Marina Hospital, the country's main referral hospital was overwhelmed, with emergency units overcrowded and staff overburdened.

"Operations have stopped, there are not enough doctors, the situation is worrisome," he said, adding that some patients were continuously rescheduled for operations while their conditions deteriorate.

MP Lekutlane also highlighted the dire situation in rural areas, where access to private healthcare was nonexistent.

"People from Xere and Mokgenene know nothing about pharmacies in their villages," he said, calling on government to act for those who rely solely on public health facilities.

Mr Lekutlane therefore proposed the reallocation of funds from special levies, including the alcohol levy, fuel levy, and road fund to address the crisis.

He further suggested suspending non-essential government projects to redirect resources toward health.

The MP also urged the public and corporate sector to consider donating to a national health emergency fund, comparing the situation to the COVID-19 pandemic response, where special funding mechanisms were quickly mobilised to protect lives

The Vice President and Gaborone Bonnington South MP, Mr Ndaba Gaolathe, acknowledged the seriousness of the health crisis but expressed concern about the motion's framing, calling it flawed.

He clarified that life-saving procedures have not been suspended, although systemic issues in the health sector persisted.

Mr Gaolathe, who is also the Minister of Finance explained that special funds, such as those from levies, were already being utilised and that the government's investment account has limited capacity. He emphasised that the health crisis reflected broader structural weaknesses in the national system, not just isolated shortages of medication.

"It is not only about medication shortages, every system is broken and needs fixing," he said, citing international engagements, including talks with Japan, as part of the government's efforts to secure external assistance.

Backing the motion, several MPs highlighted the eroding public confidence in the health

system and the human cost of inaction.

Dr Edwin Dikoloti, Good Hope/Mmathethe MP, lamented chronic understaffing, stating Botswana had only 0.3 physicians per 1 000 people, far below the WHO's recommendation.

In places like Seronga, he said, one doctor served over 3 700 people.

Maun East MP, Mr Goretetse Kekgonegile supported the motion, citing frequent delays in surgeries and the dire situation in remote regions like Chobe area.

"We are sentencing people to death," he warned, urging government to reprioritise spending to focus on healthcare. Lobatse MP, Mr Kamal Jacobs said the situation required urgent international cooperation.

"We cannot allow our people with chronic conditions like HIV, asthma, and high blood pressure to die," he said, and issued a passionate appeal to fellow leaders, urging immediate action to address the ongoing shortage of medical supplies affecting citizens across the country.

Ngami MP, Philemon Aaron made a bold call for leadership sacrifice, suggesting a 10 per cent salary cut for all political leaders and suspension of constituency allowances, especially for the President and Speaker of the National Assembly and special elected both in parliament and council, until the crisis was

resolved.

"Let us start with financial sacrifices to help redirect resources toward the health sector. I proposed a 10 per cent salary cut for all senior government officials, beginning with those in the Head Office," he said.

He said while MPs differed on funding strategies, he pointed out that the situation transcended political lines.

Mr Aaron stressed that the right to health was the foundation of all other human rights.

He therefore called on government to urgently restore confidence in the health system and deliver life-saving services. **BOPA**

Air Botswana receives government support

GABORONE - Air Botswana has received government support amounting to over P800 million since the 2019/20 financial year, despite the airline not being covered under the government's recurrent budget.

Answering a question in Parliament on Friday on behalf of the Minister of Transport and Infrastructure, the Minister of Communication and Innovation Mr David Tshere clarified that Air Botswana was mandated to operate on a commercially sustainable basis under the Air Botswana Act.

He however said government continued to support the airline through development funding and targeted financial interventions.

Breaking down government support to Air Botswana, he said in 2019/20, P17 million was given for the reflecting programme following acquisition of one Embraer E170 and two ATR72-600 aircraft.

He added that in 2020/21, P116 million was given for COVID-19 relief purposes, as well as P76.2 million in 2021/22, still for COVID-19 relief.

Mr Tshere pointed out that in 2022/23, Air Botswana was given P58 million for accumulated debt and P33 million for aircraft maintenance.

In 2023/24, he said P86.3 million was given for major aircraft maintenance, P86.6 million for operational shortfall and engine maintenance, including P149.95 million for reflecting.

He further said in 2024/25, P195.53 million was for reflecting, P37.17 million for engine overhaul and P20.41 million to cover November 2024 and February 2025 salaries.

Furthermore, he said in 2025/26, P10 million was given for March 2025 salaries and another P13.31 million for reflecting.

Minister Tshere confirmed that three aircraft were acquired in 2024, all of which were preowned

He mentioned one Embraer E175 jet (88 seats, aged 14 years) that cost US\$9.5 million and two Embraer ERJ145 jets (50 seats, aged 15 and 16 years) at US\$4.65 million and US\$4.35 million respectively.

The minister said those additions brought the airline's total fleet to six aircraft, including two new ATR72-600s bought in 2018, and one pre-owned Embraer E170 jet, also acquired in 2018.

Minister Tshere reported that five of the six aircraft were currently operational.

He mentioned that the Embraer E170 was grounded, pending a mandatory 15 000 flight hour maintenance check, which required P57.2 million, money the airline currently does not have.

The minister also acknowledged

that Air Botswana continued to face serious financial constraints, driven by an ongoing economic slump and a sharp decline in passenger numbers.

He said that has been largely worsened by reduced travel by government, parastatals and the private sector, all tightening budgets under austerity measures.

The minister was responding to a question from Chobe MP, Mr Simasiku Mapulanga who had asked the minister to state how much (budget) has been allocated to Air Botswana from 2019 to 2024

Mr Mapulanga further wanted to know how many airplanes were bought by Air Botswana during the same period and the total cost and whether the planes were bought as new.

Furthermore, he wanted to know how many were in operation and the challenges associated with the planes not being in operation.

Company to increase revenue generation

HUKUNTSI - In a bid to strengthen revenue generation and reduce reliance on government funding, Hukuntsi District Council has approved the formation of a council-owned investment company.

The decision was made during a special full council meeting, where council chairperson, Stephen Lekgobero shared that the initiative would enable the council to engage in business ventures aimed at generating sustainable income, complementing the Revenue Support Grant (RSG) from central government, which he described as insufficient to meet the council's needs.

"The purpose of the proposed investment company is to reduce dependence on the RSG, which has proven unsustainable," he said.

He revealed that three potential names for the company were Kgalagadi Investment Company, Metlhabeng Investment Group, and Kgalagadi North Investment Group.

"The proposed company's board of directors will comprise the council chairperson, Secretary, chairperson of the Investment Committee, and the Council Attorney," he said. Mr Lekgobero said the company would explore partnerships, including Public-Private Partnerships (PPPs), to generate revenue for the council.

He highlighted several investment opportunities in Kgalagadi North, including providing accommodation for public

servants, establishing a filling station to address the limited availability of fuel stations in the district, and developing solar plants to supply electricity to villages currently off the grid.

"This council-owned company will operate as an independent corporate entity with its own board and managers tasked with generating revenue for the council," he said.

In addition to revenue initiatives, the council convened to constitute portfolio committees responsible for overseeing council functions and ensuring good governance under the Local Government Act. Mr Lekgobero indicated that the

standing orders were amended to create 11 committees, from the previous seven, in an effort to enhance service delivery.

The newly formed committees include an expanded Audit and Risk Management Committee, a Human Resource Committee focused on staff morale, and separate committees for Education and Health to operate independently.

The council's move reflects a strategic approach to leveraging local resources, attracting investment, and enhancing operational efficiency to benefit the people of Kgalagadi North. *BOPA*

Wilderness injects P2.4 million in training facility

MAUN - Wilderness Safari company has injected P2.4 million on Shokomokwa Agri-Training Facility based in Shorobe which aims to enhance food security, create jobs and foster economic inclusion within local communities

The company's managing director, Mr Joe Matome revealed during a recent stakeholder engagement meeting.

Though not yet launched, he said the construction was well underway, and its potential was already evident as they had injected millions in a bid to empower and train farmers in sustainable farming, beekeeping, and agro-enterprise.

"We are making steady progress on a transformational initiative, addressing empowerment and education just outside Maun through this multi-million project which aims to deliver practical training in areas including vegetable farming, seedling production and bee keeping.

We are cultivating future farmers to produce high quality produce to both local market and the tourism industry," he added

Through the project, Mr Matome said they expected over 10 000 seedlings to be produced, adding that up to 10 new farmers will be trained every two to three years, with the long-term goal of creating a reliable supply chain for high-quality produce.

Furthermore, he said the project had created eight permanent jobs plus rotational opportunities for community members through seasonal employment giving people across Shorobe, Sexaxa, and surrounding areas a tangible introduction to agricultural livelihoods.

He also pointed out that they had signed a memorandum of agreement with their partner Stanbic Bank to support businesses that supply them under the project.

On other issues, Mr Matome dismissed reports that their partnership was coming to an end in 2026. While Wilderness is rooted in conservation tourism, he said they were powered by such partnerships as

they were the foundation upon which they built the three impact pillars of education, empowerment and protection.

The organisation has forged several key partnerships to advance its conservation and community developments goals and despite that Mr Matome highlighted that they had been misleading and disturbing reports that aimed to undermine their efforts.

"There have been news that some of these partnerships are coming to an end in 2026. The agreements we have do not have any such dates and there have been news that we do not do any social contributions to the communities we operate within," he revealed.

Mr Matome revealed that Wilderness has a strong and multifaceted relationship with the Okavango Community Trust citing that the partnership focused on community development, sustainable tourism and human wildlife conflict mitigation.

For the past ten years, he said they paid P60 million as lease fees to the community with P6 million paid annually.

He said P100 000 additional contribution per year was paid to each of the five villages affiliating to the trust for empowerment.

This year alone, he said the organisation has built a two classrooms to the tune of P1.8 million relieving pressure on classrooms in other villages of the Okavango trust to advance their pillar of education.

Wilderness company, he said is also involved in a project that is protecting humans from conflict with lions and their livestock for provision of meat to their camps.

Other project the company initiated to empower suppliers and strengthen economic ties with the tourism industry is the annual 'Wilderness Local Suppliers' Expo which brings together local suppliers to showcase their products and services.

The stakeholders also learnt that over P6.3 million had been spent in new contracts awarded since 2024 and that the organisation was on track to exceed P8 million by the end of 2025. *BOPA*

WHO promotes PWDs empowerment

MOLEPOLOLE People with disabilities continue to face systematic inequities, from reduced life expectancy and a myriad of barriers in everyday life from inaccessible transportation discriminatory health systems.

WHO Lead for Health Promotion and Social Determinants of Health, Mr Moagi Gaborone shared the sentiments at the Disability Health and Wellness Day in Gabane recently held under the theme: Healthy Bodies, Healthy Minds: Empowering Persons with Disabilities Through Inclusion.

Mr Gaborone said the theme was a call to action, a commitment to equity and a vision for a world where every person, regardless of ability could thrive.

Mr Gaborone further said people with disabilities often faced social stigma, isolation, and limited access to psychosocial support, which could lead to anxiety and depression.

He stressed that promoting mental well being was no luxury but a necessity thus inclusive mental health services, workplace accommodation, and anti-stigma campaigns must be part of every health strategy. He said the United

Disability Inclusion Strategy demanded that disability inclusion be mainstream and targeted support, demonstrating that integrating disability inclusion was not an afterthought but a core function.

He said the World Health Organisation's Global report on Health Equity for Persons with Disabilities revealed that people with disabilities die up to 20 years earlier, experienced poorer health and faced systematic barriers to care. Such outcomes, he said were not due to disability itself, but to unjust and avoidable conditions, which encircled discrimination, inaccessible, and exclusion from decision-making.

He further described WHO's launch of Disability Health Equity Initiative, as a bold global movement to transform health systems into inclusive, equitable spaces. "This initiative was built on a quad of pillars, which entailed leadership by people with disabilities and organisations, political their prioritisation of disability-inclusive health, inclusive health systems and service delivery and lastly strengthening data and evidence for accountability," he said. He said equity must be a guiding principle, which must recognise

that people with disabilities might need different support to achieve the same outcomes. He added that it meant tailoring health systems, education, employment, and social services to meet diverse needs hence ensuring that disability inclusion was not an afterthought but a foundation of every policy and programme.

He said the UN Flagship report on Disability and Development highlighted the persistent gaps in achieving the Sustainable Development Goals for persons with disabilities hence such gaps needed closure, not with charity, but with justice. BOPA



Pitso urges men to prioritise health

KANYE - Reliance on self medication with herbal remedies by men to treat Sexually Transmitted Infections (STIs) has described as a threat to their health.

Speaking at a Pitso organised for men at Logaba Kgotla in Kanye, where issues relating to men's health took centre stage, District STI Focal Person, Mr Pako Thabeng sounded the alarm on men delaying medical care until it was nearly too late.

He warned that delaying until one's health had worsened could lead to serious complications, making treatment difficult, or even impossible. He said most men would opt for using self prescribed traditional remedies over modern healthcare, a habit that was seen to be fueling STIs. "Free health services are available nationwide, use them," he urged, stressing that early detection save lives.

Additionally, Mr Thabeng said risk behaviours like multiple partners and inconsistent condom use were key drivers of rising

STI cases, urging men to adopt safer habits. Kanye District AIDS Coordinator Mr Kebonyemodisa Marumo said the pitso was more than a health focused event.

"It is a bold move to bring

services to men and spark honest conversations about issues they often avoid; from family matters to economic pressures," he said.

Looking ahead, Mr Marumo said the event was setting the agenda as it was one of the build up activities toward September, the Month of Prayer against HIV and AIDS, which was not only focused tackling HIV prevention but other social challenges such as passion killings,

substance abuse and road accidents. The event was a rallying call for men to take charge of their health and confront societal challenges head-on through community action and proactive care. BOPA

Pastors highlight church role in community building

Religious leaders and traditional authorities have emphasised the role played by churches in shaping moral values, supporting vulnerable communities and addressing modern social challenges.

In an interview, Prophet Meshack Mangadi of Heavenly Garrison Ministries said the church was instrumental in shaping people's character and instilling values that lay the foundation for strong, peaceful societies.

Prophet Keabetswe also recommended government to engage with churches by creating platforms that enabled them to offer counselling and guidance beyond traditional worship spaces.

Adding a traditional leadership perspective, Kgosi Cosmos Lelathego of Ward Moeti commended churches in his area for their ongoing support to the community.

He said churches have contributed significantly, including

Organisations team up for good cause

MAUN - In a powerful collaboration set to change the lives of vulnerable children, the Boswa Culinary Institution and Lorato House Rescue Centre have signed a Memorandum of Understanding (MoU) to work together on initiatives supporting orphans and vulnerable children in Maun.

The partnership will bring together culinary expertise and compassionate care to offer a brighter future for the 71 children currently housed at the centre.

Speaking at the MoU signing ceremony recently, Love Botswana and Lorato House director, Dr Jana Lackey, said

Lorato House currently housed 71 children aged from zero to 16 and was nearing capacity.

"Numbers are continuously rising, hence members of the public interested in adoption should register with their local council offices as we await the adoption and foster care system rollout," Dr Lackey said.

While the North West District Council was still in the process of launching its adoption programme, Dr Lackey encouraged families to prepare by requesting home assessments from social workers in their areas to facilitate the process.

"No child should grow up in foster care. Every child deserves to have a mother and father to

guide them through life," she said.

She noted that adoption efforts

She noted that adoption efforts had already begun in other regions, citing the North East District where two children were expected to be adopted within the next two weeks.

Reflecting on the origins of Lorato House, Dr Lackey said the centre was established 27 years ago after she and her husband moved to Botswana in 1987.

"We encountered a baby left without a family at Maun General Hospital after the mother's passing. Moved by the situation, we partnered with government and community stakeholders to create a safe haven. That same child is now 30-years-old and currently serves at Lorato House,

a full-circle moment of hope and purpose," she said.

Boswa Culinary Institution deputy principal, Mr Boisi Dibuile, outlined their commitments under the MoU, which he said included hosting quarterly birthday celebrations for children at the centre, sponsoring learners from Lorato House and regularly visiting the facility to assist with day-to-day activities.

Mr Dibuile also revealed that Boswa's teaching staff would train the kitchen team at Lorato House and spend time with the children to build bonds and offer practical support.

For her part, Boswa Culinary Institute of Botswana founder, Chef Rebecca Pheko, highlighted the institution's mission to empower aspiring chefs with world-class training.

"Boswa is here to bridge the gap by equipping learners with the education and training needed to join world-class chefs and successfully compete in the global culinary arena," she said.

She said the institution was committed to nurturing culinary talent across Botswana, preparing learners not only for local opportunities but also for international careers in the food and hospitality industry.

Meanwhile, Lorato House Rescue Centre operates under Love Botswana Outreach Mission and provides 24-hour care to orphans and vulnerable children, including those living with disabilities.

The centre offers a safe, nurturing environment for children affected by abuse, neglect or abandonment, while also supporting emotional healing and long-term placement planning. **BOPA**


Lebo M's victory makes her the second woman to take the top spot in the country's edition of the global street dance battle.

GABORONE - The 5th edition of the BDF Athletics Club Half Marathon saw a clean sweep for Zimbabwe, with Tatenda Hove and Melody Kaseke emerging as the male and female champions respectively.

The event, held at SSKB in Mogoditshane on Sunday, drew a diverse crowd of runners, reflecting its growing popularity.

Hove, a seasoned runner from the Zimbabwe National Army who trains with the Black Rhinos Athletics Club, finished in a time of 1:05:07.

Reflecting on his performance, he

said, "as a seasoned athlete, I am always prepared for any race. I have previously participated in marathons in Francistown, Palapye and the Sir Seretse Khama Half Marathon."

He also commended the BDF for organising a well-run event.

Meanwhile, Kaseke, running with the Fast and Furious Club, clocked 1:17:53 to claim the women's title.

She described the race as challenging but manageable, adding, "the race was tough, but I managed to conquer it. I encourage other athletes that it is possible to beat my time."

That marked her debut at the BDF half

marathon, although she had previously competed in Botswana at the Kazungula Bridge Marathon in February. She was also happy with her performance and the results. Kenya's Lazarus Too finished second with a time of 1:06:11, while Zimbabwe's Ebel Chibanda secured third place in 1:07:03.

In the women's category, Botswana's Gaone Bathoeng and Kefilwe Galeitsiwe rounded out the podium, taking silver and bronze medals with times of 1:18:54 and 1:21:22, respectively.In addition to the medals, the winners also received P10 000 for first place, P6 000 for second and P4 000 for third.

In an interview, the race's marketing and publicity officer, Major Alfred Phinias, confirmed that everything went according to plan.

"We targeted 2 000 runners, but we exceeded expectations by 100," he said, highlighting the event's increasing popularity. Since its inception, Phinias said the race had experienced steady growth, attracting more participants each year. Beyond the main half marathon, the event also featured a 5km fun run and a 10km race across various categories.

The 10km race saw individuals competing for prizes along with trophies awarded to corporate teams. **BOPA**
