Ministry, UNICEF tackle unemployment

HUKUNTSI - Minister of Youth and Gender Affairs, Ms Lesego Chombo, has raised concern over findings that many young people remained unemployed, not because of a lack of skills, but due to difficulties in navigating the job application process.

Speaking at Employability Training workshop recently in Hukuntsi, she said the programme aimed to empower youth with essential skills to thrive in the world of work and contribute to national development.

"The training will teach you how to do interviews with confidence, how to write a compelling CV, and how to present yourself with professionalism and etiquette," she

The training was hosted in partnership with United Nations Children's Frund (UNICEF) under its Generation Unlimited (GenU) initiative, a global multi-sector programme that seeks to ensure that by 2030, every young person was either in school, learning, training, or employed.

Ms Chombo said the initiative focused on connectivity, skills entrepreneurship, employment, and social impact, noting that while some youth would enter the job market, others were expected to create opportunities through entrepreneurship.

"True leadership is about lifting others as you rise," she told the participants, while also reminding them that their dreams were valid and attainable.

She said that youth unemployment remained a tough challenge that government could not tackle alone, hence partnerships with UNICEF, sister ministries, the private sector, and the youth.

She further urged youth to understand that they were not only job seekers, but were also nation builders who should seize every opportunities.

The minister also highlighted existing skills gaps in the economy and noted that government was strengthening the Technical and

Vocational Education and Training (TVET) system to align with national priorities. She encouraged young people to take advantage of training opportunities relevant to their communities and the country at large.

"Sometimes one skill, one training or one opportunity can open door of opportunities.

Ms Chombo shared that since June, the ministry rolled out a training in Good Hope, Shoshong, and Mahalapye, with Hukuntsi being the latest stop.

She said that plans were underway to extend the programme to Tsabong, Bobonong, and Tonota, as part of efforts to ensure that rural areas were not left behind.

"Youth in rural areas deserve the same training, access, and preparation as those in the city," she emphasized.

"At the close of the training, participants were assured they would be added to a dedicated WhatsApp group, where continuous job and training opportunities would be shared," she shared

In his welcome remarks, Kgosi Merapelo Tshweneyagae highlighted the pressing challenge of high unemployment in the district, noting that no major projects were initiated in the past

He said the absence of factories and limited number of shops in the area worsened shortage of job opportunities.

Tshweneyagae Kgosi contribute to social challenges such as alcohol abuse, unplanned pregnancies, and gender-based violence.

"These challenges have had a major impact on the future of our youth as they grow up in disgruntled families," he said.

He commended the ministry for the workshop, which he said came at the right time, as most youth currently were employment.

He said teaching young people essential skills such as CV writing would improve their chances of finding employment.

Beyond that, he said the programme would empower them create jobs for themselves and others.

Kgosi Tshweneyagae linked the initiative to the government's ongoing National Economic Transformation Programme, which called for citizen-driven ideas to propel the nation forward.

He commended Ministry of Youth and Gender Affairs for selecting Hukuntsi among the villages to benefit from the training, urging participants to approach it with seriousness and commitment.

"Such opportunities come once in a lifetime. Use them wisely for your own benefit and that of your community," he said. **BOPA**

Countries strengthen economic ties through Xaudum Iron Ore project

MAUN - The Xaudum iron ore exploration project is poised transform the economies Botswana and Namibia, strengthening their ties and solidifying their place in the international market.

This was a sentiment shared Infrastructure, Mr Noah Salakae and his Namibian counterpart, Minister of Works and Transport, Mr Veikko Nekundi, following a recent tour of the project's warehouse at the International Airport.

Both ministers praised the project, located near Shakawe, for its commercial potential, emphasising the need for robust support to bring it to fruition.

Minister Salakae said he was excited about the project, noting 'it looks like God's eyes are now facing Africa, especially Botswana.'

He noted that the project underscored the urgency for both nations to build a railway line from Botswana directly to Namibia's

The minister also highlighted

to Africa's rapid progress in regional integration, as the new trade corridor could facilitate the transport of commodities to Angola, Democratic Republic of Congo (DRC) and Katima Mulilo.

"Africa is waking up and seeing the reality that we need to do something to better the by Minister of Transport and lives of our people," Mr Salakae said, emphasising that such projects were key to community development, skills transfer and economic growth.

> He added that while government was clear on the path forward, financing remained a challenge, and hence exploring a Public-Private Partnership (PPP) model to leverage the private sector.

> For his part, Minister Nekundi echoed the sentiments, calling the project strategically important for both nations.

> He stated that it would enable extensive collaboration on logistics, with the iron ore being transported to the international market via the Walvis Bay Port.

"With our collaborative efforts and with our sisterly strategic relations, the iron ore shall be

the project as demonstration transported to the international market through the Walvis Bay port," he said.

> He also noted that Namibia was already at an advanced stage of developing the Trans-Zambezi railway line, which would link Grootfontein to Katima Mulilo via Divundu, just 35 kilometres from Shakawe. He said the railway would be crucial for connecting Botswana to the port.

> Moagi Meanwhile, Mr Ntukununu, an administrator for Gcwhihaba Resources Company, which is registered on the Canadian Stock Exchange, provided an update on the project.

He confirmed the discovery of 441 million tonnes of iron ore at Shakawe.

He said the company was currently in the exploration phase, with some of the ore stored at the Maun warehouse.

He added that they had been exploring since 2006 and were now conducting studies that would lead to the mining phase.

He also expressed hope for the railway line that would connect Shakawe to Namibia and eventually the DRC. BOPA

Public education crucial in GBV fight

TATISIDING Member of Parliament for Tati East, Mr Tlhabologo Furniture has emphasised that amending laws to impose harsher penalties for gender-based violence (GBV) is not an effective solution, rather, education stood out as the crucial strategy to tackle this pressing

Speaking at the second annual Tatisiding crime prevention expo recently, Mr Furniture argued that, while Parliament had the authority to enact laws, their severity will not reduce the incidence of GBV without comprehensive public education on the topic.

"Education is vital," Furniture stressed, adding that it was essential to inform the public about the dangers of GBV and its repercussions on individuals and

He reiterated that merely increasing penalties would not address the root causes of GBV, which required a collaborative effort from all stakeholders.

Mr Furniture highlighted that GBV is a complex issue that necessitated collective action for meaningful change.

"Democracy calls for fairness, but simply enhancing penalties may worsen the problem instead of resolving it," he said.

He said research had shown that informing and educating the population was paramount in the ongoing global search for effective solutions to GBV.

Mr Furniture also praised community initiatives like the Tatisiding crime prevention expo for fostering safety, noting that such efforts often resonated with the community than governmentled initiatives that may not address local concerns.

He urged other villages in the Tati East constituency to emulate the proactive approach of the Tatisiding business community in establishing similar initiatives.

In her remarks, Divisional Commander (North), Assistant Commissioner Police, Tamapo Nthoiwa discussed the security challenges faced by Tatisiding, including housebreakings, burglaries, GBVrelated crimes and drug abuse.

He emphasised that crime prevention is a shared responsibility, requiring active involvement from the entire community, not just the

"As we work together, we must remember that our combined efforts can yield positive results," said Mr Nthoiwa, assuring residents that the Botswana Police Service remained committed to innovative crime prevention strategies

Mr Nthoiwa characterised GBV as a significant violation of human rights and a major barrier to lasting peace and development, with serious long-term implications to the society.

Earlier, Kgosi Simon Kgageng of Tatisiding voiced concerns over rising crime rates in his village, attributing the issue to its proximity to Francistown, a city known for high crime rate.

He encouraged residents to collaborate with law enforcement to address these challenges.

The expo, organised by the Tatisiding business community in partnership with residents was themed: Working together to create a safe community against crime.

Botswana, India share same principles of democracy

GABORONE - India and Botswana have continued to maintain a strong and cordial relationship since establishing diplomatic ties in 1966.

The enduring partnership, built on shared values and mutual respect, was highlighted during a courtesy call from India's High Commissioner to Botswana, Mr Bharath Kumar Kuthati, to the National Assembly Speaker, Mr Dithapelo Keorapetse, yesterday.

Tax returns filing critical'

FRANCISTOWN About 80 per cent of small and medium enterprises (SMMEs) incur penalties due to late or non-filing of tax returns.

Speaking during a one-day women empowerment workshop in Francistown recently, Absa Bank Botswana's tax manager, Mr Oreeditse Matheope underscored the importance of meeting tax returns filling deadlines, not just to evade penalties, but to establish credibility and discipline within their financial practices.

He pointed out that companies facing delisting often had a history of tax payment defaults, urging business owners to prioritise maintaining valid tax clearance certificates.

He further pointed out that higher tax contribution was a reflection of a thriving business, rather than a cost to be avoided.

"Many business owners attempt to evade tax, mistakenly believing it to be a drain on their resources. They overlook the fact that these taxes are public funds essential for driving national development," he said In light of Botswana's current financial challenges, he asserted that tax revenue played a pivotal role in the country's recovery efforts. He also stressed the necessity of diligent record keeping for business survival.

Mr Matheope also advised against mixing business funds with personal expenses, highlighting how some owners might use business capital to cover family groceries. This practice, he said, undermined financial discipline and accountability.

In addition to tax matters, Absa's legal advisor, Mr Keletso Tebele, encouraged participants to familiarise themselves with relevant laws.

He noted that legislation such as the Copyright Act was designed to protect their business interests, though many owners often



overlooked such protections.

"The Copyright Act provides both moral and economic rights that you hold as creators," he explained, urging those who lacked understanding to seek the expertise of legal professionals in drafting their copyright frameworks.

Mr Tebele also covered other legislations pertinent to business owners, including regulations on personal data and the newly implemented family responsibility leave within the Trade and Dispute Act. BOP
