MOLEPOLOLE - President Advocate Duma Boko has commended the Botswana Defence Force Officer Cadets of Class 46, 2025, for exceptional display of patriotism.

The President conferred 149 officers (115 male and 34 female) with the rank of Second Lieutenant at Sir Seretse Khama Barracks in Mogoditshane yesterday.

He emphasised the importance of embodying values that would guide the cadets throughout their careers and called on the newly commissioned officers to embrace the principles of Botho, Courage, Loyalty, Integrity, Esprit de Corps and Discipline.

"These values should underpin every decision and action you take as officers of the Botswana Defence Force. They are essential in fostering a disciplined and dedicated force committed to the security and prosperity of our nation," he said.

Among the commissioned officers, two were from Zambia something President Boko said symbolised commitment to regional cooperation through joint and exchange military training.

"Initiatives of this nature strengthened bonds of solidarity within the Southern African Development Community

(SADC), and ensure that together, we remain prepared to safeguard peace," he said.

He reminded officers that core values such as leadership, discipline, courage and character remained unchanged despite the complex and ever-evolving security landscape.

These challenges include terrorism, transnational crime, cyber threats and disinformation, he said.

## Duo partner to boost medicine safety, regulation

KANYE – The Botswana Medicines Regulatory Authority (BoMRA) in partnership with the Tirelo Sechaba national service programme has trained over 740 participants nationwide as ambassadors for medicine safety and regulatory awareness, with the latest one-day workshop held in Kanye on Tuesday.

The workshop held in Kanye, forms part of an ongoing countrywide sensitisation campaign conducted partnership with the Ministry of Youth and Gender Affairs (MYGA), which oversees the Tirelo Sechaba national service programme.

Speaking on the sidelines of the event, BoMRA Public Relations Officer Ms Itumeleng Modibedi-Ledimo said the collaboration with the ministry had extended the authority's ability to promote access to safe, effective and quality health products.

"While the workshops target all Tirelo Sechaba participants, place particular emphasis on those deployed to hospitals, clinics and health posts, where they interact daily with patients and healthcare workers," she explained.

**Participants** briefed were on BoMRA's core mandate, which includes regulating the supply chain of medicines and related health products, pharmacovigilance, licensing, inspections, and public education on counterfeit medicines.

They also received practical guidance on the safe use of medicines, how to recognise and report adverse drug reactions, and the importance of regulatory compliance.

Ms Modibedi-Ledimo the trained youth were well equipped to relay this information in their workplaces communities, strengthening medicine-safety reporting at grassroots level.

added that similar workshops have already taken place in several districts, with the current Southern District phase set to conclude in Goodhope, Moshupa and Thamaga before the campaign moves to other regions.

The PRO described the sessions as highly interactive, noting that participants offered valuable suggestions on the most effective ways to spread medicine-safety messages. She emphasised that the partnership with the ministry was a key element of BoMRA's broader stakeholderengagement strategy to ensure ethical practices throughout the pharmaceutical sector.

In a related development, Ms Modibedi-Ledimo revealed that BoMRA was collaborating with traditional health practitioners to codify and standardise their medicines, which could eventually allow safe, approved traditional products to be sold in registered pharmacies.

"This initiative has the potential to create employment, stimulate the local economy and integrate safe traditional medicines into the formal healthcare system," she said. Ms Modibedi-Ledimo urged all health-sector stakeholders to actively support such partnerships in the interest of public health. The series of interactive awareness workshops, which began on October 14, 2025, was scheduled to conclude on November 27. **BOPA**

## Survey to formulate framework for security needs

**FRANCISTOWN** - The Security ongoing National Strategy (NSS) survey will lay the foundation for the formulation of a coordinated and inclusive framework to address evolving security challenges.

In an interview in Francistown on Monday, communications specialist for the NSS, Mr Ofentse Thwabi highlighted that the survey, which is currently progressing well, is crucial for Botswana for several reasons.

Mr Thwabi said further to it addressing the country's evolving security needs, it would also enhance citizen safety and wellbeing by focusing on both state and human-centric security needs.

He explained that the survey would also enable proactive management of threats such as drug trafficking, ensuring the country's resilience and

that the exercise of drawing up the NSS dates back to the previous administration, and the new human rights-centric government was keen on its implementation.

He explained that countries with national security strategies in place enjoy peaceful and harmonious living and that every nation needs its own blueprint to secure its people in a world that was becoming an increasingly

He appealed to residents to participate in the ongoing survey, stating that their participation would help in identifying areas prone to insecurity and economic threats.

"Their participation will help identify what the main threats to the economy of the country are. Therefore, we appeal to all to assist and cooperate with our teams so that we come up with tangible results," he added.

Mr Thwabi expects that having the NSS in place will make

Mr Thwabi further indicated Botswana a secure and safe nation. The development of Botswana's first-ever NSS marks a historic milestone in the country's efforts to safeguard national interests and enhance citizen well-being, creating a forward-looking framework to address evolving domestic, regional, and global security challenges.

> It integrates both state-centric and human-centric security perspectives and adopts a wholeof-government and whole-ofsociety approach.

> The baseline survey started from October 31 and will end on December 31, targeting approximately 3 362 households across Botswana in two phases, one targeting districts outside Greater Gaborone and another focusing on those within Greater Gaborone.

> The concerns of Batswana regarding national security will be revealed upon completion of the survey, Mr Thwabi said.

### BOTEPCO, BOU strive to professionalise teaching

GABORONE - The Botswana Teaching Professional Council (BOTEPCO) has cemented a broad partnership with the Botswana Open University accelerate teacher professionalisation, strengthen digital literacy and support the rollout of national teaching

The partnership was formalised on Monday during the signing of a Memorandum of Understanding (MoU) in Gaborone.

BOTEPCO registrar, Raphael Dingalo, said the MoU comes at a pivotal moment as the council has begun national registration and licensing of teachers.

He said the agreement would enhance cooperation in teacher professionalisation, Professional Continuous

Development curriculum alignment in line with the newly approved Teacher Professional Standards and Competencies, as well as the Code of Ethics for Teachers.

"The Botswana Teaching Professional Counc with BOU to work ensure verification of teacher qualifications as part of the licensing process," said Dr Dingalo. He revealed that BOTEPCO was developing a teacher registration and licensing system, which will later link with institutions such as BOU for realtime validation of graduates. This, he said, would help maintain a credible national database qualified teachers. partnership would further include joint organisation of conferences, symposia and capacity-building programmes, and might result in accrediting BOU as an official CPD provider in collaboration with the Botswana Qualifications Authority.

Describing the MoU as a 'winwin' arrangement, Dr Dingalo said the collaboration would ultimately enhance the delivery of quality education. He added that stakeholder engagement remains central to BOTEPCO's work, guided by an Influence, Impact and Interest classification model for prioritising partners.

recalled previous He collaboration between the two institutions under the Beyond Numbers project, implemented with the Commonwealth of Learning and the African Federation of Teacher Regulatory Authorities.

The initiative focused on upskilling teachers in digital literacy through Open and Distance Learning to improve 21st-century teaching competencies. Dr Dingalo said BOTEPCO intends to scale up the training nationwide in support of government's digitalisation agenda, noting that some teachers were still lagging behind in digital readiness.

BOII's national footprint and digital platforms will be instrumental in rolling out the programmes.

For her part, BOU vice chancellor, Professor Kgomotso Moahi, said the MoU celebrates a shared vision to strengthen teacher quality and elevate professional standards across the education sector. Prof. Moahi said BOU had long sought such collaboration, describing it as a natural partnership that supports teachers' professional development without disrupting their work or family responsibilities.

"Teacher quality is directly tied to educational outcomes, and the MoU will enable BOU to deliver accredited CPD programmes aligned BOTEPCO's licensing registration requirements," she said.

She added that the cooperation will include joint research, development of professional standards, rollout of Code of Ethics, and potential integration of BOU systems with BOTEPCO's licensing platform. Prof. Moahi also highlighted BOU's participation in the newly launched Regional Teachers Initiative for Africa (RTIA) as testimony to the university's commitment to innovation in teacher development. She **BOTEPCO** commended for its leadership in teacher professionalisation, saying the partnership would contribute to national education reforms and broader human capital development goals. BOPA

## BETP attracts investors, gain traction

**GABORONE** Botswana Economic Transformation Programme (BETP) is structured such that 60 per cent of its projects are purely private-sector projects, while the remaining 40 per cent were led by government.

Speaking at the showcase of BETP projects eventin Gaborone

on Wednesday, Vice President, also Minister of Finance, Mr Ndaba Gaolathe explained that for the 60 per cent private sectorled projects, government's role focused on facilitation and creating an environment where investment could happen efficiently.

This facilitation, he said included resolving issues of land allocation, change of land use, business permits, market access, and interministerial coordination that often dampened progress.

"This design reflects Botswana's commitment to shifting from a public sector-dominated model to a private sector-powered economy. This is the only path toward resilience, innovation, and longterm prosperity," he said.

Mr Gaolathe said momentum

was building up such as at The Xinii Resort project, which had encountered challenges but had finally progressed from concept to site alignment.

He said various projects including TEMCO Hospital, Centre for Nuclear Medicine and Theragnostic, strategic rehabilitation of the Botswana Railways main line, the redevelopment of the Glen Valley wastewater plant and the expansion of Maun Airport had attracted strong investor interest.

Mr Gaolathe explained that BETP goes beyond being just another government initiative; rather it is a representation of a complete redesign of Botswana's economic architecture, setting a blueprint for a future in which Botswana is more diversified, more digitally integrated, more industrially competitive and more deeply connected to global markets.

"The Botswana Economic Transformation Programme is built precisely on these principles. It is our strategy for positioning Botswana at the frontier of emerging economic opportunities," he said.

Mr Gaolathe where the focus was on the six economic sectors of tourism, agriculture, manufacturing, financial services and digitalisation, energy and mining as well as infrastructure and the accompanying three social priorities of healthcare, education, and social protection.

Showcased to acknowledge Botswana's new economic path, each sector has its own True North to ensure full alignment with government's transformation vision, the Vice President revealed.

He said with Parliament's approval of BETP, government was now transitioning into implementation stage.

"This is the stage where national aspirations become measurable outcomes, where planning must give way to productivity, and where intention is transformed into real progress," he said.

Government received 6 925 submissions from across the country and beyond borders, one which Mr Gaolathe said has been the largest citizen and investordriven economic design efforts in Botswana's history.

He said from the submissions, 186 high-impact, evidence-based projects were refined through the BETP Labs; the labs being the intensive working sessions that brought together government, industry, academia, and partners.

"Some of the BETP projects are not new, many were previously planned or initiated by government and private investors, but their progress stalled over time due to weak coordination, excessive red tape, or capacity constraints," Mr Gaolathe said adding that some projects were already operational and now sought to scale up their reach and deepen their impact.

He said projects such as the A1 Highway upgrade, Milk Valley farm and the National digital ID were now moving forward after years of uncertainty.

Furthermore, Mr Gaolathe said the 186 projects under the BETP represented an investment pipeline valued at P514 billion over the next decade.

He said no transformation of such scale, anywhere in the world, had ever been financed by government alone.

BETP Through Parliament's approval, BETP has begun establishing its secretariat under the Ministry of Finance.

The secretariat will operate as the nation's central delivery engine for BETP projects, with a mandate to coordinate action, monitor progress, remove barriers, track performance, and accelerate implementation.

The BETP portal is also setup at www.betp.gov.bw.

### Companies donate high-tech equipment to wildlife department

- The Department of Wildlife and National Parks (DWNP) in Maun has received high-tech equipment and camping gear valued at P700 000, donated by And Beyond Safari in partnership with Wild Impact as part of their ongoing corporate social responsibility initiatives.

The donation package include drones, trail cameras, tablets, and camping equipment, among other items. In addition, the two organisations sponsored first-aid training for 16 wildlife officers, who undertook a week-long course aimed at improving field safety and response capacity.

North West acting regional wildlife coordinator, Mr Thebe Horatius, appreciated the gesture, noting that this was the third donation from the partners. He said the new equipment would strengthen anti-poaching operations, particularly in vast and sensitive areas such as the Okavango Delta and Chobe National Park.

Mr Horatius said despite collaborative efforts by the wildlife department, the police, Botswana Defence Force and private organisations, poaching, especially bush-meat poaching remains a concern. The new drones equipped with visual cameras, he said, would enhance patrols, animal tracking, and wildlife population monitoring.

"They serve as a highly effective tool for counting animals and will help us in conservation efforts," he said, adding that drones would also support disaster response in hardto-reach areas and bolster research

He further noted that And Beyond had also trained officers on using camera traps, while drone training is ongoing.

He encouraged more companies to join efforts to promote responsible management conservation investment, warning that failure to do so would negatively impact the tourism industry.

The partnership between And Beyond, Wild Impact and DWNP dates back to 2012, when And Beyond voluntarily translocated rhinos from South Africa to Botswana to protect them from high-risk poaching zones.

Wild Impact regional manager, Mr Skipper Mareja, said the donation demonstrated what publicprivate partnerships can achieve in safeguarding Botswana's landscapes and biodiversity.

He described wildlife crime as one of the most pressing conservation challenges, warning that failure to act could see future generations lose the country's natural endowment.

Mr Mareja highlighted the milestone achievements of the Botswana Rhino Conservation Support Project, which builds on the legacy of Rhinos Without Borders a programme that moved over 80 southern white rhinos to the Okavango Delta, leading to more than 62 births before the rise in poaching that forced government to relocate rhinos to more secure areas.

He noted that this is not the first time they have supported DWNP, recalling their 2023 donation worth over P500 000, which provided essential monitoring and patrol equipment crucial for species protection.

Their conservation also include partnering with communities in the delta region and supporting projects aimed at improving ecosystem management. Mr Mareja added that first-aid training for wildlife officers was crucial given the risks associated with their work.

"Through innovation partnership, we can ensure that the delta remains a sanctuary for wildlife and a source of pride for Botswana and the world," he said.

## **Boko commends** officer cadets for patriotism

President Boko said the SADC region was faced with deepening humanitarian security and challenges.

Thus, he emphasised that the responsibilities also officers' extended beyond borders.

He also highlighted the situation in the Democratic Republic of Congo (DRC), where the M23 insurgency had displaced and destabilised thousands communities, despite ongoing peacekeeping efforts.

Furthermore, he said in northern Mozambique, militant attacks in Cabo Delgado continued to test regional resolve.

As such, he said peace remained fragile and cooperation was essential.

President Boko said government was facing fiscal crisis, hence he cautioned officer cadets to be prudent in managing resources. "Managing resources is the true

test of leadership as courage is on the battlefield or precision on the parade ground," he said. He said the graduates were

commissioned as officers in one of the most respected institutions in the nation.

Therefore he urged them to wear their commissions with pride and humility and lead with courage and compassion.

"Serve with integrity and devotion. Always remember that you took an allegiance oath not for personal gain, but for the peace and prosperity of Botswana," said President Boko. BOPA

## Ntobgwe Ward bid for village status fails

TUTUME - A request by residents of Ntobgwe ward in Tutume to have their

ward declared an autonomous village has been rejected.

Briefing the District Development Committee meeting on Tuesday, Physical Planner at Tutume District

Council, Mr Joel Brian informed the meeting that according to a letter received two years from people

alleging to be acting on behalf of the residents of Ntobgwe, the main reason for the request was the

under-development of the area. Mr Brian said the letter, dated March 29, 2023, was addressed to the Office of the District

Commissioner and highlighted a lack of developments in the area, mainly services and infrastructure.

He said the letter stated that residents were accessing services from Timbi and Mangana wards.

The officer said the authors of the letter complained that the council ward under which they fell

comprised Matobo and Goshwe, which were independent villages, hence they believed their ward

deserved to the elevated to village status to be at par with the other two

He noted that the District Commissioner's office referred the matter to the tribal authority

consultation and a response was given in July 24, 2024 to the effect that the proposal had not been

acceded to on the basis that the issues raised could be addressed through improvement in service delivery by relevant offices.

Nevertheless, Mr Brian informed the meeting that after the response from the tribal authority,

consultative meetings were held to get the views of the concerned party as well as those of residents of Magapatona, Timbi and Matobo which shared boundaries with Ntobgwe ward.

He noted that the outcome of the consultative meetings pointed to issues of service delivery among

the pressing needs being one for a resident nurse at the mobile stop located in the ward.

In addition, he said they had raised the issue of limited access to the Ipelegeng programme and the

elderly having to walk 12 kilometres to receive certain services at Timbi ward.

All those, he said were concerns which could be addressed by relevant authorities and offices for residents to be serviced better.

On the issue of shortage of water, which was also raised as one of the factors prompting them to

request for autonomy from Tutume, Mr Brian said the problem was not confined only to Ntobgwe but

affected most parts of the Tutume District.

He said Water Utilities Corporation had ongoing projects aimed at addressing the shortage, adding

that the said projects were almost complete.

He thus concluded that the reasons advanced by the applicants did not justify declaration into an

independent village and that at the same time residents did not meet the minimum standards

requirements set for recognition as a village in terms of the National Settlement Policy (NSP) of 2004.

He added that the NSP provided for a minimum population of 250 people for Rural Area Dwellers

500 for settlements and that the next settlement had to be 13 kilometres away.

He explained that while there were no specific statistics, given the number of households in the ward

the population could not exceed 500 and the area was not 13 kilometres away from next village as required. *BOPA*

## Official urges partners to assist new radio station

MAUN - Limited start-up funding and lack of availability of land have been described

as obstacles towards the establishment of the community radio stations.

Okavango Human Wildlife Foundation (OHWF) managing director, Mr Kenosi Kamina said during stakeholders meeting on Friday that financial constraints impacted various aspects of operations right from acquisition of basic equipment to maintaining a consistent broadcast.

He said setting up a radio station was an expensive undertaking that required a lot of money and could only be possible and sustainable through collaborative efforts from all stakeholders.

To this end, Mr Kamina pinned his hopes on Tawana Land Board to avail a plot for the envisaged radio station to materilise. "Land is essential for housing both the studio operations, the transmission equipment, news rooms and offices among others,"

He also pleaded with individuals owning chunks of land to come to the fore to remedy the situation asthe management had been given only 12 months by BOCRA to start the operations of the radio station.

Despite the challenges, Mr Kamina was optimistic that their dream of operating a community radio would be realised as a lot of progress such as the draft constitution and operational framework had been developed.

"Registration of the radio station has been done and we are also yet to finalise licensing of a transmitter, conduct capacity building workshops for volunteers and broadcasters as well as embark on community consultation to take the radio to the people and also

launch community fundraising drive," he added.

Stakeholders learnt that the main station would be in Maun while satellite stations will be established in Kasane and Shakawe.

Stakeholders hailed the foundation's efforts saying the setting up of the radio station was a step in the right direction as it would contribute to local development and promote participatory and good governance.

Pastor Nonofo Mataboge thanked the foundation for achieving such a milestone of establishing a community radio and wished stakeholders could take advantage of the development.

A radio station, he said, had the potential to shape and influence community development, information sharing as well as promote economic activities.

North West acting regional wildlife coordinator, Mr Thebe Horatius also appreciated t the idea, stating that it was long overdue.

He was happy that the radio station would come handy to department of Wildlife and National Parks as far as issues of human wildlife conflict were concerned.

"This development will indeed ease our work as we will be able to reach a large audience and share pertinent information".

Some tourism operators also hailed the establishment of the community radio station saying it would complement existing radios in terms of disseminating information.

They also indicated that the station would help promote local tourism and empower communities.

"We will be able to advertise local tourism businesses to both local and international audience. We are grateful that the radio station will also promote cultural heritage of the local community," said Ms Mojadi Obert. *BOPA*

He said the incident happened after the border was temporarily closed due to floods.

The traditional leader lamented that the situation did not only pose danger to residents but also to children who try to catch fish from the river, urging parents to restrain them from going fishing alone.

Some residents also shared Kgosi Sekwenyane's sentiments saying the government should fulfill its promise since they had long been promised a better bridge.

The customs officer at Phitshane Molopo border, Ms Lesego Sebina also concurred with Kgosi

Sekwenyane that the temporary closures negatively affectsed their daily operations and the communities they served.

She said even though the border was small, they were servicing a lot of customers as many of the villagers along the river had relatives in the neighboring country.

Ms Sebina expressed concern that the rainy season was not intense and already their services were disrupted. She said government should consider erection of a bigger culvert that would be able to

allow the water to pass without having to spill over it. **BOPA**

Mr Selelo noted that the council was allocated Road Levy fund amounting to over P5.7 million for 2025/2026 projects.

He said the funds were to cater for culvert construction, supply and delivery of electrical materials, a decision that came after a consultation and assessment of which projects were to be conducted through the funds.

Mr Selelo shared that some of the projects to be conducted included culvert construction, paving, construction of storm water drainage, road maintenance, and the installation and maintenance of streetlights.

He said the projects would be conducted in different wards in Selebi Phikwe town at various costs. Commenting on the submissions, councillor Timothy Sejankabo of Newstance approved the proposed projects, pointing that the move was a commitment towards enhancing the town's infrastructure and ensuring sustainable developments.

He said the decision to install more streetlights at Newstance was timely and would help enhance safety in the area.

However, he was also worried that his area was promised installation of 200 streetlights, but the number had been reduced to 150.

Mr Sejankabo said this could compromise efforts to fight criminal activities head on that continued to pose a challenge in the area.

Councillor Silent Leburu of

Phase 1 also shared that the proposed projects underscored the council's efforts to improve local infrastructure, enhance transportation, and potentially boost economic developments in town.

Councillor Stephen Nyoni of Botshabelo East appreciated the proposed developments, saying they would significantly enhance safety and promote the overall community well-being.

He said the initiatives were crucial in fostering a secure environment where residents could thrive.

In addition, Mr Nyoni noted that these developments reflected the council's unwavering commitment to creating an inclusive living space that catered to the diverse needs of the community.

Specially Elected Councillor, Ms Onalenna Kobe, said construction of more storm water drainage systems in some areas of the community was ideal.

She said stagnant water was due to insufficient drainage that could lead to various health hazards, including the proliferation of waterborne diseases. Furthermore, she said the storm drainage system would aid in addressing flooding in some areas, which not only disrupts life but also incurs significant financial costs for clean-up and repairs. Ms Kobe said that by investing in proper drainage infrastructure, the community could mitigate these risks and improve overall public health and safety. *BOPA* 

### Authorities urge vendors to build trade skills

MOLEPOLOLE - Street vendors have been urged to abide with council trading byelaws and sustain their enterprises as there are a foundation of livelihoods in many households.

The call was made by the chairperson of Kweneng District Council, Mr Ontefetse Rankhibidu at the maiden entrepreneurial workshop for the informal sector on Tuesday in Molepolole.

He said the sector that was dominated by women must fully comply with trade regulations for its survival and cordial operation, given its importance and positive impact to the society.

Mr Rankhibidu said engaging with the informal sector was part and parcel of his roadmap and its objective was to empower street vendors with business management skills that could help them up their game in compliance with byelaws.

Held under the theme: Building tomorrow's Kweneng today, Mr Rankhibidu said informal traders were the mainstay of the economy and major contributors to the Gross Domestic Product.

He described street vendors as a magnificent source of job creation mainly through self-employment, hence urging them practice good business acumen that could sustain them into long term trading and growth.

He was of the notion that street vendors were at the foreground in converting Kweneng's economy into a melting pot and their challenges needed immediate attention.

Rankhibidu also said he wanted to protect local small scale businesses, render them support and where possible give them priority in awarding tenders.

He however cautioned those who were engaged in illegal trading practices such as selling illegal products, as well as opening a window of market for carcasses of stolen livestock.

KDC Secretary, Mr Olebile Mafala encouraged street hawkers to focus on running profitable businesses.

Mr Mafala said a stable business would be in a position to make profit and allow room for expansion.

He said the idea for holding such a workshop was to engage street hawkers on how to maintain a good customer service, practicing good hygiene and good management, maintenance of trading structures in compliance with bye laws.

Mr Mafala assured them that

council was not a monster to their businesses but a guardian who was ever present to monitor how they could run their business in a much acceptable manner.

He therefore, pleaded for collaboration between the council and traders. Some hawkers pleaded with council to regulate established businesses such chain stores and supermarkets to avoid competition.

Some cried of some foreign nationals who were illegally engaged in small business activities reserved for citizens, a situation that has congested the informal sector. The KDC Deputy Council Chairperson, Mr Kenna Odirile encouraged hawkers to join a WhatsApp group that would be used to engage them and for ease of communication with council authorities. *BOPA* 

## Mabanda pleads guilty to cruel punishment of child

MAUN - Monica Mabanda, 30, of Maun has pleaded guilty to a single count of cruel punishment to a child.

She appeared before Maun Magistrate Court on Tuesday accused of assaulting her minor child on February 28, at Boseja ward in Maun.

She allegedly beat her son on the back with a stick and burned his hands using melted plastic.

Mabanda told the court that she understood the charge fully and did not dispute the evidence presented against her by the state.

"I admit to the offence, and I am not in disagreement with the witness statements," she confirmed when asked to respond to the facts.

Presiding Magistrate, M

Gofaone Mosweu emphasised the seriousness of the offence, noting that the courts treated cases involving cruelty to minors with utmost gravity, as they concerned children who were vulnerable and entirely dependent on adults for safety and care.

Magistrate Mosweu advised Mabanda to reflect deeply on the reasons she was intending to present as mitigation, stressing that it would be her opportunity to justify why the court should consider leniency in its sentencing.

"You must think carefully about the reasons you will give to this court as to why you believe you deserve a lenient sentence, because the charge you are facing is a very serious one," she said.

Mabanda will appear before court on December 08, for mitigation and sentencing. *BOPA*

## **Business associations critical**

He said advancing their interests as a unit would be more manageable and effectively contribute toward the township's economic development.

Speaking at a consultative meeting with the informal sector recently, Mr Ntsimako said as part of his roadmap, he was committed to enhancing community engagement with various sectors of the economy.

Ms Gaobonale Watshipi urged the council to strengthen their monitoring systems and make regular follow-ups on market stall rentals

She noted that this would go a long way in identifying defaulters on time as well as ensure optimal compliance.

## 'Delays at border posts require solutions'

FRANCISTOWN - Botswana is experiencing a surge in complaints regarding Non-Tariff Barriers (NTBs) at its three major borders of Kazungula, Martin's Drift and Tlokweng.

Speaking at a two-day capacity building workshop for the Francistown informal traders organised by the City of Francistown on Tuesday, senior trade officer in the Ministry of Trade and Entrepreneurship, Ms Kelebogile Nyathi identified prolonged and unprecedented delays as the primary issue, requiring urgent resolution.

Ms Nyathi highlighted that trucks travelling from Zambia to Botswana spend between eight and 12 hours waiting at the Kazungula One-Stop Border post due to slow processing and intermittent system failures.

She pointed out that the absence of harmonised NTB charges within the SADC region was a significant contributor to recurring delays.

"The major reason is the too

long and unprecedented delays, which need to be addressed with immediate effect," Ms Nyathi

According to Ms Nyathi, NTBs in the SADC region, were largely driven by government monopolies aiming to protect domestic markets, cumbersome customs and pre-shipping procedures, poor inter-agency coordination, and multiple weighbridge stops, practices that Botswana does not follow.

She noted that these barriers had substantial economic impacts, with the SADC region losing over P3 million annually due to NTBs.

Additionally, NTBs increase the cost of doing business and reduce competitiveness, equivalent to a 10 per cent increase on SADC imports and seven per cent on exports.

Ms Nyathi proposed several policy recommendations to address these issues, including strengthening national NTB focal points, enhancing awareness of reporting tools, improving border digitalisation, and holding

regular coordination meetings.

She urged traders to report discriminatory NTBs to policymakers and stressed the need for private sector collaboration.

"Going to other blocks away from SADC, there is no stronger coordination amongst regional blocks," she said, appealing for unity in tackling NTBs.

Traders, particularly those importing from Zambia, voiced their major concerns about excessive NTBs, including numerous roadblocks and unwarranted charges.

Ms Kgalalelo Yuyi, a trader, reported being charged exorbitant prices for her vehicle when crossing into Zambia, citing a P3 800 charge for her vehicle, and complained of unwarranted charges at roadblocks in Zambia.

"Bribery in Zambia amongst security agents is an order of the day," Ms Yuyi said, calling on the Botswana government to waive charges as a means of boosting the country's revenue.

Ms Yuyi also criticised the lack of regulation of informal sector

operations at the Francistown bus and taxi rank, where she said foreign traders operated without licences.

Another trader, Ms Lulwamisani Tothodzani, echoed Ms Yuyi's sentiments, urging that Zambia be reined in.

"They are terrorising us in Zambia, making us pay exorbitant charges without apparent reasons," Ms Tothodzani said, mentioning a six-month ban on entering Zambia that was imposed on her without clear justification.

The workshop was organised by the City of Francistown in conjunction with the United Nations Development Programme with facilitators from Botswana Unified Revenue Services.

It aimed to empower informal sector traders with the knowledge and skills to utilise African Continental Free Trade Area (AfCFTA) opportunities, expand their cross-border businesses, and understand the basic principles of AfCFTA and rules of origin. *BOPA*



## Consultation ongoing over borehole allocation

GABORONE - The government is currently engaged in consultation and technical assessments before making a final decision on reducing the minimum distance for borehole allocation in communal areas from six to four kilometres in communal areas.

Acting Minister of Lands and Agriculture, Dr Edwin Dikoloti, said the assessments were being undertaken in collaboration with the ministries of environment and tourism, minerals and energy and water and human settlements, as well as development partners, to ensure that among other things, groundwater resources, environmental sustainability, and

land use planning were being fully addressed.

Furthermore, Dr Dikoloti highlighted that ensuring water development for the agricultural sector was a priority currently being integrated into the ongoing review of the National Agricultural and the country's envisaged livestock development programmes. Tswapong South MP, Dr Kesitegile Gobotswang had sought an update on the implementation of a parliamentary motion that called on the government to reduce the distance between boreholes from six to four kilometers in communal areas.

## Kaizer raises concern over poor school infrastructure

GABORONE - Although schools in the Selebi Phikwe area are synonymous with good performance, they are faced with challenges among them dilapidated buildings and shortage of equipment, which should be attended to.

Selebi Phikwe West Member of Parliament, Mr Reuben Kaizer, said the government's attitude towards education was unsatisfactory.

He faulted the UDC government with making promises it would not fulfill, and warned that such could dent their reputation.

Mr Kaizer advised the government to come up with laws and policies that were conducive for business and investment.

He also said government's idea to hire office security guards and cleaners, currently being outsourced, would result in many security companies and cleaning services providers losing business. Such, he said, would also lead to a loss of jobs, which the Umbrella for Democratic Change (UDC) said it would create when elected into power.

He said the affected companies, other than employing other Batswana, were paying taxes in the country, and contributing to government coffers. Some business owners are still servicing loans, Mr Kaizer said, demonstrating that move would be detrimental to such companies.

By insourcing, he said that the government would also be importing risks associated with the cleaning and security services. Mr Kaizer also said some of the Selebi Phikwe residents who were relocated to pave the way for the expansion of the airport had not been compensated.

He suggested that government look into the destitute policy and disability allowance with the possibility to increase them.

Kgalagadi North legislator, Mr Reason Lekutlane, said the SONA represented hope for a better future, adding that the UDC was still committed to improving the lives of Batswana.

He said with only a year in office, President Advocate Duma Boko had already made history by burying Pitseng Gaoberekwe at his ancestral land in CKGR, after a prolonged battle between his family and the previous government over his burial site.

The legislator also commended the introduction of news broadcast in indigenous languages, on *Btv* and *Radio Botswana*, and called for more appointments of marginalised people to positions of power, noting that there were educated and capable people among those tribes.

He said Kgalagadi areas were epitome of poverty because they were underdevelopment. Mr Lekutlane said lack of infrastructure development had led to some people refusing to work in those communities.

He recommended a health facility with a maternity ward in the area, to avoid long distance travels to access the service, unified school in Hunhukwe as well as a referral hospital in Kang. **BOPA**

## Citrus farm injects over P200 million in FDI

GABORONE - The citrus fruit farm along Tobane road on the outskirts of Selebi Phikwe has brought over P200 million direct foreign investment, supported other industries involved in input supplies as well as other services and communities in Botshabelo.

The project has received a lot of attention because of its large scale production of citrus which has never been experienced locally, Minister of Trade and Entrepreneurship, Mr Tiroeaone Ntsima has said.

He was answering a question in Parliament on Wednesday, explaining that the project which commenced on December 2022 had made considerable progress, with 1 077 hectares developed out of the 1 822 available and 819 000 trees planted.

The Minister said the total investment to date was P491 million with employment level of 405 employees and 734 during peak season. He said the farm had 16 managerial positions which consisted of eight locals and eight South Africans.

Minister Ntsima said the project had potential to create 1 500 jobs when in full production.

The project has just completed its second harvest which has increased from 5 000 tonnes to 22 000 metric tonnes and has been able to export to international markets such as EU, Canada,

Middle East and South Africa, said Mr Ntsima.

Apart from imparting knowledge to locals, he said the company had partnered with the Botswana University of Agriculture and Natural Resources under the graduate scheme and already, eight graduates were being mentored to become future managers.

Selebi Phikwe East MP Mr Kgoberego Nkawana had wanted to know if government was satisfied with the current performance of the farm and measures being taken to ensure its long-term sustainability and contribution to the local community. BOPA

## School uniform production reserve for citizens - Ntsima

GABORONE - In an effort to strengthen the local textile industry, school uniform manufacturing continues to be a reserve for the citizens as per the reviewed Industrial Development Act 2019, says Minister of Trade and Entrepreneurship, Mr Tiroeaone Ntsima.

Responding to a parliamentary question on Tuesday, Mr Ntsima said that a citizen empowerment initiative the ministry further introduced a Statutory Instrument No. 76 of 2021, which restricted importation of school uniform.

He told Parliament that school uniform production was dominated by duly licenced companies and that business inspections were continuously carried out, to ensure compliance.

During inspections, a few cases of foreigners were found to be manufacturing school uniforms and were engaged in illegal importation, Mr Ntsima said and explained that the ministry in conjunction with other stakeholders had taken necessary measures such as imposing fines and confiscating the goods. "These efforts are continuing with a view to address the raised concerns," he said

Additionally, the minister highlighted that during implementation of the National Quality Policy the ministry had started to inculcate quality culture among consumers, retailers, suppliers and regulators, to promote demand and supply of quality goods and services.

He said the Botswana Bureau of Standards (BOBS) developed national quality standards on school uniform, to ensure that the products were of quality standard and could competitively access both local and global markets.

He thus said, that local tailors

were encouraged to approach BOBS for assistance in that regard and to urged consumers to buy school uniforms that complied with quality standards.

The minister highlighted that it was pleasing that there were good quality products from Batswana noticeable in the market.

In line with international standards, the school uniform standards were voluntary as they were not related to health and safety, Mr Ntsima explained.

He said it was a concern that consumers were much more skewed towards price rather than quality.

"This now means that sensitisation and campaigns should now be customer focused so that their choices could reflect quality and not just the price alone," he said.

He appealed to Ministry of Child Welfare and Basic Education, through the Parents and Teachers Associations that in the procurement processes of school uniform, preference be given to tailors within their constituencies. Mmopane/Metsimotlhabe MP, Ms Helen Manyeneng had wanted to know whether the minister was aware that foreign nationals were increasingly dominating the manufacturing and sale of school uniforms in various constituencies often using low quality materials.

This, she said was to the detriment of local businesses that produced authentic and durable uniforms.

She also wanted to know whether the ministry would consider to put measures in place to support and prioritise local tailors within constituencies for the production and sale of school uniforms, in order to promote quality standards and empower local entrepreneurs. *BOPA* 

## Govt works to stabilise economy

GABORONE - Government is working on stabilising the economy and will ensure the national economic cake benefits all citizens, Assistant Minister of Local Government and Traditional Affairs, Mr Ignatius Moswaane has said.

Debating the State-of-the-Nation Address (SONA) on Wednesday, Francistown West Member of Parliament (MP) Mr Moswaane said the new government inherited depleted coffers, making it difficult to immediately implement social spending.

"But, after working on stabilising the economy, the government would make good on their promise to implement a P4 000 living wage, P2,500 students' allowance, P1,800 old age pension scheme and P300 child grant among other social benefit initiatives."

Mr Moswaane said the government was also working on ensuring that the country's economy broadened its income revenue streams in order to become more sustainable.

He called on government to invest in making Francistown more economically viable as the second city in the country.

He said there was adequate land in Francistown and the surrounding areas, including an empty land at Gerald Estates and the Tati land that had been acquired by the state. The designation of Francistown as a transport and logistics special economic zone should lead to the relevant investment to generate jobs, income and wealth, Mr

Moswaane said. Rural areas in part such as Ngami, Okavango, Chobe, Ghanzi and Kgalagadi, he said were poverty stricken, but had strong potential if the right investments were made.

Letlhakeng MP, Brigadier Domcaza Mokgwathi said the Botswana Economic Transformation Plan would be the goose that lays the golden egg of job creation, economic regeneration and poverty reduction that would be pursued through the 12th National Development Plan (NDP 12). He said government

sought to make meaningful political, economic, social and technological change, which would be addressed through NDP 12.

Brigadier Mokgwathi said land reform and the Bonno National Housing Programme, as well as the distribution of water and solar energy countrywide would also uplift the livelihood of rural communities such as those in his constituency.

He expressed delight at the proposed Letlhakeng Primary Hospital project and Letlhakeng-Kaudwane Road, which had long

been sought by the constituents. Brigadier Mokgwathi said the residents of the villages to be connected by the road, Diphuduhudu, Hatsalatladi, Ngware and Botlhapatlou were excited at the proposed development.

He said better healthcare and social protection would be realised through proposed policies such as the national health insurance that the government had committed to pursuing, to ensure that all citizens had access to quality health. *BOPA* 

### Motshegwa acknowledges shortage of medicines

GABORONE - The Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa has acknowledged the persistent shortage of medicines and consumables across all facilities, including those in rural areas.

Responding to a parliamentary question on Wednesday, the minister noted that in his State-of-the Nation-Address (SONA), the President indicated that the country should expect a significant increase in the supply of medicines in the coming weeks.

"While the Central Medical Stores (CMS) is responsible for bulk procurement and distribution, the ministry is committed to the redistribution and rationalisation of medicines within local authorities, as well as ensuring timely ordering and diligent tracking of supplies at CMS," Minister Motshegwa said. Regarding the retention and motivation of healthcare workers in hard-to-reach areas, he highlighted

the existing Remote Area Service Allowance which was in place to motivate and retain public officers serving in remote areas. Additionally, officers serving in these areas are provided with free accommodation.

However, Mr Motshegwa stated that the ministry acknowledged the need to consider developing specific deployment plans that took into account the unique circumstances and challenges faced by certain districts.

On the integration of digital health solutions, he stated that optimising digitalisation for health remained a key priority, aligning with the health sector's true North of transforming the Botswana health system to match the global Universal Health Coverage average by 2036 through stronger care, workforce, and digital innovation.

A number of systems are utilised in health facilities, such as Patient Information Management System, Integrated Patient Management System, District Health Information System 2, and E Pulse, said Mr Motshegwa, adding that those were active and in use, although not currently interfaced to permit data sharing or access across all health facilities.

He further explained that progress on connectivity included 223 clinics already connected through the ongoing village connectivity programme, with a further 60 targeted under the current phase.

Minister Motshegwa confirmed that by the end of the financial year, a total of 283 clinics were expected to be online.

He said challenges such as power surges, often resulted in damage to equipment however, the ministry was installing power surge protectors in affected facilities.

"The ministry is also advancing the development of integrated systems such as the Electronic Medical Records, currently being piloted in two districts, and the Clinic Information Management System, which will ensure access to specialist care," Minister Motshegwa explained.

He said the systems would link to the Botswana Health Information Exchange to support a Master Patient Index that maintained citizens' medical histories across the public and private health facilities.

Boteti West MP, Mr Sam Digwa wanted the minster to state plans in place to address persistent challenges in rural healthcare, that included shortages of medicines and consumables, retention and motivation of staff in hard to reach places, and the integration of digital health solutions, to bridge the urban-rural divide in access to health care. *BOPA*

### Batswana enjoy restored rights - Bagaisamang

GABORONE - The civil rights of Batswana have been restored under the Umbrella for Democratic Change (UDC) government and now, members of the community are free to protest whenever they are unhappy, without fear of victimisation, says Shoshong legislator, Mr Moneedi Bagaisamang.

Mr Bagaisamang, who was debating the State-of-Nation Address in Parliament on Wednesday, said government was a proponent of human rights and would protect the rights of its people, especially the marginalised.

He also said government should not be apologetic about insourcing security guards and cleaning services providers, which were previously outsourced because that would ensure that the employees, whose rights were trampled upon, were now protected.

"The guards and cleaners will now, among other things, be entitled to pensions and other benefits, something that is not the case with outsourcing these services," Mr Bagaisamang said. He said ill-treatment of security guards by their employers put the previous government in bad light, and the UDC led government would not commit the same mistake.

Protecting security companies is akin to protecting the interests of a few individuals at the expense of the majority, Mr Bagaisamang said. Regarding the promises made by the UDC prior to elections, he said it was not possible that the government would fulfill them at once, owing to the status of the economy but, some had been fulfilled.

Mr Bagaisamang said that Shoshong area needed roads that connected villages within the constituency. Gabane/Mmankgodi MP, Mr Kagiso Mmusi, for his part said conversion of special constables to mainstream police service was in the second intake when the government changed guard, as such, it would not be

accurate to ascribe that to the new government, when it was him who mooted the idea, which was then implemented by the previous administration.

Also, he said the health sector had collapsed under the ruling party, adding that when they took power, the previous government was advanced in navigating ways of procuring medicines directly

from suppliers.

Mr Mmusi said the UDC government inherited a strong economy with robust credit ratings,

and that the government was to blame for the current situation.

Further, he said the government was failing on its promises, except for a few such as increasing old age pension by P540, and Technical and Vocational Education and Training students' allowance to P1,900, though now failing to procure food for the same students.

Also, he said the ploughing had commenced but government was failing to assist farmers, something that could lead to starvation in the coming months. *BOPA* 

## Councillors appointments in line with Local Government Act

GABORONE - Specially elected councillors have received total remuneration amounting to approximately P50,418,966, inclusive of basic salaries and allowances.

This figure covers 157 specially elected councilors across the country's 61 constituencies and 31 district/town councils.

Responding to a parliamentary question on Tuesday, the Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa, said the expenditure was justifiable because specially elected councilors were appointed in terms of the Local Government Act No. 18 of 2012.

He said Section 13(1) of the Act

provided for specially nominated councilors in the constitution of councils

"This means that for a council to be truly and legally constituted, it must comprise both elected and specially nominated members, as confirmed by a subsequent Order published in the Government Gazette."

On the question of reviewing or abolishing the special nomination dispensation for councilors, the minister stated that the current specially nominated councilors must serve their full five-year term, from November 2024 to October 2029.

He acknowledged that acute skills gap still existed in some

local authorities, particularly among directly elected councilors.

Mr Motshegwa assured Parliament that the ministry would take into consideration the relevance and necessity of specially elected or nominated councilors when the Local Government Act, 2012 was reviewed.

The question was posed by the Member of Parliament for Bobirwa, Mr Taolo Lucas, who asked the minister to state whether the expenditure on specially elected councilors was justifiable under the current economic situation and whether the ministry was open to reviewing the special election or nomination system for councilors. *BOPA*

## Mpuse: The lensman, the bountiful life

ave you ever imagined an individual fond of essentially running to things that other people run away from? Well, the chronicles of the life of our departed brother Godfrey Mpuse demonstrate a delicate balancing act between journalistic bravado tempered with the thirst to tell unfiltered stories. Rebaone Tswiio writes.

We must premise our sojourn on one thing dear readers, that Godfrey was such a larger than life character to the extent that his life remains an uncompleted puzzle where anyone anytime can fill-in the blanks and still get him right. I must confess also that "larger than life" in this instance has nothing to do with the giant that he was in physical terms.

We rewind to the year 1994, Gaborone West to be precise, which in street parlance is referred to as Ko Kasi. A group of boys have just finished their Primary School Leaving Exams in Bophirima Primary School and are idle most of the day, street football and pigeon hunting being their order of the day. Among these boys is Godfrey Mpuse, tiny framed, light skinned with a bright smile that does not seem to ever fade, however tough the circumstances could be.

These boys end up at the nearest Catholic Church playground, St Bernadette, which offers ping pong, volleyball, football, marimba, traditional dance, choral music as a way to lure and fashion young people into responsible adults. As fate would have it, most of them in a short space of time are welcomed by this writer into the service of the Altar. And that marks the beginning of instances where Goddy, as he was affectionately known, started running to things that other people run away from.

Soon as he was oiled enough to know right from wrong as a young catholic, Goddy applied to study while staying at the St Charles Lwanga Minor Seminary in Kgale, a strict boarding facility where boys test themselves on whether they can or cannot undertake the vocation of a celibate priesthood. For context 'sake, in secular discussions the moment you mention the word celibate to young people, they immediately disengage. Now picture a cute little boy, between the ages of 17-19 attempting to experiment a life of chastity, prayer and studies only. And test the life he did, through commitment throughout his three years of secondary education. The results of the three year experiment are seldom discussed immediately as is tradition, and this is often where the desire falls within the cracks. We witnessed a nonchalant Godfrey whenever priesthood was discussed.

He would later transition to Durban Institute of Technology where he studied Fine Arts, a key turning point that would blossom exponentially into the Goddy that we have known as an impactful photojournalist. As a representative of the G-West Kasi in Durban, boys would organize trips to go see the Indian Ocean with full knowledge that a host with the most will ensure their excursion is blissful. Experiential as he was, he chanced on being a broker in car trading transporting grey imports from Durban to Botswana, a market that was booming at the time. Occasionally when he touched down, having locked a sale we

would all gather around him as bees would to a sweet nectar in what we had termed "go ja madi a ga Satara."

Goddy was everything to everyone, evergreen, a man for all seasons who would laugh as much as he breathed and loved as long as he lived. His contagious energies would diffuse whatever tension he found in a room. I still do not believe I'm referring to him in the past tense but at least you and I know that when someone you love becomes a memory, the memory then becomes a treasure.

In his subsequent attempt to be the next Satara, he trialed small scale pig farming upon graduation, quite a stark digression from what he had studied. Unapologetically he would say to everyone who could hear that

money knows no origin. And boy did we enjoy 'eating' the proceeds of pig farming. The only challenge with pig farming though was the obvious one; pigs kind of love a filthy sty. For the clean polished boy that he was, it really presented a challenge. Hiring an extra farm worker would skyrocket the wage bill, so he eventually opted for a job in Lehutshelo CJSS in Hukuntsi as an Art Teacher and abandoned the farming enterprise.

Little did we all know that Hukuntsi would turn out to be his most favorite place in Botswana, of course save for Thamaga where his mother lived. His stay in 'Four Huks' as he called the place, demonstrated that family is not only defined by genes, but also built and maintained through love. The friendship that he

made then, has now matured into a tight brotherhood support system. The Boys' trips actually are mostly coordinated from the Hukuntsi side of brotherhood led by close confidante Kagiso Moapare casually referred to as Buruboy.

Under three years of his stay in Hukuntsi, he applied for the position of a Photojournalist with the Botswana Press Agency (BOPA) and in a short space of time was invited for an interview at the Ministry headquarters (Old Radio Botswana premises). So we scheduled a coaching session a day prior as he claimed to have never attended an in person job interview. Goddy arrived in the company of an unknown gentleman at the time, hilarious in speech, notorious in trying to solve problems, unstructured in approach, just chaotic by presence. And throughout the coaching session, this guy would intrude with outrageous responses much to the chagrin of his candidate friend. Nonetheless we believed the session went well, wrapped up and chilled for relaxation. So this naughty guy bursts, suggesting to us that in his view our academic approach was bound to misfire. He instead said he had contacts of a traditional doctor in Mogoditshane who could unlock all obstacles that could present themselves and even give Goddy the best English diction one could ever imagine. We dismissed him, laughed it off and went on with our business. If you were close to Goddy you would have guessed who that could be, yes, Jomo Mantu, his bossom friend casually called Jouleke.

As fate would have it, Goddy got employed sometime in 2007, being among the first group of newsroom-

ready Photojournalists for the Daily News. Among that crop were committed and dedicated graduates including Gaseitsewe Moruakgomo, Phenyo Moalosi, Michael Joseph and later Tshoganetso Mokowe who continue to bring life to us through

Since that time until his untimely demise, Godfrey has been synonymous with carrying a camera which had become a mouthpiece that gave him a voice in a very noisy world

He truly believed that a journalist who does not carry a camera is like a warrior who does not carry a sword. And like a true warrior he always went to war with his camera, his true signature being action photography. In one of his training sessions to Freelance Reporters, one still vividly remembers him cautioning them to 'look and think before opening the shutter.' The heart and mind are the true lens of a camera, he would say.

His bright trajectory in BOPA Photo section has been visible to all. His fingerprints are in almost all the photography awards locally and regionally, SADC Media Awards being the epitome of his brilliance. Informally he has almost patented the Botswana National Sports Commission (BNSC) Awards which he has won every time he made a submission. He covered the 2010 World Cup in South Africa, whereupon we had to navigate a number of administrative challenges occasioned by uptight civil service policies and procedures to enable his successful assignment.

Committed as he was to journalism though, Goddy was quite unstructured to fully fly in an administration-centric organisation, he really did his best to comply but the rigid hierarchical design of the civil service was miles away from his imagination of a well-functioning news organisation. The only deadline he was religious to, was the production deadline. The rest which involved overtime reconciliation, trip retirement processes etcetera, truth be told he was tardy on those.

Funny guy he was, and with a funny lot he closely associated. Accounts remain uncountable of the multiple times he has been on the face of danger with colleague Kesentse Ketumile, how he has survived assaults alongside Duncan Kgangkenna owing to their notoriety, the untold stories of a Mozambique trip that involved him, Baleseng Batlotleng and now legislator Boniface Mabeo.

And all this tells us that what we have once enjoyed we can never lose because all that we love deeply becomes a part of us. Goddy was such a jolly good fellow, oops Goodfellow is actually his little brother, they really do not fall far from their trees these apples.

Goddy was married to his post varsity era sweetheart, Nametso Mpuse, a lady we grew up with back at St Joesph's, with whom they have three boys called Ditawana by their dearest father. If all our memories could at least build a staircase, mortal as we are I reckon we would walk right up to heaven and bring him here again. For the simple reason that whenever a journalist dies, public debate loses a voice. With lumps on our throats, we nonetheless find solace that Goddy's powerful master has given leave to his servant to go in peace according to their covenant signed on his baptism day, circa 1994. Rest in peace my Brother. **BOPA**

## Mpuse legacy lives on

Dr Seretse Khama lan Khama, President Dr Mokgweetsi Masisi and President Advocate Duma Boko. His work carried him across the breadth and length of Botswana and abroad, often accompanying Presidents as he documented occasions of national significance. Ms Mpuse said he was never interested in physical brawls or fighting, more so that the mother was always there to protect him.

His uncle, Mr Seakgano Moarabi described Godfrey as a friendly person.

"We worked together to put forth a memorable wedding just as he wanted it to be," she said.

Ms Ramphana said Godfrey was a visionary, a man who wanted to leave inheritance for his children.

She added that he was a generous person and would go all out to assist his siblings.

Ms Ramphana said the death of her nephew had left wound in their hearts that would take time heal

Another family member, Mr Shosha Leso described Godfrey as a visionary, the man one would find comfort, who also worked with eager to see developments happening in their community.

He concurred with other speakers that Godfrey was helpful to many people in the community and his presence would be missed by his family, friends and the nation.

His niece, Ms Marea Mpuse described him as a caring and loving person.

She said her uncle was unifier, with the demeanor that attracted many to associate with and get comfort in gatherings where he was present, a man who wanted people happy all the time, a leader of repute and orderliness.

Ms Mpuse said they would forever miss his cheerfulness, compassion, care and love. **BOPA**



The site is approximately 9.932 km from the main Kgotla of Dinokwe village The overall area (footprint) for the proposed quarry-stone measures approximately 200.79 km2. as per approved Prospecting Licence NO 0128/2023. Industrial minerals extraction is estimated to last for 42 years with probabilities of extension.

#### (ii) Rationale for the project

The material will be used for commercial (construction) purposes and supplied to the residents and other nearby villages for construction purposes.

#### (iii) Location of the Activity

The proposed project is located in Malegare Lands near Dinokwe Village, in the Mahalapye Sub-District. The site is approximately 9.932 km from the main Kgotla of Dinokwe village

### (iv) Anticipated Environmental impacts of the Activity and proposed mitigation measures to respond to the negative environmental impact

# Thagale carves space in arts industry

MAUN - In a world where young people are often encouraged to choose predictable career paths, 34-year-old Karabo 'Silver Creatif' Tlhagale of Maun has taken a different route, one shaped by passion, sharpened by resilience, and sustained by a refusal to abandon the creative voice within him.

Today, Tlhagale is widely regarded as one of the most consistent photographers and videographers in Ngamiland's creative space, known for his distinct visual style and steady presence at weddings, in documentaries, adverts and lifestyle projects.

But his journey into the arts was neither glamorous nor clearcut. It began, he said with instinct rather than strategy.

"I did not enter photography because I knew it could make me money. I entered because it made sense to my heart, even when it didn't make sense to my pockets," he recalled.

His defining moment arrived more than a decade ago when a friend invited him to a small documentary screening about skateboarding.

It was not the subject matter that struck him rather it was the

"I remember thinking: who created this? I asked my friend who proudly confirmed that he was the creative behind the masterpiece and I was captivated and inspired," he said.

Something shifted that day and by 2014, driven by curiosity and a growing desire to learn the art properly, he enrolled at Limkokwing University to formalise his training.

"School helped me understand the technical side, but passion is what kept me going when everything else got hard," he said.

Behind the polished images and creative acclaim lies a world of uncertainty and struggle that many outside the industry rarely see. Like many creatives, he has battled inconsistent income and the persistent challenge of underpayment.

Clients, he said often demanded high-quality work but hesitated to pay its value.

While some creatives leave the industry out of frustration, he has learned to survive its unpredictability with discipline and humility.

"You cannot sit home waiting for gigs. You must be moving, learning, working and staying alive long enough for your breakthrough to find you," he said.

It is this mindset that has kept him relevant for more than a decade.

His visual style, moody, crisp, storytelling in its composition has become his signature.

Asked how he has remained visible in an industry where many fade within a few years, he said: "Consistency and humility. You treat every small job like it is the biggest opportunity of your life."

Thagale remembers shooting earlier events for little pay, simply to build a name.

"Reputation in this artwork is very important and for one to be recognised there is need to unveil talents to the people," he said.

His advice to aspiring photographers and videographers is rooted in passion rather than glamour.

"Enter this industry with passion first and not desperation, not the desire to trend, if your motivation is money alone, disappointment will come fast," he said.

He encouraged young creatives to keep learning and sharpening their craft.

"Skill grows only when you push it, your camera should feel like an extension of your hand," he said. Among his proudest achievements is a music video he shot for his brother, work he continues to reference when measuring his artistic growth.

In a country where the creative industry is still developing, where funding is limited and opportunities unevenly distributed, maintaining momentum is itself a remarkable feat. Yet, Tlhagale is not done.

"I want to build something that outlives me, perhaps a training centre, a space where young creatives can access equipment, mentorship and opportunities," he said.

Tlhagale's story is more than a creative journey. It is a testament to the courage required to choose passion in a world that often treats the arts as optional and to remain committed even when the road is steep. **BOPA**

## Yang basks in National Games glory

GUANGZHOU - A year after a swift exit from the 2024 Paris Olympics, Chinese fencer Yang Hengyu stood atop the podium at the National Games, a gold medal around her neck and a wave of hard-earned peace washing over her.

For Yang, the path to her maiden National Games individual title was paved not just with physical strain, but with a victory over the inner demons of self-doubt and anxiety that have long shadowed her career.

"I did not expect this result," Yang admitted after her 15-13 victory over Jiangsu teammate Fu Ying on Sunday.

"Compared to the previous two National Games, I think I was much calmer this time."

At Paris 2024, where she was the sole Chinese representative in the women's sabre individual event, her campaign ended in the round of 32 with a 15-9 defeat.

The sting of that loss was familiar, but the context was different from her first Olympic experience in Tokyo in 2021.

"The last time, because the team went together, and it was my first time, I was more nervous," Yang had reflected before Paris.

"But now it is the second time, and our team did not qualify, so I will go by myself. I feel more relaxed, with no burdens. I think I will just need to do my best."

Doing her best has always been a complex battle for Yang, who describes herself as 'contradictory'.

Her career is about managing not just the physical toll of a combat sport, but a relentless cycle of inner turmoil.

"I am the type of athlete who needs to train a lot to perform well," she admitted.

A two-month break earlier in 2024 left her 'a little lost' and subsequent competitions did not go as planned. Her mind, she said, was a constant whirlwind of analysis and self-critique.

"I really think a lot. Every day, I keep repeating, 'Why am I like this?

Why didnt I perform well in the competition? Why did I perform well this time?" she

explained. "It's a bit of inner consumption."

This 'inner consumption' was exacerbated by a body bearing the marks of her profession. She listed a catalog of ailments: worn cartilage in her knees, a recurring back issue, and wrist pain.

"These are all long-term strains," she said.

"There's no way to cure it. As long as you train, it will always be there, it will always follow me."

The low point came after the Tokyo Olympics, where she had a breakout personal performance by upsetting world No. 1 Olga Kharlan of Ukraine, a result she called 'an unexpected surprise'.

The high, though, was short-lived

"It actually gave me a lot of confidence," she said of the Tokyo win.

"But then I came back and competed in the National Games, and it was not ideal, which instantly dampened my spirits. So my emotions are very complex, always fluctuating."

"So it is quite similar to my experiences these past few years, always up and down," she added. The pressure to win once paralyzed her. "There was a period when I was especially afraid of losing, and I was extremely tense. You can't execute anything you do in normal training.

It feels like your body is restrained, you can't even move.

Then your opponent can very easily take you down."

Her coping mechanisms are as multifaceted as her personality. She finds solace in music, especially rock, and the catharsis of live concerts.

"I get really excited at live shows. I feel much more relaxed afterward." She also turns to what she calls "cynical motivational quotes" online that offer temporary relief.

A significant shift came from an unexpected source: literature, particularly Shi Tiesheng's works.

Shi was a renowned Chinese essayist and novelist who, after being paralyzed at age 21 after an accident, produced profound works reflecting on life, suffering and human resilience from the confines of his wheelchair. "I thought, someone who has already suffered so much can still write such beautiful words.

I found it very inspiring. I thought, why should I be afraid?

What comparison is there between me losing a match and what he went through?" This perspective sparked a form of self-acceptance.

"I told myself, don't be afraid to lose. If you're destined to lose, you might as well be brave and express what you want to express through your fencing.

If you lose, you lose. After that, it actually got better."

"I started choosing to forgive myself," she said of her post-Olympics mindset that fueled her at the National Games.

"It felt like I sealed away the memories of the Olympics. I still don't have the courage to rewatch the videos. It took about three months to recover." *Xinhua*

## Playgrounds boost development in Maun

MAUN - Three Maun primary schools, Kubung, Moremi III Memorial and Boyei Primary have received new fully equipped playgrounds under the ongoing Project 40/40 Playgrounds initiative, a legacy project by Love Botswana Outreach Mission and project Playground aimed at advancing holistic childhood development through safe, engaging play spaces.

Co-founder and CEO of Love Botswana, Jana Lackey said the initiative represented a longterm investment in strengthening learning environments across the North West and Okavango regions

She explained that the project sought to install 40 playgrounds in primary schools as part of a broader mission to enhance children's growth beyond the classroom.

"This project is designed to nurture children's overall development by creating spaces that encourage physical activity, teamwork and social growth," she said.

Lackey also highlighted the organisation's ongoing partnership with the Ministry of Basic Education and Child Welfare under the Metro World Child programme, which complements the playground installations.

"We have signed a Memorandum of Understanding with the Ministry of Child Welfare and Basic Education, and through this partnership under the Metro World Child programme, our team spends 45 minutes in primary schools engaging with learners to instil essential life skills," she said.

Love Botswana's Field Team lead under the Metro World Child programme, Maokaneng Modisaemang emphasised that the playgrounds were a product of strong community partnerships and shared vision.

"Meaningful relationships between schools, NGOs and development partners are key to improving children's wellbeing," she said.

School heads from the three beneficiary institutions echoed the importance of play in supporting learning, emotional balance and social development, areas often overshadowed by academic expectations.

Kubung Primary School head, Grace Molapisi said the playground would significantly improve learners' emotional and mental wellness, ultimately enhancing academic performance.

"A happy child performs better academically, and this playground will give our learners the space to release energy, interact freely and regain focus," she said.

Moremi III Memorial School head, Ngonda Setlhare described the donation as a necessary investment in well-rounded education.

She noted that while some learners excelled academically, others thrived in expressive and physical environments, making playgrounds essential in nurturing balanced development.

She also said the programme supported the emotional, physical and psychosocial growth of learners, giving them opportunities to develop confidence and creativity.

Representing Boyei Primary School, Oleta Gaorere said the playgrounds were a catalyst for personal growth, helping children build essential life skills.

"These facilities shape character, and they help children learn teamwork, courage and problem-solving through play," she said. *BOPA*

A total of 149 international matches, including 74 friendlies,


have been contested during the period as Argentina, France and England kept their places from second to fourth in the rankings, respectively.
