Atamelang urges staff to remain focused

KANG - Employees of the Ministry of Transport and Infrastructure have been encouraged to remain committed to their work despite the ongoing financial constraints affecting government operations.

Speaking during consultative engagements with the ministry staff in Kang on Monday, Assistant Minister of Transport and Infrastructure Mr Keoagile Atamelang acknowledged the difficult fiscal environment but

reassured the employees that government was working actively to address the situation.

"We are doing everything we can to stabilise the finances. Your continued dedication, even during these tough times, is both appreciated and essential," he said.

The assistant minister further noted that one of the key objectives of his tour was to identify gaps in the current planning process ahead of the public rollout of the upcoming National Development Plan (NDP).

"Before the NDP is implemented, it is important that we address any shortcomings and ensure the planning is thorough and inclusive," he stated.

Mr Atamelang applauded the staff for their resilience and commendable performance under the challenging circumstances.

"Your dedication does not go unnoticed.

Keep up the good work, and know that better days are ahead," he concluded.

As part of his nationwide infrastructure assessment, Mr Atamelang also toured key gravel roads connecting settlements such as Zutshwa, Monong, Maake, and Ukhwi in an effort to gather first-hand information about infrastructure needs in the area.

For her part, senior human resources manager from the ministry, Ms Lebang Lerothodi, echoed the minister's sentiments and issued a strong warning against corruption.

Ms Lerothodi advised that corruption did not only damage the nation, but that it also affects families hence the need for members of staff to uphold integrity in the execution of their duties.

Officers took the opportunity to voice their grievances over ongoing challenges affecting their daily work life.

Amongst the key concerns raised were prolonged overstays, poor management, unpaid or excessive overtime, and inadequate accommodation arrangements.

Employees described the situation as unsustainable, noting that such issues have negatively impacted morale and productivity within their departments.

A ministry employee, Mr Othusitse Hamate said while they were committed to serving the country, they felt they were being stretched beyond reasonable limits as most of them had overstayed in the district.

"Some of us have been here far longer than our assigned rotations without proper support or clarity," Mr Hamate said.

The issue of poor management and communication was highlighted as a recurring problem, with staff calling for improved leadership, transparency in deployment procedures, and better planning to avoid extended field postings without relief.

Accommodation was also cited as a serious concern, with reports of substandard living conditions and lack of proper support for employees stationed in remote areas. **BOPA**

Residents demand review of law

SEDIBENG- Residents of Sedibeng and Phitshane Molopo have urged their area MP, Dr Edwin Dikoloti to advocate for the review of section 37 of the customary law.

Residents argued that under that section, perpetrators were free to demand where they could be tried, noting culprits always demanded to be taken to court.

They gave example of stock theft cases, which took long for culprits to be convicted.

Residents claimed, in kgotla meetings recently, that in the process, culprits ended up being given bail and continued reigning terror in the community.

In his welcoming remarks, Kgosi Brown Keogotsitse of Sedibeng reiterated lamentations of Phitshane Molopo residents that time was now for government to review the act. He asserted that if left unchecked, perpetrators would continue with their bad deeds as the laws seemed to be giving them preference over victims. Responding to resident's grievances, Dr Dikoloti who is also the acting Minister of Lands and Agriculture, said he would consult with relevant authorities and present the issue to them for consideration.

He also said that he was worried about the escalating number of stock theft cases because they impoverish Batswana.

Earlier, Kgosi Keogotsitse also told the MP that they needed staff houses for nurses in their village.

He pointed out that without proper accommodation, civil servants were not able to deliver to the best of their ability.

He urged Dr Dikoloti to look into the issue when the economy recovered. *BOPA*



Ministry opts for direct purchase of medicine

FRANCISTOWN

Government has taken steps to tackle present challenges facing the Ministry of Health.

Addressing the community of Somerset East on Wednesday, Francistown South MP, Mr Wynter Mmolotsi said a decision was taken to allow the ministry to directly purchase medicines from manufacturers, eliminating the use of agents.

"The use of agents in purchasing of medicines was more expensive. We want to buy directly, which means we can save up to 70 per cent of the budget," he said

Mr Mmolotsi who is also the Minister of Environment and Tourism said government had reached a decision to set up a pharmaceutical within the country.

Additionally, he said as part of ongoing interventions to rescue the health crisis, the Vice President, Mr Ndaba Gaolathe was currently on an official visit in Japan to engage more on majors to address drugs shortage.

The Francistown South MP remained hopeful that with time, given the ongoing interventions, the situation would normalise.

Meanwhile,

Somerset East commended their MP for giving them timely updates from Parliament. However some issues of concern emanated from the meeting.

Mr Sani Mojeremani was concerned by increasing unemployment rate in the city. He urged Mr Mmolotsi to advocate for re-opening of Botswana Meat Commission abattoir in Francistown which he said used to hire a good number of people.

Thabo Ramontsho, echoed the same sentiments that unemployment especially on graduate youth was a serious concern in need of urgent interventions.

Ms Maipelo Mabutho, pleaded with MP Mmolotsi to take cognisance of the illiterate at an era where advancement and use of technology was the norm.

Even though appreciated, she said such developments could somehow hinder those who did not know much about technology to miss on opportunities and other new developments.

Mr Mmolotsi assured residents that despite ongoing economic challenges government taking all possible measures to introduce interventions aimed at lessening the impact of financial

Government strengthens GBV response

GABORONE - Amid the growing incidence of violent crimes against women, government is committed to strengthening its national response to gender-based violence.

The vice chairperson of the National Gender Commission, Dr Morena Rankopo said Wednesday, during the launch of the intimate partner violence stigma and help seeking behaviour study findings.

He explained that the country had frameworks such as the National Gender and Development Policy and the National Strategy Towards Ending Gender-Based Violence.

"But we know that strategies are only as effective as the partnerships and actions that bring them to life. This is where your role, as stakeholders from government, civil society, academia, faith-based organisations, traditional leaders, and development partners, comes in," he said.

Dr Rankopo also appreciated the role of the University of Botswana and Botswana Gender Based Violence Prevention and Support Centre in conducting the study.

"Let us remember, behind every statistic on intimate partner violence is a woman, a man, a child, a family, real lives disrupted, sometimes loss, because stigma and silence stood in the way of protection," he added.

He said the overarching responsibility was to ensure that survivors did not feel alone, fear speaking out, and fid system ready to support them with dignity, respect and justice.

Dr Rankopo further said stigma could be dismantled, violence reduced if stakeholders and community work together, and when response was bold, evidencebased and inclusive.

University of Botswana(UB) Deputy Vice Chancellor for Research and Innovation, Professor Doreen Ramogala-Masire stated that one in every three women experience some form of intimate partner violence in their lifetime, adding that such was a major challenge faced by families and communities.

Prof Ramogala-Masire said the study aimed to explore the health-seeking behaviour of women who had experienced intimate partner violence and to develop, validate, and test a measure of culturally salient intimate partner violence stigma as a deterrent to intimate partner violence self-help seeking behaviour among women.

Noting that the study was led by academic community partnership between the UB and Botswana gender-based Violence Prevention and Support Centre, a leading support service in Botswana for those affected by gender-based violence.

She said it was exemplary of the priorities of the UB to advance high-quality, socially impactful scholarly research that was consequential to society and contributed to the upliftment of the nation and the region.

She said university's strategy of 2020-2030 had put intensification of research at the centre of the strategy in a way to answer to the 2030-36 vision of the nation, which looked at making Botswana a knowledge-based society and economy, and a socially impactful economy as well.

The study among others found that women in intimate partner violence survivors who endorse such are likely to experience more intense forms of anticipated, enacted and internalised intimate partner stigma, while others who endorse are more likely to have contemplated or attempted suicide or less likely to disclose their abuse to someone. *BOPA*

Group mulls peaceful demonstration

MAUN - Despite efforts by North West district leadership to intervene, members of Okavango Kopano Mokoro Community Trust (OKMCT) are mulling a peaceful demonstration against the hosting of the third edition of the Tapyowa NG 32 Experience initiative billed for Saturday at Xaxaba in the Okavango Delta.

Organised by OKMCT, the annual initiative is a cultural tourism aimed to celebrate the diverse multi-ethnic groups found in NG 32 concession.

The event brings together communities from villages affiliating to the trust to participate in mokoro race and it is also characterised by activities such as storytelling, cultural activities and games among others.

The concerned group call for cancellation of the event this year saying it did not benefit the large community from all villages affiliated to the trust.

They threatened to protest in a peaceful demonstration if the trust proceeded with the event.

In an interview, vice chairperson of the concerned group, Mr Tlotlo Baganeletso said following an arbitration meeting by North West district commissioner, Mr Thabang Waloka on Tuesday at Botswana Wildlife Training Institute to address burning issues between the trust and concerned group.

He said the meeting was convened after they wrote to the district commissioner's office demanding explanation on the said initiative and its significance as well as demanding the board of trustees to account for the event stating that they had noted that a significant amount of money was spent in organising and hosting the cultural tourism event.

The concerned group also wanted to know who approved the budget for such activity since the annual general meeting had

not been convened. community could approve the budget and they also pleaded appraisal on actual amount to be spent on the event.

They also argued that the trust was complaining about insufficient budget, which resulted in some projects suspended for the current financial year and questioned where the money for event would be sourced.

"I do appreciated efforts by the district commissioner to convene the meeting but we are not convinced with the advice and if the trust proceed with the event, we will do all in our power to distract it because it does not generate revenue for the trust and it uses a lot from our coffers," he added.

While he appreciated the significance purpose of the activity, Mr Waloka advised board of trustees to prioritise the interests of the community noting that they should revisit the issues at hand.

"I am not taking decision for the board, but I can advise them to consider proceeding with the event provided they have sponsors but if it is digging a lot of money from the trust coffers, then it should stop. As the trust, you should put your priorities right and ensure provision of potable water first," he added.

Although, Mr Waloka appreciated that the event attracted a lot of attention from both locally and internationally adding that it also has the potential to diversify the tourism product through cultural and sport tourism and provide the travellers with a variety of experience.

He wished the trust could design attractive initiative in a manner that it could generates more income to diversify the trust's revenue streams.

However, he urged the community to work as a unit noting that they should appreciate that government had granted them NG32 to operate tourism activities and reap benefits.

As such, he said they could achieve that through teamwork and cooperation. He also vowed to consult communities from all the six villages affiliated to the trust to appreciate the cause of the division within the trust and address the standoff amicably. On the other hand, the trust leadership maintained that Tapoywa event would proceed as planned.

Ms Boitumelo Samoxhosa said preparations were on track as the community approved the event during the recent kgotla meetings. She argued that only the community could cancel the event not a concerned group adding that the event would have been held in June but delayed due to some cases before the court.

The trust general manager, Mr Seikaneng Moepedi also concurred that they would continue with the event saying thy had secured funds from some of their partners.

The trust, he said has some joint venture partnerships with several companies that conduct photographic tourism in the area. **ROPA**

Court remands two pending ruling

FRANCISTOWN - Principal Magistrate Thapelo Buang of Francistown Magistrate's Court has remanded in custody a murder accused mother and daughter, Ruth and Onalenna Fana pending a ruling on their bail application.

The two appeared before court for bail application on Tuesday.

Magistrate Buang, who extended their remand to September 25 when they will make their next appearance, also ordered that the brother to the first accused appear before court in the next mention for the court to further enquire from him.

The two accused persons applied for bail, with the second accused,

Onalenna advancing the possible lack of accommodation for her children as one of her reasons.

She said her children had been accommodated by one teacher and that she was worried that when the school term ended they would no longer have a place to stay.

Further, she said the other child was unwell and therefore needed her care.

Ruth, a teacher at Mpiti Primary School who is the daughter to the deceased and Onalenna who is the granddaughter to the deceased are accused of killing their mother and grandmother, Elicah Fana who was found dead on June 9.

The two were arrested on June 24 following a police breakthrough. *BOPA*

School head condemns rising violence among learners

MAUN - An alarming rise of violent behaviour among school children has sparked concern in Matlapana in Maun, with educators urging parents to take a more active role in shaping their children's discipline and

Speaking during a recent community engagement, Sexaxa Primary School head, Ms Keabonye Maoto expressed concern over the increasing number of physical altercations among learners, citing a an incident where a fight between two pupils escalated to one stabbing the other with a pen on the shoulder.

"That's no longer just a fight rather this is attempted murder. Children must be taught that violence is not the solution as these acts can lead to lifethreatening injuries," she said.

She stressed that parents needed to be more involved in instilling discipline and guiding their children at home.

"If we do not correct them at home, they will come to school and harm others hence the need to teach our children to resolve conflicts peacefully," she said.

Ms Maoto also condemned a trend where some parents, upon learning that their child had been hurt or bullied, resorted to attacking the bullying child.

"Instead of reporting to school authorities or speaking to the other child's parent, some adults are taking justice into their own hands by beating someone else's child and that's not the way," she

She appealed to parents to model respectful conflict resolution and to work closely with schools in addressing such issues legally and constructively.

For his part, Kgosi Tapologo Mosika of Matlapana Ward shared the school head's sentiments, particularly around the rise in gender-based violence and emotional abuse in the home.

"We are seeing more cases of verbal abuse, especially women insulting men. These fights often end in violence or even death hence when things get heated, step away and let emotions cool before sitting down to talk," he

Kgosi Mosika encouraged residents to turn to church, saying it offered spiritual guidance, peace and healing.

"We need to find our way back to God because He is our Redeemer and through Him, we find peace and learn how to live with one another," he said.

He also raised concerns about noise pollution and urged people to respect quiet hours during the night.

Furthermore, he addressed growing waste management issues, especially the improper disposal of diapers and the burning of waste, which posed health risks. BOPA

Lawyer accuses state of delay tactics

GABORONE - A lawyer representing, Bantshuti Nkgarapi, who is charged with murdering a University of Botswana employee in June, Mr Tiroyaone Sedimo has accused the state of using tactics to prolong his client's remand.

He made the accusations when appearing before Chief Magistrate Chief Ms Kamogelo Mmesi of Extension II Magistrate Court on Monday.

"The contentious conduct of the state is deliberate and purposeful to ensure the accused is remanded in custody," Mr Sedimo said.

"It is a covert approach to perpetuate the remand of the accused," he argued in court after the state indicated that the accused had not undergone psychiatric assessment as ordered by the court during the last sitting.

The state counsel. Mr Michael Mookantsa, had informed court that the accused was booked for assessment on August 21, hence he had not been assessed had the court had ordered. However, Mr Sedimo expressed apprehension about the state's statement, arguing that the state was in contempt of the court

He said the accused was rushed to Sbrana Psychiatric Hospital the previous week after he inquired about when he would be taken for assessment as per the court order. "The doctors, I am told, made it clear that the assessment cannot be taken hastily; it takes a minimum of a week," he said.

He added that the state should be cautioned for delaying in presenting his client for assessment as per the court order.

Additionally, Mr Sedimo requested court to grant the accused's family access to the farm in Mokatse, where he kept his livestock.

He said the farm was co-owned by the deceased and the accused, and the deceased's family had been denying the accused's family access to the farm to provide care for the livestock.

However, the Magistrate advised the attorney to make a miscellaneous application to offer the deceased's family an opportunity to respond.

Nkgarapi is alleged to have murdered one Bogadi Mokganelwa at the University of Botswana, where she was employed, by stabbing him with a sharp instrument. He is set to appear for status hearing on September 3. BOPA

Court grants 16 Letlhakane male learners bail

Magistrate Atlanang Manchwe of Letlhakane Magistrate Court has granted bail to the 16 Letlhakane Senior Secondary school male learners accused of assaulting another pupil of the same school. Conditions of the bail were that parents for each learner bind themselves with P1 500 and that the pupils should report to Letlhakane Police station every Friday during school holidays and to the school head every Friday when schools are open.

Meanwhile, the victim is said to be recuperating from home and attending scheduled medical checkups.

In another matter, Senior Magistrate Manchwe has sentenced Emmanuel Mothobi

(39) to a 15-year imprisonment for possession of Methcathinone, LETLHAKANE - Senior an illicit drug popularly known as Cat weighing 150 grams.

He was charged in February 2024 for unlawful possession of illicit substances contrary to section 4 of the Illicit Traffic in Narcotic Drugs and Psychotropic Substance Act, 2018 of the laws of Botswana.

She said the offence carried a minimum sentence of 15 years imprisonment or P1 million charge. She therefore said she had found no exceptional extenuating circumstances in the matter hence the 15-year jail term.

In his mitigation, the accused had indicated that he was a breadwinner, taking care of his mother and children, and also that his partner was heavily pregnant. **BOPA**

China supports companies innovation drive

BEIJING - China's private companies are spearheading breakthrough innovations across various key sectors, supported by favourable government policies that encourage entrepreneurship and unleash market vitality in technological advancement.

The latest data shows that the private sector has emerged as a key driving force behind China's technological development, with private firms accounting for over 92 per cent of the country's high-tech companies since the beginning of the 14th Five-Year Plan period (2021-2025), according to the National Development and Reform Commission (NDRC).

In recent years, Wuhu Churui Intelligent Technology Co., Ltd. has dedicated itself to developing high-performance AI computing batteries.

The tech company, based in Anhui Province one of China's fastest-rising tech powerhouses, has secured a solid footing in the global power battery supply chain.

According to Zhang Huai, president of the company, its rapid development results from the deep integration of industry, universities and research institutes.

"We have worked with several universities to build joint laboratories, and as an outcome of the collaboration, many of our technologies have reached globally leading levels," Zhang said.

This success story exemplifies how China's evolving policy framework enables private enterprises to thrive.

The enterprise-led collaboration between industry, universities and research institutes represents one of the key policy measures outlined by this year's government work report to help businesses advance technological innovation.

Over the past years, the government has implemented multifaceted policies that foster a favorable environment for private firms to flourish.

A landmark development came in May this year, when China officially put into effect a historic private economy promotion law, which provides legal guarantees for enterprises to promote innovation.

Notably, the law stipulates that support should be provided for the private sector to play an active role in advancing science and technological innovation, fostering new quality productive forces, and building a modern industrial system

Furthermore, eligible private firms should be supported to lead China's major technological breakthroughs, while the country's key scientific and technological infrastructure should be made accessible to private companies, according to the law.

Beyond legislative support for private companies' growth, the country has rolled out heavyweight policies to alleviate corporate burdens. From 2021 to the first half of 2025, China has implemented a total US\$1.4 trillion in tax and fee cuts, with 72.9 per cent benefiting taxpayers in the private sector.

The government has also enforced a nationwide unified negative list system for market access and continuously reduced the number of items on the list. These comprehensive measures are yielding measurable results, with recent indicators showing that China's corporate innovation vitality has strengthened, while new quality productive forces have continued to grow.

In July, the Purchasing Managers' Index for the equipment manufacturing and high-tech

manufacturing sectors stood at 50.3 per cent and 50.6 per cent, respectively, with both remaining within the expansion zone.

The high-end equipment manufacturing sector also maintained its expansion momentum.

In recent years, China's financial system has made continued efforts to expand financing access for private companies, including those committed to technological innovation.

The outcomes have been remarkable, with official data showing that outstanding inclusive loans for small and micro enterprises surged from 15.1 trillion yuan at the end of 2020 to 35.6 trillion yuan by the end of June 2025.

Building on this foundation, China has introduced innovative financing mechanisms to further diversify funding channels.

A key move was the introduction of a sci-tech board in its bond market in May, which aims to better cater to the financing needs of technology firms. Since its launch, the new platform has attracted a wide range of participants, with 288 entities issuing approximately 600 billion yuan in technological innovation bonds by the end of June.

A prime example is China's leading AI company iFlytek, which successfully issued 800 million yuan technological innovation bonds with a coupon rate of 1.83 per cent.

"We will spend the majority of the funds we raise on technological research, development and application," an iFlytek spokesperson said. Currently, 63 per cent of China's A-share listed companies are private enterprises. Xinhua

Domestic water bills cripple WUC

JWANENG - Water Utilities Corporation (WUC), Kanye Service Centre is choking with a close to P58 million domestic water debt.

The centre covers Kanye, Moshupa, Jwaneng, Mabutsane and their catchment areas.

Speaking at the stakeholder engagement in Jwaneng on Wednesday, the General Manager, Mr Monametsi Ramosu said domestic customers' debt amounted to P33 million, followed by government with P13 million, businesses at P6 million and P5.8 million for local authorities.

Mr Ramosu said efforts to recover debt included revised tariffs, which commenced in April, as well as the just-ended debt amnesty.

"The debt amnesty was intended to encourage customers to pay their bills in order for the corporation to continue providing and improving services. Even though a lot of people benefited from this initiative, there are still calls to redo it," he said.

He appealed to stakeholders to encourage the community to conserve water and pay their water bills on time to avoid disruption of

He urged them to visit the nearest offices for clarity on the billing system and any queries related to water consumption.

"As community leaders you are our strategic partners in mobilising the communities to pay their bills and also conserve water at all times," he noted.

While he acknowledged water shortage in some areas, Mr Ramosu said WUC were concerned about mismanagement and use of domestic water for farming purposes.

Regarding waste water services, he said blockages and old infrastructure were some of the factors hindering effective waste water works in the area.


Mr Ramosu noted that WUC was currently undertaking two projects intended to improve waste water services, to cater for the growing demand experienced particularly around Jwaneng/Sese areas.

He however noted that the long term plan was to have a Jwaneng Water Master Plan to address the challenges.

WUC Lead Engineer for the Jwaneng Cluster, Mr Kagiso Lobeko cited declining borehole yields, illegal connections, vandalism and cable theft, old infrastructure and pipe blockages by lime as some of the challenges experienced in the area.

Mr Lobeko said the cluster covered nine villages with close to 50 boreholes. He said the waste water infrastructure was old and not properly designed, resulting in inefficient service delivery.

"The Jwaneng waste water network was built in 1982 and it has a total of 61 pump stations, which is a big number for a small area like this one," he said. **BOPA**



BrainSTREAM hosts successful camp

GABORONE - Botswana's BrainSTREAM Institute of Technology team has just returned from a Robotics & Coding Holiday Camp in South Africa where they hosted more than 200 learners from over 100 schools.

The initiative introduced children aged 6-14 years to robotics, coding, artificial intelligence, animation and drone technology.

Head of Education at BrainSTREAM, Mr Mohit Lohani, said the camps were more than just technology lessons.

"This is not just about teaching technology, it is about nurturing curiosity, creativity and critical thinking. We want every child to feel they can be an inventor, a coder or a problem solver," he said.

He noted that interest generated in Durban was overwhelming that a second camp had to be scheduled immediately.

Mr Lohani also mentioned that learners with special needs participated fully, showing that technology-driven learning could be inclusive and empowering.

The programme tour included

Hillcrest Primary School in Durban, Education Evolution Academy in Johannesburg, Morning Star Academy in Vryburg, Aborvitae Academy in Benoni and Pink & Blue Preparatory in Pongola.

He said the initiative was also endorsed by the Gauteng District Education Department, which praised its alignment with South Africa's digital skills and youth empowerment goals.

Mr Lohani said what made the event significant was that it was led by a Botswana-grown institution. He said so far, more than 80 teachers had been trained through the Human Resource Development Council accredited STEM & Robotics Educators Certification Course, with another 30 set to join in August.

"Most of these teachers are already running robotics and coding programmes in schools across Botswana and the region," he said.

He further said the success in South Africa was only the beginning, as BrainSTREAM would launch Robotics & Coding Camps in Harare, Zimbabwe, later this month in partnership with Eastern Heights Junior School. However, Mr Lohani said while neighbouring countries were embracing Botswana's innovation, uptake at home had been slower.

"If our teachers are not trained and supported, implementing Robotics and Coding across schools will face critical delays," he said, adding that local institutional support was needed.

With the right backing, he said, Botswana's classrooms could also become hubs of innovation, preparing the next generation of problem-solvers for Africa and the world. *BOPA*



Her message to young brides is a simple yet powerful one: "Always use phate to give your marriage dignity and to preserve this aspect of culture for the coming generations."

Despite her dedication Botha faces significant challenges. The most pressing is a shortage of raw materials, particularly game skins. This forces her to import hides from South Africa, a process that is both challenging and lengthy.

The creation process itself is also time-consuming due to the lack of modern machinery.

To overcome this, Botha is seeking pledges to acquire a tanning drum, which would make her work easier and faster, allowing her to produce more mats and increase her income.

Through her skilful hands and unwavering spirit, Botha is not just making mats; she is weaving the threads of her culture, one stitch at a time, ensuring that the legacy of phate endures. BOPA

Legong set to release 28-track mixtape African Khumbai

KANYE - Botswana's music scene is about to experience a cultural explosion as rapper and producer Johnson Legong aka J-Traxy gears up to release 28-track mixtape titled African Khumbai by November end.

Born and raised in Selebi Phikwe, J-Traxy started his musical journey 2008. identifying as a Motswako artist, a style of rap that blends Setswana and English.

In an interview, he shared that his early career began on the streets through freestyle rap battles, before moving to the city where he developed an interest in music production.

"I started producing because I felt that back then, the producers did not quite understand my sound. I dropped my first single Daddy's Baby in 2016, followed by Voka Ntwana. In February this year, I released Selepe while compiling the African Khumbai mixtape.

According to J-Traxy, African Khumbai is a celebration of African beauty, diversity, culture, and unity.

J-Traxy runs his own recording label, True-African Studio, based in Gaborone. The studio has become a hub for both upcoming and established artists.

mixtape boasts collaborations with top local and international talent, including the late Dramaboi, Motlha, M.O.D. and others.

International features include Munemo Simns (Zambia), Nel Carter (Nigeria), Brian Lorenzo (Tanzania), Ntate Stunna (Lesotho), Thembi Mona (South Africa), and Prince Dube (South Africa).

As a producer, J-Traxy has worked with major names in Botswana's music industry such as Motlha, Spizza, Double-Up, and Brio. He also recalls recording a single for the legendary Vee Mampeezy.

"As an artist, I have collaborated with several international acts, including Nail Cutter from Nigeria," he added.

"When it comes to recording artists at my studio, I am not all about the money.

I believe in supporting raw talent. I charge those who can afford it, but I have helped many artists get their break, like Spizza, Motlha, and Double Up, who came through me," he said.

His performance resume is equally impressive.

He once co-hosted an Edutainment show funded by the government alongside

Thipe: From village boy to president

GABORONE – A teenage boy's journey from Mmathubudukwane in Kgatleng District, to the classrooms of Molefi Senior Secondary School in 1992, was not just about a change of environment, but a crucial moment in his life and a leap into the unknown, in a quest of a brighter future.

Leaving home at 17, saying goodbye to loved ones, he carried with him more than just his belongings, he also carried the hopes and expectations of those who believed in traditional paths of becoming a teacher, soldier, or nurse. Yet, the atmosphere in Mochudi and within the halls of Molefi Senior Secondary, would open doors to a world of new

possibilities and forever reshape his destiny.

"During boxing training, I used to go and watch," recalls Dirang Thipe, now the president of Botswana Boxing Association (BoBA). Gradually, I got more interested and eventually joined the school club," he said.

Back then, while in Form 3, Thipe was under the mentorship of teacher Peter Mlewa.

He describes how boxing was Mlewa's passion, his breath, and purpose. By 1993, Molefi made history when its learners became national boxing champions.

After finishing at Molefi, Thipe took a two-year break from the ring to serve in the Tirelo Setshaba programme, working as a teacher.

But even during this time, he

did not let go of his dream. During school breaks, he continued to nurturing his talent and honing his

His journey took him to Botswana Diamond Valuing Company boxing club, now known as Diamond Trading Company Botswana.

His stay there was brief, however, as he soon found a new chapter with his current employer, the Botswana Defence Force (BDF).

Today, Thipe is a librarian with BDF, but his true passion has always been boxing.

He boasts 33 years of experience, starting as an amateur, rising to professional, coaching and serving in administrative roles and ascending to presidency.

In our interview, Thipe keeps on highlighting how pivotal his employer has been in his boxing journey. "In 1999, after training, I decided to go back to boxing," he says. "One thing about BDF is that when they see potential in you, they give you an opportunity."

He was appointed Glen Valley Boxing Club head coach from 2008 to 2010. In 2008 also, Thipe recalls being assigned to coach the Botswana youth boxing team that participated in South Africa, where eight boxers competed and secured five medals.

"From there, in 2009, I was promoted to the senior team, which took part in the Zone 4 Games in Swaziland. We sent 10 boxers and returned with 10 medals (nine gold and one silver), marking the best team we have ever had," he explains.

In 2010, he was also elected BoBA vice president (technical). When his tenure ended, he returned to coaching at Glen Valley until mid-2013, when he was elected BoBA secretary general, a position he held until 2015.

Throughout this period, whenever possible, he returned to coaching, resuming his role as head coach at Glen Valley for the next two years. In 2017, he was elected vice president of BoBA, once again halting his coaching career.

In 2020, SSKB, where he is currently based, appointed him as head coach, a role he held until August 9, when he was appointed p resident. With 15 years as a boxer (1992–2007), Thipe's achievements include a bronze medal at the 1999 World Military Games in Croatia.

That same year, through dedication and hard work, he was called up to the national team, serving until 2006.

His notable accomplishments include a bronze medal at the 2002 Commonwealth Championships in Malaysia, gold at the 2002 African Military Games in Nairobi, reaching the quarter-finals at the 2003 Abuja All Africa Games, and a bronze medal at the 2004 Gaborone African Championships, narrowly missing Olympic

qualification.

Just as a soldier fights tirelessly to defend and serve, Thipe's extensive experience is reflected in his efforts to transform SSKB, which he joined with just four boxers, into a club boasting 11 female and 17 male boxers.

He is committed to reviving boxing to its former glory during his four-year tenure as the president.


"As a product of school sport, I want to start at the grassroots, making sure clubs adopt schools at the same time reviving various categories from junior to elite tournaments, similar to the days of the Keone Mooka Mageu Championship," he said.

A priority for Thipe is increasing the number of women boxers to match their male counterparts, with plans to host sparring sessions and women-only tournaments.

Although financial challenges remain, he remains optimistic about securing sponsorships rather than relying solely on the Botswana National Sports Commission.

He describes the BDF as his backbone and hopes for its continued support, whether through venues or other means.

A father of three, Thipe's passion for boxing has also influenced all his children. His second born, Gift Thipe, represented Botswana at the 2019/20 Malawi Youth Games, showing the family's dedication to the sport. *BOPA*

The Mares climb FIFA rankings

GABORONE - Botswana Football Association (BFA) president has revealed that the senior women national football team, The Mares has climbed FIFA rankings, moving from position 153 to 146 following their performance at the TotalEnergies CAF Women's Africa Cup of Nations, which were held in July.

Speaking at the team's prize money award ceremony in Gaborone on Wednesday, Tariq Babitseng said the results were a statement of progress, discipline and determination.

Meanwhile, The Mares players were each rewarded with P33 000 for their performance at WAFCON, technical staff each got P15 000.

The incentives were from the business community and BFA, which dedicated US\$75 000 from the WAFCON US\$150 000 prize money for rewarding the players.

For his part, Botswana National Sport Commission chairperson, Marumo Morule hailed BFA for dedicating part of the WAFCON prize money to reward the players, saying that proved that athletes' efforts and sacrifices mattered.

He also said they were grateful for government's P11million investment on The Mares.

He said they wanted The Mares'preparations impactful, as they had to engage people with the skills, competencies backed by training.

First National Bank Botswana Communication and Public Relations Manager, Boga Chilende-Maseku said they came on board as partners in 2018 and the team team had shown growth.

Chilende-Maseku said The Mares carried the national flag with dignity when they played in the continental competition.

With every pass and sprint, she said players proved that Botswana also belonged to the continental stage, adding that beyond the statistics, the real story was the team's resilience, passion and determination that inspired every girl child to aspire for greatness. BOPA
