## False asylum claims tarnish Botswana image

GABORONE - Botswana citizens now require a visa to enter the United Kingdom, following a rise in false asylum claims and illegal migration.

The change, announced by the UK government on October 14, has sparked concern among Batswana travelling for education, business, and tourism.

High Commissioner to the UK, Mr Shimane Kelaotswe, confirmed the development in an interview with *BOPA*, explaining

that the decision was prompted by incidents of illegal migration earlier this year.

"The UK announced that any Motswana wishing to visit will now need a visa," he said, adding that the policy was intended to curb irregular migration and false asylum claims.

Mr Kelaotswe highlighted a case in June involving a woman and five men arrested in Southampton, Manchester, Nottingham, Sheffield and Bradford for allegedly bringing fellow Batswana into the UK illegally.

"Initial estimates suggested that around 200 people could have been involved, though the actual number may be higher," he said.

The High Commissioner also expressed concern over the rising number of asylum claims, which he described as false and harmful to Botswana's international image. "Currently, 1 329 Batswana are registered as refugees or asylum seekers in the UK. It is hard to imagine refugees coming from a peaceful and stable country like Botswana," he said.

Mr Kelaotswe further stated that

most claims cited discrimination based on sexual orientation, gender-based violence, or alleged ritual killings, claims he strongly denied.

"One shocking case involved a woman claiming she fled Botswana because she was to be sacrificed in a family ritual and this is false and deeply troubling that a small number of individuals are misrepresenting our country," Mr Kelaotswe added.

Despite the new visa requirement, the high Mr Kealotswe remained optimistic about bilateral relations.

"The UK government has affirmed the strong relations and cooperation between our countries, which we continue to value," he said.

He also reassured that the government of Botswana was engaging UK authorities to address the visa implications and safeguard the reputation of law-abiding citizens travelling abroad.

He said currently, 1 835 Batswana were legally residing in the UK and registered with the Botswana High Commission.

"We are concerned that the actions of a few could unfairly affect many citizens who travel for legitimate reasons, including education, business, and tourism," said Mr Kelaotswe.

He urged citizens to exercise caution and adhere to legal channels when travelling abroad, while affirming that the government was committed to protecting Botswana's image internationally. "Botswana remains a peaceful, stable, and law-abiding country and we will continue to ensure that this is reflected in our international relations," he said. *BOPA*

# Stakeholders to hatch modalities of house allocations

SELEBI PHIKWE - Sharing a sombre memory at a meeting in Selebi Phikwe on Friday President Advocate Duma Boko recalled when, one of the fateful days, a man who was traveling home with a heavy heart after losing his job, and probably more, stopped the truck driver so he could relieve himself in the nearby bush, only for his lifeless body to be found hanging

This man and many more formerminers, their dependents and residents of the Selebi Phikwe and peripheries, suffered consequences of the abrupt closure of BCL mine, October 2016.

Owing to the closure of the mine, which was subsequently put under liquidation, some former employees, who saw their dreams deferred and lives thrown into immediate turmoil and confusion, fled the copper-nickel mining town, retracing their steps back to their villages while others stayed put and hoped.

They, through the Botswana Mine Workers Union, engaged with the liquidator and the then government over several issues, like soft-landing, that could help numb the pains of former BCL employees albeit to no success.

While some vacated staff houses voluntarily to look elsewhere, others remained in the houses and faced eviction threats by the liquidator whose part of the job was to sell the houses and other BCL

mine property before wrapping up the liquidation process. The houses were acquired mostly by the financially resourced persons, leaving the former employees not only in the lurch and watching helplessly as their former abode exchanged hands before their eyes.

However, the government intervened and acquired 1 226 houses through the Ministry of Minerals and Energy, the portfolio of which mines fall under.

The ministry then handed-over the housing units in question to the Ministry of Water and Human Settlement under the stewardship of Minister Onneetse Ramogapi.

It is against this backdrop that the government has tasked the affected ministries and the district leadership, under urban development committee, to devise and perfect modalities of allocating the houses to deserving Batswana, not only former BCL employees.

The acquisition of the staff houses and imminent allocation have been dubbed steps in the right direction towards attainment of provision of dignified housing to Batswana.

Speaking at the handover of the houses, President Boko said the acquisition of the houses at a time when the government was faced with financial challenges was a clear indication of fulfilling its commitment to providing housing for people through measurable and quantifiable outcomes.

He assured those who faced threats of eviction that since the

houses belonged to government now, the committee responsible for allocation would not adopt an oppressive approach to dealing with current occupants.

"We will have a different approach that is not going to persecute anyone," said President Boko on how the current occupants of the acquired houses would be treated as Bonno Housing Scheme receives the houses.

During the handover, there was a general feeling by the attendants which was communicated by Member of Parliament for Selebi Phikwe West, Mr Reuben Kaizer, that there lacked clarity on who was getting the houses and the procedure to be followed.

Some bore that the acquired houses would be distributed to former BCL employees only, a misinterpretation that minister Ramogapi cleared in a post-event interview. Mr Ramogapi said that several factors would be considered to determine ultimate deserving beneficiaries.

"We must be cognizant of the impact of the decisions we will make to people's lives and as such we will not allocate to just anyone," said Mr Ramogapi. He cleared that former BCL employees were paid their dues as per their contracts with their former employer.

"That matter has been finalised and closed and what is left here is for us together with the town leadership to determine who deserves these Bonno houses," Mr Ramogapi said. BOPA

# International forensic conference November

GABORONE - The International Institute of Certified Forensic Investigation Professionals (IICFIP) Botswana Chapter is scheduled to host a global forensic investigations conference in November, a first for Botswana.

"This prestigious event underscores Botswana's growing prominence in the field of forensic investigations and its commitment to combating economic and cybercrime," said IICFIP Botswana Chapter chairperson, Ms Thato Tshupeng-Sambere, during a media briefing, Friday in Gaborone.

She described the conference as an opportunity to address Africa's challenges in forensic investigations, such as limited resources, capacity building, cybercrime surge, and corruption and financial crimes.

The conference aims to address these by bringing together experts, practitioners, and stakeholders to share knowledge, best practices, and innovative solutions.

Its objectives include; enhancing forensic capacities, promoting collaboration, knowledge sharing, and advocating policy reform, among others, Ms Tshupeng-Sambere said

The IICFIP Botswana Chapter country director, Mr George Kiilu, said forensic investigations were still developing in the country, adding that the Botswana Chapter had about 100 members.

Furthermore, Mr Kiilu said IICFIP was registered in the US as a professional body, where its headquarters were domiciled, and the local chapter was affiliated to the mother body.

Locally, he said they were registered with the Registrar of Societies and also that the local IICFIP whose members included those in the private and public sectors, aimed to collaborate with other organs.

Mr Kiilu said the chapter would lobby for the advancement of the profession locally, which would include changing policies to establish a legal framework for the registration of members.

Last year's addition was held in Johannesburg, South Africa, and Botswana participated.

The 9th IICFIP conference, scheduled from November 17 to 21 in Gaborone, will feature speakers from Botswana, Kenya, Zambia, Nigeria, Uganda, and Malawi, among others. *BOPA*

## **'GBV** threatens social stability'

GABORONE - Chairperson of Ntlo Ya Dikgosi, Kgosi Malope II has called for urgent and united action to tackle the growing scourge of genderbased violence (GBV) in Botswana, describing it as a national crisis that continues to traumatise communities and undermine social stability.

Speaking during the official opening of the 4th meeting of the 5th Ntlo Ya Dikgosi in Gaborone on Monday, Kgosi Malope expressed concern over the persistent rise in GBV cases across the country, emphasising the need for collaborative solutions.

"Gender-based violence causes distress in the nation, it is tearing apart the social fabric of our communities and we must come together as government, traditional leaders, civil society and citizens to put an end to it," he

He said Botswana Police Service recorded alarming figures between December 19, 2024 and January 2, 2025, adding that there were 60 cases of rape, 19 cases of murder and 13 cases of defilement.

"These statistics paint a deeply troubling picture, this is not just a women's issue or a legal issue, it is a societal crisis and we must all respond with urgency," Kgosi Malope noted.

Kgosi Malope stressed that traditional leaders have a unique role to play in fighting GBV, particularly in influencing cultural attitudes and norms that could either

enable or prevent violence.

"As custodians of culture, we must lead by example and champion values that promote respect, equality and justice, our role is critical in transforming harmful practices and supporting victims," he said.

He further urged the government continue traditional empowering institutions like Ntlo Ya Dikgosi to be more effective in driving social change at the grassroots level.

Kgosi Malope II also highlighted the ongoing partnership between Ntlo Ya Dikgosi and the United Nations Population Fund (UNFPA), following a successful capacity-building workshop on sexual and reproductive health rights, which was held in June.

He said UNFPA has completed a new resource to package support communities in addressing GBV and promoting gender equity, adding that the package, will be validated during the ongoing Ntlo Ya Dikgosi meeting.

He also expressed gratitude to UNFPA and other key stakeholders including the ministries of Health, Youth and Gender, the Botswana Police Service and Legal Aid Botswana for their continued

The Ntlo Ya Dikgosi's twoweek session will include debates on the Constitution Amendment Bill 2025, as well as discussions on 98 questions and 12 motions submitted by members. BOPA

## Marriage under pressure as divorce cases mount - Boko

**FRANCISTOWN** approximately 2 000 divorce cases pending at the high courts, the marriage institution is clearly

Speaking during the second edition of the Botswana Police Commissioners' Run in Francistown, Saturday, President Advocate Duma Boko said the figure did not account for many individuals who remained in unhappy marriages.

Many feel trapped due to fears related to divorce, among them potential social stigma and disapproval from their communities, President Boko

As a legal expert, President Boko advised those considering marriage to opt for an arrangement outside of the community of property.

"Please get married out of community of property so that when the time comes for you to go, your difficulties will be lessened," he said and explained that opting for out of community of property regime could help facilitate smoother separation, reducing hostility and violence typically associated with disputes over shared property.

Regarding the emotional toll of unhappy marriages, President Boko recommended that couples seek counselling from family members, friends, or religious leaders when faced with relationship challenges, stressing that the decision to remain or part ways rested with the individuals involved. Ending a relationship is not necessarily a sign of failure, President Boko

He also talked about the ongoing societal impact of marital tensions, including their contribution to incidents of gender-based violence (GBV) and other forms of violence.

President Boko said that anger often escalated to tragic consequences, including murder, when heated words were exchanged between partners.

"Words are like weapons. They wound and can injure someone irreparably," he said and called for respectful communication even amidst conflict. To men, President Boko urged a departure from the inclination toward violence and encouraged them to be calm, even in the face of provocation, as a demonstration of true manhood that encompassed protection and safety.

He said that fostering a safe and nurturing environment for children was crucial, as they often emulated the behaviour they observed.

"Children raised in a hostile and inhospitable environment copy our behaviors," he warned.

In addition to addressing marital challenges, President Boko acknowledged the pressing issue of youth unemployment.

He indicated that administration was committed to collaborating with young people to develop solutions, particularly within the creative industry.

He said Cabinet had resolved to increase the budget for content procurement at Botswana Television (Btv) from P2 million to P200 million, a move expected to create approximately 8 000 jobs for the youth. Police commissioner, Ms Dinah Marathe emphasised the importance of community safety, particularly concerning youth. She stressed the Botswana Police Service's commitment to addressing rising GBV and related issues through initiatives such as the commissioner's run and called on civil society, industries, government stakeholders, and the public to take action. ## Visits strengthen economic partnerships

"The talks will focus on opportunities and investment in financial services, minerals development, infrastructure and agriculture," adds the release.

Botswana's continued engagement in the Gulf region is expected to unlock enhanced government

business collaborations, to drive economic diversification and sustainable employment creation in Botswana.

The release further states that the President's investment promotion engagements in Switzerland will take place from October 25 to 29, where he will meet with international CEOs. entrepreneurs and investors, explore opportunities enhanced partnerships in the financial services, infrastructure, energy

telecommunications sectors.

**President Boko is accompanied** by senior government officials, and they are expected to return to Gaborone on October 29.

Minister for State President, Mr Moeti Mohwasa is the Acting President until today, and thereafter, upon the return of the Vice President from the IMF meeting, Mr Ndaba Gaolathe, will serve as the Acting President for the remainder of President Boko's absence. BOPA

# MPs call for equitable distribution of resources

GABORONE - Members of Parliament have implored government to strive for equitable distribution of resources and infrastructure developments across the country to empower

arts sectors.

Their Friday contributions on the proposed developments in the sport and creative industry in the National Development Plan (NDP) 12 follows a presentation by Minister of Sport and Arts,

communities to play a role in growing the sport and creative

Mr Jacob Kelebeng.

The legislators were optimistic that the sector has potential to contribute toward employment creation and economic diversification, provided it received the necessary recognition and support.

Chobe MP, Mr Simasiku Mapulanga said centralising all developments around Gaborone limited economic growth and optimal exposure of all sectors with the potential to generate income for the country.

"We are still failing to decentralise the infrastructure. Next year the World Athletics Relays will be coming to Gaborone, yet we do not have adequate facilities for accommodation, recreation and tourism purposes in the city," he

He said there was need to distribute and also expand sport infrastructure to equally benefit Batswana in all their localities. He said there should be mini sport stadia and other sporting infrastructure in primary schools across the country.

MP for Thamaga/Kumakwane, Mr Palelo Motaosane said government should invest in developing sport facilities in different areas across the country to afford young people the equal opportunity to unearth their talent.

He also noted that while the plan should address pending projects, the ministry should consider the construction of a new national stadium to avoid further cost implications incurred in regular maintenance of the national stadium.

Additionally, Mr Motaosane said the plan should also target other sporting codes, other than athletics and football.

He also said grassroots development should be supported through sport academies and school sports.

"Let us support Batswana who have initiatives intended to groom young people through sport academies. Let us also engage teachers who are skilled and passionate about coaching children to develop their talents, instead of looking for coaches outside," he said.

Mogoditshane East MP, Mr Letlhogonolo Barongwang noted that hosting World Relays should motivate government to establish well equipped sport facilities.

Mr Barongwang said the government should implement programmes which will address unemployment and drug abuse, which were currently on the increase, especially in highly populated cosmopolitan areas like Mogoditshane.

"Mogoditshane, which has a vibrant youth, can be used for a pilot youth development centre intended for recreation and counselling services, in the wake of high unemployment and drug abuse among the youth,"he noted.

For his part, MP for Bobirwa Mr Taolo Lucas said NDP should desist from adopting the centre periphery approach, which he said centred developments in big cities and villages.

He said this approach further increased development gaps between urban and rural areas, hence failing to address economic challenges in rural areas.

Mr Lucas said local communities should also be accorded the opportunity to play a role in developing facilities in their areas, through collaborations with the government and other stakeholders.

He noted that school facilities should cater for various sporting codes to target different talents possessed by young people.

Charleshill legislator, Mr Motsamai Motsamai implored the government to provide resources that will empower local communities to formalise natural talents and indigenous knowledge.

He said the creative sector had the potential to generate income and uplift lives, particularly for people in less developed and rural communities.

"There is a lot of natural talent and indigenous knowledge in our local communities but they need to be supported and their talents brought to formal platforms for them to grow.

We need to take resources closer to these people as a way of creating an inclusive economy," he said.

Responding to legislators debate, Minister Kelebeng said consultations had began to establish a Sport and Recreation Act which would comprehensively incorporate various sport bodies and ensure better coordination.

Mr Kelebeng noted that while sport development centres and mini stadia would be established in various areas, the World Relays would be hosted in Gaborone in line with international standards requirements.

"The requirements are that we should have a certified track which we are currently preparing at the national stadium," he explained.

Mr Kelebeng further noted that as part of reviewing incentives, plans were underway to establish a sport fund that would assist in improving rewards. He said this would be achieved in collaboration with the private sector. He said even though some schools had already made strides in starting the school sport programme, the full integration was expected at the beginning of next year.

He noted that his ministry would collaborate with the lead ministry to implement the programme. *BOPA*

# Govt to invest P6.7bn in sport, creative industry

GABORONE - Government is intending to invest an estimated P6.7 billion in sport and creative industry development infrastructure during National Development Plan 12 (NDP 12).

The investment will support the sectors to grow significantly during the plan period.

Presenting the sport and creative sector proposed priorities for NDP 12 to Parliament on Thursday, Minister of Sport and Arts, Mr Jacob Kelebeng said the objective was to position Botswana as a global hub for sport, culture and creative industries.

He said the sector was expected to grow above 5.46 per cent by 2030, an improvement from 3.3 per cent in 2022 and 4.3 per cent in 2023. He noted that while the country was making strides in sport particularly athletics, there was need to support athletes through incentives and other resources to promote further growth. In addition to job creation, he said creative arts contributed to various cultural and social aspects of communities.

"The creative industries Botswana's cultural preserve enables identity, intergenerational knowledge transfer, promote national pride and identity, as well as social cohesion. The industry holds significant potential for economic growth, job creation and the preservation of Botswana's rich cultural heritage," he said.

He noted that the creative industry, which included arts, entertainment, marketing,

creative tourism and cultural goods and services, contributed 5.6 per cent to the GDP.

Minister Kelebeng said such activities were instrumental in creating direct and indirect job opportunities for Batswana.

Subsequently, he noted that government made a deliberate decision to include the creative industry in NDP to formalise its operations and stimulate its growth.

deliberate "Therefore, its inclusion in NDP 12 serves to formalise the industry and demonstrate the government's unlocking commitment to its potential for exponential growth," he noted. Furthermore, the minister said the country's efforts in supporting sport and creative arts contributed toward positioning it as a hub for hosting sporting and creative operations and activities.

He said hosting the World Athletics Relays next year was a major milestone for Botswana, demonstrating capacity for hosting international events, while at the same time serving as a tourism destination for the internal community.

Notwithstanding, Mr Kelebeng said lack of comprehensive framework to support the sport and creative industries contributed to its underdevelopment.

"A number of cross cutting challenges in the sector which include regulatory framework, inadequate funding, monitoring and evaluation and reporting systems stifle the growth of the sector, resulting in inaccurate reporting, especially its contribution to the GDP.

The reporting system is not standardised across agencies and the value chain contribution remain accounted for," he added.

While he regretted that substance abuse and prolonged suspension of school sports hampered sport growth, he noted that the government would prioritise sustaining the sector through stakeholder partnership, cultural heritage creative industries and sport tourism in order to position Botswana as a global hub for sport, culture and creative industry sustainable economic growth. He underscored the need to review policy frameworks, including enabling regulations for private sector participation in propelling the sector.

Mr Kelebeng also said policies and guidelines aimed at athletes' welfare development, sport funding, sport education accreditation system and sport integrity instruments would be reviewed. He noted that reviewing such frameworks would not only increase job opportunities but would also enhance resilience and economic diversification.

Mr Kelebeng said there was need to expand and decentralise services and facilities such as theatres, cinemas and studios to accord communities equal opportunities. To that effect, he said enclosed in the NDP 12 was construction of community sport stadiums, outdoor recreational centres in remote areas, national horse race course, refurbishment of sport facilities, digitalisation of national art collection, among others. *BOPA* 

## 'Agriculture priority under NDP 12'

GABORONE - Agriculture is a prioritised sector under the NDP 12 because of its strong linkages with the rest of the economy and its potential to create jobs, sustain livelihoods and contribute to GDP growth

Presenting the draft NDP 12 Lands and Agriculture sector to Parliament, Acting Minister of Lands and Agriculture, Dr Edwin Dikoloti said the new direction in the agricultural sector would move Botswana from subsidy dependency toward enterprise driven empowerment.

He noted that this would align agriculture with national

diversification, food sovereignty and employment creation. Key enablers for this transformation, Dikoloti said included the policy and legal reforms, agricultural financing insurance, research development as well as Public Private Partnerships (PPPs). He said the sector remained guided by critical cross sectorial priorities that reinforced inclusivity and sustainability.

 $Dr\, Dikoloti\, thus\, highlighted\, that$ the True North was to transform Botswana's agriculture into a diversified, resilient and exportoriented sector that achieves food security, reduces imports and

drives economic growth. This, he said was anchored on livestock production and processing, agricultural production and land resource management.

proposed "Some of the programmes expected transform the sector over the medium-term include promoting the use of agricultural technology to enhance productivity through the use of precision farming, water management systems and soil enhancement technologies," he said.

He indicated that government was also keen to provide support for small-scale farmers to ensure their accessibility to resources, training and financing needed to

Dr Dikoloti also cited that they would be cultivation and export of medicinal cannabis and industrial hemp to facilitate the innovative use of hemp-based materials like hempcrete, hemp bricks and hemp fibre panels. Additionally, he said water security was an area of priority through borehole development, rain water harvesting and irrigation infrastructure particularly under the Agro-Zambezi project.

Outlining some of the key national priorities, Dr Dikoloti stated that government would promote commercialisation and diversification of agriculture adding that the diversification agenda was anchored on the production and export of key agricultural commodities like dairy production, livestock and horticultural production as well as fodder production.

He noted that the Botswana Vaccine Institute (BVI) remained a critical player in the animal

health and bio-security. He said efforts were underway to improve operational efficiencies through increased plant availability and enhancing regulatory compliance with the goal to expand vaccine production capacity transform BVI into a competitive multinational enterprise.

Dr Dikoloti said government would within the NDP 12 establish framework finance agricultural insurance facility to strength access to finance.

"This institution provide structure, transparent and market orientated solutions including insured loans, crop and livestock insurance, drought relief mechanisms and flexible loan payment schemes as well as credit life insurance," said Dr Dikoloti.

Such interventions, he said would safeguard farmers from unforeseen shocks while improving sector resilience. **BOPA**

## Saleshando decries inadequate youth tailored consultations

GABORONE - Leader of Opposition in Parliament, Mr Dumelang Saleshando pleaded with government to consider incorporating Youth Parliament in the country's development strategies.

Contributing to the debate on the general principles of the National development Plan 12 draft document, Mr Saleshando decried of inadequate consultation of young people by government when drafting the NDP 12.

He cited that it was disappointing for the youth not UDC government was failing to to be consulted in the planning process despite being voices that could lead to better-tailored policies.

"I am certain that young people in Maun and other parts of the country were not involved in the planning process and I need to highlight that involving young people brings diverse and innovative perspectives to the table, leading to smarter more inclusive decisions and strengthening overall institutional credibility," he said.

Saleshando Mr urged government to create a conducive for environment investment and growth by removing bureaucratic obstacles, and establishing a fair regulatory

He said though the Botswana Congress Party (BCP) fully supported social democracy, the onus was on the Umbrella for Democratic Change (UDC) lead government to support private sector development but cautioned government to avoid excessive state intervention that could hinder innovation and growth.

Mr Saleshando, who is also Maun North legislator cautioned government against luring foreign investors without any trail of

Additionally, he also said the fulfil manifesto promises.

"It is disappointing that the NDP 12 draft is silent on a lot UDC manifesto promises and there are no timelines to many of the proposed projects. One of the key features of the old Botswana making unattainable promises and we cannot be having a government that is quick to make pledges and do the opposite," he said.

Gaborone Central MP, Dr Phenyo Butale applauded the NDP 12 draft saying it was a product of extensive consultation.

He said it was testament that government was committed to upholding strict micro economic discipline to continue promoting structural transformation that energised the private sector.

Mr Butale noted that it was also impressive that the country's ration of debt to GDP had remained under 30 per cent, something that would boost investor confidence.

Tlokweng legislator, Phenyo Segokgo highlighted the need for commitment from all spheres of government to ensure the effective delivery of the plan.

He called for an in-depth public service reforms to spearhead and ensure the success of NDP 12.

When contributing to the debate, Kgatleng East MP, Mr Mabuse Pule credited the former ruling party, BDP for laying a solid foundation ideal for the transformation of the country's economy through sound policies creating and enabling environment for private sector to thrive.

Mr Pule nonetheless indicated that the growth of a private sector led economy partly depended on revamping of SMMEs thus calling for re-introduction of Chema Chema funding and other SMMEs development geared programmes.

He also expressed displeasure the exclusion of the Malolwane-Mmaphashalala road on the NDP 12 draft despite the approval of the proposed project in NDP 11. *BOPA* 

## Parliament approves draft NDP 12 General **Principles**

GABORONE - Parliament on Thursday approved General Principles of the draft National Development Plan (NDP) 12.

The General Principles under chapters one, two and seven of the draft plan were presented by Minister for State President, Mr Moeti Mohwasa.

The five-year plan, which spans between 2025/2026 and 2029/2030 financial years has an estimated budget of P388 billion.

Contributing to the debate, Okavango East MP, Mr Gabatsholwe Disho underscored the need to prioritise job creation for Batswana, particularly in his constituency which he said was one of the poorest in the country.

He also noted that rampant stock theft in his constituency affected their contribution to the government's proposed target of five million national cattle herd

Mr Disho further said owing to poor workmanship by citizen companies, the road construction planned constituency should be awarded to a Namibian company. He said the move would ensure the project was delivered in good quality, within budget and stipulated time

Shoshong MP, Mr Moneedi Bagaisamang said the draft NDP 12 was the government's commitment to deliver a new Botswana. However, he said there was need to ensure effective implementation towards a diversified economy and transformed livelihoods.

Optimistic that the NDP 12 would transform the economy, Serowe West MP, Mr Onalepelo Kedikilwe underscored the need to guard against corruption by

adopting robust public sector

For his part, Moshupa/Manyana MP, Mr Karabo Gare said the plan should clearly outline how the P388 billion plan would be funded, considering the current economic situation.

Mr Gare also underscored the need to consider the Pitseng-Ralekgetho-Moshupa road in the plan, adding that the road would improve accessibility in his constituency.

for Lentsweletau/ Lephephe, Mr Tshenolo Bogatsu appreciated that the plan entrepreneurship promoted and reduced dependency on government. Consequently, he implored Batswana to position themselves for opportunities and invest in commercialising their enterprises.

He also said the agricultural sector should be given priority to maximise job creation through its value chains.

Responding to the debates, Mr Mohwasa noted that the plan was aligned with the government's omises to Batswana.

He said the private-sector led transformation model would be largely funded by the private sector to ensure economic growth and poverty eradication.

"The state of our economy affects how the government deliver services to the people and therefore the budget for this plan will be largely funded from the private sector. We need to give the private sector opportunities to invest in order to grow our economy and create job opportunities for Batswana and eradicate poverty. We also need an agile public service that will facilitate investors through creating a conducive environment," he said. BOPA

# Accurate data vital for national policy

GABORONE - Botswana has taken a significant step forward in strengthening its data infrastructure and promoting evidence-based decision-making.

Speaking at a seminar, organised to discuss emerging issues and strategies under the Second Botswana Strategy for the Development of Statistics (BSDSII) in Gaborone on Thursday, Ministry of Finance acting secretary for Macro Economics, Dr Sayed Timuno emphasised the vital role of accurate data in shaping national policy.

Dr Timuno said BSDS II marked a pivotal moment in the nation's commitment to transforming statistics into a powerful tool for sustainable development, governance and accountability.

"A decision without data is like a journey without a map, you may keep moving, but you will not know where you are going. Botswana's path to transformation requires reliable official statistics," said Dr Timuno.

He said the BSDS II, launched as a blueprint for strengthening production, coordination utilisation of statistics across government sectors, aimed to support key national frameworks such as Vision Botswana Economic 2036, Programme, Transformation National Development Plan 12 (NDP 12) and continental and global commitments such as the African Union Agenda 2063 and the Sustainable Development Goals (SDGs).

Dr Timuno said unlike previous strategies, BSDS II reflected an inclusive, bottomup approach, with the number of mainstreamed sectors rising from nine to 12.

He commended Statistics Botswana and all stakeholders for adopting the participatory model, adding that "the strategy is not for Statistics Botswana alone, it is ours," hence called on permanent secretaries and chief executive officers to take full ownership of their sectorspecific statistical strategies.

Dr Timuno further reminded participants that while some data was transmitted to Statistics Botswana, much remained siloed within ministries, whom he appealed to, to analyse and disseminate their data under the guidance of Statistics Botswana, to enhance consistency, transparency and trust in government reporting.

"These sector-specific reports must become the official sources of indicators for planning, monitoring and reporting," he said

Highlighting the importance of sustainable investment in data, Dr Timuno also called for ministries to integrate statistical planning into their budgeting cycles.

"Implementation requires resources," he noted, while also recognising the vital support of development partners in bridging financing and technical capacity gaps.

Dr Timuno also emphasised that building a robust National Statistical System (NSS) was a collective effort, dependent on coordination, collaboration and leadership.

"Every revolution needs champions and the statistics revolution is no different. As permanent secretaries, you are the chief stewards of this transformation," he said and called for culture change, that statistics should be viewed not merely as technical outputs, but as tools that reflected the realities of Batswana.

Statistician general, Dr Khaufela Lekobane said the BSDS II, followed successful implementation of the first strategy (BSDS I: 2015–2020) and aimed to further strengthen statistical capacity across sectors and integrate data into all stages of the development planning cycle.

Dr Lekobane highlighted that Botswana's economic transformation depended heavily on evidence-based planning, adding that without credible, timely and comparable data, progress could not be measured, monitor policies effectively or achieve sustainable development.

He also highlighted that while Statistics Botswana played a central coordinating role, the production and use of statistics was a shared responsibility among all ministries, departments and institutions.

"Data is not a by-product of development, it is the foundation, ministries and departments must view themselves not only as users but also as producers of statistical data, this requires investment in both human and financial resources," said Dr Lekobane.

The seminar also provided a platform to renew high-level commitment to strengthening Botswana's National Statistical System and to ensure that the BSDS II translates from strategy into tangible development outcomes, by reinforced the collective resolve to build a more robust, responsive and integrated data ecosystem that supports Botswana's vision for inclusive growth and long-term transformation. *BOPA*

# Kenewendo updates on BCL liquidation, final closure

SELEBI PHIKWE - Ministries of Labour and Home Affairs and that of Minerals and Energy have on their tables the liquidation protection fund and rehabilitation protection fund respectively, to help in future mine closures.

While the ministry of Labour and Home Affairs was seized with finalising the liquidation protection fund, which would ensure that employees were not left in lurch when mines closed, the ministry of Minerals and Energy was ensuring that funds for safe closure of mines were available when liquidated mines were left open and unsafe, minister of Minerals and Energy, Ms Bogolo Kenewendo has said.

Speaking at an event to handover former BCL employees houses at Sam Sono Stadium, Friday, Minister Kenewendo said that the ministries would work continually with the task team to conclude the winding down processes at BCL mine in the rightful manner while continually endeavouring to resuscitate the ailing economy of Selebi-Phikwe and the nation at large.

On other matters, minister Kenewendo said that not only did government acquire houses of former BCL employees, but also managed to buy the farm that was used for mango planting and the BCL lab which had been handed over to Botswana Geoscience Institute (BGI). The lab will be converted into a metallurgical lab to carryout sample test.

The minister also informed the meeting attendants about some of the former BCL property that has been successfully sold by the liquidator.

The state of the art smelter, highly regarded in the southern hemisphere, has been sold as scrap metal.

Other sold properties include concentrator, BCL hospital, mechanical workshops, fuel depot, earthmoving workshop amongst other things.

However, Ms Kenewendo said, some sold property were yet to reach financial close as they had been acquired but were yet to be handed over to the new owners. When handed over to owners, the minister expressed optimism that jobs could still be created if and when government worked together with the new property owners.

"We discovered that the last time we were here, most of the property has been sold and we had to devise ways to better the lives of the residents of this town, identify what was left and how best we can put them to good use," minister Kenewendo said and added that acquisition of the staff houses required expedited, undivided attention.


In addition to acquiring staff houses, minister Kenewendo added that care and maintenance of south east extension shaft would be done in order to address the frequent earth tremors that residents complained about.

Resultantly, BGI came on board to measure and gauge seismic movement and tremors while also finding ways to stabilise them.

Further, a decision was taken to flood shaft three, south east extension, with the hope that the interventions will help reduce the amount of money required for regular care and maintenance.

However, the minister warned that the care and maintenance did not mark the final and official closure of the mine saying the mine still needed to be closed properly to reduce potential dangers to the town and neighbouring villages.

"We have people charged with the mandate to close off the mine safely and ensure that property that we can still benefit from are placed in the right hands," she said. **BOPA**



# Thespians call for reforms

GABORONE - Botswana's acting industry may be brimming with raw talent, however, the country stars are calling for urgent reform to bring structure and credibility to the country's growing film and theatre scene.

Speaking at a panel discussion at the University of Botswana, the stars namely, Seneo Mabengano (Muvhango), Kgomotso (Scandal), Ratsie Lone Motsomi (Woman King) and Maxwell Dichi (Generations) said the system meant to nurture creative talent remains painfully underdeveloped.

They highlighted issues challenges from with professionalism and lack of briefs during auditions as well as the lack of suitable technology for film production.

"Time management at auditions is still a problem as well as a lack of transparency on the role an audition is for. Often times you only get to find out during the audition," said Ratsie.

Mabengano concurred, "unlike in South Africa where a brief detailing a character's height, accent and anything necessary for the role, is provided, briefs are still lagging behind in Botswana."

The Muvhango actress also emphasised the need for the establishment of agencies to ensure a timely and fair distribution of information to all actors whenever casting calls are made. Meanwhile, Dichi called on film producers to invest in proper film equipment.

The stars stated that Batswana had talent and possessed special traits such as a unique accent and fluent mastery of English, attributes they shared were greatly sought after in international markets such as South Africa.

In addition, Woman King's Motsomi advised actors to make use of digital spaces to access global auditions and practice monologues to grow their art as it had helped catapult her further in her career. She also revealed her upcoming project named Kgolo, a programme she is yet to establish to assist actors in Botswana with mentorship access potential opportunities.

"It is still on paper, but the project is meant to guide and equip actors with the skills needed to penetrate the market," she said. BOPA


