#CountMeIn refurbishes Molefi secondary school

MOCHUDI - Molefi Senior Secondary School in Mochudi has benefitted from the Ministry of Child Welfare and Basic Education's refurbishment of campaign dubbed #CountMeIn. The campaign, launched at Molefi and Gaborone Senior Secondary schools on Tuesday by Minister of Child Welfare and Basic Education, Ms Nono Kgafela-Mokoka is meant to refurbish and maintain dilapidated school infrastructure across the country.

Govt partners with AfDB, HRDC to tackle unemployment

GABORONE - The Ministry of Higher Education, in collaboration with the African Development Bank (AfDB) and the Botswana Human Resource Development Council (HRDC), recently launched a highstakes consultancy project, to tackle the unemployment by developing a National Human Resource Development Strategy (NHRDS).

The NHRDS is poised to be the heartbeat of the nation's plan to transition into a diversified and knowledge-based economy, anchored in human capital excellence and sustainability.

therefore, represents a monumental bet on the country's people, designed to forge a future beyond the enduring sparkle of its natural resources.

Officiating the recent launch, Minister of Higher Education, Mr Prince Maele, underscored the project's dual mandate to not only review and evaluate the first NHRDS (2009-2022) but critically, to draft a second and transformative NHRDS for 2026-2036.

He said the alignment was crucial, as the new strategy aimed to remedy past shortcomings by tightly aligning with Vision 2036, the overarching national development roadmap and bridging the gap between national development plans.

'This process is an opportunity to recalibrate and sharpen our focus, ensuring alignment with Botswana's long-term vision for prosperity and global competitiveness," said Minister Maele.

He envisioned the strategy to be a dynamic blueprint, a key roadmap that anticipated future challenges and opportunities while addressing the evolving needs of Batswana.

After all, human capital development is the heartbeat Botswana's transformation strategy.

Once complete, the strategy will serve as a key resource and align not only with the Botswana Economic Transformation Programme (BETP), but also with government's broader mandate for a transformative economic development agenda.

The robust 10-year plan will directly guide crucial government

development and ensure coherence across all national planning

The minister said to achieve such an ambitious transformation, the consultancy project was structured around three key, interconnected deliverables, each vital to the success of the new era of development.

The first step is a comprehensive evaluation of the 2009-2022 NHRDS, a component that will be an honest assessment of past performance, rigorously scrutinising the relevance of existing education, training and employment policies in the pursuit of a knowledge-based society.

ensure thorough understanding, Mr Maele said the evaluation would involve analysing critical performance indicators such as access, quality, gender equality, youth development and return on investment as well as conducting national consultations to measure the tangible impact of the previous strategy.

"The evaluation and impact assessment will accord us an opportunity to introspect and reimagine our future in maximising our people's capabilities and capacities," said the minister.

Building upon the lessons learned from the evaluation, the second component focuses on the core creative process, the development of the transformative NHRDS for 2026-2036.

The new strategy must be the engine that propels the country toward economic transformation and diversification and ultimately lead to improved livelihoods for all citizens by spearheading domestic and foreign investment while advancing innovation and technology to ensure that national growth is sustainable, inclusive and rooted in product development.

The third and final element is the strategy implementation plan.

Recognising that even the best ideas require practical execution, this component, the minister said, would establish clear delivery timelines, specify project costs and propose concrete sources of financing to ensure the NHRDS move from a strategic document to an active, well-resourced force for

Civil society key in combating illicit financial flows

GABORONE - Civil society organisations have a duty to work towards assisting African nations combat the growing scourge of money laundering, terrorism financing and illicit financial flows.

These were the sentiments echoed by the President Advocate Duma Boko yesterday during a keynote address to the High Level Africa Civil Society Conference on Anti-Money Laundering and Countering Financing Terrorism held in Gaborone.

The President urged delegates from civil society institutions across Africa to use their threeday deliberations to engage and introspect on how to best combat money laundering and financing terrorism.

President Boko said countering the financing of terrorism and illicit financial flows should entail an honest discourse down to the grassroots.

"Why do we have this big challenge of money laundering? What money is this that is being laundered? Where does it come from? Because we are trying to establish the channels through which it moves and flows. What is its source and origin? Where does it come from?" President Boko said.

said civil society organisations, which were drawn from the community and work closely with the people at grassroots level, needed to consistently probe those in public office who may partake in the misuse of public

"When those who hold public office turn the public purse entrusted to them into their own private chest, this is the real problem. These funds, these resources, this wealth is illegally obtained, stolen, obtained corruptly, then channeled and concealed, beyond the reach of crime intelligence organisations. This is what we are wrestling with," he said.

Acknowledging that civil society formations in Botswana were weak, owing to a lack of sufficient financing, apart from labour organisations, which rely on the monthly member subscriptions, President Boko called on trade unions to utilise their resources

to be the anchor of national civil society.

He called on civil society to also self-introspect how they could be used to partake in or aid and abet illicit financial flows, 'so that when civil society probes leaders, politicians, they themselves must have already submitted to selfexamination.

President Boko said Botswana would continue to submit as a country to the evaluations that take place periodically, including an upcoming evaluation in 2027 that would determine whether Botswana was fully compliant with Financial Action Taskforce (FATF) global regulations.

"We have made impressive strides. But we are not there yet. And sometimes when we celebrate the little successes that we have attained, we might become complacent. Let me remind government that we are not there yet," President Boko said.

The Minister of Labour and Home Affairs, Major General Pius Mokgware buttressed the argument that civil society organisations were key in combating money laundering and terrorism financing.

He said as largely community based institutions, civil society formations should collaborate into a network that offered strategic direction and accountability to combat the human suffering that is brought about by illicit financial

For his part, Executive Director of Civic Advisory Hub, Mr Yona Wanjala said Africa lost about US\$88 billion (over P1 trillion) annually to illicit financial flows, which throve on the erosion of good governance and human rights, the suppression of oversight and accountability, and thus required an active role by civic organisations in offering a solution. **BOPA**

BCP vows to compete strongly in Kgalagadi South by-election

Botswana **GABORONE** Congress Party (BCP) has vowed to participate and compete strongly in the upcoming Kgalagadi South by-election as part of its 'Going South' plan to ensure the party competes effectively in the southern part of the country.

Addressing a press conference in Gaborone, on Tuesday, BCP leader, Mr Dumelang Saleshando said they have been absent the longest from Kgalagadi South, as per the 2024 general elections results, which showed that the party did not fare as well as it would had wanted to in the southern part of the country.

"Out of the 15 Members of Parliament (MPs) that we have, only two are from the southern part. So, we are very intentional about this that we would want to commit greater energies, resources and time to making sure that the party competes effectively in the southern part of Botswana," he said.

By having two BCP MPs in two constituencies in the southern part of the country, the BCP leader said was evidence enough that Batswana did not reject BCP.

'There are a number of constituencies in the southern part of Botswana where no party can claim is their strong hold.

They swing from one party to another and it has mainly been the former ruling party and the current party. So, we would like to give the voters an option of BCP, as a strong contender in the area," he said.

Mr Saleshando, who is also the Leader of Opposition and Maun North MP, said BCP had identified a candidate and would be deploying its foot soldiers throughout the Kgalagadi South constituency in preparation for the upcoming by-election.

"We will see what Batswana have to say. We have been absent the longest on that part of the country. We were not on the ballot paper for 2019 and 2024 general elections and this will serve as an opportunity for the party to have a good assessment of how it performs in the most Southern part of the country," he added. He said from now onwards, till the 2029 general election, the BCP would be contesting byeelections everywhere, in the country, whenever there was a bye-election.

Additionally, he said BCP would also contest in another by-election that would be held in Boteti-West constituency, following the death Moreomaoto Ward councillor, Mr Diagelo Madimo. BOPA

FRANCISTOWN October is recognised as World Blindness Awareness month, Blind Smart Access is playing a vital role by leading some initiatives aimed at raising awareness. educating community as well as celebrating the capabilities and contributions of blind and visually-impaired individuals.

Blind Smart Access, an innovative private entity, works to promote accessibility, inclusion and equal participation for people with visual impairments.

Its founder and director, Mr Thabo Baseki disclosed in a recent interview that some of the initiatives they have been aggressively pushing this month include awareness campaigns, radio discussions, community outreach and school engagements designed to challenge stereotypes and promote accessibility.

Mr Baseki, who has been driven by a passion for accessibility and inclusion said the organisation also participates in and supports events such as White Cane Safety Day, using them as platforms to advocate for inclusion, accessibility and equality.

"For Blind Smart Access, October is not only a month of awareness but a reminder that inclusion should be a year round commitment," he said.

"Inclusion is not a favour, it's a shared responsibility. When we build systems, workplaces and communities that include the blind, were are not just helping a few, we are strengthening the whole nation," he added.

Stock theft concerning trend

KANYE - The staggering reports of cross border livestock theft involving sheep, goats and cattle valued at P910,700 in the greater Southern Region highlights a persistent challenge for the community in the border villages.

staggering figures recorded between June and August 2025, aggregates the estimated market value of stolen nimals across multiple incidents, underscoring the economic strain on local farmers who rely on livestock for their livelihoods.

In an interview with BOPA on Monday, Station Commander of Ramatlabama Police Station, Superintendent Mary Baabina said the livestock theft and rustling cases were concentrated in eight vulnerable settlements near the Botswana-South Africa border in the Southern District. The affected villages included Phitshane-Photlokwe, Papatlo, Ditlharapa, Phihetshwane, Marojane, Rakhuna, Logagane, and Ramatlabama.

Supt Baabina stated that her station has implemented various interventions aimed at curbing stock theft.

"These measures included intensifying patrols during both day and night, specifically along border lines and at known ambush spots used by perpetrators," said Supt Baabina.

Collaborating stakeholders such as Botswana Defence Force (BDF), Supt Baabina emphasised the importance of strategic efforts like house-to-house campaigns.

She said campaigns help to sensitise farmers on effective measures to safeguard their livestock against theft.

Additionally, Supt Baabina said they have engaged their intelligence office to gather information about offenders, which has facilitated apprehension of thieves.

The establishment of farmers' committees (mephato) in each village has proven beneficial as the groups assist with patrols and alerting the community about suspicious activities.

Ms Baabina noted that the effort aforementioned has fostered strategic ties farmers' committees across the border in South Africa's North West region, allowing for easier

access to information regarding perpetrators.

"One of the key successes of the partnership between the Botswana and South African police has been the effective flow of information on stock theft between the two countries.

"This collaboration has led to coordinated operations at the border, with plans for a joint operation scheduled for this week," said Supt Baabina.

To further protect their assets, Ms Baabina urged farmers to consider installing surveillance cameras on their properties to combat the ongoing threat of theft, which significantly affects their financial stability.

Unfortunately, Supt Baabina said the recent outbreak of Foot and Mouth Disease (FMD) in South Africa complicated the situation.

She explained that due to a travel ban on animals crossing the border, rightful owners were unable to reclaim stolen livestock after recovery efforts.

The community remains hopeful that these initiatives would lead to a decrease in stock theft and safeguard their livelihoods. BOPA

I refused to be sick breast cancer survivor

GABORONE - For years, 52-year-old Ms Margaret Linachi lived with worry quietly lodged in her heart, a fear she tried to ignore since her teenage years when she first noticed a lump on her right breast.

It was not painful then, she told BOPA in an interview, so she convinced herself it was nothing

Later, Ms Linachi said her left breast began discharging pus; mucus mixed with blood but still, she dismissed it.

"My aunt had similar symptoms and eventually became very sick and died in my arms. Watching her go through that made me too afraid to seek medical help," she

That fear followed her into adulthood. Married and busy raising her family, she said she learned to live with the discomfort until 2019, when everything changed.

"One day, I felt a lump on my left breast but this time, it was different, it was hard as wood and extremely painful, the pain was so bad I couldn't sleep at night. Even painkillers didn't help," Ms Linachi recalled.

The unbearable pain finally pushed her to seek medical attention. After several tests, she waited anxiously for the results, three long months of fear and sleepless nights.

While waiting, she said she turned to her faith for strength.

"I went for counselling at my church," she stated, "I was so anxious, but the counselling the time the results came, I had already accepted that whatever it was, I would face it with courage," said Ms Linachi.

When the results finally came, they confirmed her worst nightmare: it was breast cancer.

Ms Linachi said she felt a strange calm going through her body and told herself that if God had allowed, then she would fight to beat the disease.

In April 2020, at the height of the COVID-19 pandemic, she underwent surgery. Her doctors told her she was at stage 3B. The cancer had spread to her lymph nodes, and to save her life, they had to remove both breasts.

"It was the hardest moment of my life," she said softly.

Recovery was long painful, physically, mentally, and emotionally.

"The wounds were so painful and my body was weak but I was determined to resume with my everyday life," she said.

followed, Chemotherapy with all its harsh realities, nausea, weakness, hair loss, and exhaustion. The treatment brought with it side effects that tested her strength in ways she never imagined.

"The nausea was unbearable, I would vomit until I felt like I had nothing left inside me," she said.

She said her nails turned dark and brittle, lost her hair including her eyelashes and eyebrows, her feet would swell and ache and her joints were stiff.

"After each chemotherapy session, instead of lying down like most patients do, I would fight to

helped me find peace and by resume my normal duties," she

"I would cook and clean through the pain. My husband would be shocked at my willingness to work, but I knew in my mind that if I acted sick. the disease would swallow me whole," she stated.

Her determination became her medicine.

"It was painful, but I had to keep moving. I refused to be sick, I refused to let cancer take my spirit," she added.

But through all of it, Ms Linachi refused to let the illness break her

Another hurdle came when she had to undergo radiation therapy.

"I approached one private hospital and the charge for radiation was P130,000 and I did not have that kind of money nor medical aid," she said.

Linachi approached Journey of Hope for assistance but they too did not have funds.

Eventually she was able to raise funds for her treatment.

"Radiation burned my skin, the treated area turned dark and painful and I was always tired," she said.

Today, five years later, she proudly calls herself a survivor.

"Cancer tried to destroy me, but it didn't win," she says with a gentle smile. "It taught me to value life, to listen to my body, and to never take health for granted."

Her message to other women is clear and urgent, "Don't ignore the signs. Don't wait like I did. Early detection can save your life." **BOPA**

Botswana steps up fight against breast cancer

GABORONE - Every October, the world turns pink in honor of Breast Cancer Awareness Month, and in Botswana, that pink carries a powerful message, said Ms Gloria Rakgotla, the chief information, education and communications officer of National AIDS and Health Promotion Agency (NAHPA).

In an interview, Ms Rakgotla said "Itse Mabele a Gago -Tshwara, Leba, Tlhatloba," translated to mean Know Your Breasts, Touch, Look, Examine, was more than just a slogan, but a life-saving call to action.

She pointed out that breast cancer did not shout, it whispered, a small lump, a subtle change, a little discomfort, adding that but when ignored, those whispers could become a roar too loud to silence.

Giving statistics, she said across the globe, breast cancer was now the most common cancer among women.

In 2022 alone, over 2.3 million people were diagnosed, and 670 000 lost their lives, many simply because they did not catch it early enough, Ms Rakgotla said.

She said locally, breast cancer was the second most common cancer, especially among women.

"According to the Global Cancer Observatory, 257 new cases were reported in 2022, with 91 deaths recorded," said Ms Rakgotla.

Nevertheless, she highlighted that more women were getting diagnosed, a sign that awareness campaigns and outreach efforts vere working.

Still, she said the challenge remained as many still showing up too late and often when treatment options were limited and outcomes are poor.

Ms Rakgotla mentioned that the rural communities faced barriers like long distances to clinics, lack of access to screening, and low health-seeking behavior.

She nevertheless said the government, through NAHPA, Ministry of Health, together with local organisations like Journey of Hope Botswana and The Fighters Support Group, were all going out as they were taking breast cancer awareness from hospitals to homes, cities to cattle posts.

"From mobile clinics in remote villages to health talks at dikgotla and workplaces, we are building a national movement, that breast cancer can be prevented," said Ms Rakgotla.

She was quick to point out that not every case of breast cancer could be prevented, but many could be delayed and even avoided by changing the way one lived.

Being active, eating better by choosing fresh fruits and veggies, not processed junk, limit alcohol, stop smoking, she said were habits people should adopt, adding that tobacco was a known cancer culprit.

A healthy lifestyle is not just about looking good, but about living longer and stronger, Ms Rakgotla said.

She highlighted that October was not just about pink ribbons and T-shirts, "October is a reminder that breast cancer does not have to be a death sentence."

Ms Rakgotla emphasised that Botswana had joined the global goal to reduce breast cancer deaths by 2.5 per cent every year until 2040, a move that she said could save 2.5 million lives worldwide.

She said government was stepping up through early detection as screening services were being brought into local clinics and outreach programmes in rural areas.

Ms Rakgotla also mentioned education, adding that through national campaigns, dramas (hello Makgabaneng!) and partnerships with media and community leaders were spreading the word.

She called on individuals to play a part, talk about breast cancer and start conversations at home, church and work. learn how to do a breast selfexamination monthly, as well encourage loved ones to get screened, saying early detection saves lives, support local support groups as they made the journey less lonely and live healthier.

"Breast cancer can happen to anyone, women, men, young, old, but together, we can catch it early, we can treat it effectively and we can save lives, so, Itse Mabele a Gago - Tshwara. Leba. Tlhatloba, because knowing your body might just save it," said Ms Rakgotla. BOPA

Firm buys stake in Bayport

wellness through responsible access to credit and foster financial inclusivity.

"Bayport takes a conservative

approach to lending," he said, adding that borrowing was used for the betterment of livelihoods.

He said among the top uses of

money borrowed from Bayport were health services, education fees and building houses.

Mr Pule further added that Africa Lighthouse Capital was attracted to Bayport by its ability to grow even when the economy was challenging, noting that the loan book had been substantially growing over the years.

He noted that Africa Lighthouse Capital has seen growth in new customers, especially those not getting assistance from commercial banks.

The process of buying the stake, he said, started in March 2024 and will be completed in November, adding that Africa Lighthouse Capital satisfied itself through a thorough due diligence process before investing.

Group Chief Financial Officer, Mr Greg Davis, hailed the partnership between the two firms, adding that Bayport was a strong business entity.

He said the investment would impact Batswana, allowing people to advance their lives, and noted that Bayport was a major player in the country's microlending landscape.

Mr Davis said the company, having operated in the country since 2010, felt it was time to partner and empower locals.

He added that Bayport Management Limited was privileged to be working with Africa Lighthouse Capital and that the partnership would move the business of empowering Batswana forward.

Bayport Botswana Chief Executive Officer, Mr Sinclair Sithole, said Bayport was a market leader that supports responsible lending.

He said the financial institution was leading mostly to salaried employees, deducting from the source, and was cautious to ensure that clients were not overburdened with debt.

"We ensure that people do not hurt themselves in the lending process; we protect our clients," he said, adding that Bayport was in support of any oversight legal framework to ensure industry sanity and adherence to set standards and regulations.

Mr Sithole said Bayport Botswana provided loans and insurance to government employees and other sectors of the economy, stating that the company currently had over 25 000 active clients. *BOPA*

China VAT data shows growth in companies spending on home appliances

BEIJING - China's State Taxation Administration on Thursday released value-added tax (VAT) invoice data, which reveals growth in firms' spending on equipment renewals and rising sales of home appliances in the first three quarters of this year.

Boosted by the equipmentrenewal and consumer goods trade-in programmes backed by the government, the value of enterprises' purchases of machinery equipment increased 9.4 per cent year on year in the period, the data showed.

In particular, machinery equipment purchases in the high-tech manufacturing sector grew 14 per cent year on year, while firms' purchases of digitised equipment grew 18.6 per cent.

During the same period, the retail sales revenue for home appliances such as refrigerators grew 48.3 per cent year on year, while retail sales for audiovisual gadgets saw a 26.8 per cent growth. Retail sales revenue for furniture increased by 33.2

per cent year on year, while the sales revenue for cell phones grew 19.9 per cent. The trade-in programmes have also boosted China's car consumption.

Latest data from the China Association of Automobile Manufacturers showed that China's new energy vehicle sales surged 34.9 per cent year on year to nearly 11.23 million units in the first nine months of this year, accounting for 46.1 per cent of total vehicle sales in China. *Xinhua*

Basket monument boosts revenue

MAUN - Nhabe Museum has become a centre of attraction and has cultivated interest in cultural tourism due to the iconic basket monument placed at its entrance.

The historic artwork has transformed the museum as it is now experiencing an influx of visitors who enjoy interacting with the artwork through photo shooting.

Nhabe Museum board chairperson, Tshematshe Monwela confirmed in an interview that the basket structure had brought the community-based museum to life by creating unique visitor experience that drew tourists and locals alike.

Monwela appreciated that the structure had not only given the museum a facelift, but has also significantly boosted income generation from the P15,000 per annum that they used to make.

The museum generates revenue through crafts sales, stall rentals to producers and visual artists, auditorium hire and entrance fees, he said.

He said the structure was a hit with both international and local travellers who loved it for the fact that it promoted and preserved the region's culture and traditions.

"This artwork has created a lively atmosphere. It has attracted a lot of attention not only of visitors but of some companies as many are now willing to invest in the museum to enhance its attractiveness as well as make Maun a destination of choice," he added.

Monwela revealed that some companies had shown interest to develop the museum into a state-of-the-art facility to enhance its relevance and cultural impact in Maun.

He is of the view that museums needed to find new ways to keep visitors captivated and to stay relevant and appreciated that some companies viewed the facility as an important asset with the potential to enhance the area's tourism offering.

He also pointed out that the board had worked hard to take the museum to the community and to ensure that all tribes in the region contribute material content to help it to deliver on its mandate to promote and preserve heritage, history and cultural diversity.

The museum curator, Tumelo Thuthuka reiterated Moswela's view that the basket structure has brought vibrancy to the museum, luring scores of visitors.

The art he said, offered a unique, high value experience across all age groups, citing that the traffic had propelled them to design a package of fees for

locals, international visitors, and for clientele from within the SADC region.

He said they recently hosted learners from Francistown and a lot of international travellers who appreciated the artwork, saying it provided them with a deeper understanding of the diverse cultural milestones in the region.

"This artwork has indeed improved our overall operation. We started around May to charge entrance fees and have since been generating P15,000 a month," Thuthuka added, confirming the leap in income generation that Monwela had mentioned.

"We have also done a lot of improvements by offering exciting exhibits and displays to ensure customers receive value for their money," he elaborated.

Thuthuka further noted that efforts were ongoing to forge partnerships to host unique events throughout the year that could attract visitors, explaining that they intended to create special exhibits with activities that were not just artistic but also educational.

He said currently, they were in talks with Debswana Letlhakane mine to display the diamond

GABORONE - While the delicious and mushy banana has many gastronomical uses, Legakwa Veils is redefining how to use the fruit, but not the mushy part, to make a fashion statement.

Known for their exquisite

handcrafted and customised bridal and occasion pieces such as veils and bouquets, the fashion brand also offers sun-ready creations ranging from widebrimmed hats and portable hand fans to fashionable fascinators made from materials that are anything but ordinary. While the brim of their hats is made from recycled potato sacks, the innovative designers at Legakwa Veils weave their exquisite fascinators using banana leaf fibres, otherwise known as banana silk.

The fibres are extracted from the outer sheath formed by the leaves that grow around the trunk of the banana plant.

The centuries-old practice, with evidence dating back to the 13th century, has recently caught the eye of Western fashion, and now, Legakwa Veils.As if that were not peculiar enough, the fascinators are further adorned with ostrich eggshells, a daring seal to their fashion statement.

To the touch, the texture of the fascinator is surprisingly tough, giving off a sense of great durability.

"The banana leaf fibre is not only eco-friendly but also very durable," said Tshireletso Sekaiwa, millinery assistant at Legakwa Veils, who described the process of extracting the fibres as arduous but worthwhile.

"Not only are the fibres strong, but they are also lightweight, making them perfect for fashion," she added.Beyond celebrating sustainable practices, Legakwa Veils also infuses elements of Botswana's culture into their creations, incorporating traditional prints into hats and hand fans.

"We make feel-good fashion. We customise our creations according to what the client wants, we make bold fashion statements," Sekaiwa said *BOPA*.

Furthermore, he said relays would also expose the countries' tourism to the world and underscore Botswana's athletics prowess.


