Norris reveals vision behind UB success

GABORONE - Behind every successful institution is a visionary leader and this, is the story of the University of Botswana (UB), with Professor David Norris as vice chancellor.

The improvement in the university's regional and international rankings signify his dedication and strategic focus in shaping its future.

An announcement during the 43rd graduation ceremony on October 16, that its research output has surged by 400 per cent over the past seven years, is a story worth telling.

In the same breath, Prof. Norris university's highlighted the innovation centre which has developed several products now ready for commercialisation.

BOPA reporter, Ndingililo Gaoswediwe paid Prof. Norris a visit, to appreciate how far he has come in transforming the university.

"Towards the end of 2017, when I joined UB, I examined the institution's act and realised that the university was primarily focused on teaching, with limited emphasis on other vital functions such as quality research, innovation, and contributing to the country's economic growth," Prof. Norris explained.

The discovery set the foundation for a new strategic direction.

"Research, when integrated effectively, enhances the quality of teaching and can be a powerful tool to support a knowledge-based economy," he added.

Prof. Norris, who currently oversees a university population nearing 20 000, recounted that his journey with the Londonbased organisation, Times Higher Education World University Rankings (THE WUR), began around this time.

These rankings are crucial because they help prospective students, researchers, institutions understand where universities stand globally and identify areas for improvement.

Prof. Norris explained that being ranked is an achievement in itself, "it indicates that the university has reputable publications and is recognised on the global stage."

THE WUR evaluates universities based on five key areas namely; teaching, research environment, research quality, industry income and International outlook, Prof. Norris said.

Although South universities generally rank higher, with a 62.9 per cent research score, Prof. Norris said that UB surpassed some, such as University of Pretoria (57.5 per cent), and was approaching the level of the University of Johannesburg (69.9 per cent).

"Our ultimate goal is to reach the standards of top institutions like Stellenbosch," he added.

Today, UB is the leading university in Botswana and ranks second among nine institutions in Southern, Central, and East Africa, 16th out of 56 Sub-Saharan African universities; 37th out of 141 African universities; and falls within the 1 001 to 1 200 band globally out of 2 191 institutions, a sign of relentless focus on quality.

"Quality is paramount, we do not accept substandard work. Rigorous quality assurance processes are ingrained before any publication," said Prof. Norris.

The university has also been actively advancing innovation from its laboratories and Innovation Centre toward commercialisation.

As with all great achievements, Prof. Norris admits that room for improvement remains.

His priorities include refining teaching methods through digital technology, despite the significant investment required, and ensuring degree programmes remain relevant to today's global demands.

While research funding has largely depended on limited institutional resources and external agencies like the NHI, he stressed the importance of establishing dedicated research centres.

Engaging industries. particularly small, medium, and micro enterprises (SMMEs), through high-quality research can be a catalyst for economic growth. He also talked about the urgency of transforming signed Memorandums of Understanding (MoUs) with various organisations, companies, and ministries into tangible collaborations rather than mere formalities.

To sustain and elevate the university's global standing, Prof. Norris outlined that becoming a lecturer required holding a PhD, and promotion to senior lecturer depended heavily on the number of published journals.

Although happy with the progress, Prof. Norris wishes to see the university producing more post

Out of the 3 539 who graduated this year, only 22 were honoured with PhD, and 500 awarded Master of Philosophy and Master's Degrees, including Postgraduate Diplomas.

UB's Institutional Planning director, Mr Richard Neill, pointed out that prior to 2019, there was no formal monitoring and evaluation

"Achieving a ranking in THE WUR was a major milestone, out of 30 000 applicants, only 2 500 universities are ranked," he said.

UB made a major breakthrough in 2021, with its research impact score soaring from 11 to 62.9 per cent, a feat attributed by Mr Neill to the university's specialisation in clinical, health, and social sciences.

Mr Neill highlighted innovations such as feed derived from black soldier fly larvae, hospital beds made from recycled plastics, as well as capacity-building initiatives

in pharmaceuticals and biotech.

In terms of commercialisation, UB's Faculty of Engineering is leading pioneering research into biodiesel, with an aim to reduce reliance on imported fossil fuels and promote a clean energy transition.

This aligns with Botswana's Vision 2036 and its commitment to attain a 15 per cent reduction of greenhouse gas emissions by 2030. **BOPA**

Collective efforts vital for development

Assistant Minister for Local Government and Traditional Affairs, Mr Ignatious Moswaane, made the call during a Kgotla meeting at Etsha 13 on Monday.

Moswaane residents against internal conflicts, urging them instead to combine efforts for the common good. He said the new administration was committed to removing bottlenecks and reviewing regulations that hindered business operations in the country. He emphasised the importance of having a shared community vision, saying development should be a holistic

"You can form a council that includes young people and come up with ways to generate income for your village's development," he advised.

Mr Moswaane encouraged community members to apply for business plots and start enterprises regardless of their social standing, noting that everyone had a role to play in development. He also called on political leaders to serve their communities without bias or party affiliation and to work closely with Village Development Committees (VDCs), as the new government prioritises people and development.


On VDC regulations, Mr Moswaane said they were still under review, adding that educational

effort involving all members of requirements might disadvantage some rural communities.

He further urged community trusts to be accountable and to consult residents before using public funds.

Meanwhile, the assistant minister said government continued to face financial challenges, which had delayed the implementation of some promises, such as the P2,500 salary for Ipelegeng workers.

In his welcome remarks, Kgosi James Sivako of Etsha 13 said the village continued to face challenges, including a shortage of office and staff accommodation for public officers such as police. He noted that while the village clinic was upgraded from a health post in 2012, only staff houses were built, and the clinic facilities were yet to be constructed. **BOPA**

Siamisang urges voters to ensure orderly poll

TSABONG - Kgalagadi South voters have been urged to work effectively with election officers in the upcoming by-election to ensure its success.

said by the This was Electoral Independent Commission (IEC) Secretary, Mr Jefferson Siamisang in a kgotla meeting in Tsabong recently, marking the beginning of a series of consultation meetings across the Kgalagadi South constituency in preparation for the by-election.

The by-election, which comes following the death of the area Member of Parliament who was also Minister of Lands Agriculture Dr Micus Chimbombi, would be held in November 15.

Mr Siamisang commended the Kgalagadi South voters for their cooperation and patience during the past 2024 elections.

He noted that 18 454 people registered and 16 029 voted, resulting in an impressing turnout of 86 per cent. He also lauded voters for displaying good behaviour at different polling stations.

He urged that the same patience and respect be demonstrated in the coming elections. Mr Siamisang

emphasised the importance of being patient and respectful, and requested that voters prioritised people with disabilities, pregnant mothers, and senior citizens.

He encouraged voters across the 68 polling stations to work effectively with presiding officers and polling officers to ensure the smooth running of the election.

The polling stations he said, were scheduled to open at 6.30am and close at 7pm, after which all ballot boxes would be transported to the constituency counting centre in Tsabong.

Voters were also encouraged to ensure that they have a valid Omang card.

Tsabong One resident, Mr Fedrick Cooper, who acknowledged the Secretary's visit, requested that all polling stations be adequately supplied with necessary materials to prevent delays.

Mr Cooper cited that, in the past, some polling stations ran out of voters rolls, causing a long wait and leading to some voters leaving without casting their ballots.

Nursing students use billboards to fight drug abuse

MOCHUDI - An initiative aimed at curbing the growing problem of drug abuse among young learners has been warmly received by Lady Mitchison Primary School in Mochudi.

Speaking during the handover of a substance abuse awareness billboard, Lobatse pyschiatric mental health nursing student, Ms Boikobo Moakofi said the billboard would serve as a constant reminder of the dangers associated with drug use, especially among children.

"We want to catch them young, to help them understand the ills that come with substance abuse,"

Ms Moakofi explained that

the campaign was designed to educate primary school pupils about the negative effects of drug abuse, including poor academic performance, mental health challenges, and physical harm.

She added that Lady Mitchison was chosen because of its proximity to Molefhi Senior Secondary School, teachers had previously reported cases of primary pupils allegedly sharing drugs with secondary school learners through the school fence.

Given such concerns, Ms Moakofi said there was an urgent need for awareness campaigns targeting younger learners.

The six nursing students from Lobatse Nursing College, she said, had taken up the challenge through the billboard project.

"The initiative also emphasises the roles of teachers, parents, and the community in fostering a safe and drug-free learning environment," she said.

She further called for the formation of peer-support clubs in schools to promote counselling and guidance among pupils, noting that some had shown signs of aggression linked to substance

Ms Moakofi encouraged pupils to become agents of change, promoting positive behaviour and resisting peer pressure.

a generation that is upright, responsible, and ready to lead in the future," she added.

Deputy School Head Mr James Sefhako applauded the donation, describing it as timely and impactful.

He said targeting pupils at an early age was crucial in the fight against social ills linked to drug abuse, which often lead to poor academic results and health problems, including mental illness.

Mr Sefhako expressed hope that similar outreach initiatives would become routine, saying pupils were often more responsive to such interactive awareness activities. BOPA

Japan donates over P1 million to BGBVC

GABORONE The government of Japan has donated more than P1.13 million (US\$ 84,942) to support the Botswana Gender-Based Violence Prevention and Support Centre (BGBVC) in expanding its GBV shelter.

Speaking during the Grant Assistance for Grassroots Human Security Projects signing ceremony in Gaborone yesterday, the Japanese Ambassador to Botswana, Mr Shindo Yusuke, said the gesture underscored long-standing partnership between the Japanese Embassy and BGBVC.

Mr Yusuke recalled that in 2012, the embassy donated the

building that housed BGBVC's current temporary shelter. He added that through the Japan Overseas Cooperation Volunteer programme, Japan had continued to assist the centre by providing volunteer staff.

He said the latest gesture was part of Japan's commitment to helping build resilient societies and restoring the spirit of Ubuntu, a principle he described as essential not only to combating GBV but also to rebuilding communities and strengthening national unity.

"GBV is one of the most human security pressing challenges of our time. It affects individuals, families and entire communities. This grant affirms that survivors of gender-based violence are not forgotten, and their right to live in safety is supported not only locally but globally," he said.

The Ambassador expressed concern that GBV in Botswana had reached crisis levels, citing a 2021 United Nations Population Fund (UNFPA) report, which found that 67 per cent of women in Botswana had experienced some form of GBV in their lifetime which is more than three times the global average.

"These are not just statistics they represent lives interrupted. families broken and communities in pain." He commended the government for drafting the country's first-ever National GBV Bill, as a milestone aimed

at strengthening prevention and response mechanisms. However, he noted that challenges remained in ensuring access to safe spaces and comprehensive support for

"It is for this reason that the Embassy of Japan is proud to support BGBVC. This funding will enable the construction of additional shelter housing, allowing the centre to support more women and children in urgent need of safety," he said.

For her part, BGBVC Chief Executive Officer, Ms Lorato Moalusi, thanked the government of Japan for its continued partnership, describing it as a demonstration of solidarity in advancing gender equality and social justice.

"As we sign this grant agreement today, let it serve as a symbol of hope, a promise that together we are building a Botswana where every person can live free from violence, discrimination and fear," she

Ms Moalusi added that the expansion of the Gaborone shelter would mark a significant step toward a safer and more inclusive nation.

"Today's occasion is not merely a funding agreement, it is a statement of shared purpose and a commitment to uphold the dignity, safety and rights of survivors of GBV. It is a reminder that behind every statistic lies a human story, a woman, a child, or

a family seeking refuge, healing and hope," she said.

BGBVC, she said, continued to stand at the frontline of the fight against GBV, serving women, men and children seeking safety and dignity. The organisation currently operates in Gaborone, Ghanzi and Francistown, providing counselling support services to over 5 000 survivors to date, including more than 800 who have benefited from its shelter programme.

Beyond shelter, Ms Moalusi BGBVC said provided psychosocial counselling, support, medical assistance, legal referrals, empowerment programmes and community education to address harmful gender norms and practices.

She said the existing shelter, built with Japan's support, accommodates a maximum of 18 people, who typically stay for one to two weeks.

She added that due to the complexity and risks associated with GBV, which included threat to kill and attempted murder, the centre did not turn away clients or put anyone on a waiting list as these were emergencies.

Ms Moalusi further said when demand exceeded capacity, BGBVC with the support from the government and private sector arranged for alternative accommodation, though this has proven difficult as most rented spaces were not suitable for survivors. BOPA

Strategy addresses human-wildlife conflict

GABORONE - The Minister of Environment and Tourism, Mr Wynter Mmolotsi says addressing human-wildlife conflict is among priority areas of the National Development Plan 12 (NDP 12) strategy.

He acknowledged that humanwildlife conflict was one of the major impediments of economic growth and food security within the rural communities, with an average of over 9 000 incidents recorded annually.

Mmolotsi said the government was committed to reducing these incidents by 10 per cent annually during the plan period. Presenting the Tourism and Environment chapter in the draft NDP 12 to Parliament on Wednesday, Mr Mmolotsi said 'a total of 46 744 human-wildlife conflict incidents were recorded between 2020 and 2025, translating to an average of 9 349 incidents per year.

Mr Mmolotsi said in order promote a sustainable environment toward economic growth and social wellbeing, plans were underway to review the current compensation rates, construct electricity powered wildlife-proof fences as well as supporting farmers to construct electrified fences around cluster farms. Additionally, he noted that government was intending to develop a new financing strategy toward compensation for damages caused by wildlife, while also creating an opportunity for other stakeholders to contribute towards conservation.

"A new financing strategy for compensating damage caused by wildlife would be developed and a green fund would be created to attract resources from outside of the government to be used towards conservation and humanwildlife conflict," he said.

Furthermore, the minister noted that value chain development opportunities would be optimally explored to grow the wildlife economy. He noted that during the plan period, government would also implement the biodiversity financing model to support protected areas.

Mr Mmolotsi said in addition to strengthening anti-poaching, wildlife patrols and community participation, cross-border collaborations would be enhanced

to control wildlife trafficking to

neighbouring countries.

On other issues, he noted that stakeholder engagements would be intensified focusing on capacity building and compliance on plastic management, which contributed to environmental degradation. "Key stakeholders will continue to be engaged through consultations, capacity building and awareness initiatives to ensure inclusive participation and compliance," he said.

Mr Mmolotsi also noted that, strategies such as strengthening regulatory framework, multisectoral climate mainstreaming and capacity building and improving weather systems to enhance weather forecasting, early warning and disaster preparedness would be put in place. BOPA

Tourism plan targets restrictive legislation

GABORONE - Reviewing and harmonising all legal frameworks to create a conducive environment for the tourism sector to flourish has been identified as one of the priority areas of the National Development Plan 12 (NDP 12).

Presenting the tourism chapter in the draft NDP 12 to Parliament on Wednesday, the Minister of Environment and Tourism, Mr Wynter Mmolotsi said as a multistakeholder industry, the tourism sector was essential for driving inclusive economic growth and employment creation.

"Tourism is one of the strategic sectors that government has earmarked and prioritised under the Botswana Economic Transformation Programme (BETP). Its full development is essential to our national ambition of transforming from an upper middle economy to a high income economy," he said.

He noted that plans were underway to review harmonise legislation such as the Tourism Act, Botswana Tourism Organisation (BTO) Act and Immigration Act to enable and enhance growth and diversity in the tourism industry.

He further said a Tourism Equity Fund will be established to encourage citizen participation and enhance collaboration.

"To boost citizen participation, a Tourism Equity Fund will be established and partnerships

with private financiers explored to improve access to capital for Small, Medium and Micro Enterprises (SMMEs).

"Additionally, we consider the privatisation of wildlife resource management to enhance efficiency and revenue generation." he said.

Mr Mmolotsi said since the development priorities of NDP 12 were premised on building a sector that was both diversified and inclusive, they were committed to repositioning Botswana as a destination of choice for tourists.

He said through various interventions, the government intended to increase average length of stay and average spend per day by tourists visiting the country.

Minister Mmolotsi said the development would be achieved through improved product booking packaging, digital systems and targeted marketing strategies which attract high value tourists.

He noted that tourism continued to increase its contribution to the GDP and job creation, currently employing over 50 000 people and a projected increase of 25 per cent by 2030.

Additionally, he said the Tourism Sector Real Value Added Growth Rate, premised on accommodation and food services, was anticipated to increase from 4.4 per cent in 2024 to 6.7 per cent by the end of the plan period in 2030.

He underscored the need enhanced stakeholder collaborations, development, strategic investments and infrastructure development.

Mr Mmolotsi said government was committed to improving key infrastructure in the tourism industry to align with regional standards.

"Government continues to invest in the state of the art infrastructure to enhance regional competitiveness. Key developments include the Kasane/ Kazungula re-development project, refurbishment of the National Museum, Ntsweng Museum and upgrades to Kasane, Maun and Sir Seretse Khama international airports," he noted.

Mr Mmolotsi said the government had partnered with the United Nations Development Programme (UNDP) through the biodiversity financing project to develop an online parks revenue system to streamline bookings and promote financial transparency.

He underscored the need to strengthen domestic supply chains to address revenue loss through importation of goods and services. He cited restrictive immigration policies, inadequate infrastructure and communication connectivity as some of the challenges hindering the growth of the tourism sector.

Tourism opportunities remain untapped - MP

PARLIAMENT - Despite its potential to transform and diversify the country's economy and create more employment opportunities, the tourism sector has a lot of untapped opportunities across the country.

Contributing to the debate on the Environment and Tourism Chapter of the National Development Plan 12 (NDP 12) on Wednesday, Selebi Phikwe East MP, Mr Kgoberego Nkawana said government should review the licensing requirements for tourism enterprises to enable more people to play a role in growing the sector and creating employment for youth.

He also said there was need to establish a museum in Selebi Phikwe as a way of promoting cultural tourism.

"There is nothing that shows that Selebi Phikwe is a mining town and we need to have a museum to showcase the history of the town and the mine," he said.

In addition, Mr Nkawana emphasised the importance of public education on best waste management practices. He urged government to come up with initiatives that would motivate people to turn plastic waste into income generating projects, to curb environmental degradation caused by plastic litter.

For his part, MP for Nata/Gweta Mr Lawrence Ookeditse said Makgadikgadi Pans had a lot of potential worth harnessing to diversify the economy of the communities. He said the area had rich cultural heritage which needed to be properly packaged for tourism purposes. "The area offers more diversity and potential than we are currently doing. The people have a lot of interesting stories based on history and indigenous

knowledge," he noted. He said there was potential for archaeological explorations which could enhance the cultural heritage of the area and contribute towards economic diversification.

He further said there was need to establish a craft shop to showcase the artifacts produced by local people to take advantage of its strategic location for tourists.

"There should also be an online version of the same craft market facilitated by the department using earnings from tourism, to empower the communities to generate income with their products," he said. He further called for effective implementation of human wildlife conflict strategies which would not only prevent incidents but also ensure better compensation for loss of lives and property.

In his contribution, Kgatleng East legislator Mr Mabuse Pule said government's tourism initiatives should not only be concentrated in the same areas, while leaving out the potential in other places in the Southern part of the country.

He said Kgatleng East had a variety of fish species which could boost the tourism industry.

He noted that various cultural sites in Kgatleng could be developed to create employment opportunities for young people.

Additionally, he said the ministry should consider adopting effective and new technologies for waste management.

He said landfills in Kgatleng area were not properly managed and were life-threatening as they encountered fire outbreaks from time to time, as well as polluting the environment. He also said fire breakers should be regularly maintained to curb veld fires which were a threat to food security.

Furthermore, Mr Pule called for the inclusion of environmental

management in the school curriculum.

"I urge your ministry to collaborate with the ministry of education to introduce environmental management in the school curriculum and undertake capacity building for teachers," he

Lowapi academy donates books to four schools

MAHALAPYE - Lowapi Study Centre has donated about 1 476 books to different schools in Mahalapye.

The centre donated books to Flowertown and Tamocha primary schools, and Mowana and Pekenene junior secondary schools recently.

Speaking during a handover ceremony in Mahalapye recently, founder of Lowapi, Ms Bonolo Boitshwarelo said her institution were a neurodiversity centre aiming to curb learning impairment within the education system.

Furthermore, she said it was a literacy enhancement centre dedicated to early childhood education and supporting neurodivergent learners.

Therefore, she said the month of October was important, as it was Dyslexia awareness month.

She stated that Dyslexia was a learning impairment or disorder that disrupted how the brain processes written language.

In addition, Ms Boitshwarelo said failure to diagnose Dyslexia early had left some children out of school. She emphasised the importance of books in the academic life of learners and buttressed more on the significance of enforcing literacy as well as identifying neuro-divergent learners.

She spoke of need to do something to detect learners with learning disabilities at an early stage. "Reading is a human right and everyone should be literate. The way people have access to water is the same way they should have access to reading skills and therefore we need to ensure that

our donations should focus more into ensuring we equip our young ones with that which cannot be stolen from them and benefit them for a considerable period of time," said Ms Boitshwarelo.

Speaking at the same occassion, Mahalapye West Boseja/ Flowertown councillor, Mr Khumo Ramagapu expressed gratitude to Lowapi Study Centre, noting that everyone should play a role in assisting developing schools by collaborating with the government.

He said as the country continues to tackle numerous challenges, communities were encouraged to come up with innovative avenues to be self-reliant.

Mr Ramagapu spoke of the significance of education urging teachers to continue being resilient and persevere in contributing to the lives of learners.

Furthermore, he said government has put in place an Act that mandates businesses to contribute towards development of communities in their areas of operation. For her part, Flowertown Primary School head, Ms Boipelo Fane said the noble gesture was a welcome development. She said schools were facing challenges of learning/teaching aids and therefore a donation of such books will go a long way in improving academic performance in schools.

Appreciating Lowapi Centre's expertise, she said, the school was grappling with learners who were unable to read and therefore their assistance came at the opportune time to encourage students and teachers to work hard towards ensuring learners invest in reading. **ROPA**

'Multi-disciplinary approach key to food production'

GABORONE - Sustainable food production demands multidisciplinarity, says University of Agriculture and natural Resources (BUAN) vice chancellor, Professor Ketlhatlogile Mosepele.

Speaking at BUAN and Capacitating One Health in Eastern and Southern Africa (COHESA) meeting, in Gaborone on Wednesday Prof. Mosepele said sustainable food production demanded adapting an integrated approach that recognised the value of healthy ecosystems that extolled the virtues of human health and acknowledge on the importance of healthy animals.

He said a silo approach was not only counter-productive but also regressive because 'we are compelled to walk together on this journey and work assiduously to develop sustainable agri-food systems. One-health is not an option, but a critical necessity.'

Prof. Mosepele cited challenges like emerging pandemics, antimicrobial resistance and food insecurity, as demanding collective action and integrated policy-frameworks.

He said the World Organisation for Animal Health (WOAH) reported that 75 per cent of globally emerging infectious diseases, 36 per cent of which were associated with food producing animals were zoonotic diseases and also acted as magnifiers of wildlife pathogens.

"Therefore, there is a compelling case for us to adopt a One-Health approach comprehensively to not only achieve food security but also to realise the objectives of the UNSDGs. It was for this reason that the COHESA project was developed.," he said.

developed. ," he said.

Prof. Mosepele said the COHESA project revealed that Botswana had a robust foundation for One-Health with broad, multisectoral cross-cutting networks across government, academia and external partners.

He said critical coordination was already handled at the highest levels in government and the academia.

Reporting on the One-Health Net-Mapping results, BUAN Prof. Moatlhodi Kgosimore said One-Health was to optimise the interconnection between people, animals, plants and their shared environment.

Prof. Kgosimore said they had to ensure optimal outcomes and realised the expected results.

He said they needed to work on the technical and societal issues while societal issues were the ones they were usually omitted making adoption an issue.

Prof. Kgosimore also said the One-Health issues they came across were inadequate crosscollaborations which was key.

He further said there was inability to adopt health solutions to national context and cascading of solutions.

Prof. Kgosimore said they also found inadequate research infrustructire, limited funding as well as integration of efforts as contributors to inadequate implementation of One-Health.

"So we really need to come together as different stakeholders to make sure that health outcomes are realised," he said. *BOPA*

MOGODITSHANE- Failure to fully implement government policies and programmes has always been a headache for farmers and a setback in improving the agricultural sector and livelihoods of the farming community.

Farmers in Mogoditshane-Thamaga District strongly believe that lack of implementation of policies was a handbrake to progress and growth of the sector.

They shared their sentiments during a consultation meeting on the review of the National Policy on Agricultural Development of 1991 on Tuesday in Mogoditshane. Despite government coming up with good policies and programmes, farmers were of the view that implementation remained a challenge.

They hastened to say that the review of the agricultural policy should be a break through, allowing farmers to benefit in large numbers.

One of the farmers, Ms Tanki Sola said time had come for government to assist serious and committed farmers determined to produce food for the nation.

She said commercial farming had great benefits both for the owner and market therefore encouraging fellow farmers to commercialise their farming to reap the benefits.

Ms Sola said even though her bee keeping and honey production business was doing well, her hope was for the review of the policy to come up with interventions to assist small scale

farmers grow and expand their businesses.

She added that farmers should not look down on themselves, as no matter how little they started, opportunities for growth were in abundance.

Another farmer, Mr Thato Motlhagodi said it was unfortunate to note that some beneficiaries of government programmes aimed at growing the agriculture sector had been wasteful, rendering such programmes impractical.

He argued that it could not be said in totally that farmers had not benefited from government programmes as many had and continued to benefit but majority failed to take responsibility of their projects.

Mr Keletso Makgethe said he was worried that many agricultural products that came into Botswana were not fully tested to ascertain their impact on the landscape of the agricultural

He said the new policy should come up with regulations that protected Batswana farmers from agricultural imports that could negatively impact the local

Mr Makgethe concurred with Mr Motingwa Tshiping that the provided fertilisers had caused harm than good to the soil, even though government believed it was for enhanced production.

Mr Tshiping also observed that imported seeds had brought with them species of unknown pests and weeds, difficult to deal with, hence the need for every farmer to be careful when using them.

Chief Policy Officer, Ms Lorato Sello said the country was shifting from primarily focusing on food self-sufficiency and food security to food sovereignty.

She said the move emphasised on local controls over food systems, sustainable practices, and the rights of communities to shape how food was produced and distributed in alignment with national values and ecological preservation.

Ms Sello said another government shift was from being the market sector to market enabler, an approach that strengthened the role of the private sector and farming community by creating a supportive environment that encouraged investment, innovation and efficiency across the agriculture value chain.

"The current policy shifts focus towards farm profitability and commercialisation to transform agriculture into a market-driven, income generating sector that productivity, attract investments and create jobs, especially for smallholders and youth," she said

Ms Sello said the policy shift adopted a new strategic orientation incorporating lessons learned and addressing past limitations.

Kgosi Keabetswe Dihutso of Mogoditshane said people should be ready to expect changes as the government was now run by a new administration.

He said changes were imminent, hence consultations on the review of the agriculture policy. **BOPA**

Residents decry unfair business practices

MAUN - Some Maun residents have called on government to consider reinstating the Department of Consumer Affairs, saying its absence has left consumers vulnerable to unfair business practices and unsafe goods.

The residents voiced their oncerns during a consultative meeting in Maun Tuesday meant to solicit stakeholder input on the proposed National Food Safety Strategy, which aims to strengthen food safety management across all sectors.

They said the abolition of the Consumer Affairs Department in 2022, and subsequent transfer of its mandate to the Competition and Consumer Authority had negatively affected consumer protection particularly in Maun where the local office was closed.

Residents complained that some businesses were now selling unsafe or expired food, failing to maintain hygiene standards, and displaying incorrect or inflated prices, with little enforcement taking place. Responding to the concerns, Chief Health Officer in the Nutrition and Food Control Division under the Ministry of Health, Ms Onalenna Ntshebe, appreciated the feedback and said the proposed National Food Safety Strategy would promote stronger collaboration among government departments.

"Food safety is everyone's business, and as such good collaboration between departments, food producers, and consumers is needed to help ensure food safety and a stronger food system", she said.

Ms Ntshebe added that food safety began at the production storage, including transportation, and handling at household level, noting that contaminated food posed serious health risks. She said the envisaged strategy would define clear roles and priorities for all stakeholders and ensure cultural sensitivity in its implementation.

"We want to develop a strategy that addresses challenges faced by Batswana from farm to fork," she said. BOPA

Magistrate asked to recuse himself from case

LOBATSE - Two men accused of breaking into Good Hope Rural Administration Centre Offices and stealing items worth over P86,000 between December 31, 2021 and January 5, 2022 have demanded that Lobatse senior magistrate Tshoganetso Atamelang should recuse himself from their case.

The items that Kgosietsile Pilato, 41, of Molepolole, and Orapeleng Motshidisi, 29, of Papatlo were accused to have stolen included three desktop computers, a laptop, bar fridge, camera, two camp chairs, and a gazzebo, amongst others.

First accused, Pilato alleged that the prosecuting officer, Mr Mompati Koosimile accepted P4,000 bribe from him not to register the case with court and have Pilato walk free. Additionally, Pilato claimed that his phone, which had information which he could use as evidence in his defence, was stolen by the police in Francistown.

Magistrate Atamelang dismissed the claims as an attempt to derail the court, pointing that the allegations levelled by the accused were of no effect to the case.

Furthermore, he cautioned Pilato who had maintained his innocence, that causes of action could arise from the allegations he made.

"I do not understand why a bribery was given if there was no offense committed. This is a case of defamation that the officer might raise. You have just conceded that you bribed the prosecutor, are you aware that conceding that you bribed a public officer is a criminal offense punishable by law?" he said.

In a dramatic turn of events, the accused then pressed for the Senior Magistrate to return the case to Chief Magistrate Rebecca Motsamai who initially handled it, claiming that Mr Atamelang was biased against them.

Mr Atamelang however said: "The issues you are raising are trivial, and do not necessitate my recusal." He said he could not delay trial with trivial matters and therefore set November 3, 5 and 7 as the trial dates. BOPA

Veldt fire ravage 50 000 hectares

PANDAMATENGA - A total of 50 000 hectares of land in the CH9, CH8, and CH12 controlled hunting areas have been burnt by recent veldt fire that occurred near Pandamatenga in the Chobe District.

Regional manager for the Department of Forestry and Range Resources (DFRR) in Chobe, Mr Keletso Seabo has explained that the fire erupted when a local farmer burned debris at his farm in Pandamatenga on October 7.

"The fire started in CH12 and CH8 and spread quickly because of dense vegetation and strong winds," Mr Seabo said.

Fortunately, no human lives, wildlife, or livestock were lost, although grass and shrubs were severely burnt, he said.

Immediately after outbreak, DFRR officers and the Pandamatenga Ipelegeng workers were deployed to help contain the fire.

The team used fire beaters, engine air blowers, and fire balls to reduce oxygen supply to the flames. They also conducted back burning and created firebreaks to stop the fire from spreading.

Community including the Pandamatenga-Lesoma-Kazungula (PALEKA) Community Trust, provided vehicles, generators, and air compressors to assist with the firefighting efforts. Local government departments and individuals also contributed and additional manpower equipment.

Mr Seabo said it took the team nine days to fully extinguish the blaze due to persistent winds. He added that the affected areas had not burned since 2023 and were covered with dense vegetation, making the fire difficult to control.

He further noted that poor access routes and the presence of wildlife in the area posed risks to the firefighters.

"The affected zones are wildlife-infested, and our teams were at risk of encountering animals fleeing from the fire, he said.

Mr Seabo warned that more veldt fire were likely to occur due to high temperatures and thick vegetation, following last season's good rains.

He said the fire season ran from May to November, and therefore urged farmers and residents to be extremely cautious when using fire at farms, cattle posts, or safari camps.

Mr Seabo also advised the public to clear vegetation around homesteads, avoid leaving fire unattended, and always extinguish cooking or campfire completely.

He also reminded farmers to obtain free burning permits from the DFRR before burning debris.

Additionally, he said farmers should avoid burning large heaps of debris at once but instead, they should burn small portions separately and have enough manpower on standby in case the fire got out of control. BOPA



Lobatse potential logistics hub for SADC

LOBATSE - On a daily basis, continuous streams of diverse colossal trucks move with lumbering motions through Botswana's historic town of Lobatse in a defined pathway.

Their roaring engines, rumbling powerful axels ferry varied commodities to various destinations across the African continent.

For an ordinary Lobatse resident, this daily truck traffic is a norm; a heartbeat of the town that makes part of a broader economic system where the giant lorries connect factories to ports, distribution centres to markets across the Southern African Development Community (SADC) region.

To harness these markets, Lobatse town has started preparations to develop into a robust logistics hub.

According to Lobatse Mayor Aron Ganakgomo, it was therefore critical to develop appropriate infrastructure to improve efficiencies as part of addressing national key policy issues.

Thus, he said during implementation of National Development Plan 12, a deliberate action needed to be taken to develop a National Infrastructure Plan focused on energy, logistics, and internet connectivity.

"There is dire need for a regional and spatial approach to infrastructure development, especially in the area of transport network services, to open up the economy for greater regional integration and possibly transform Botswana into a transport hub for the SADC region," he said.

Mayor Ganakgomo highlighted that Trans Kalahari Corridor was a key trade route connecting the Atlantic port of Walvis Bay in Namibia to Botswana, South Africa, and further into SADC as such Lobatse's proximity to the route made it a natural gateway for goods moving in between landlocked states and coastal ports.

He underscored that Lobatse had comparative advantage on transport connectivity due to its rail linkage which provided direct bulk cargo movement into South Africa and beyond.

"This gives traders a costeffective option for transporting
large volumes. The town also
benefits from the existing road
network, which includes our
proximity to the A1 highway
which links Lobatse to Gaborone,
Francistown, Zambia, and
Zimbabwe and the A2 highway,
which is part of the TKC linking
it to Namibia and the Port of
Walvis Bay," he said.

He noted that the Pioneer and Ramatlabama commercial borders offered seamless road and rail access into South Africa, the region's largest economy.

At present, he said Lobatse Town Council was working on a local economic development strategy, and one of the key focus areas was positioning the town as a logistics and trade facilitation hub for the SADC region.

He added that investors,

logistics operators and development partners would be invited to collaborate in transforming Lobatse into a vibrant logistics hub.

This move, he noted, could unlock opportunities that could strengthen regional trade while building a sustainable local economy through establishing truck stops, warehouses and distribution facilities freight operators, promoting public-private partnerships to build logistics parks and bonded warehouses as well as developing value-added services such as cold storage, vehicle maintenance and fuel depots.

According to Botswana Unified Revenue Services (BURS), the truck movement at Pioneer and Ramatlabama commercial border posts which are in close proximity to Lobatse, between January 2024 and June 2025, a total of 417 136 trucks ferried cargo in and out of Botswana through the two borders. Of the total figure, the arrivals were 226 959 while departures were 190 177.

In the first quarter of 2025/2026 financial year, the amount of revenue generated

from Pioneer border, which was largely contributed by trucks stood at over P30 million while the revenue at Ramatlabama border amounted to over P12 million.

According to BURS, the trucks from the two ports of entry serve three major routes, which are the Trans Kalahari Corridor, which connects Botswana, and Namibia through the Mamuno border post, the A1 Highway linking Botswana and Zimbabwe to the north via the Ramokgwebana border post, and the A3 Highway, which is a busy trade route and gateway to the Great Lakes via the Kazungula One Stop Border Post.

"These logistics efficiency instruments, serve as vital transportation and infrastructure routes that ease the movement of people, products and services between SADC member states," said executive director of the Trans Kalahari Corridor Secretariat (TKCS) Mr Leslie Mpofu.

Currently, Mr Mpofu said TKCS worked with member states to implement initiatives geared towards improved trade facilitation. He added that TKCS

in collaboration with member states customs authorities continued to work collectively to remove impediments to ensure seamless movement of goods and persons aimed at ensuring agility and just in time delivery of goods.

"Some of the programmes implemented include but not limited to data exchange between customs authorities, Authorised Economic Operator (AEO), Implementation of pre-clearance, infrastructure development such as the new terminal building at Pioneer Gate, the One Stop Border Post (OSBP) between Botswana and Namibia at Mamuno and Trans Kalahari Border," he said.

He underscored that the initiatives have resulted in increased volumes along the TKC, which was a welcome development.

"As a result, we have seen some transporters moving from the North South Corridor, which is from Martin's Drift and Beit Bridge to the TKC borders," he said.

Truck drivers, Mr Nyasa Chitavati of Zimbabwe, Mr Mojalefa Maine of South Africa and Mr Immanuel Sheehama of Namibia expressed their desire for improved service delivery rendered to them to improve seamless movement of goods.

They suggested that borders must have effective and timely customs service, canteen area, automatic teller machines, showers and truck stops in their proximity to make travel much easier for them.

Mr Sheehama, working for the Genesis Logistics appreciated service at Mamuno, noting that since implementation of the one stop border post, they have not experienced delays.

"We can even use our national identity cards to travel from Botswana into Namibia and vice versa. It has made travel much easier," he appreciated. **BOPA**

In a statement on its official Facebook page, International Airport described

The airport, in central Khartoum, had come under drone attacks on Tuesday and on Wednesday morning. Earlier in the day, the paramilitary Rapid Support Forces (RSF) claimed responsibility for Wednesday's attack on Khartoum.

"Our forces carried out a precise special operation in which drones successfully targeted sites and gatherings inside the perimeter of the General Command in Khartoum. The focused strike neutralised a number of officers present at the headquarters," said RSF field commander Colonel Othman Jaafar in a post on social media platform X.

The facility was among the first sites attacked by the RSF when war erupted on April 15. 2023, and had sustained heavy damage during the early phases of the conflict.

Authorities have since worked to rehabilitate the airport after the army regained full control of Khartoum State in May.

Port Sudan International Airport, in the country's east, remains the only operational hub for international flights, while some local airports continue to operate on a limited basis.

In recent weeks, the RSF has intensified drone attacks on military positions and vital infrastructure in areas controlled by the Sudanese Armed Forces

Sudan remains gripped by a devastating conflict between the SAF and the RSF, which erupted in April 2023. The war has claimed tens of thousands of lives and displaced millions, plunging the country deeper into a humanitarian crisis. Xinhua

The Ghana Infrastructure Plan, developed by the National Development Planning Commission, provides coordinated framework guide the rapid and disciplined transformation of Ghana's economy and society, and will be built around nine strategic pillars, including areas of energy, water, transport, human settlements, and housing.

Launching the plan, Mahama said that a strong infrastructure backbone will open up the entire country for investment and job creation, with almost equal and similar opportunities for the youth across all 16 regions of the country.

The president said despite Ghana's need for rapid infrastructure development, the infrastructure delivery has often been fragmented, politicised, and inefficient.

"The Ghana infrastructure plan makes a strategic reset. This new approach aligns our development infrastructure with our government's Big Push agenda, the African Union's Agenda 2063, and the United Nations Sustainable Development Goals," the president said.

The plan also includes building a new green digital city, which would combine sustainable urban design, renewable energy, and digital innovation to attract global investors and talents, the

president said.

Part of the 30-year plan is also the expansion of the water systems in the Northern Region to ensure clean and fair access to water and the strategic road and transport corridors to enhance national connectivity, boost trade, and ease urban congestion.

Spokesperson of the company, Katlego Lenyora told *BOPA* in an interview that the company, which is self-sponsored, registered early this year in Serowe with the objective of empowering and training individuals to become confident and powerful beauty queens.

He said the company was introduced after realising that most of young ladies who were mostly at primary and secondary level were interested in pageantry but no one was assisting them to pursue their talents.

Lenyora, aged 23 years and from Morwakwena ward in Serowe shared that grooming young ladies for beauty pageants involved aspects of competition and focusing on personal development such as confidence and physical presentation.

He said though they were still struggling to find their own venue for training, the young ladies were currently using Masuga ward community hall in Serowe, but faced challenges that sometimes it would be occupied.

Furthermore, he said the area of training focused on the qualities and mindset that were critical for success in pageants competitions and life in general.

"We focus on building

self-assurance and charisma, especially for the interview and stage positioning. Young ladies were taught how to articulate their thoughts and speak with confidence," he said.

He noted that contestants received coaching on social beauties, manners and composure in both on and off stage, adding that they were also encouraged to maintain a healthy lifestyle through a balanced diet and regular exercises rather than promoting an extremely unhealthy body type.

"Coaching covers skincare routines and makeup application to techniques that would look polished under stage lights and during interviews," said Lenyora.

He said they were grooming girls aged nine to 19 years, noting

recently they competed at Maun region in three categories, where they emerged victorious scooping various awards.

In addition, he said they competed in Miss Little in primary and secondary schools level, adding they won the best in academics in Miss Little, best walk in primary and came the best in the region.

Lenyora shared that they had encountered many challenges in their quest of achieving their goals being financially and that most parents were not supportive, among other challenges.

He opined that they used their own cars to transport pageants and therefore appealed to the business community, Serowe District Council, Members of Parliament for Serowe region to assist in whichever way they could.

He said they had approached several stakeholders to assist in that regard but to no avail.

Lenyora said the company also spread wings to assist students in schools for tutoring free of charge and that they were concerned about young ladies who had valuable talents roaming streets idling.

Thus, he appealed to young ladies to try to engage in some small businesses to uplift their lives and fight unemployment in the country.

Lenyora appealed to those willing to participate in the coming Grand Final competitions in Serowe on December 13 to register to make hay while the sun still shines. *BOPA*

Doping crisis thorn in the flesh menace

GABORONE - In Botswana's pursuit of global sporting excellence, a silent menace is eroding the integrity of its success, unregulated supplements.

BOPA sportswriter, Anastacia Sibanda, takes a look at what could be the cause, the implications and what can be done to address this menace engulfing local athletes at a high rate. A recent study by

Sport and Exercise Psychology expert, Associate Professor Tshepang Tshube of the University of Kentucky has sounded critical alarm, revealing that 60 per cent of Botswana athletes use supplements, establishing a strong correlation with those who eventually dope.

What is particularly worrying, according to Prof. Tshube, is the fact that athletes can walk into any local pharmacy and purchase supplements without guidance regulation, potentially exposing them to contaminated products and unlisted prohibited substances.

Prof. Tshube said the widespread use of supplements was just one symptom of a deeper problem and therefore warns that if the issue was not aggressively addressed, the country risks sliding toward a level of systemic doping comparable to nations like Kenya and eventually,

He attributed the drive to cheat to a fierce competitive spirit fuelled by the country's own sporting

"We know that Amantle Montsho shattered the glass ceiling in terms of success at a global level, that alone inspired athletes like Isaac Makwala, Letsile Tebogo, Bayapo Ndori and Collen Kebinatshipi," he explained.

This hunger for success, while positive, he says has a dark side and Prof. Tshube's research was clear that athletes determined to win would seek out any possible advantage, even if it meant resorting to prohibited substances that risk their long-term health.

Prof. Tshube's warnings have now been echoed with the recent casualties and suspensions of two prominent national athletes, confirming that the threat is no longer theoretical.

Quarter miler, Zibani Ngozi and 100m sprinter, Karabo Mothibi have both been suspended with immediate effect after testing positive for banned substances.

Mothibi tested positive for stanozolol and oxymetholone. It is reported that Stanozolol has been a scourge in athletics since it was first banned in 1974.

It is historically infamous for its role in the Ben Johnson scandal, where the Canadian sprinter was

stripped of his 1988 Olympic 100m gold medal after testing positive for the drug.

positive Ngozi tested norandrosterone methylhexaneamine, a substance classified as a Specified Stimulant on the World Anti-Doping Agency (WADA) prohibited list.

These high-profile cases underscore the immediate and tangible cost of the doping threat to Botswana's sporting ambitions and its reputation on the global stage.

the regulatory loophole might be the most critical first step in

safeguarding the future of Botswana sport.

The suspensions of Ngozi and Mothibi serve as a crucial inflection point.

It is now imperative for national sporting bodies, regulatory authorities and health agencies
