MAUN - President Advocate Duma Boko has assured Maun residents that government will fulfill all its promises, as some programmes will be fully implemented in the next financial year. He said this at a political rally where the Umbrella for Democratic Change (UDC) welcomed 1 500 new members from opposition parties, including former Botswana Democratic Party regional chairperson, Mr Reaboka Mbulawa in Maun on Saturday.

# China trip strengthened strategic cooperations - mayor

GABORONE - The Gaborone City Council's recent trip to China is a transformative step toward strengthening urban development, investment cooperation and people-to-people relations between Botswana and China.

During a dialogue with China Ambassador to Botswana on Friday, Gaborone city mayor, Mr Oarabile Motlaleng revealed that one of the most promising trip outcomes was China's willingness to support Botswana in establishing stronger human-resource structures, an area which had not previously been recognised as a standalone committee within national development frameworks.

"We wanted to empower our communities and when we raised the idea of creating a Human Resources Committee, the Chinese Embassy agreed with us, that gave us great joy," he said.

Mr Motlaleng said the visit also opened opportunities for investment partnerships, especially those linking local committees with potential Chinese investors.

He acknowledged China's longstanding contributions to Botswana's economic development, citing Chinese-owned businesses such as those at Oriental Plaza and major infrastructure developments, including the new skyscrapers rising across the country.

Mr Motlaleng said the delegation also visited the city of Linyi, renowned for its advanced environmental and vegetation-management systems, adding that the practices offered valuable insights for Gaborone's urban-planning initiatives, as Botswana was preparing for the development of a new 'Diamond City.

He further said another highlight was progress on solar-powered infrastructure, announcing plans to install between 30 000 and 40 000 solar-powered streetlights across Gaborone by next year.

Schools, roads and public spaces, he said would benefit from the renewable-energy initiative.

Mr Motlaleng further revealed that relations formed during the visit had already borne fruit, with a delegation from Linyi arriving in Botswana to explore business opportunities.

Areas of potential collaboration include investment, sport, maintenance and improvements to the athletics village and city lighting.

For his part, China Ambassador to Botswana, Mr Fan Yong, reaffirmed China's commitment to strengthening development cooperation, deepening people-topeople exchanges and supporting Botswana's national development He described the councillors' visit as 'very fruitful', noting that it had laid a solid foundation for expanded collaboration.

Ambassador Fan said China was advancing toward its second centenary goal of becoming a 'great modern socialist country in all respects'.

A key component of this vision, he explained, was the newly adopted recommendations guiding China's 15th Five-Year Plan, which emphasised high-level opening-up and global cooperation.

He highlighted local-government partnerships as critical pillars of the bilateral relationship.

Gaborone's sister-city agreement with Nantong in Jiangsu Province, established in 2008, continues to facilitate cultural and developmental exchanges.

Another MoU with China's Fujian Province was signed in 2023. During the council's latest visit, Gaborone also deepened its partnership with Linyi in Shandong Province.

"These interactions will surely enhance mutual understanding between our peoples and inject fresh impetus into our practical cooperation," he said.

Meanwhile, Mr Fan said Botswana's ongoing formulation of the 12th National Development Plan and implementation of the Botswana Economic Transformation Programme presented new opportunities for alignment with China's 15th Five-Year Plan.

He identified key areas of strategic synergy, including high-quality development and industrial transformation where China's focus on new energy, new materials, aerospace and next-generation technologies complements Botswana's economic-diversification goals.

He also discussed China's commitment to high-standard opening-up, which aligns with Botswana's trade and investment aspirations. Frameworks such as FOCAC, the Belt and Road Initiative and the Global Development Initiative which offer platforms for further collaboration, he noted.

Sharing experiences from the visit, Phakalane Ward councillor, Mr Kaisara Sejoe praised China's advanced security systems, noting their high effectiveness in detecting crime.

He expressed appreciation for the Chinese Embassy's support in sponsoring capacity-building initiatives, saying the training and exposure gained in China would significantly enhance their work and the city's overall development. primary school learners would next financial year receive breakfast and lunch under the operationalisation of the Home-Grown School Feeding Programme.

He said the initiative was meant to boost nutrition, support academic performance and stimulate local agricultural production.

Also, he said the P300 allowance for new born babies and improved access to essential services for all would be implemented next financial year.

While government had already implemented some initiatives such as the increase of old age pension allowance and brigade students

allowance from P300 to P1,900, he further revealed that the Ipelegeng programme would be transformed into Ikageng Programme.

The revamped programme, which would be implemented by the end of the year, he said would provide employment opportunities with a monthly pay of P2,500. When welcoming new members to the party, President Boko urged them to work hard for the growth and transformation of the party and the nation.

He said the party needed numbers to strengthen its position and improving the livelihoods of Batswana.

For his part, Mahalapye West MP and Minister of Communications and Innovation, Mr David Tshere said UDC championed programmes that uplifted citizens.

He highlighted the launch of Botswana's first satellite, BOTSAT-1, as one of the programmes that proved government's commitment to digital transformation and national development.

He said BOTSAT-1 leveraged technology for national development, job creation and economic diversification.

THAMAGA - The Department of Information Services photographer, Godfrey Mpuse has been described as a man of many admirable qualities, unifier, family man and a dependable source of wisdom.

Speaking at Mpuse's funeral service in Thamaga on Saturday, former president, Dr Mokgweetsi Masisi described Mpuse as an individual of exceptional character, whose contribution to the nation deserved honour and recognition.

He said it was befitting to have such a gathering when bidding farewell to a unifier.

Dr Masisi noted that Mpuse's special duty as a presidential photographer required precision and artistic vision, which he executed with precision.

"He even took my last photo in office," Dr Masisi recalled, adding that he had an eve for detail.

He explained that working as a presidential photographer demanded a unique artistic ability, discipline and commitment.

He thanked Mpuse's wife, Nametso and his parents for giving the nation a true servant.

Addressing aspiring photojournalists, Dr Masisi encouraged them to emulate Mpuse's dedication and hunger for quality, adding that learning from him would guide them to produce

excellent work.

Dr Masisi emphasised that photographers played a crucial role in preserving national history, not only through words and writing, but visually.

Acting Director of the Department of Information Services, Mr Thebeyame Ramoroka said Mpuse joined the public service in 2007 and quickly proved himself as one of Botswana's most reputable photographers.

He praised Mpuse for delivering world-class photographs that communicated a thousand words, noting that his work ethic often pushed him to go beyond protocol to capture exceptional images.

Mr Ramoroka added that Mpuse was part of a trusted group assigned to high-profile national duties involving elders, where decorum was essential.

"He never faltered in his assignments. His behaviour and dress code were exemplary," he said.

He highlighted Mpuse's respectful frankness, saying he spoke his mind with humility.

His passing, he said, dealt a major blow to the department.

Mpuse's uncle, Mr Bathusi Moarabi, shared that the deceased had recently informed the family of his health challenges, yet remained active in family responsibilities.

Mr Moarabi said Mpuse's final

days included attending a meeting for a family wedding in Hebron.

On his way back, he said he felt sick and had beathing difficulties and was taken to Kanye Adventist Hospital, where he later passed on.

"We have lost as a community, but we are comforted by the life he lived and the impact he made," he said

Family representative, Mr Shimane Dikobe said Mpuse was 'more than a son-in-law', describing him as loving, supportive and fatherly to many.

Friend and caregiver, Mr Thato Mosiny, who described Mpuse as loyal, courageous and resilient, thanked God for the privilege of walking with him through his final journey.

He recalled attending an assignment at the Office of the President with Mpuse, where he complained of chest pains and breathing difficulties but still displayed his persistent spirit.

Mpuse's niece, Ms Bonno Mpuse, described him as a unifier who related well with everyone.

Member of Parliament for Thamaga-Kumakwane, Mr Palelo Motaosane said Mpuse's ability to work with the former president showed his exceptional skill and discipline.

He urged Mpuse's wife to stay strong and grounded as she continued raising their children.

# Drones technology use to save lives

MAUN - President Advocate Duma Boko has hailed the launch of 'Drones for Health' as an innovative breakthrough reaffirming government's commitment to equitable access to life-saving and provision of essential medicines even in remote areas

President Boko, who witnessed the virtual take-off of the drone from Letsholathebe II Memorial Hospital in Maun and the landing at Chanoga clinic, which took approximately 15 minutes in a radius of 40km, appreciated that the technology was key in transforming healthcare delivery enhancing accessibility, efficiency and quality care.

The 'Drones for Health' project is aimed at transporting medical supplies, blood samples, vaccines and enhance public health initiatives.

The initiative is a collaborative effort between the ministries of Health as well as Communication and Innovation and its primary goal is to ensure timely delivery of essential medicines.

President Boko said in the next 2-3 years, the project should be rolled out to all hard to reach areas while training of local pilots, who were taking part in the project was ongoing.

"This project is a bold commitment of the government toward inclusive and resilient

healthcare system that leaves no one behind. We believe that all members of the communities including those in remote areas or far from services should have access to timely and quality healthcare services," he said.

He also acknowledged that the drone technology had Internet connectivity, which people could use to improve communication.

Giving an overview of the project, drone coordinator at the Ministry of Health, Mr Sinka Matengu said it was piloted in Palapye in 2021, starting with Mogapi, Lecheng, Moremi and Mokgware respectively.

He said the technology was later expanded to cover more villages in the Ngamiland region targeting areas such as Gudigwa

and Shakawe, among others.

Mr Matengu said 'Drone for Health' project would come handy as it would cut costs and ensure easy and quick delivery of essential medicines in hard to reach communities. He highlighted that the drone had a capacity to carry 30 kilograms of goods and could cover a stretch of 200km.

"This is the best technology that will limit transport resources especially when roads are impassable. It will accelerate delivery of health supplies in a timely manner and eventually save lives. We will be able to deliver essential care drugs and laboratory specimen without struggle," he said.

Minister of Communication

and Innovation, Mr David Tshere said as the country was facing financial challenges, the project would address transport challenges and save government money.

He said they were already working with some four Batswana companies with the help of an expert company from California, adding that they would contract them further to fly the drones as their main aim was to roll the project to the rest of the country.

For his part, Minister of Health, Dr Stephen Modise thanked all who ensured the success of the project saying the aim was to ensure all Batswana had access to free quality healthcare services irrespective of their locations. **BOPA** 

# Africa trade integration key - Boko

GABORONE - Africa must leverage its vast natural wealth and demographic advantages to deliver real value for its people.

Speaking during a courtesy call by the Director-General of the World Trade Organization (WTO), Dr Ngozi Okonjo-Iweala in Gaborone yesterday, President Advocate Duma Boko said Africa was endowed with potential and abundant natural resources, yet those assets were not translating into meaningful benefits for citizens.

President Boko further noted that African countries often operated in isolation along major trade routes, resulting in weak bargaining power and limited access to international markets.

He stressed the need to strengthen infrastructure to connect African economies more effectively, arguing that improved transport and logistics networks would enhance intracontinental trade.

Citing industries such as pharmaceuticals, where timely delivery was crucial, he said better connectivity would support countries in pooling production,

coordinating procurement and developing shared industrial capacity.

"However, success will depend on significant investments in resilient infrastructure and improved connectivity," he said.

President Boko also said African nations had long faced unfair trade dynamics and disputes that placed their economies at a disadvantage.

He therefore called for a more equitable global trading system and urged African countries to work collectively to secure fairer outcomes.

In addition, he outlined Botswana's strategic push to transform its geographical position from a perceived limitation to an economic advantage.

"Some will say we are landlocked, we say we are landlinked," he said, positioning Botswana as a future logistics and trans-shipment hub for southern Africa.

President Boko, who further expressed strong support for Dr Okonjo-Iweala's bid for a second term as WTO Director-General, praised her leadership.

For her part, Dr Okonjo-Iweala

commended Botswana's peaceful and stable environment, saying the country was well placed to take advantage of emerging economic opportunities.

She applauded Botswana's governance record, noting that stability was a key asset for attracting investment and driving long-term development.

She said her visit underscored the WTO's recognition of Botswana's role in international trade and development, while providing the country opportunity to articulate its priorities ahead of the 14th WTO Ministerial Conference (MC14) to be held in Cameroon in March 2026. Dr Okonjo-Iweala said her visit formed part of the WTO outreach initiative to selected African nations to discuss preparations and potential outcomes of the MC14.

The conference, she added, was a critical moment for shaping global trade policy and urged that Botswana must ensure that its interests, particularly those concerning Landlocked Developing Countries and Net Food-Importing Developing Countries were well represented. **BOPA** 

# Bonno housing project status impresses minister

She said the project commenced in August, adding that the construction was planned to be completed in August 28, 2026.


However, as the project seems to be behind time, Ms Sebego said they negotiated with the contractor to increase the number of employees so that they could push the project to finish within the expected time.

# Lemang Dijo to address food security

GABORONE - The newly revised arable sector subsidy programme, Lemang Dijo will go a long way towards addressing food security among small scale farmers and rural households, the Acting Minister of Lands and Agriculture, Dr Edwin Dikoloti has said.

Giving a statement in Parliament on Friday, Dr Dikoloti said the new programme would be geared towards insuring cost-effective delivery of food security at household level, through state support provided at one hectare per farmer.

The minister revealed that the nature of support to be availed to farmers included draught power, seed supply, the provision of pesticides, threshing and shelling mechanical support, the procurement of a one colony beehive and enhanced extended services.

He said that government had secured insurance for the Lemang Dijo facility through the Agricultural Credit Guarantee Scheme, to reduce investment risk and to promote sustainable household level food production. "In the event of drought or other natural disasters, the insurance facility will help mitigate potential losses and insure programme continuity," said Dr Dikoloti.

He further told the National Assembly that commencing this week farmers could develop their seasonal farming plans and work with his ministry to register to benefit from the programme.

"I wish to inform the farming community that beginning Monday, November 24, they

may start developing their cropping plans through the Crop Management System, which will enable applications for the Lemang Dijo grant. Extension officers across the country are ready to support the 2025-26 cropping season," said Dr Dikoloti.

He added that while stakeholder engagement would continue to take place, it would be imperative for both farmers and service providers to register before undertaking any programme related activities.

"I further urge all stakeholders to appreciate that in re-basing many corrections have to be made, which have to result in the appropriate use of resources without undermining the primary objectives of aiding food security," said Dr Dikoloti.

The minister said as a consequence, the ministry of agriculture, working with other ministries and agents of government, would apply technological and other means to ensure productivity was improved and historical abuse of programmes was curtailed.

In developing the Lemang Dijo programme, Dr Dikoloti said government had factored in various considerations, including the economic challenges the country was experiencing at both national and household level, past experience of yields per farmer assisted, the bill of imported cereal per annum, as well as sub-optimal management of past programmes.

"This necessitated continued state support for particularly poor subsistence farmers but with great care taken to ensure productivity and to avoid leakages." *BOPA*

# Mohwasa explains armoured vehicle procurement

GABORONE - The procurement process for the 16 custom-made vehicles for transportation of the President and the Vice President was initiated, evaluated, and concluded under the previous government.

The vehicles, six Land Cruiser extended length SUVs, six GMC vehicles, and four ambulances, cost around P70 million. The Minister for State President, Mr Moeti Mohwasa, said in Parliament on Thursday that the acquisition of the vehicles was guided by the VIP security assessment that had been guided by the Directorate of Intelligence and Security Services (DIS).

He said the procurement process began with a saving gram dated March 13, 2024, addressed to the Ministry for State President permanent secretary, requesting a waiver for the direct appointment for supply and delivery of armoured motor vehicles.

This, he said was followed by a positive response received by DIS on March 22, 2024 and an invitation to tender was then issued, and it ran from April 29 to May 20, 2024. "A savingram dated May 28, 2024, formally recommended the award, and was approved on June 13, 2024, and the contract was formally entered into on June 27, 2024," Mr Mohwasa said.

The minister said the value of the procurement contract was nearly US\$5, 213, 648 (about P72 million). He explained that the total cost of the contract included costs for training, maintenance, spare parts, customs clearance, and transportation. Mr Mohwasa said that the vehicles arrived in Botswana in August this year

and were registered in September

He said that in accordance with national security legislation, the specific registration details of the presidential and vice presidential fleet remained classified to safeguard the safety, protection, and operational integrity of the highest offices of the state. When the new government assumed office, the contract was already a legally binding commitment on the state, Minister Mohwasa said.

"The vehicles are highly specialised, custom-made assets, meaning they were being built to our specific requirements and could not be used or sold to any other party," he added. Also, he said the previous administration's assets included the acquisition of a Leonardo AW109SP Grand New helicopter for VVIP transportation and two AW189 helicopters by the BDF.

The Leonardo AW109SP helicopter purchase was approved by the Ministry for State President permanent secretary in September 2024, and a onceoff payment of P71.6 million was made in October 2024. The aircraft was delivered in March 2025, fully complying with contractual and administrative requirements.

Mr Mohwasa said there was also a purchase of two AW189 super-medium lift helicopters powered by twin engines, designed for long-range missions with a carrying capacity of eight to 14 passengers, depending on configuration.

"The investment of P1 billion had been planned, with the contract signed in December 2023 through BDF, the aircrafts are due to be delivered in January and February next year," Mr Mohwasa told Parliament.

He said upon careful review,

the administration confirmed that cancelling the contract would have triggered severe financial penalties as the supplier would have been legally entitled to claim for all costs incurred, including materials, labour, design, and lost profit, likely amounting to significant millions.

"Therefore, the decision was not between cancelling or proceeding. It was between losing a substantial non-recoverable sum for zero benefit or receiving the specialised vehicles we require," he said.

Minister Mohwasa said throwing away millions of dollars in penalties would have been an irresponsible use of taxpayers' money, especially when the state would have received nothing in return.

He said cancelling the contract would had been an act of financial recklessness, causing a direct and substantial loss to the public purse, adding that the decision to honour the legally binding agreement was the only financially responsible course of action.

Maun North MP, Mr Dumelang Saleshando, had asked the minister to make a full disclosure on all aspects of the recently purchased vehicles for the transportation of the President and Vice President.

He wanted the disclosure to include the precise date on which the vehicles were ordered, whether they had been included in the annual budget or not, the total costs for the vehicles, delivery date in Botswana, and when they were registered.

Additionally, Mr Saleshando wanted the minister to further state if the government considered cancelling the purchase in light of the economic conditions that the country was facing. *BOPA* 

# Minister to propose name for brigades

GABORONE - The brigades, vocational training institutions for out of school youth countrywide, will be renamed 'vocational centres,' the Minister of Higher Education, Mr Prince Maele has said

Debating the State-of-the-Nation Address (SONA) on Thursday, Mr Maele who is Tswapong North legislator, said in order to address some of the stereotypes attached to brigades, they would be renamed.

He promised Parliament that he would soon present to them the renaming proposal for the brigades, which were founded in 1965 by the late Mr Patrick van Rensburg, to offer practical skills such as carpentry, plumbing and agriculture, and were initially tied to offering trade skills to the producer and consumer cooperative societies.

Mr Maele said in addition to increasing the student allowance in brigades and vocational centres from P300 to P1,900, government

was committed to reaching the P2,500 per month across the board student allowance for all institutions of higher learning.

He said the clustering of courses would be done to ensure vocational training is linked to industry needs, citing the example that if the hospitality and tourism was dominant in a place like Maun, the vocational training there would be linked to such an occupation.

Mr Maele told Parliament that given that government had been facing a shortage of funds, cost saving measures had been introduced, including the reduction of travelling delegations among others

He called for the improvement of the storm water drainage systems in Tswapong North because almost all the 21 village in the constituency were built in elevated areas next to hills.

Mr Maele said they were promised roads such as Lesenepole-Maunatlala and the one linking the villages of Seolwane, Mosweu, Mokokwana and Maunatlala, initially proposed under the Development Manager Model, but had since been dropped from development plans.

He pleaded with the government to revive plans for the construction of these roads as well as the upgrade of the Majwaneng-Lerala and Manaledi-Ratholo roads.

Mr Maele also called for a major reconstruction of Moeng College and the construction of hostels in some primary and junior secondary schools in Tswapong North, in order to alleviate the current situation where pupils walked long distance to school.

In his submission, Opposition whip, and Maun West MP Mr

Caterpillar Hikuama commended government for the introduction of the use of minority languages in national radio and television bulletins but called for a national policy that would guide the cultural development of these languages in Botswana.

On transforming the education sector, Mr Hikuama called for curriculum review, teacher training, robust monitoring and evaluation, schools infrastructure development, as well as improved access and inclusion for marginalised groups such as girls.

He said technical and vocational training required both the review of the curriculum as well as the engagement of industry to ensure that subjects being taught were relevant for the job market as well as the country's economic needs.

On the issues affecting his constituency he said junior secondary schools such as Ngami and Sekgoma were in a derelict state and needed to be refurbished.

Mr Hikuama said the water shortage in the constituency had reached crisis levels, and the health sector in his area also needed intervention. He said some people in Maun West lived in ungazetted settlements and called for mobile clinics to address their healthcare needs. *BOPA* 

# Mophuting lauds efforts to restore dignity

GABORONE –The reduction of tariffs and revising minimum wage upward amidst economic hardship, demonstrates government's commitment to justice, equity, and restoration.

The Assistant Minister for State President and MP for Bonnington North, Ms Maipelo Mophuting, said when debating the State-ofthe-Nation Address (SONA) on Thursday.

She said government had chosen a path that centred on people over profit, compassion over convenience, and legacy over popularity.

She hailed the government's deliberate focus on social protection, inclusive governance, and restoration of dignity.

Ms Mophuting said that the decision to raise old age pension, introducing child support grant, and reforms on programmes such as Ipelegeng into skills-based opportunities spoke to a government that saw beyond numbers and indicative of social justice in motion.

She stated that when a government decided on an amnesty for water bills, that demonstrated to those who could not afford to pay that they were not forgotten and government cared about them.

Government's success would not be measured by GDP, but by the lives it touched, especially the voiceless, powerless, and vulnerable, Ms Mophuting said, adding that the bold measures announced for the youth, such as the Presidential Youth Empowerment Campaign, increase in TVET allowances, and the development of creative industries through a P200 million fund were encouraging.

Such she said showed a government that believed in its young people and saw them as innovators, creators, and nation-builders of today.

Also, she said the establishment of the Sovereign Wealth Fund, the Botswana Mercantile Exchange, and reforms in the mining, agriculture, and digital sectors signified a government that understood stewardship.

Focusing on her constituency, Ms Mophuting said the government should continue building a conducive environment for investment in the interest of employment creation. She said Phase II clinic needed refurbishment, noting that the area was experiencing a shortage of ambulances and staff.

Ms Mophuting said medicine supply, although improving, was still a challenge.

Also, she highlighted that schools' infrastructure was dilapidated and there was a shortage of furniture.

As for drugs abuse, Ms Mophuting said the situation affected mostly young people and welcomed the intervention of a drugs and rehabilitation center.

Mogoditshane East legislator, Mr Letlhogonolo Barongwang said the current legislators were champions of transformation.

He said MPs would preside over the first comprehensive constitutional review, which he said would be tabled in Parliament.

Mr Barongwang said that the upcoming constitutional review exercise would be a bold step to restore hope and dignity among Batswana. Nonetheless, he said the current government faced a challenge of a disingenuous opposition and a constrained fiscal situation, which would affect delivery.

Mr Barongwang said there was a problem of global market shift, which had affected the country's economic performance.

Regarding his constituency, he said Mogoditshane schools and health facilities were grappling with an increasing population.

"An area of over 80 000 people was serviced by three public health facilities, with only one operating 24 hours, as well as overcrowding in schools which affects performance."

Also, Mr Barongwang said the area faced a problem of storm water drainage and maladministration at the Mogoditshane Land Board.



Kgatleng West MP, Dr Unity Dow called for deeper public consultation on major national decisions, emphasising that inclusive policymaking strengthened democracy. She urged government to prioritise citizen engagement and transparency to ensure policies truly reflected Batswana's needs.

# Dow calls for consultation on national issues By Bonang Masolotate She said the proposed P200 million it would avail for the

GABORONE - Kgatleng West Member of Parliament, Dr Unity Dow, has faulted the government for lack of consultation even on important issues, and departure from policies.

The MP, who was making her contribution to the State-of-the-Nation Address on Thursday, said major policy shifts were announced without Parliament's input and consultation with Batswana.

For instance, she said the President announced the Citizenship by Investment Programme without consulting with Batswana, the very owners of the country.

She regarded that as a major shift from the norm, adding that apart from the lack of consultation, the price tag for the citizenship was too low.

"In her view, the country's citizenship was worth more than the proposed price, and should not even be sold."

The Umbrella for Democratic Change government has had direct appointment tenders, which was also a departure from the norm, Dr Dow said, adding that such stifled competition and transparency.

Also, she said Batswana learned through the media about the creation of a new city in Kgalagadi, something that did not happen with the previous government, which prior to building the Botswana International University of Science and Technology (BIUST) in Palapye, allowed for the matted to be discussed and debated in Parliament.

Dr Dow said it was wrong for government to designate such a huge piece of land without involving the people.

She said the proposed constitutional review under the new government also lacked consultation, noting that during the previous government, the constitutional review collapsed because of the process, which lacked consultation.

Talking about the Botswana Economic Transformation Plan and National Development Plan 12, Dr Dow said the two were overloaded, unrealistic and bound to fail. She said government should prioritise if it desired to take country forward.

Concerning her constituency, Dr Dow said they were still waiting for the construction of a hospital and also that Bakgatla wanted something done about the smoke from Pilane landfill.

Dr Dow was concerned that government was not clear about if it was going to assist farmers during the current ploughing season and equally so about the poor state of school buildings in her constituency and high unemployment rate, especially among young people.

Gamalete MP, Mr Boniface Mabeo said the government was more on talk, while lacking in action.

While great speeches were important, it was actions which accompany speeches that changed lives, Mr Mabeo said, adding that government's actions appeared opulent while at the same time selling the nation the narrative of a broke government.

He gave an example of government officials on E-scale and above who enjoyed commuted overtime allowance, while junior officers were barred from overtime on the basis that government was broke. However, Mr Mabeo commended government for the

P200 million it would avail for the creatives, but said he was worried that the government could be throwing money at problems.

He said without a proper and comprehensive strategy on how the funds would be used to benefit the industry, its impact would be illusional.

Mr Mabeo appealed to the UDC administration to let go of state media, let it thrive be a money spinner for government.

He said piggery was a popular enterprise in Gamalete but without proper programmes for those engaged in it and neither were statistics available about the industry.

Also, Mr Mabeo decried the poor service at Bamalete Lutheran Hospital (BLH), saying the government was only assisting the hospital partially.

The legislator pleaded with the government to address Bamalete Lutheran Hospital staff welfare issues, noting that it would be prudent if the staff were paid by the Ministry of Health.

He said the community was collaborating with the private sector to refurbish the hospital's maternity ward.

Mr Mabeo expressed disappointed that the Ramotswa-Otse road was left out of NDP 12, although it was crucial as an alternative road since there was only one road linking Ramotswa to the rest of the country.

Bonno Housing project he said got 175 plots from Gamalete land board at no fee, but the houses would be sold at a hefty figure, which would not be afforded by many, a sad reality considering the waiting list for land allocation exceeded 30 000. **BOPA**

TLOKWENG - The newly opened Tlokweng taxi rank mall, known as the Batlokwa Centre, marks as a major step in transforming Tlokweng into a modern economic hub in line with Botswana's Economic Transformation Plan (BETP), which promotes economic growth through Public Private Partnerships (PPPs).

# Serowe district anticipates good harvest

SEROWE - Serowe District anticipates a good harvest for the 2025/26 ploughing season given the early rains favourable for ploughing and based on the outlook of rains from Meteorological Services rainfall

In an interview recently, Mr Samson Motlhala, Agronomist for Serowe District said that the district was expecting a good harvest for the 2025/26 ploughing season, of which the predicted rainfall was normal to above normal.

He said the district contributed significantly to the national food production thus contributing an average of above 1000 tons of production to the national the country. production annually.

Furthermore, he said in 2023/24 ploughing season the transitional period from Temo district contributed 933 tons by 1 113 farmers who had tilled their ploughing fields as compared to 2024/25 ploughing season in which 1 162 tons by 1 601 farmers that had tilled their arable land, contributed to the national food production.

This, he said showed that there was an increase in both production and number of farmers who tilled their arable land and therefore was of the view that the district was on the right track to attain food security and self-sufficiency.

Mr Motlhala reiterated that considering the good rains there was hope that there would be a

However, he said tractor pondering owners were increasing ploughing prices per hectare, which might lead to a low turnout of farmers into ploughing because of high ploughing prices In an effort to heighten the country's food security and self-sufficiency, the Ministry of Lands and Agriculture has embarked on a move to transition Temo Letlotlo to Lemang Dijo.

Meanwhile Acting Agricultural District Coordinator for Serowe Mr Kenneth Mabote told BOPA in an interview recently that Temo Letlotlo has opened applications for Lemang Dijo programme to boost food security and self-sufficiency in

He said subsistence farmers would be assisted during the Letlotlo with seeds for a measure not exceeding one hectare for each farmer as compared to the previous two hectare of Temo Letlotlo, given that the new programme's focus was to boost production per hectare than just cultivating a huge chunk of land.

Furthermore, he subsistence farmers would also be assisted through Lemang Dijo programme's transitional phase for ploughing.

Farmers would also be assisted with bee colonies in their ploughing fields for cross pollination purposes to boost food security. Scientifically it has been proven that bee colonies

have a significant positive effect by providing a crucial pollination services that are essential for crop production and by so doing increasing yields per

In addition, Mr Mabote said currently the Agricultural Policy of 1991 was under review, thereafter the findings would guide which direction to take to improve crop production.

Mr Mabote said Lemang Dijo programme would be rolled out to different parts of the country the farming community would be consulted through kgotla meetings. **BOPA**



# Lebakeng embraces dream

The motivational book she said, was a simple guide for a person to realise his or her potential.


"I am also still on the journey of self-discovery and I have realised that it is better to influence the next person when you are on the same process as compared to when you believe you have reached your mark," she said.

# II hail Ntungami

GABORONE - November 22 will forever be engraved in the hearts of Batswana, as it marks the day a 16-yearold boy from Nshakashogwe, Ntungamili Raguin, won the World Tennis Tour Juniors/ITF J60 boys' singles title on home soil.

Ntungamili defeated Alex Lap Hang Hui of Hong Kong 6-4, 6-2, becoming the third Motswana to win the tournament, following in the footsteps of Denzel Seetso and Mark Nawa.

Stepping into the court on Saturday, Ntunga faced a tough opponent in Alex. When he lifted his eyes to the crowd, he saw the stands nearly full and signaled to the spectators, as if to say, "We got this."

The first set was tense, with both players struggling to hold serve. However, fueled by thunderous home support, Ntungamili settled in. Playing with aggression, heavy topspin, and safer margins, he broke Alex's serve and secured the set 6-4.

In the second set, Ntungamili's momentum grew as he dictated most rallies.

His improved first-serve percentage put him at a clear advantage. Though Alex refused to give up, adjusting and playing more high-percentage shots

he could not halt Ntungamili's rising confidence. Even when Alex climbed back to 5-2, Ntungamili remained composed. Showing excellent court craft and coverage, he held firm until championship point, sealing the title 6-2.

On Friday, Ntunga and his French partner Yanael Beranger won the World Tennis Tour Juniors/ITF J60 Gaborone boys' doubles title, defeating Seabo Saleshando and Zimbabwe's Mengezi Sibanda 6-0, 6-3.

Speaking after his victory, Ntungamili said he was thrilled to win two titles on home soil, noting that he had often won championships abroad.

"Now I have delivered at home, and I want to thank all those who supported and believed in me," he said.

With the J100 tournament starting this week, Ntungamile said his focus was now on maintaining his strong performance.

His coach, Killian Sinclair, said the J60 mission was accomplished, as their goal had been to win both the singles and doubles titles.

He added that Ntungamili celebrated humbly saluting the crowd because there was still work ahead in the J100 tournament. He said the ultimate ambition was to collect enough points to qualify for the Australian Open next year. BOPA
