TATAKI Mine spurs growth

FRANCISTOWN - Global Critical Resources Corporation (GCR), who are the owners of the TATAKI Mine, plans to invest P2.66 billion (US\$200 million) into the mine over the next 10 years, including P665.48 million (US\$50 million) in the first 18 months to increase production levels.

The entity projects to generate over P55.9 billion (US\$4.2 billion) in revenue and contribute a 1.5 per cent increase in annual GDP to Botswana.

It is for these reasons that President Advocate Duma Boko welcomed the agility and tenacity of negotiators to ensure that TATAKI Mine, formerly Tati Nickel mine, was opened after an eight-year hiatus, which would help improve people's livelihoods through employment creation and breathe life into the country's ailing economy.

Speaking at the commissioning of TATAKI Mine on Tuesday in Matsiloje, North East District, President Boko said reopening the facility would also help push the country to the desired 6.8 per cent to take the economy out of the woods.

Other than the 300 direct jobs that the poly metallic mine would create, President Boko relayed that about 3 000 indirect jobs and other potentialities that included treated water, crushed rocks that would be used as aggregates for road construction, were welcome developments that would spur improved livelihoods and growth.

The high-tech that the mine would use to augment human capabilities, according to the President, would mean people

would be up-skilled, rendering highly trained personnel for the country.

He said despondency and despair that had engulfed Batswana due to the prevailing economic dire straits called for those at the helm of governance to think and draw conclusions quickly.

President Boko said the unfavourable economic situation of Botswana left no room for sloppiness by those charged with decision-making if resurgence was to be achieved.

"People want solutions now and not tomorrow. It is therefore our responsibility as leaders to provide answers to these pressing problems they are facing on a day-to-day basis."

Also, President Boko said investors did not have the latitude to go out of their way to mobilise resources only for people entrusted with stewardship to employ a laissez-faire attitude in today's dog-eat-dog business environment.

He relayed that the unprecedented rate of unemployment, especially among the youth who accounted for the majority of the population and were educated, called for swift decision-making because the 3.8 per cent economic growth realised by Botswana in the last decade had failed to create job opportunities for the citizens.

Minister of Minerals and Energy, Ms Bogolo Kenewendo was equally pleased that the commissioning of the resource had finally taken place, following the closure in 2016.

"The fervency with which the government took to the negotiations that paved the way for reopening was truly a reflection of the dire need for employment opportunities for Batswana."

Through ventures such as TATAKI Mine, Minister Kenewendo said the government intended to increase the contribution of both critical minerals and base metals to its mining output and the overall economic growth of the country, which would make Botswana the investors' number one choice.

It is to this end that her ministry was on the verge of 'The Minerals Resource Development, Exploration, Exploitation and Value Chain Strategy' to ensure more was derived from the country's rich mineral resources through value addition.

Councillors adopt municipal bond initiative

MAUN - The North West District Council has adopted a municipal bond initiative with the hope of enhancing its financial independence through innovative avenues such as public-private partnerships and investments in income-generating assets.

Councillors unanimously supported the programme following a presentation on Monday by the Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa and officials from the Botswana Stock Exchange (BSE).

They all underscored the need for the council to develop creative ways of raising revenue.

BSE officials briefed the council on the proposed bond structures and how they worked owing to an existing appetite from investors to support councils.

They also learned that their ministry fully supported the initiative, with the BSE providing technical support and capacity building to help councils achieve fiscal sustainability to deliver social development and transformative infrastructure.

"This initiative came at the right time as government is making efforts to transform the economy.

We believe that the bond will help us as a council to generate more revenue and eventually implement development and provide quality services to our communities," specially-nominated councillor, Mr Kedibonye Kgari.

Cllr Petrus Mbaeva of Toteng ward also acknowledged that tapping into the programme would help them generate better revenue and carry out developmental projects within their jurisdictions through innovative and sustainable funding.

He said they would reduce their dependency on government undertaking sustainable infrastructure projects that would also generate more money.

Cllr Busang Letshabo of Boro-Senonnori ward called on the council to speed up the establishment of the company so they could benefit from the initiative.

Earlier, Minister Motshegwa urged the council to consider collaborating with the BSE, noting that government was gradually working to reduce its financial support to local authorities.

Such commitment, he said, highlighted the need for councils to adopt proactive approaches to maximise and diversify their revenue streams.

The minister explained that the Local Government Act of 2012 (CAP 40:01), empowered councils to establish entities, trusts and other organs to facilitate service delivery.

He added that in light of persistent financial constraints, the ministry had observed that several councils had responded by establishing business entities to supplement their income.

He also stated that a council had the power to do anything and enter into any transaction which, in its opinion, was calculated to facilitate proper discharge of any function conferred or imposed upon it by the Act or any other

Furthermore, the minister indicated that Sections 63 and 64 outlined permissible revenuegeneration mechanisms available to councils, noting that the ministry had been facilitating

innovative approaches to enhance recurrent budget and 100 per cent financial sustainability within local authorities.

"A notable development is the ongoing collaboration between the Gaborone City Council and BSE. This partnership was formalised through the signing of a Memorandum of Understanding on August 12," he said.

Mr Motshegwa added that following such a milestone, the ministry coordinated a platform for the BSE to present the initiative to the leadership of all local authorities, including council chairpersons, mayors and executive officers.

"This also recognises that there are other ongoing initiatives to establish private companies by various local authorities as a means of coming up with creative ways of raising revenue," he

He further noted that the central government had been funding almost over 90 per cent of the of the development budget.

"This reliance on central government funding has made it difficult for local authorities to fully implement their development plans and carry out operational activities, which has severely affected quality service delivery to the people," he said.

Also, he said the initiative complemented their commitment urban transformation, saying cities were not merely administrative zones, engines of innovation, economic productivity and development, as referenced by the recently launched City Tourism initiative.

"We shall continue to provide the regulatory backing and policy and legislative alignment necessary to facilitate the implementation of municipal bonds and other innovative financing instruments," he said.

Kanye council steps up revenue collection

KANYE - In light of the ongoing economic challenges, Kanye District Council is ramping up its revenue collection efforts to strengthen its financial position.

Speaking during the official opening of the third ordinary Full Council Session on Monday in Kanye, Council chairperson, Morapedi Kgosithebe emphasised the need for strategic financial reforms to boost revenue generation.

He reported that by the end of August 2025, the council incurred expenses of P59,944,101, while revenue collection was a mere P2,024,510, translating to just 25 per cent of the anticipated 42 per

address this shortfall, Mr Kgosithebe identified the need to intensify collection efforts for sanitation fees, advertising taxes, road cut fees, and other underutilised revenue sources.

Discussing public health improvements, he noted that medication availability in the district had seen enhancements following President Advocate Duma Boko's declaration of a Public Health Emergency.

The district received its first shipment of essential drugs on September 4, raising the availability of vital drugs from 63 per cent to 67.4 per cent and essential drugs from 53 per cent to 61.2 per cent.

He expressed hope for further improvements as the government continued to secure medications.

Additionally, Mr Kgosithebe acknowledged that ongoing financial constraints have prompted the Ministry of Health to streamline services, prioritising life-saving interventions.

This includes the suspension of the Chronic Medicine Dispensing Programme, which previously collaborated with private clinics and catered to 464 clients.

Chairperson also highlighted a notable advancement in water quality across the district, enhancing public confidence in the council's efforts and reflecting the commitment of their water quality monitoring teams.

However, he raised concerns regarding the Water Utilities Corporation and their staff movements, warning that frequent transfers could hinder progress on existing community issues.

He suggested a more prudent approach to staff transfers to ensure continuity in addressing pending cases with residents. **BOPA**

Stoffel back in court for bail ruling

GABORONE - A Directorate of Public Prosecutions (DPP) attorney, Mantrakis Keipeile Stoffel will appear in court today for bail ruling.

The 35-year-old, who was remanded in custody following court appearance on Tuesday, is facing two counts of common assault and one count of illtreatment of minor children.

Stoffel, who works in Lobatse, appeared before Regional Magistrate Mareledi Dipate at the Broadhurst Magistrate Court. His appearance followed a viral social media video that allegedly showed him assaulting a woman.

The court details showed that Stoffel is accused of assaulting Ms Pearl Montsho by hitting her with a stick and assaulting a minor child by pressing on her collar bone in Lobatse in August.

He is also charged with causing psychological distress to three children aged seven, eight and 14 by assaulting Montsho in their presence.

Objecting the bail application on Tuesday, the investigating Malebo officer. Detective Kesenogile, told court that the investigation was still in its early stages and the case was sensitive because it involved minors.

She said the investigating team has had difficulty getting information from Ms Montsho, who had been uncooperative, hence awaiting a social welfare report to move the investigation forward.

She also told the court that a cellphone involved in the case had been handed over to specialists for footage analysis.

She further indicated that the minor children had been moved to a safer home, adding that the victim, however, had refused to leave the accused's house.

During cross-examination, the defence counsel, Mr Obonye Jonas, highlighted Montsho's desire to reconcile with the accused.

Mr Jonas cautioned the investigating officer, suggesting that the victim might later claim that she was not a victim of gender-based violence and that the police forced her to incriminate the accused.

In a private testimony, Ms Montsho reportedly pleaded with the court to grant Stoffel bail and expressed her desire to welcome him back home.

However, the magistrate decided to reserve the bail ruling for today. BOPA

Mohwasa urges action on chemical terror threats

GABORONE - Rapid evolution of chemical and explosive terrorism threats, notably driven by the growing sophistication of non-state actors and the illicit cross-border trafficking of hazardous materials, demands a proactive and adoptive approach from nations, sectors, and stakeholders.

Officially opening INTERPOL Global Congress on Chemical Security and Emerging Threats, a peer-to-peer exchange meeting for Sub-Saharan Africa in Gaborone on Tuesday, Minister for State President, Mr Moeti Mohwasa, called for concerted efforts to counter these emerging

By providing a platform for multi-sector global cooperation and partnership, the congress enables its members to foster relationships, exchange expertise, share information on emerging threats and innovative best practices, and ultimately enhance their capabilities to combat the evolving chemical security landscape.

Mr Mohwasa highlighted the timing of the conference, observing that Botswana was currently grappling with issues surrounding illicit drugs, some of which were synthetic in nature. "I am, however, tempted to believe that this challenge extends across the region and beyond, hence the importance of adopting coordinated regional and international interventions to address it," he said.

INTERPOL's Chemical and Explosive Terrorism Prevention Unit, Mr Alan Grimmer underscored the escalating threat, saying, "the threat of chemical and explosives terrorism is increasing at an alarming rate." He underlined the growing sophistication of non-state actors, who were increasingly adept at leveraging chemical materials for harmful purposes, thereby posing significant challenges.

This situation, he said was further worsened by illicit trafficking of hazardous materials across international borders, a stark reminder of the dangers the globe

Mr Grimmer said such worrying trends prompted the launch of the Global Congress in 2018, responding to a call to action from the G7-led Global Partnership against the spread of weapons and materials of mass destruction.

The congress aims to establish a robust framework for international collaboration in combating the emerging threat. Crucially, Mr Grimmer said the initiative sought to enhance the capacity of law enforcement agencies and relevant stakeholders worldwide to detect, prevent, and respond to chemical and explosive attacks.

He also called on the urgent need for proactive measures, including strengthening international cooperation, enhancing intelligence sharing, and bolstering the security of chemical materials. The illicit trafficking of hazardous substances, therefore, requires a multifaceted approach, one that involves not only law enforcement but also international collaboration and robust regulatory frameworks.

said the new identity card (Omang) would have a QR code and chip, which could connect to a smartphone App.

He also said people would be able to see their passport, driver's licence, education and health records all in one place.

"You will also be able to sign documents online, like land sales or contracts, without using paper,"

He said this would make it easy for government to send money directly to citizens for services like grants or farming subsidies.

"You will be able to use the wallet to pay for services, traffic fines, and even taxes."

He explained that the plan also included lowering bank charges, making payments instantly, and allowing street vendors to accept digital payments cheaply.

Mr Naidu said this would bring a "24/7 by government in your pocket" so that Batswana access services anytime, anywhere.

Speaking at the same event, Vice President Ndaba Gaolathe said digitalisation and digitisation which were pivotal in advancing rural development, had the power to transform rural areas by facilitating access to data and Artificial Intelligence systems.

He said the rollout of rural digital infrastructure represented a strategic direction for rural revitalisation and addressing climate issues. The Vice President further said that digital technology in agriculture could enhance farming practices and rural livelihoods, but successful implementation required access to digital tools, digital literacy, and

alignment with local values. Mr Gaolathe explained that while rural villages had transformed in terms of physical infrastructure, the livelihoods of rural communities remained a major concern, with poverty being most vicious.

To address unemployment, the Vice President suggested that the council should continue to coordinate efforts to identify opportunities for job creation in rural areas, focusing on sustainable industries that leveraged natural resources and traditional skills.

He emphasised the need to promote entrepreneurship, vocational training, and renewable energy development in rural areas, adding that tourism remained another area with huge opportunities to change rural lives.

Furthermore, Mr Gaolathe highlighted that financing was a critical factor in the success of renewable energy and rural development initiatives hence assured that the government was committed to developing smart fiscal policies and partnerships with international donors to finance initiatives and ensure that new and existing enterprises could access the resources they needed for sustainable growth. Campsites to revive tourism

NGWATLE - Hukuntsi District Council chairperson, Mr Stephen Lekgobero, has applauded the handover of the newly developed Masetlheng Ecotourism Campsites to the communities of Ukhwi, Ncaang, and Ngwatle, describing the project as a milestone in reviving community-based tourism in Kgalagadi.

Mr Lekgobero said this during the official handover of the five ablution blocks and bush kitchens which were developed through the Kgalagadi and Ghanzi Drylands Ecosystem Project (KGDEP) at Ngwatle, with funding from the Environment Facility (GEF)

He highlighted that the new facilities would enhance the attractiveness of the Masetlheng Pan campsite to both local and international tourists, adding that the development was not only beneficial to communities within KD1 Wildlife Management Area but to Batswana at large.

"This campsite is very important, not just for the communities within KD1, but also for all Batswana, including those beyond our borders," he said.

Mr Lekgobero stressed that the initiative followed requests from communities seeking to revive ecotourism activities as an alternative livelihood.

He said such ventures had the potential to create employment, improve household incomes, and reduce dependence on traditional economic activities such as commercial hunting.

He further noted that Botswana's financial challenges, particularly those linked to reduced diamond revenues, made it necessary for communities to explore economic opportunities."I encourage the Nqhwaa Khobee Xeya Conservation Trust to make use of this opportunity to attract more tourists and generate better returns to uplift the lives of their members and the country at large," he urged.

Mr Lekgobero also underscored the importance of wildlife stating ecotourism not only sustained livelihoods but enhanced the natural beauty of the landscape, turning it into a stronger tourist attraction.

He recalled that earlier efforts to revive the campsites, funded by the National Environment Fund (NEF) under the project Exploring Alternative Livelihoods through Ecotourism Developments in the Nqhwaa Khobee Xeya Trust settlements, had laid the foundation for the current progress. However, he emphasised that more still needed to be done.

Looking ahead, the Council Chairperson encouraged the Trust to seek further funding and technical support, particularly from the District Technical Advisory Committee (TAC), to strengthen

capacity building, environmental education, and long-term project sustainability.

challenged the also community to diversify tourism offerings beyond the campsites, suggesting activities such as hot air balloon rides, photographic safaris, guided game drives, cultural village tours, hiking, and trekking.

"These are some of the different activities that can boost economic returns for the benefit of our communities," he said.

Mr Lekgobero further extended gratitude to the Ministry of Environment and Tourism, the United Nations Development Programme (UNDP), and the Global Environment Facility (GEF) for their financial and technical contributions towards the project.

While providing the overview of the entire project, Hukuntsi, Department of Wildlife and National Parks, Wildlife Officer, Kgosietsile Tau hailed the successful implementation of the KGDEP, describing it as a model for conservation and sustainable livelihoods.

He noted that, the KGDEP Funded by the Global Environment Facility (GEF) at P75 million, the project received additional cofinancing of P255 million from the Government of Botswana, US\$1 million from UNDP, and P6.1million from BirdLife International.

"The project commenced on November 1 2017, underwent a mid-term review in 2021, and a project reset in 2022. Operational closure took place on May 1, 2025, while financial closure is expected by November 1," he said.

He added that the project was structured around four key components, adding that the initiative sought to address both conservation and community development needs.

Mr Tau shared that c omponent one focused on strengthening national capacity to combat wildlife crime such as poaching, poisoning, and illegal trade, implemented through partners including DWNP, JOC, and NAPS.

He further noted that Component two promoted community-based conservation through alternative livelihoods and enterprises in six

Puma open to govt partnership

MAUN - Puma Energy is ready to partner with government, not only to fuel aircraft but also in the vision of a more connected, competitive and compliant Botswana.

This was said by the company's general manager, Ms Tendai Mwewa in an interview.

Ms Mwewa said they were also committed to supporting government's economic enhancement plans.

She said Pula Energy had invested over P170 million in Botswana during the last five years on infrastructure and operations.

The company's primary role is to ensure a secure and reliable fuel supply and preventing it from ever being a constraint to connectivity.

Regarding the aviation sector, Ms Mwewa said she believed that collaboration with government would chart a flight path for Botswana to become a hub of opportunity for Africa.

She indicated that connectivity went beyond routes and schedules, adding for Botswana, it was about connecting world-renowned destinations like Maun and Kasane to global markets and linking Gaborone to centres of trade and investment.

She said Pula Energy had been in Botswana since 2010 and had been a consistent supporter of government's national development agenda, including efforts to address youth unemployment.

She added that the company's global reach was extensive, operating in over 135 countries and servicing more than 100 airports worldwide, present in 17 countries in Africa and serviced over 89 airports.

She outlined compliance as the bedrock of aviation safety and reputation, hence commended the Civil Aviation Authority of Botswana (CAAB) for earning international recognition for its strong safety oversight.

"Compliance is not just a tickbox exercise for us but a culture that protects lives, reassures airlines and safeguards Botswana's reputation as a trusted partner," she

At Puma Energy, she said, they complemented such by embedding rigorous safety and quality management systems into every step of their operations.

With Botswana confirmed to host AviaDev Africa 2026, a key forum for enhancing air connectivity, Ms Mwewa said Puma Energy was committed to showcasing the nation's excellence in every aspect of aviation.

At a recent Aviation Pitso, Mr Joseph Ebineng from

the Directorate of Accident Investigation in the Ministry of Transport and Infrastructure, revealed that Botswana was doing well in aviation compliance and was leading the region with a 92.4 per cent rating.

While he acknowledged the measures CAAB had implemented to manage occurrences, Mr Ebineng underscored the need for continued vigilance to minimise risks, particularly bird strikes which he said were a persistent challenge.

He noted that Botswana's wildlife-rich environment. particularly around the Okavango Delta, contributed to such incidents.

For his part, Aviation consultant, Mr Olefile Moakofi noted that global safety trends were steady since the COVID-19 pandemic until a tragic incident on December 29, 2024.

Mr Moakofi cited the loss of Flight 2216 involving Jenju Air, where a bird strike caused engine failure, resulting in 179 fatalities from 181 people on board.

The incident, he said, served as a crucial case study and thus emphasised the importance of safety as the cornerstone of aviation. He praised Botswana's proactive approach to preventing future accidents. **BOPA**



"The series focuses on masks and ritual movements, adapting traditional performances for vertical screens," said Ji Li, a partner at Guangxi's Shanhai Group. "We have combined ethnic minority features with

Chinese mini-dramas are rapidly expanding into overseas markets, from Southeast Asia and the Middle East to Europe, the United States, Japan, and the Republic of Korea.

> With compact storytelling and fast-paced plots, these shows have become a fresh medium for cultural exchange. Industry estimates indicate that China's mini-drama market exceeded 50 billion yuan (about US\$7.04 billion) in 2024.

> Many companies are now looking abroad for new growth opportunities. Guangxi, which borders ASEAN countries, has become a key base for firms aiming to reach Southeast Asian audiences. The region's cultural similarities and high smartphone usage are driving demand, which makes its market even more appealing.

> "We focus on dubbing and overseas operations, especially for Thailand, Vietnam, and Indonesia," said Qin Li, general manager of Guangxi Hualibo Media, adding that the company was also actively seeking coproduction and copyright partnerships. 

GABORONE - The nation is expected to come to a standstill as three of Botswana 400 metres running powerhouses line up to electrify the World Athletics Championships in Tokyo, Japan, today.

The trio of Bayapo Ndori, Collen Kebinatshipi and Lee Eppie has already made history, as Botswana has never before fielded three athletes in a single event at a major competition.

Many have described this as more than just a race, but a chance to finally seize a major individual medal in an event where Botswana has long claimed Kebinatshipi, who qualified as one of the non-automatic qualifiers, turned the tables by clocking a National Record and a World Leading time of 43.61

Eppie finished second in his semi-final with a time of 44.51 seconds. Ndori, in heat three, dubbed the 'final before the final due to its competitive field, finished first with a Season Best time of 44.21 seconds.

With several favourites now eliminated, the question is, can Botswana finally secure its first-ever men's 400-metre medal?

The final line-up also includes Jereem Richards of Trinidad and Tobago, Jacory Patterson of the USA, Rusheen McDonald of Jamaica, Zakithi Nene of South Africa, and Yuki Joseph Nakajima of Japan.

Botswana is known for its dominance in the men's 400 meters, but for a long time, athletes have failed to cement that reputation with a major individual medal.

All three athletes are in good shape and have demonstrated aggression from the blocks and solid curve technique throughout the rounds, giving the nation hope.

Coach Chilume Ntshwarang said in an interview that qualifying three athletes in the same event was no small feat

'Credit to them, they outdid themselves

and this shows that we are a 400m hub, like people always say. This is our ability," he said.

Ntshwarang added that he had prepared the athletes to remain calm and manage the excitement after the semi-finals.

He noted that the technical team was also confident the athletes would deliver, given their determination.

Meanwhile, both Kethobogile Haingura and Tshepiso Masalela will also compete in the 800m semifinals today. Haingura cruised to the semi-finals after clocking 1:45.02 and finishing in third place, while Masalela finished in second place with a time of 1:44.74. *BOPA*
