High-cost financing hinders Africa dev.



President Advocate Duma Boko said availing affordable financing to Africa would serve the world economic agenda better as it would allow the continent to power on its own development agenda. He said this at the official opening of the United Nations-backed platform - Global Africa Business Initiative in New York on Sunday, ahead of United Nations General Assembly.

NEW YORK - Expensive financing afforded to Africa continues to hamper the pace at which the continent evolves in terms of development.

President Advocate Duma Boko said this at the official opening of the United Nationsbacked platform - Global Africa Business Initiative (GABI) in New York on Sunday.

He said availing affordable financing to Africa would serve the world economic agenda better as it would allow the continent to power on its own development agenda.

Advocate Boko said it was vital therefore for financiers to approach the issue of mobilisation of financing differently for the continent in order to enable it to fully tap into its enormous potential for growth.

He further noted that Africa's wide array of resources, including the dynamism of its young people, were forces that the continent could use for growth through innovation and industrialisation.

BETP to anchor economic transformation

PALAPYE - Acting President Ndaba Gaolathe has reaffirmed government's commitment to national development.

Mr Gaolathe was speaking at Botswana International University of Science and Technology (BIUST) the 10th graduation ceremony in Palapye on Friday,

"Government will not rest until every citizen is employed, empowered, and fulfilled," Mr Gaolathe said.

He also used the occasion to highlight the nation's economic transformation efforts, extending an invitation to graduates to join the ongoing economic reforms.

"I wish to extend an invitation to you today, an invitation to the bold economic transformation process that we, as a government and nation, are embarking on. The Botswana Economic Transformation Plan promises to be an emerging anchor for the transformation of our economy," he stated.

Mr Gaolathe said the country was moving from diamonds and government as the centre, to a vibrant ecosystem fired by the private sector, innovators, social entrepreneurs.

"We are building an economy with an export-based, an economy that is diversified, digitally-led and one that churns jobs for every citizen," he said.

He said the Botswana Economic Transformation Programme (BETP), a process which was a mirror of a government, and a nation that had reimagined country's future.

Mr Gaolathe said six were economic sectors and included agriculture, tourism, energy and mining, manufacturing, financial services, infrastructure and digitalisation.

"The other three are of a social dimension, underpinning our commitment to access to high quality basic services, and the empowerment of our people - healthcare, education and social protection," he said.

The Acting President further said that Botswana had a tradition of excellence in policy conceptualisation and policy

formulation, but had consistently fallen short in execution and so BETP focused and emphasised on execution.

He therefore said the time had come for the nation to build a culture of getting things done and had started doing so with the PEMANDU economic lab methodology.

He said BETP was bold, uncompromising, and placed digitalisation at the heart of the growth model, to transform Botswana into Africa's best managed economy, a paragon of unity, discipline, and inclusive prosperity.

He said Science Technology Engineering and Mathematics (STEM) as well as Technical and Vocational Education Training (TVET) were the twin - engines that would drive Botswana away from diamond dependency to a digitally-led, export driven and diversified economy.

The Minister of Higher Education, Mr Prince Maele encouraged the graduates to position themselves and not just to take jobs but to create them, not just to learn but to lead and to be pioneers.

He also encouraged them to turn a new page where research was not just academic but transformative.

"We need research that fills granaries, power villages, grow industries, and save lives," he said.

BIUST Vice Chancellor, Professor Otlogetswe Totolo said the graduates were not mere recipients of degrees but resolute builders of bridges, sublime weavers of boundless visions, and unfaltering architects of Botswana's tomorrow.

The graduation ceremony also recognised outstanding achievement, with Ms Hlengiwe Dlamini named Valedictorian and awarded the best overall student. She graduated with a Bachelor of Science in Computer Science and Software Engineering.

A total of 384 graduates received their degrees, including 54 postgraduates and 330 undergraduates from diverse disciplines in science, engineering, and technology. *BOPA*

Manyeneng decries illegal sand mining

MMOPANE - Member of Parliament for Mmopane/ Metsimotlhabe, Ms Pushie Manyeneng who is also the Deputy Speaker of the National Assembly decried the rampant illegal sand mining in the village with perpetrators being deliberate on breaking the law.

Speaking during a Kgotla meeting addressed by the Acting President, Mr Ndaba Gaolathe in Mmopane recently, she said perpetrators without fail and delay pay the fine but and would immediately go back to the wrongful act of mining sand illegally.

This, she said was due to the fact that the law against illegal sand mining were lenient. Therefore, Ms Manyeneng called for firmer penalities to deter repeated offences. Ms Manyeneng suggested that VDC must be given the right to mine the sand and generate income for the village as the current situation was not benefiting the community.

When addressing Mmopane residents, Acting President, Mr Ndaba Gaolathe said the economic transformation plan was the pathway that sought to resuscitate economic activities in the country.

He said steps to transformation were put in place to restore financial stability through the Economic Transformation Plan (ETP) taking note that the new government had inherited strained government coffers.

He said the ETP was the true north for the new Botswana government.

Mr Gaolathe indicated that areas of focus were; improving infrastructure for trade, exploring Value Added Tax (VAT) reforms and digitisation of services to ease accessibility and deliver for all.

He also said other areas of consideration included strengthening water and energy sectors, adding that Botswana was considering buying water from Lesotho as well as diversifying economy through agriculture, tourism and financial services.

He further said government was striving towards developing and strengthening state owned institutions like Botswana Meat Commission (BMC) and Botswana Vaccine Institute (BVI) which were all part of building a resilient economy.

Mr Gaolathe revealed that over 6 900 business idea proposals have been submitted under the ETP and so far, about 300 have been approved.

He urged Batswana and the residents of Mmopane to work together, stressing that the transformation agenda was the nation's true north that aimed to create jobs, boost trade and ensure

inclusivity for all.

For her part, Village Development Committee (VDC) chairperson, Ms Edith Setlhoka said the welcomed projects such as the construction of Post Office, kgotla office and the new police station which were all at completion stage.

Ms Setlhoka said one of the achievements was the fencing of Mmopane Primary School.

However, Ms Setlhoka said the two primary schools in the village were congested since the village's the population had grown significantly over the years.

Ms Setlhoka added that coupled with overcrowding, the two primary schools were experiencing dire shortage of classrooms as some classes were conducted outside, despite the challenging weather conditions.

She appealed to government to consider constructing a junior secondary school in Mmopane as currently, their children travel long distances for secondary eudcation.

In his welcome remarks, Kgosi Simon Manthe of Mmopane highlighted the need for a unified secondary school, wary that long distances forced some learners to play truant.

Kgosi Manthe was worried that the future of such students lie in danger as some end up engaging in drugs and alcohol abuse that destroy them even more. *BOPA*

Botswana sets sight on pharmaceutical production

GABORONE - Government's partnership with Cyprus is poised to accelerate Botswana's efforts establish pharmaceutical value chain across critical areas of healthcare.

Speaking at a press conference recently, acting Minister of Health, Mr Lawrence Ookeditse said his ministry was setting its sights on a new direction to transition from a consumer of pharmaceutical commodities to being a producer, a move he said was crucial for building long-term resilience and selfsufficiency in Botswana's healthcare sector.

He said the ministry was actively exploring avenues of cooperation and investment in pharmaceutical production, with starting enhanced collaboration with Cyprus.

"It is important for Botswana to forge ahead and not only remain consumers, but also grow into producers in the pharmaceutical commodities space, this is how we build a sustainable health system, by developing our own capacity to meet our needs," he

He emphasised that the recent

engagement with the Cypriot delegation represented a key step in laying the groundwork for capacity building and local production.

"We are working towards identifying and developing within opportunities pharmaceutical value chain, this includes key therapeutic areas such as paediatrics and oncology, where there is a growing need for consistent access to medicines and treatment options," he said.

He added that local production would not only strengthen supply chain resilience, but also offer economic opportunities through job creation, technology transfer, and increased investment in health infrastructure.

Mr Ookeditse said the recent visit by the Cypriot delegation was both timely and strategic and the ministry was optimistic about the outcomes of the discussions, which were aimed at establishing technical cooperation, joint ventures and knowledge exchange.

"Engaging Cyprus vital to our health industry transformation goals, support can help us bridge the gap between dependency and self-reliance," he noted.

He further said the partnership was more than just about medicine, but about building a resilient health sector that was prepared for the future.

During the engagement, both parties identified several key areas for potential collaboration, as strengthening pharmaceutical supply chains, advancing healthcare technology exchange as well as capacity building for healthcare workers.

Presenting the Cyprus's vision to Botswana, High Commissioner of Cyprus, Mr Antonis Mandritis, reaffirmed his government's dedication to deepening bilateral collaboration as well as commitment to pursuing innovative, long-term solutions that would transform Botswana into not only a centre of healthcare delivery, but also a hub for pharmaceutical manufacturing in the region.

Mr Mandritis highlighted that such partnerships were essential in addressing current healthcare challenges and sustainable reform.

He thus pledged continued support and partnership with Botswana in transforming the health sector, amidst global challenges such as medicine shortages and limited access to specialised medical care.

"Together we can build a healthier, stronger Botswana and contribute to global health advancements," he said.

Mr Mandritis also outlined several key areas where Cyprus sought to extend its collaboration Botswana, including training and capacity building in healthcare and related fields, scholarship opportunities for Botswana students to study in Cyprus, telemedicine initiatives to improve access to specialised care in remote areas, support for vulnerable families, particularly in health-related emergencies people-to-people connections. Moreover, he commended African countries for having begun to pursue the issue of beneficiation of their mineral resources as carting them off to other continents in their raw form had proven disadvantageous in many ways.

"Africa is well on its way to moving away from being a source of raw materials for the world to being a hub of innovation, creativity and industrialisation," said, pinpointing developing complete value chains for mineral beneficiation within the continent would spur on creativity and innovation in its population, ultimately driving industrialisation.

Boko President underscored the importance of having in place harmonised systems, pieces of legislation and frameworks to enable a seamless flow of trade between African states, noting that bureaucratic bottlenecks continued to rob the continent of the opportunity for its trade to grow and flourish.

He added that respective governments also needed to form durable and solid partnerships with their private sectors, and observed that such partnerships should be characterised by speed and agility on the part of governments with regard to ensuring improved ease of doing

Namibia president, Dr Netumbo Nandi-Ndaitwah said, with the adoption and operationalisation of the African Continental Free Trade Area (AfCFTA), Africa had become one big market and was evolving into a hub for goods and services production.

Dr Nandi-Ndaitwah rallied African countries to work together as a team to make the continent attractive for foreign investment.

United Nations secretary general, Mr Antonio Guterres similarly highlighted significance of the AfCFTA.

"We must unleash the full potential of Africa's growth through the AfCFTA. This requires enhanced infrastructure, grids roads, energy predictable regulations," he said.

Mr Guterres said being home to the world's youngest population and being endowed with an abundance of raw energy, creativity and a wealth of resources, Africa would rise above its challenges if afforded the appropriate support. **BOPA**

Gaolathe warns of financial crimes consequences

FRANCISTOWN - Acting

President Mr Ndaba Gaolathe has warned about the consequences of financial crimes, saying it can lead to risk of countries being placed on the grey list.

In his keynote address at the conclusion of a 10km walk organised by the Financial Intelligence Agency (FIA) in Francistown on Saturday, Mr Gaolathe highlighted the critical need to safeguard Botswana's economy from the damaging effects of money laundering and terrorism financing.

The event, which was also aimed at educating learners from Francistown Senior Secondary School, sought to raise awareness among the youth about the importance of financial integrity and their role in preventing financial crimes.

Mr Gaolathe urged young people to be vigilant and proactive in supporting efforts to combat

financial misconduct. He cited the example of the East and Southern African money laundering groups, which have

come together to fight the menace. "When a country is grey listed, it paralyses and affects everyone. whether involved or not. It cannot source out loans and businesses in those countries may collapse" he

The Vice President, who is also the Minister of Finance emphasised that Botswana could not afford to be grey listed, particularly in this era of financial crisis facing the country.

He urged the school-going children with access to technology, to be aware of the dangers of financial crimes and to play a role in preventing them.

FIA Director General, Ms Bopelokgale Sokwe, raised a growing concern about youth involvement in financial crimes.

She said 80 per cent of persons between the ages of 18 and 36, were reported to involved in financial crimes in Botswana during the last quarter.

This, she said, represented 8 per cent increase from the previous

Ms Sokwe said that the trend could undermine the country's future leadership, emphasising the

need to address the issue before it gets out of hand. She said crimes such as obtaining money by false pretences and internet scams had had attracted more youth.

The FIA Director General emphasised the importance of training young minds to be responsible leaders able to resist the temptation of financial crimes. She referenced the adage 'catch them young,' highlighting the need to instill values and integrity in young people at an early age.

Acting director-regional (North East), Dr operations Salani Bafaneli, said the fight against financial crimes was not just a legal battle but a societal one. He emphasised the need for vigilance, education and a shared commitment to ethical conduct, adding that young people must be equipped with values and integrity to build trust, opportunity, and prosperity.

The event provided a platform for learners to share information and ideas that can shape future policies, promoting a collaborative approach to addressing the issue of youth involvement in financial crimes. BOPA

Botswana, Zambia to launch Bridge Authority

KASANE - Botswana and Zambia have passed a resolution to commission the Kazungula Bridge Authority (KBA).

The authority, expected to be officially launched in Kasane on October 15, would be responsible for the management and maintenance of the Kazungula Bridge and its surrounding infrastructure, with the goal of

facilitating seamless movement of people and goods.

Speaking at the Joint Ministerial Committee meeting for the bridge project recently, Minister of Transport and Infrastructure, Mr Noah Salakae, said the authority was a clear indicator of the two countries' shared commitment to African integration and improving the quality of life for the people of Botswana and Zambia.

Mr Salakae added that the KBA

would position both nations as global competitors in trade and investment as well as solidify the Kazungula One Stop Border Post as a facility of choice for travellers.

He said the Kazungula Bridge was an iconic game changer that had successfully overcome mobility restrictions that existed for many years.

The minister also noted that the operationalisation of the KBA

was a top priority at the recent Bi-National Commission (BNC) in Lusaka, where Presidents Advocate Duma Boko and Hakainde Hichilema reaffirmed their commitment to seeing the authority become fully operational.

He further said the new KBA board would serve as the contracting party, managing the authority's affairs and conducting its activities with full transparency.

Thus, he urged lead border agencies to continue implementing the Kazungula One Stop Border Post operating procedures to ensure that the project's objectives were realised.


For his part, Zambian Minister of Infrastructure, Housing and Urban Development, Mr Charles Milupi, said the Kazungula Bridge was a model and benchmark for the entire region and continent due to its strategic location and economic benefits.

Mr Milupi added that the bridge infrastructure was modern and iconic structure, calling it Africa's newest and admirable super-bridge.

Since its commissioning in May 2021, he said, the bridge had significantly contributed to the national economies of both countries and promoted regional trade.

Mine aims to raise copper output

MAUN - MMG Khoemacau mine has acquired six nearby farms to support its expansion project, aiming to facilitate growth and diversify the mine's resources and production.

The mine acting general manager, Mr Neo Kwakwa told the North West councillors when updating on the expansion progress noting that currently transfer duty payments was on

The project, he said targeted to increase copper production from 60 000 tonnes to 130 000 tonnes driving growth and enhancing the country's role as a major copper producer. The ambition of the mine is to eventually reach a target of 200 000 tonnes per annum of copper in the phase of growth. He said that the government had also given them the green light on the Environmental Impact Assessment (EIA) saying they had completed the exercise and Environmental and Social Impact



MMG Khoemacau Mine acting general manager, Mr Neo Kwakwa informed the North West councillors that the company had acquired six farms around the mine's vicinity to support its expansion project.

Assessment (ESIA) authorisation granted for Zone 5, Mango and associated works.

"We have bought six farms around our site for our future expansion as we are busy building three new mines at Zone 5 and Boseto sites. The planned expansion will leverage on the existing key infrastructure and our ambition is to grow and diversify our resource production and value by leveraging Chinese International expertise," he added.

Mr Kwakwa further revealed that early works had commenced and that Toteng-Boseto road and Zone 5, Mango and Zeta NE had been awarded noting that feasibility study would be conducted in November this year commence in December 2025.

"Our commitment international standards maintaining strong relationships with stakeholders are critical to enabling our growth ambitions and support from shareholder, China Minmetals Corporation (CMC) is critical to our success and positioning as China's premier international growth platform".

Mr Kwakwa highlighted that the mine was on the path to world class scale and quality as they created production flexibility while the three boxcuts would through development resourcing and optimisation and focus on discovering the next Zone 5 beyond 20 years.

The mine's director of external affairs, Mr Boikobo Paya also concurred that the future of the mine is bright as they had discovered more copper in the belt and also intends to explore for new resources.

Sustainable business in mining, he said talked about product and "we have to drill more and where we are now is the best because within a radius of 10km, we have discovered that product and we have to develop further." He also said they intended to inject P13 million towards community activities mentioning drilling and equipping of boreholes and water reticulation at Toteng, some maintenance at Ngami Junior Secondary School, community bus shelters, community sports, arts and culture as well as the upgrading of Kuke Primary School among others.

Mr Paya indicated that they intended to strengthen Village Development Committee (VDC) governance and capacity to enhance the effectiveness and leadership capabilities of VDCs to support sustainable community initiatives. "We also intend to promote active participation and meaningful contributions from contractors toward local community initiatives and social upliftment," Mr Paya added.

Enhance beef sector value chain - official

RAMATLABAMA delegation from Kenya that recently visited Ramatlabama Bull Ranch has encouraged Botswana to tap into the beef industry value chain to achieve greater returns.

Kenya Member of Parliament for Marsabit region, Mr Dido Rasso said Botswana's plentiful cattle by-products presented an opportunity to learn from Kenya on improving the value chain.

He said they had started exporting finished by-products such as shoes adding that they also manufactured produces such as cheese and yogurts.

"Kenya is a center of excellence in the dairy industry and the belief is that Botswana can one day visit us to go and learn on how to improve the sector," he said. Furthermore, he pointed out that agriculture was one sector that had shown ability to take the African continent forward, making it selfsufficient in feeding its nation and the world at large.

Mr Rasso was of the view that with abundant land that Botswana boasts of, and right priorities, everything was possible and Africa could benefit a lot from such initiatives. As for their visit to the ranch, he said although they had similar initiative, they gained valuable insight. Mr Rasso pointed out that new ideas were exchanged and the bench marking exercise gave them a sense of purpose and solidified relations between the two countries.

For his part, Ramatlabama councillor, Mr Gaone Lobelwane said it was critical for African countries to invest in cattle farming for self-sufficiency.

He said by tapping into the beef industry, African countries could be counted among fastest growing economies. Mr Lobelwane said they would continue to explore areas of mutual interest and foster cooperation between the two nations. **BOPA**

Water scarcity threatens Tsabong agriculture

TSABONG – Water scarcity and outdated policies were at the forefront of a stakeholder consultative meeting in Tsabong, where residents gathered to review the 1991 National Policy on Agriculture.

The meeting, held in Tsabong on Tuesday, aimed to gather input from the community to help shape a revised policy that addresses modern challenges and fosters national food sovereignty.

The primary concern raised by residents was the crippling effect of water shortage on agricultural activities in the arid Tsabong

Local Small Stock Farming Area, chairperson, Mr Leo Tumaeletse, noted that while opportunities were abound, water shortage defeated any ideas they might wish to pursue.

"Government initiatives are failing because of water shortage," he said. Prohibitive cost of digging boreholes Mr Tumaeletse

said did not help yet that was the only way to access ground water. Water shortage in the area does not only affect farming but tourism and other developments as well hence Mr Tumaeletse suggested that Tsabong be treated differently from other districts when developing policies, as its arid and desert-like conditions required a unique approach.

A resident, Ms Reginah Mosweu, pleaded for utilisation of water from the Molopo River for household gardens and larger fields while Mr Reuben Mosimenyane, proposed that ground-water survey be instituted to save farmers money.

Mr Mosimanyane further advocated for the use of drones along the border to curb livestock theft, a significant problem in the area. Meanwhile, Tsabong District Council chairperson, Mr Elias Motlhanke urged the government to do more in educating the public about existing policies and initiatives and to seek feedback on their effectiveness. He also

pleaded for financial institutions like CEDA and LEA to ease their requirements, especially for women and youth, so that they could be motivated to engage in farming. He proposed providing special discounts on technology to further encourage their participation.

Ministry of Lands Agriculture oragnised meeting as part of a broader effort to revise the 1991 policy to position agriculture as a key driver of economic transformation.

The goal of the new policy is to promote sustainable, inclusive, and competitive agriculture, with focus on innovative technology and commercialisation.

Feedback from the community would be used to inform the situational analysis and propose new projects and strategies for the updated policy. The meeting underscored the community's desire for a policy that was not only robust but also practical and tailored to the unique challenges of their region. BOPA

Gaborone DHMT leads in maternal death

GABORONE - Gaborone
District Health Management
Team (DHMT) leads in
maternal deaths.

According to Botswana Statistics Maternal Mortality Ratio report for 2023, out of 88 maternal deaths recorded in 2023, Gaborone reported 27 cases, followed by Francistown with 16 cases.

Most maternal deaths occurred in referral hospitals, with Gaborone recording 20 deaths and Francistown reporting 12 deaths.

Districts with the lowest number of maternal deaths were Tutume, Kgalagadi South, Kasane and Ghanzi, each reporting a single case.

Gumare, Good Hope, Kgatleng and Palapye each recorded two cases, while other districts, including Serowe, Mahalapye, Kweneng East, Ngamiland and Boteti, reported between four and nine cases.

The report highlights that the highest proportion of maternal deaths in 2023 occurred among women aged 30-34 years, followed by those aged 35-39 years and 40-44 years.

Notably, there was only one reported case of maternal death among women aged 45 years and above.

According to Statistics Botswana, this trend was consistent with previous years, with maternal deaths peaking among women aged 30 to 39 years.

The Maternal Mortality Ratio in Botswana slightly increased from 175.5 to 176.7 maternal deaths per 100 000 live births between 2022 and 2023, indicating a fluctuating trend over the years.

It says the country still had a long way to go in achieving the Sustainable Development Goal (SDG) target.

The top underlying causes of maternal deaths in 2023 included maternal disease conditions such as gestational hypertension with significant proteinuria, obstetric complications, unspecified abortion, obstetric embolism, spontaneous abortion, obstetric trauma, eclampsia, ectopic pregnancy, abnormalities of labour and excessive vomiting during pregnancy. *BOPA*

to Village Development Committees (VDC).

Mahalapye District Council chairperson, Mr Outule Segolame told the full council meeting recently, that the drive would also target land leases and would employ legal mechanisms as well as payments plans.

He also emphasised the need for public-private partnership within the council to manage collaborative projects. *BOPA*





Court grants Stoffel bail

GABORONE - Regional Magistrate Mareledi Dipate has granted Keipeile Mantrakis Stoffel bail. Stoffel is facing three counts of assault and ill-treatment of children.

Appearing before the Broadhurst Magistrate Court on Thursday, Stoffel was granted bail on condition that he bind himself with P3 000, and provide two sureties each binding themselves to the same amount.

It was also stipulated that he must appear before court without fail as and when required to do so.

The accused person was further ordered not to interfere with police investigations or commit any other offences while out on bail.

He is accused of unlawfully assaulting Pearl Montsho in the presence of minor children, including pressing a minor child's collarbone, and of ill-treating children.

Meanwhile, a social worker, Ms Goabaone Mogapi, informed the court that Montsho exhibited signs of emotional distress in their past three meetings as she was not eloquent in her presentations, therefore recommending that, the victim (Montsho) be placed in a rehabilitation centre to facilitate her healing process.

The court was also informed that the three minor children alleged to have witnesses the assault, were currently relocated to safe havens; one relocated to her biological mother, while the other two were with Montsho's parents.

Consequently, Montsho was ordered to undergo psychosocial analysis and be placed in an environment far from the accused person and with minimal contact.

GABORONE - Dolphins' men and women basketball teams have been crowned the 2025 Botswana Basketball League (BBL) champions following their exceptional victory against Police V in the best of three series championship finals played over the weekend.

The BBL champions will represent Botswana at the Zone VI preliminary club basketball championships.

Despite the cloud of muddle that has been hovering the league regarding sponsorships, the skirmish for the championship spot went all the way to the wire this season. With the league games at penultimate stage, only four teams been both Police V teams for men and women and their Dolphins counterpart, lived to fight another day.From Friday evening, all roads lead to Botswana National Youth Council courts for the BBL battle of titans as Police V and Dolphins men and women battled it out for the BBL national championship. In the men's games, Dolphins started the three games series on a high note with an impressive 67-50 victory.

On the ladies side, Dolphins won the series 2-1 to be crowed the ladies champions after defeating Police 63-60 and 56-49 on both game one and three. Following their game defeat Police started off game two strong behind the hot hands of Sesupo Balosi's 14 points and the leadership of senior players, Kemmonye Madikwe and Katlego Jankie who were no match to a smaller Dolphins defensive line.

Relay stars end USA dominace

GABORONE - Botswana men's 4x400m relay team on Sunday, surged to an emotional and groundbreaking gold medal to end the long-standing dominance of their track nemesis, USA in a rain-soaked thriller at the World Championships in Tokyo, Japan.

The victory, a first for Botswana and for the entire African continent in the 4x400m event, was a moment of national pride and evidence of the team's unwavering spirit.

Despite the heavy rain pouring down during the final, the quartet of Lee Eppie, Letsile Tebogo, Bayapo Ndori and Collen Kebinatshipi stayed focused on the prize and delivered a performance that would be remembered for years to come.

When the team left for the World Athletics Championships, one of their main targets was to end USA's reign in the men's 4x400m relay, and they did just that. They

same rain as they celebrated the historic medal.

Botswana did it on the slogan, Pula! and on their currency, Pula!, with a time of 2:57.76. The USA and South Africa clocked the same time of 2:57.83, but the USA won the silver by a few thousandths of a second.

In an interview, the team coach, Chilume Ntshwarang, said he was happy with the team's performance because they had also followed instructions.

The intention, Ntshwarang said, was to obliterate the world record of 2:54.29 set by the United States team in 1993 at the World Championships in Stuttgart, Germany, but the pouring rain was a hindrance.

"The rain was very heavy. It was difficult for the athletes to fully apply themselves," he said, adding that during their team talk they discussed all the possibilities.

"We said should we lead from leg one, we control, we don't rush because they we just guard and strike where it matters. And that's what they did," he said.

Meanwhile, at the last Olympics held in Paris, France, the USA had inflicted pain on the national lads as they snatched the championship right at the finish line, hence this time Botswana did not want to leave anything to chance.

On one hand, USA had fielded their reliable anchor leg, Benjamin Rai, who comfortably led the relay, but that did not help, as Kebinatshipi, who was running the anchor for Botswana, snatched it on the line.

The icing on the cake was when President Advocate Duma Boko spoke to the relay team, telling them that the nation wanted September 29 to be declared a holiday to celebrate their performance, and he could only declare a holiday if they agreed.

The team did not disappoint, as they delivered a historic gold medal and a before Independence Day.

Meanwhile, the team brings home three medals which include a gold in the 4x400m men's relay, another gold from Kebinatshipi in the 400m as well as Ndori's bronze in the same distance.

Not only did the team win a first for Botswana and for the entire African continent, but the three medals at this year's World Athletics Championships, have placed Botswana in position five out of around 200 competing countries.

For coach Ntshwarang, the 2025 World Athletics Championships were Botswana's most successful excursion given that all the athletes made it to the semi-finals.

That alone, he said, had helped them to gain confidence and experience, adding that he was confident that they would do better in
