Awareness campaign targets 450 villages

FRANCISTOWN - Gambling Authority Botswana has launched its new flagship initiative for responsible gambling dubbed 'Motshameko o phepa Public Education campaign'.

The initiative to ensure responsible gambling and fair play amongst stakeholders because gambling on its own is addictive if not played with responsibly.

The occasion marked an annual mass nationwide community based education programme aimed at raising awareness on responsible gambling in 450 villages in a period of eight months.

Launching the campaign, Minister of Trade and Entrepreneurship, Mr Tiroeaone Ntsima said the campaign was a symbol of the ministry and the Gambling Authority's shared commitment to building a gambling industry that was not only safe and well-regulated, but also aligned with Environmental, Social, and Governance (ESG) principles.

"ESG reminds us that an industry's success is not measured by revenue alone, but also by the integrity of its governance, the inclusiveness of its social footprint, and the sustainability of its operations," he added.

"From reaching 100 villages in its first phase, to 150 villages in the second, Motshameko o Phepha has left behind empowered communities who now understand the risks of gambling, the importance of moderation, and where to seek help when needed," he added.

Mr Ntsima further indicated that building on this success, this new phase would extend to over 500 sites across Botswana, reaching cities, towns, and the most remote villages. This, he said was an unprecedented outreach, and demonstrated their determination to leave no one behind.

He said the campaign was more than gambling regulation, but also about protecting families, youth, and communities; ensuring that gambling contributed to the economy without compromising the wellbeing of the people. Mr Ntsima said evidence from the recent National Gambling Prevalence Survey demonstrated that about 13 per cent of gamblers in Botswana were at risk of problem gambling, while 3.4 percent already fall within the problem category.

These figures he said though slightly lower than the global average of 5–6 percent, they still represented a pressing social and public health concern. He said particularly concerning were the findings on youth and women, where nearly one in five young people aged 18–24 were at risk, and women increasingly affected as gambling becomes more accessible through digital platforms.

These trends mirror global shifts and highlight why our interventions must evolve. "Motshameko o Phepha is therefore timely. It resonates with Vision 2036, which envisions a prosperous, inclusive, and sustainable Botswana, and it

supports government's focus on social protection, empowerment, and strong institutions," he added.

He said the Gambling Authority has shown leadership by continuously looking for ways to embed sustainability and ESG values in its mandate. 'Beyond regulation, it is about education, partnerships, and protecting players. By working with village development committees, schools, NGOs, youth groups, faith-based organisations, law enforcement, and the media, the Authority ensures that this campaign belongs to all of us," he added.

He said that Innovative tools introduced, included a 24-hourtoll-free helpline and digital platforms that provided counselling and real-time information. These interventions bridged the gap between awareness and practical support, ensuring that no one faces problem gambling alone.

'While we reflect on the social dimension, we must also recognise the economic weight of gambling. Globally, gambling generates over US\$500 billion in Gross Gambling Revenue annually.

In Botswana, our industry currently averages P250million, and projections show this could exceed P1billion pula next financial year. The launch also saw the authority introduce the 800 metres sprint runner, Mr Nijel Amos as its brand ambassador, and a vibrant team of influencers. "Our message will travel further.

touch more lives, and inspire change.

Mr Amos' profile and recognition, both in Botswana and globally, make him an ideal figure to draw attention to the message of responsible gambling," he said.

As a well-known athlete, he also has a significant influence on young people, and partnering with him, the Gambling Authority could reach a younger audience

with the message of responsible gambling, potentially impacting their attitudes and behaviors early.

Mr Amos's qualities, such as discipline, perseverance, and personal integrity, he said aligned well with the values of responsible gambling.

Social media influencers include MmaRabachanaki, Van Gauteng, Sis-Six Comedian, Mawee Mokgware, Moshweshwe, and others. Their voices, rooted in the communities, will amplify the message of responsible gambling across the nation.

The objective of the launch was to formally introduce the national initiative to the public, outline its objectives, and rally stakeholders and the wider public behind the Authority's commitment to fostering a safe gambling culture in the nation. **BOPA**

Botswana makes strides in palliative care services

GABORONE - Acting Minister of Health, Mr Lawrence Ookeditse, has underscored the urgent need to prioritise Community Home-Based Care (CHBC) and Palliative Care as core components of Africa's health systems.

Speaking at the 5th African Ministers' of Health Session on Palliative and Comprehensive Chronic Care held in Gaborone on Tuesday, to delegates and stakeholders from across the continent, Mr Ookeditse described CHBC and palliative care as "two critical pillars of the healthcare system, essential for delivering comfort, dignity, and sustained support to individuals living with chronic conditions or facing terminal illnesses."

Mr Ookeditse highlighted Botswana's progress in integrating palliative care within the broader health framework saying the key milestones included, the launch of the National Hospice and Palliative Care Policy, aligned with WHA67.19 and SDG 3.8 on Universal Health Coverage, adoption of the Community-Based Integrated Health Services Guidelines, institutionalisation of peoplecentered care as well as hosting of both the 8th International African Palliative Care Conference and the current 5th Ministers' Session in Gaborone.

"These strides reflect Botswana's commitment to ensuring no one is left behind in accessing care," he said.

However, Mr Ookeditse

also acknowledged persistent challenges, citing political prioritisation, insufficient funding, limited rural coverage, and inconsistent access to essential medicines.

"Too often, urgent diseases overshadow palliative care, funding is insufficient, rural coverage is limited, and access to essential medicines inconsistent," he said. Mr Ookeditse said Botswana was committed to strategic priorities aimed at embedding palliative care into the national health strategy and Universal Health Coverage goals, mentioning (UHC) among them strengthening frameworks, building policy a resilient, multidisciplinary workforce, ensuring consistent access to essential medicines, including opioids and scaling up community-based care models that empower families, and traditional healers.

He further said they were yet to close gaps in children's palliative care, ensuring dignity and support for every child, as well as promoting innovation and research, including deepening regional collaboration, endorsing joint declarations, and sharing best practices across borders.

Mr Ookeditse called on partners, particularly the African Palliative Care Association (APCA), World Health Organisation (WHO) and regional health bodies, to help scale up access, harmonise care guidelines, and invest in sustainable financing.

"Together, we can build a

continent where no patient or child suffers in silence, and where compassion is a promise, not a privilege," he said and extended gratitude to all stakeholders, from grassroots volunteers to international partners, for their dedication to improving palliative and chronic care across

The World Health Organisation (WHO) representative to Botswana and SADC, Dr Fabian Ndenzako emphasised that the true strength of a health system was not only in saving lives but also in how it cared for people at the end of life.

"Palliative care is not a luxury, it is a human right, it is the compassionate response to suffering from life-threatening illnesses like cancer, HIV/AIDS, cardiovascular disease, and diabetes," said Dr Ndenzako.

Dr Ndenzako stressed that palliative care was both cost-effective and ethically imperative, describing it as central to health equity and sustainable development.

He added that it played a key role in humanitarian response, climate resilience, and peacebuilding.

He called on African nations to build health systems that cured and cared, ensuring no individual died in pain, isolation, or indignity.

Addressing the session virtually, WHO director-general, Dr Tedros Ghebreyesus, said more than 70 million people needed palliative care each year, but many did not receive it, especially in low- and middle-

income countries.

He highlighted the widespread lack of access to essential palliative care services, which were often underfunded, misunderstood, or simply unavailable in many parts of the world.

Dr Tedros highlighted that WHO was working with governments, communities, and frontline health workers to address the gap by supporting the integration of palliative care into primary health systems, expanding professional training, and ensuring the availability of pain relief and other essential medicines

He further called on all sectors of society to take action, saying the health workers, could bring comfort and dignity to every stage of life, governments should invest in cost-effective services and policies that make care accessible to all and communities must raise their voices to demand dignity and compassion for people facing serious illness.

"Palliative care is not just about the end of life, it is about the value of life itself, every person should receive the care they need with comfort, respect, and dignity," said Dr Tedros.

The session that was attended by various ministers from other African countries served as a platform for reflection and a rallying cry for renewed commitment to compassionate, inclusive healthcare systems in Africa, systems that affirm life, alleviate suffering, and restore dignity to the most vulnerable. **BOPA**

NEW YORK - Botswana and Google's mutual desire to collaborate sparks hope that the journey towards digitalisation will gain momentum, and will someday usher the country's economy into a new setting, one not defined entirely by revenue from diamonds.

Therefore, the decision to adopt digitalisation as a strategy for economic transformation means Botswana should have in place the right infrastructure, as well as the skills and expertise necessary to thrive in the digital

The sentiments were shared by President Advocate Duma Boko in New York on Tuesday during his meeting with the vice president of Google Mr James Manyika.

President Boko said the development of digital infrastructure remained at the core of the noble aspiration to go the digitalisation route, and that Botswana was banking on possible partnerships with entities like Google who had firmly established themselves within the digital environment.

He also indicated that delving into the space digitalisation, skills and expertise on how to properly engage with the digital space were necessary, hence upskilling the population would be

President Boko added that in spite of the immense possibilities found within the digital space, it was similarly fraught with many potential dangers, which required skill to be able to navigate away from.

He said tools that came with digitalisation such as Artificial Intelligence (AI) needed to be properly understood and to be handled properly.

The President informed the Google team that Botswana was keen to have sovereignty over its data.

"As a country we also want to maintain some fair measure of data sovereignty, where we have opportunities to have the data housed in-country. It would be the ideal approach for us," he

In the end, he reiterated Botswana's keenness readiness to partner with Google in the endeavour to digitalise and move the economy away from over-reliance on revenue from diamond sales.

Manvika labelled Botswana's digitalisation aspirations as quite exciting, and stated that Google was equally keen to explore ways in which it could collaborate with the country.

Regarding the tech giant's work in Africa, he said the company had long-standing commitments in the continent, which began when it was just starting off in 2006.

He said one of the areas the company had focused on was infrastructure development, particularly connectivity infrastructure, which had been identified as one of the primary challenges for Africa.

"When Google was just starting in 2006, it got the first undersea cable to connect Africa, and has continued to be very focused in investing in Africa," he said.

Mr Manyika said the company had also opened its first Southern Africa regional cloud hub, a unified and centralised platform for managing data, applications and digital infrastructure.

He said he was optimistic that Botswana would take advantage of the cloud hub, which he explained was located in South Africa.

The Google vice president said the company was also opening up access to some of its products and tools, with an announcement in the past week that it would be giving free access to its AI tools to students in eight African countries.

Further, he said Google was committed to helping Africa build talent and capacity, saying in the last couple of years, the company had skilled more than seven million people to be able to operate effectively within the digital space. BOPA

For Phases Two and Three, she said 473 facilities were connected across the country, noting that 261 of those connections were through

Ms Mophuting further said that the current Phase Four rollout, would cover 455 facilities, adding that the 350 Starlink device received would directly support the rollout to targeted 129 devices Dikgotla, 116 schools, 122 health facilities, 80 libraries, and eight youth centers. She emphasised that the donation would ensure that schools, clinics, libraries, youth centers, and dikgotla were equipped with reliable high-speed internet, noting that the impact would be immense.

Hence, she said the donation would strengthen digital learning and access to global knowledge in schools, as well as enable telemedicine, referral services, and improved patient care in the health sector.

Also, the donation, she said opens up innovation opportunities

for entrepreneurship, coding, research, and innovation for youth, while expanding citizen access to e-services and enhancing community engagement for the government sector.

Thor International The Representative, Mr Kambole Sakala, said the donation of 350 devices would enable thousands of children to access education, adding that the donation represented a partnership of shared vision between his company and the government.

He said the 350 Starlink internet devices, which would be installed across the country, were part of the company's corporate social responsibility.

Presidential Projects Advisor, Mr Omphile Sehurutshe, said the donation started with less than ten devices, but the figure eventually grew to 350 internet devices, including internet subscription for all devices for the first 12 months.

He added that such partnerships with the private sector were desirable as they have the potential to move the country forward.

Project cost escalation justifiable - minister

KANYE - A number of factors have led to cost escalation on the Kanye Sanitation project from P700 to P3 billion, says Minister of Water, Sanitation and Human Settlement Mr Onneetse Ramogapi.

Addressing Kanye District Council meeting on Tuesday after touring the wastewater sanitation plant and pump stations for Kanye Sanitation Project, Mr Ramogapi therefore said the cost escalation was justifiable.

He said one factor was the large bedrock that covered the whole village.

Trenches, which were dug out for pipe fitting, he said needed to be covered with soil and were compelled to secure it from as far as Lobatse, which also came at a cost from those who had the mining rights.

Another factor, which contributed to the escalation, Mr Ramogapi said, was Cost Adjustment Price and Value Added Tax.

He further said initially compensation amount for those properties affected by the project was P5 million, however P37 million had already been spent on 1 119 properties.

He indicated that some of the stakeholders who were affected by the project were not cooperating, which led to more money being spent.

Nonetheless, he said the project would be completed in March 2026 as opposed to the initial completion date of November 2025.

He further urged councillors to encourage the residents to apply for connection so that they could benefit from the project.

In addition, he encouraged public education on proper usage of wastewater sanitation.

Commenting on the Minister's brief, Councillor Tebogo Thebeyame of Lodubeng Ward said they did not expect a budget variation of 100 per cent from the initial budget.

Therefore, he pleaded with the minister not to defend misuse of funds.

"This justification we are trying to do as the new government would throw us under the bus, somebody should account, and it is clear we still need more funds for the project," he said.

Another councillor, Mr Kgomotso Jacobs of Lorolwane Ward wondered if the project would require more funds and if it would reach its completion stage.

For his part, Councillor Pako Ramaselwana of Bagami Ward implored the minister to continue soliciting funds for the sanitation project, saying more investigations in to the project would delay it even further. **BOPA**

MP calls for district-specific agricultural policy

HUKUNTSI - The new National Policy of Agricultural Development should be tailormade to the unique agricultural potential of each district.

Speaking during a consultative kgotla meeting on the ongoing review of the 1991 National Policy on Agricultural Development, which was conducted by the Ministry of Lands and Agriculture in Hukuntsi recently, Kgalagadi North MP, Mr Reason Lekutlane.

He shared that it was not appropriate to adopt a 'one-size-fits-all' approach in drafting such policy, as farmers across the country face different realities.

"The new policy should, at this stage, be deliberate in providing programmes that directly benefit farmers according to their respective districts. It is not proper to have a policy that is the same for the entire country," he said.

Mr Lekutlane further advised that the revision of the policy should promote coordination and coherence within the ministry's departments.

He indicated that different departments within the ministry worked in isolation and in competition with each other, a situation, which undermined effective service delivery.

"These departments must work together, especially in identifying available land for allocation, zoning, and overall land management. The office of the District Commissioner should also collaborate with them to ensure such harmony," he said.

On land use and conservation, he urged the ministry to take into account principles adopted by Conservation International, which he said could help farmers in Kgalagadi to deal with predators and maximise the productive use of land, as much of it falls under wildlife management.

Turning to water challenges in the district, the legislator addressed the much-delayed Ghanzi South and Kgalagadi North Villages Water Supply project, explaining that the matter was currently before the courts following a contractor's complaint over tender irregularities.

"Government has no control over the case at the moment, but once it is resolved the project will commence. When completed, boreholes currently in use will be reserved for cattle watering," he explained.

Mr Lekutlane pleaded with the ministry to ensure that through the new policy, water could be ferried to production areas, saying this would ensure that resources were channeled where they were needed the most.

Presenting a position paper on behalf of the constituents, Lokgwabe Councillor, Mr Tshireletso Molemele has called for bold reforms in the agricultural sector, urging government to ensure that

the new agriculture policy prioritised commercialisation, youth empowerment, and farmerfriendly support systems.

Mr Molemele proposed that the Arable Lands Development Programme be retained, as it used to benefit farmers.

He further suggested the introduction of an agricultural mentorship programme to encourage young people to venture into farming and help transform the sector into a commercial activity.

"Farming should not only be limited to Batswana, because many are not active and lack technical skills for commercialised agriculture. We need to treat agriculture as a commercial business that creates employment," he said.

Mr Molemele stressed the importance of supporting local manufacturers of feeds and fertilisers to drive agricultural industrialisation and reduce unemployment.

He also called for a review of the Matimela Act, noting that confiscating cattle with brands and baits was unnecessary since such livestock could be easily traced to their rightful owners. Mr Molemele urged government to ensure that Botswana Agricultural Marketing Board (BAMB) purchase prices were regularly reviewed to align with prevailing market rates.

He also pressed for reforms in borehole allocation processes

and encouraged the clustering of farmers to enable shared resources and enhance commercial viability.

On infrastructure, Mr Molemele emphasised that the policy should deliberately include developments to support large-scale production.

He highlighted the district's water challenges and advised that pit wells be recognised under programmes such as LIMID and CEDA, alongside boreholes.

Mr Molemele proposed for a review of stock taxation, especially the system used by middlemen who traded in cattle.

"Currently, middlemen tax per cow, but this is not properly captured within BURS systems. The policy should ensure fair taxation while protecting smallscale farmers below the tax threshold," he said, also calling for price regulation of middlemen to protect communities.

Mr Molemele said it was high time the country established a dedicated Agricultural Bank to provide farmer-friendly financial services.

He also called for the creation of a national pool of accredited water survey experts to offer standardised and affordable services, supported by a register to protect farmers from scammers.

Mr Molemele further emphasised on the need to promote agricultural awareness among non-pastoral and non-arable communities such as the Basarwa, who traditionally depend on hunting. *BOPA*

Lobatse tannery revamp on track

LOBATSE - The Botswana Meat Commission (BMC) Lobatse Tannery Revitalisation Project which is anticipated to create employment opportunities is on track, standing at 54 per cent completion rate. It is expected to be completed in December 2025.

This was revealed by Lobatse Town Council deputy mayor, Mr Legodile Mothibi when updating a Lobatse full council meeting recently. He said Lobatse continued to strive to shape its industrial innovation base, adding that the BMC tannery project was one of the critical economic revitalisation building blocks. Mr Mothibi said government had demonstrated commitment to its revitalisation and refurbishment having invested P218 million in the project which would restore operations and create about 80 full-time jobs. So far it has created 85 temporary employment opportunities.

The project, Mr Mothibi said was more than just a refurbishment but a strategic economic anchor for the development of meat and leather value chains across Botswana. Once operational, he said, the revitalised tannery would process hides to wet-blue stage, laying the foundation for downstream investment in leather goods which included shoes, bags, belts, and more to be manufactured at the planned Leather Park City.

"This is Phase I of a broader industrial vision, and will stimulate Phase II, attract investors and unlock new economic opportunities. This is how we build a future for Lobatse by turning legacy into potential, and potential into progress," he said.

On other mega projects in the town Mr Mothibi said the construction of the BMC Meat Value-Addition and Secondary Processing Plant was also progressing well, currently at 34 per cent completion rate. It is constructed by China Jiangsu International Botswana with AMA Projects as Project Manager. The project is scheduled to be completed by June 2026.

Regarding the Milk Valley Farm project, he said it was currently managed by the Botswana Development Corporation (BDC) targeted at reducing imports and increasing local milk production in line with the National Dairy Strategy.

"The farm is now operational with 250 cows. The intention is to have 2 000 animals at full capacity, to be achieved through local sourcing and artificial insemination. The project is already supplying, though not at full capacity, both businesses and households with milk," he said.

On yet another project, Mr Mothibi said Lobatse Clay Works (LCW) had been successfully resuscitated after closure in 2017 due to operational challenges adding that the plant was refurbished in November 2024, with modernisation works that replaced outdated equipment, improved energy efficiency through hybrid systems, and

enhanced brickmaking process.

At present, he said, LCW boosted of a strong pipeline of government projects and was also pursuing private sector clients and working on clinching export opportunities through sales and marketing campaign. The company have so far created 154 jobs and expected to employ up to 240 people once it was fully operational to contribute significantly to Lobatse economic revival

Additionally, Mr Mothibi said the town was boosted by Delta Motives company -an automotive electrical manufacturer based in Lobatse which produce exclusively for export. He told councilors that the company had already employed 327 people out of which 75 per cent were women and 95 per cent citizens. The company recently secured major contracts with Nissan and Volkswagen and it has plans to expand its workforce to 1 000 within four years.

Mr Mothibi underscored that the Botswana Economic Transformation Programme (BETP) was recently launched demonstrate government commitment to building a high-income economy was digitally-enabled, exportdriven driven and economically diversified, where every citizen was employed, empowered and fulfilled.

"We are duty bound to ready Lobatse for Investment opportunities that may emanate from BETP and ensure our developmental agenda aligns with this national drive." *BOPA*

'Cancellation of alcohol levy unlikely to benefit consumers'

BOBONONG - Minister of Trade and Entrepreneurship, Mr Tiroeaone Ntsima says the cancellation of alcohol levy, which stands at 35 per cent, will not benefit consumers as presumed, but will be of benefit to alcohol businesses and or traders.

When responding to comments, during a consultative meeting on the liquor amendment bill 2025, in Bobonong, Tuesday, Mr Ntsima explained that if and when the government cancelled the alcohol levy, beer prices would not be reduced as was expectation by some advocates of scrapping of the levy in question.

He clarified that rather, businesses or traders in alcohol would keep the levy and use it to grow their businesses.

"They will find some justifications as to why they cannot reduce prices of alcoholic beverages while simultaneously enjoying the levy much to the benefit of their businesses," minister Ntsima said and revealed that his claim was a product of meetings with some big alcohol producers and or traders.

The minister said that the only feasible solution currently would be to advocate for the retention of the levy at the current percentage.

"Most importantly, the government can build rehabilitation centres and help rehabilitate alcohol addicts," he said.

The minister also cleared that liquor restaurants operated on an exemption not to apply for liquor license.

He said that with a restaurant license, an operator can automatically sell liquor.

"The onus of control and protection of minors is on the parents and guardians to ensure that children accessing liquor restaurants do not come to contact with alcohol," minister Ntsima said when responding to queries on age restriction at liquor restaurants.

Some residents had observed that liquor restaurants exposed underage kids to alcohol while they were there for food.

The minister said that the said exemption was a way of easing doing business as some patrons enjoyed their meals with alcohol.

On other issues, Mr Ntsima said that where traditional brews were sold at homes, there ought to be some demarcation between the business side and the home side so as to protect kids from being exposed to liquor.

"We don't have to be oppressive in approach, but we have to work together to ensure that underage children and or minors are protected at all times," Mr Ntsima said and added that only traditional brews were sold from such home-based operations.

The minister also indicated that bars and liquor holes that played music would be required to have their facilities sound-proofed to avoid being a menace and nuisance to neighbours.

While speaking at the same event, area Member of Parliament, Mr Taolo Lucas called for brewing and preservation of local traditional brews in large scale.

He said that when produced and preserved in large quantities, such brews as palm wine and setopoti (watermelon brew) may be enjoyed all year round while also creating jobs and wealth for locals

Mr Lucas said that eventually, local brews could be exported the same way Batswana enjoyed imported liquor.

"Let's think differently... alcohol should be consumed moderately and responsibly," the Bobirwa legislator said and argued that alcohol had never been a problem, but the irresponsible consumption.

Some speakers like Ms Sylvia Phethu advocated for 24-hour taverns where patrons could enjoy alcohol while relaxed in the knowledge that they had ample time.

She argued that shortening liquor trading hours forced patrons to guzzle too much alcohol in a short period of time, under pressure.

"And let there be stiffer penalties for those who ignore sound-proofing their buildings because the community decries bitterly such noise especially at night when people should be resting," Ms Phethu said.

One Mr Sediba Robert called for clear regulations regarding musical activities at the bar premises.

He wanted the ministry to clarify who should hold live band performances and under what conditions since such activities were staged outside the bar yet within the premises or complex.

He argued that such events would obviously offend the calls for music to be played indoors and under sound-proofed facilities.

"Sometimes there's a grey area between how far the police can enforce and how the byelaw can intervene, and the subsequent punitive actions for perpetrator," he said. *BOPA* Disposal Ref. No: MTI/POU/GFM/SER/04 2025-2026



Court to decide on rape charge validity

MOCHUDI - Magistrate Queen Moanga of Mochudi Magistrate Court is set to deliver a ruling on October 14 regarding whether the charge of rape against founder of Divine Anointing Church International, Goitsekgosi Mojadigo should stand.

This follows arguments presented in court on Wednesday concerning the nature of the alleged offence.

The case took a turn when the defence lawyer, Mr Olehile Manchwe, submitted that there was consent between the accused and the complainant.

Contrary to the charge sheet dated June 19, 2024, which alleged that the accused unlawfully had carnal knowledge of the complainant without her consent in Morwa, Mr Manchwe argued that, during cross-examination, witnesses testified to the presence of consent.

He further explained that with consent, the offence fell under a different category that of sex obtained under false pretences.

According to Mr Manchwe, the narrative of the victim indicated that she went to the accused's house for an exorcism, during which she willingly undressed and allowed the accused to retrieve a condom and performed the exorcism, although she complained about the duration.

He contended that this behaviour suggested the complainant was

Gopong man convicted for raping minor

LOBATSE - Lobatse Magistrate Court has found a 28-year-old man of Gopong, Tlhalefang Sekwaere, guilty of raping a 14-year-old girl of Lerwana.

Sekwaere, who appeared before Chief Magistrate Rebecca Motsamai on Monday, was ordered to submit fingerprints and will appear for sentencing on October

The court heard that the accused raped the victim three times without protection on October 10, 2024, when the victim was on her way to school.

The victim escaped while Sekwaere was allegedly trying to rape her for the fourth time and sought help from school. The matter was then reported to the police who conducted investigations and arrested the accused on November 11, 2024.

Though Sekwaere pleaded not guilty to the offence, the prosecution proved beyond reasonable doubt that he was guilty, as analysis of blood samples extracted from the accused for DNA comparison reflected that there had been sexual contact, which brought the accused to book.

The accused, who denied the offence, claimed that he was at work at the time when the incident was said to have occurred.

The accused has another pending judgement in another rape case involving a minor, which will be delivered on October 8. *BOPA*

not entirely unaware of the sexual activity.

Therefore, he said, even if she was deceived, it did not necessarily constitute rape

He advised the court to consider further proceedings to clarify the case and suggested amending the charge sheet to specify the offence more accurately.

Meanwhile, the the state prosecutor from Directorate of Public Prosecutions, Ms Seeletso Ookeditse, informed the court that section 141 of the Penal Code stated that consent could be obtained through false pretences.

Consequently, she said this meant there may be no genuine consent.

She also pointed out that section 149 of the Criminal Act allowed the DPP to amend the charge sheet

as long as this did not prejudice the accused.

Ms Ookeditse argued that all witnesses discussed false pretences, and during cross-examination, it emerged that the victim visited the accused's house for sexual cleansing.

She highlighted that the victim's enquiry about a scripture related to sexual cleansing indicated doubt, and the fact that the accused denied knowing about this, suggested he was aware he was involved in a different purpose with the complainant.

Furthermore, the court was told that when the victim complained about the accused taking too long, he allegedly pleaded with her to ejaculate, an act Ms Ookeditse said qualified as sexual intercourse rather than a cleansing ritual. *BOPA*

MOCHUDI - As the nation gears up to celebrate 59 years of independence, Kgatleng District is already alive with anticipation.

Here, the familiar rhythms of dikhwaere, also known as dikopelo, will once again dominate the festivities, proving

so too did the choirs. In Mochudi, five choirs-Morema, Kgosing, Tshukudu, Mabodisa and Manamakgota, rose to prominence.

They competed vigorously in a practice known as go kgopa (to initiate) where one choir would challenge another to a festive sing-off. The exchanges were not only about entertainment but honour, recognition and respect.

"These choirs were not just singing, explains Lesolobe, noting that they were sending messages, sometimes advising, criticising, or even praising. Even dikgosi listened carefully because the music carried the voice of the people.

Over the years, dikhwaere became a vehicle for social commentary. Back then, songs educated communities about the dangers of HIV/AIDS. More recently, during the COVID-19 pandemic, choirs turned into frontline communicators, using

music to spread awareness and encourage protective measures.

With the introduction of the President's Day Competitions in 2010s, dikhwaere moved into the commercial space. Choirs began performing at corporate and national events, adapting their messages to suit themes of unity, resilience and development.

"Today, they are a serious business," says Lesolobe, noting that their music now reflects not only cultural pride but also the economic realities of survival.


In recognition of their cultural significance, dikhwaere were inscribe in 2017 on the UNESCO Intangible Cultural Heritage list.

The milestone both honours the heritage and safeguards its continuity for future generations.

Independence approaches, the tradition will once again be on full display. Revellers from Mochudi and surrounding villages are expected to flock Matshabe Park for Koma 48, an annual festival that has become a fixture in Kgatleng's cultural calendar.

The fourth edition, beginning on Independence Eve and running until October 1, will feature eight choirs. For many in Kgatleng, the sound of dikhwaere is not simply music. It is the sound of belonging, the echo of history and the pulse of a people who continue to build the future. **BOPA**

Beijing to stage 2026 World Swimming Championships

BUDAPEST - World Aquatics has announced that the World Aquatics Swimming Championships (25m) - Beijing 2026 will be held from December 1 to 6 next year.

The Championships, cooperated with the China Swimming Association and the Beijing Municipal Bureau of Sports, will bring together over 1 000 elite athletes from more than 200 countries and regions for six days of short-course swimming.

This marks the fourth time China hosts the Championships, following previous editions in Hong Kong in 1999, Shanghai in 2006 and Hangzhou in 2018.

"World Aquatics is delighted to return to Beijing for the

World World Aquatics Swimming d that Championships (25m)," said mming World Aquatics President Beijing Husain Al Musallam.

"With competition now confirmed for December 1 to 6, 2026 and after a brilliant last edition in 2024, we are confident the world's best swimmers will deliver another extraordinary display of short-course racing in one of the world's great sporting cities," said the president.

The last edition of the short course worlds was held in 2024 in Budapest, where a total of 985 athletes from 195 countries and regions participated in 45 medal events, breaking 30 world records, 13 world junior records, 46 championship records, and 63 continental records. *Xinhua*

GABORONE - Rewarding athletes remains crucial in not only acknowledging their hard work, dedication and success but to also fuel future performance and ultimately raise the profile of the nation on the global stage.

It is on such a background that government has committed to support athletes and promote the growth of sport and arts throughout the country.

Addressing a press conference on Tuesday, Minister of Sport and Arts, Jacob Kelebeng, announced that government had rolled out a P1.559 million reward package for the athletes and officials who participated at the recent World Athletics Championships held in Tokyo, Japan.

Minister Kelebeng said the reward package was in line with the existing Incentives and Rewards Policy, which included rewarding athletes with P150 000 for a gold medal, P100 000 (silver medal), P75 000 (bronze medal) and P20 000 for top eight finish.

He said the reward package

was, over and above, the support provided for team preparation, which included a pre-competition acclimatisation camp in South Korea and also covered appearance fees and facilitation of qualification to the World Championships through build-up competitions like the World Relays held in May this year.

Kelebeng also told the media that the ministry had, however, begun the process of reviewing and refining the incentive policy to ensure that it aligned with national priorities, which aimed to ensure sport became a key driver of the country's economy.

"This indicates a strategic move toward making professional sport a more sustainable and financially viable sector in Botswana," he said.

On issuing diplomatic passports to excelling athletes, Minister Kelebeng said the ministry desired to see athletes use such documents and believed that the move would significantly motivate other athletes to strive for greater achievements.

To that effect, he said the ministry had already made efforts

and had since referred the matter to the Ministry for International Relations.

On one hand, Kelebeng acknowledged lack of representation in field events at major international competitions.

"We are aware of the fact that the country used to have a Memorandum of Understanding (MoU) with Cuba helping with field events," he said.

He thus highlighted the need to revisit the MoU in efforts to restart development and further ensure holistic growth across all athletic disciplines. *BOPA*

Real Madrid, FC Barcelona clash set for October

MADRID - La Liga confirmed on Wednesday that the first El Clasico of the season between Real Madrid and FC Barcelona will be held on October 26 at the Santiago Bernabeu Stadium, kicking of at at 16:15 Central European Time (14:15 GMT).

This will be the first match in charge of a Clasico for Real Madrid coach Xabi Alonso, who will aim to improve on Carlo Ancelotti's record against Barcelona last season.

In the 2024-2025 season, Barcelona defeated Real Madrid four times: winning 4-0 at the Bernabeu and 4-3 at Montjuic in La Liga, as well as triumphing in the Spanish Super Cup final with a 5-2 victory in Saudi Arabia, and

winning the Copa del Rey final 3-2 in Seville, with Jules Kounde scoring the winning goal in the 116th minute.

Real Madrid currently leads La Liga with six wins from six matches, while Barca is five points

But Hansi Flick's side still has a midweek match in Oviedo scheduled for Thursday night. *Xinhua*



"You have shown them that Botswana can rise, compete, and triumph, to our coaches and technical staff - the architects of this triumph, we say thank you. You selected, prepared, conditioned, mentored, and carried our athletes beyond themselves," he said.

Gaolathe said Bank of Botswana during their 50th Anniversary, unveiled commemorative P50 note bearing the faces of track stars, adding that he was confident that it was not a mistake but a was foresight.
