Bonno project on track

34 567 houses are currently at different phases of construction

GABORONE - A total of 34 567 houses are currently under construction through the Bonno National Housing Programme.

Ultimately, the programme aims to deliver 100 000 affordable housing units nationwide, for

Addressing a press conference Monday in Gaborone, the Minister

of Water and Human Settlement, Mr Onneetse Ramogapi explained that there were also 2 819 BHC Commercial houses, 4 743 BHC partnership houses, 58 Bonno Turnkey development scheme houses, 27 002 targeted housing by private investors' houses and three houses donated toward attainment of the 100 000 target for Bonno houses.

Construction of the Bonno

houses, he said was made possible through partnership with private developers, appealing for the participation of the business community.

The press conference was meant to provide an update on the progress made and challenges faced by the ministry over the past 12 months in delivering its mandate that includes; housing development, water and sanitation

and infrastructure, among others.

Currently, Mr Ramogapi said the ministry was faced with a challenge of unavailability of land and shortage of manpower to successfully accelerate the delivery of affordable housing across the country under the programme.

In line with the government's promise to Batswana, to create 100 000 jobs, he said the ministry had so far created 3 392 jobs under water and sanitation.

Additionally, Mr Ramogapi said the installation of Smart Prepaid Water Metres. outsourced to the private sector had also created eight 850 jobs.

The housing programme, he said was expected to create 300 000 jobs, toward government's promise to create 450 000 to 500 000 jobs within five years, across new and existing sectors.

Furthermore, Ramogapi highlighted that about 1 225 BHC houses were currently under construction, generating 1 518 employment opportunities.

Of these houses, he said 557 had surpassed 50 per cent completion and were expected to be ready for beneficial use during the second half of the financial year.

"Additionally, 1 594 more units are at the pre-construction stage, further demonstrating the ministry's commitment to addressing housing challenges," said Mr Ramogapi.

government's commitment to meeting the diverse housing needs of the population and some private investors ready and waiting to hit the ground running, the minister expressed concern that the ministry still faced persistent challenge of non-payment and delayed settlement of water bills by some government institutions and other companies.

The milestone celebration held under the theme: A Legacy of Learning; 40 Years and Beyond, drew past and present students and lecturers from various parts of the country as well as the Minister of Higher Education Mr Prince Maele who was also the guest speaker.

Mohwasa welcomes resuscitation of bargaining council

GABORONE - The Minister for State President, Mr Moeti Mohwasa, has commended the Public Service Unions; Botswana Public Employees Union (BOPEU), Botswana Nurses Union (BONU), Botswana Teachers Union (BTU), Botswana Sectors of Educators Trade Union (BOSETU), National Amalgamated Local and Central Government and Parastatal Workers Union (NALCGPWU), Botswana Doctors Union (BDU), and Botswana Land and Local Authorities and Health Workers Union (BLLAHWU) together with the Employer Party for successfully concluding the negotiation process that has led to the signing of the Constitution of the Public Service Bargaining Council (PSBC) on October 17.

A press release from the state president ministry, says the milestone marks a new chapter in the resuscitation of the Public Service Bargaining Council and represents a renewed commitment by all parties to strengthen dialogue, collaboration, and mutual respect in addressing matters affecting the welfare and conditions of service of public officers.

The release further says, the signing of the constitution paves way for its registration with the Commissioner of Labour, expected to be completed by the end of November 2025.

Mr Mohwasa commends all parties for patience, professionalism, and spirit of constructive engagement demonstrated throughout the negotiation process.

"Their collective dedication reflects a deep sense of duty to the public service and to the broader national interest," the release states

According to the release, the recently concluded negotiations focused on salary adjustments for public officers within Salary Scales A to D.

Employees within Salary Scales E1 and above did not receive any salary increase as part of this round of negotiations.

Significantly, the agreement ensures that no public officer earns below the minimum living wage of P4,000, marking a progressive step toward improving the livelihoods of lower-income employees within the public service.

The resuscitation of the PSBC reaffirms the centrality of social dialogue as a cornerstone of good governance, labour peace, and sustainable development. It is through such cooperation that lasting and equitable solutions can be achieved, ensuring that progress benefits all stakeholders in the Public Service.

The minister reaffirms government's unwavering commitment to improving the conditions of service for public officers

This achievement, the release says is a reflection of the UDC's government broader agenda to build a fair, inclusive and dignified public service that rewards hard work and upholds the principles of social justice and shared prosperity. *BOPA*

Minister Maele commended the college for its four decades of dedicated service to teacher training and nation building, describing MCE as one of the finest institutions in Botswana' that continued to produce educators of integrity and distinction.

Minister Maele stressed that the celebration was not only about the passage of time but about the legacy of learning and enduring impact that Molepolole College of Education has had on Botswana's education system, on communities and on the thousands of teachers who had walked through its gates.

Tracing the college's journey, Mr Maele recalled that the groundbreaking ceremony for MCE was held in 1983 and presided over by the late Dr Gaositwe Chiepe while the official opening took place in 1985 under the leadership of the late, President Sir Ketumile Masire. He praised the college for maintaining high academic standards and producing teachers who have served the country with dedication. He said as Botswana moved toward the Fourth Industrial Revolution, investing in education and human capital remained "It is people, not infrastructure that drive progress. When we invest in education, in our teachers, our youth and our innovators, we create the very engine that propels Botswana's economic growth and prosperity," he said. Mr Maele reaffirmed government's commitment to transforming tertiary education to meet modern needs, highlighting key priorities such as strengthening research partnerships, promoting lifelong learning and reorienting education towards digital and critical thinking skills.

Earlier, MCE principal Ms Bawisisi Nchabe reflected on the college's legacy and called for the introduction of Bachelors' Degree programmes in colleges of education to align with the country's evolving needs.

"Introducing a credit system in 2023 was not enough. A diploma qualification is now outdated and does not suit the 21st-century learner. We call upon the minister to ensure that colleges of education offer Bachelors' Degree qualifications," she said.

Ms Nchabe said MCE had enrolled a total of 7 748 students since 1985 with 7 630 graduating, representing a 99.6 per cent success

rate. She noted that the class of 2025 achieved 16 distinctions with a progression rate of 99.8 per cent.

She described MCE as a trailblazer in education that continued to nurture responsible global citizens.

In his remarks, Kgosi Lawrence Mhaladi said MCE remained a source of pride for Bakwena, noting that the college had lived up to its founding purpose of producing teachers who mould future generations.

Representing the alumni, Mr Selefo Mosanako of the pioneer class of 1987 reminisced about the early days of the college, recalling that their class had just about 70 students when lessons began on March 4, 1985.

"Our motto, 'Lesedi le apotswe' meant that where you see a teacher, you see light. "We were taught that teaching is a calling; something you do because you love it, not just because you need a job," he said.

The Student Representative Council (SRC) president, Mr Matthews Batlhatswe encouraged students and decision makers to embrace innovation and collaboration in shaping their future. *BOPA*

Debswana restructures amid poor diamond sales

KANYE - Termed the 'Future Fit Structure,' Debswana's new, future-focused organisational structure and operating model is expected to be finalised and fully resourced by December 2025.

According to a Debswana official Ms Agatha Sejoe, the restructuring exercise entails an organisational redesign which would ensure long-term business sustainability and operational resilience.

Ms Sejoe said all Debswana operations across the three sites being Orapa, Letlhakane and Jwaneng were included in the redesign process.

She revealed that as part of the ongoing austerity measures to respond to a decline in diamond sales, a total of 15 companies engaged by Debswana had been affected to varying degrees,

including outright termination of two contracts and reduction in activity of 13 contracts.

She said evaluation was still ongoing to determine the need for more contracts rationalisation that would support further organisational realignment as dictated by the evolving business climate.

According to Ms Sejoe, as part of the demobilisation of contractors, it was a requirement that employees were properly released from employment prior to their final payments being settled by Debswana, including completion of exit medicals, and settling their dues from their employment in line with their employment contracts.

She stated that a deliberate campaign to prepare employees for voluntary separation was launched prior to the commencement of voluntary separation process,

which began in December 2024.

She indicated that through Debswana wellness service, a tailored programme of care was created, which ensured that every individual departing the company left not just with a financial package, but with emotional readiness and practical tools to thrive in the next chapter of their lives. When commenting, general secretary of Botswana Mine Workers Union Mr Mbiganyi Gaekgotswe advocated for a change of laws to limit contracts to a minimum of one year as opposed to the current three months, which he said could be renewed over a period of three years in many

He indicated that terminal benefits were not protected in terms of the law, and that as such a lot of companies terminated workers' contracts without paying them their benefits. Mr Gaekgotswe further expressed concern that companies owned by locals often times failed to pay their employees, noting that as a result, many of their members preferred to work for foreigner-owned companies.

Ministry of Labour and Home Affairs public relations officer, Mr Moreri Moesi said the ministry did not have cases of employees who were not fairly compensated for voluntary separation.

Mr Moesi said the voluntary separation process was a negotiated and consultative process done by Debswana management and the Botswana Mine Workers Union.

He said the ministry had registered only two trade disputes from former employees who alleged they were coerced into opting for voluntary separation by the employer when Debswana outsourced the services of the department of transport.

Mr Moesi said the former employees who re-surfaced and demanded to be reinstated to their former positions had their disputes mediated at the district labour office in Letlhakane and Jwaneng, respectively.

Shedding light on employment contracts, Mr Moesi said employment contracts in Botswana could either be fixed term or indefinite, with a fixed contract being valid for a specific period while an indefinite term contract did not have a set end date.

Moesi said there was no statutory restriction on the duration of an employment contract or the number of times it can be renewed.

Nonetheless,he said employers were encouraged to offer long-term contracts where possible, in alignment with the duration of their projects. **BOPA**

Medicines availability at 36 per cent - Modise

GABORONE - The Minister of Health, Dr Stephen Modise, has assured the nation that the supply of drugs and other essential medicines has significantly improved, following months of critical shortages that led to the declaration of a State of Public Health Emergency in August this year.

Giving an update on the state of medicines and medical commodities in the country on Friday, Dr Modise said the situation, which had severely disrupted service delivery in public health facilities, was now stabilising.

He said medicine availability was increasing from 17 per cent in August to 36 per cent by early

"Our target is 97 percent by December and we are confident we will get there," he said.

He said the situation at clinics had

improved, particularly for chronic conditions such as diabetes and hypertension, as well as antibiotics and pain medication," Dr Modise

He however said hospitals remained the most affected due to their reliance on specialised commodities, where he said shortages of specialised theatre, laboratory and emergency care commodities remain critical.

Despite these hurdles, he said the ministry was working towards long term stability through restructuring the Central Medical Stores, adopting pooled procurement strategies, exploring innovative financing and even considering local manufacturing to reduce dependence on imports.

Dr Modise had outlined a combination of global, financial and logistical factors behind the shortage of medicines and medical commodities, saying the crisis was the result of both international disruptions and local systemic challenges.

"The declaration was necessary to focus the country's attention and resources on addressing the urgent need for medicines and medical commodities," Dr Modise said, saying at the time, critical supplies across hospitals including theatre, laboratory, ICU and emergency items were at only 17 per cent availability.

He reiterated that medicine shortages in the country were triggered by among others, the global supply chain breakdowns, delayed procurement, financial constraints and operational inefficiencies within the health

According to Dr Modise, the procurement of medical supplies is a complex and delicate process that required strict compliance with safety and quality regulations.

Even in emergencies, those checks cannot be skipped, which slows delivery.

"It is an intentionally slow, meticulous and highly regulated process, designed to protect public health safety," he said.

Adding to the complexity, he said Botswana's relatively small population and limited purchasing power made it difficult to meet the minimum order quantities set by manufacturers.

"This makes our orders less attractive to respond to, particularly for laboratory reagents and supplies, which have a short shelf life and very specific manufacturing requirements," Dr Modise noted.

The minister also revealed that the country's current fiscal situation has compounded the problem, saying suppliers were now demanding upfront payment before shipment, which further delays delivery, further saying, 'we are operating in a global market affected by wars, tariffs and inflation, all of which continue to disrupt international supply

Locally, he pointed out that some of the shortages have been worsened by administrative bottlenecks. Dr Modise pointed out that communication lapses between health facilities and the Central Medical Stores (CMS) had occasionally caused medicines to 'sit in warehouses while patients went without.'

"We are working to close gaps because it is unacceptable for medicines to be available at CMS yet not reach the facilities where they are needed," he said.

However, he confirmed that recent deliveries had started to ease the strain, and full stabilisation was expected before Christmas.

A1 highway to have toll gates

GABORONE - As part of government's commitment to mobilise funding and ensure road network maintenance, tolling will be considered through partnership with the private sector.

In this regard, A1 highway has been identified as a candidate for tolling through Public Private Partnership (PPP) where the investor will recoup their capital investment from toll fees.

Presenting the chapter for Ministry of Transport and Infrastructure in the draft National Development Plan 12 (NDP 12), Minister Noah Salakae indicated that efforts were also underway to assess the viability of tolling other roads around the country through a feasibility study.

He said Botswana currently relied on 32 500 kilometers network, out of which 10 725 kilometres are tarred, thus admitting that this was not nearly enough and created a bottleneck for other sectors such as tourism, agriculture and mining by limiting production and increasing transport costs.

Minister Salakae said the focus therefore would be on the rehabilitation and upgrading of these roads to not only improve access but also ensure safety for the communities.

"As part of the transformation drive in the transport sector, 2 722 kilometers of roads will be upgraded and rehabilitated during NDP 12. This will increase the current Road Condition Index (RCI) of 65 per cent to more than 75 per cent," he said.

He stated that some of the strategic roads geared towards facilitating trade were upgrading and reconstruction of the A1

highway, reconstruction of Palapye-Martin's Drift, including Martin's Drift bridge, reconstruction of Dikabeya-Lerala road, development of Tsabong-Hukuntsi Road and Shorobe-Kachikau Road as well as reconstruction of Kokotsha-Tsabong-McCathy's Rust Road.

These roads, he said would remove bottlenecks and facilitate access for sectors such as tourism, agriculture and mining as well as facilitate connectivity and transportation of people, goods and services in general.

Mr Salakae highlighted the need for a well-developed infrastructure sector to facilitate economic sectors, improve access to key production areas and markets as well as improve movement of goods and services.

He however stated that the sector has been marred by project implementation challenges.

Such challenges included amongst others, poor performance of some contractors, inadequate supervision, monitoring and evaluation as well as limited implementation capacity. He said it was therefore government's intention to ensure that these challenges were addressed.

"To achieve this, we have set our vision as a sector, which is to transform Botswana into a premier regional hub for trade, travel and investment by building world-class integrated infrastructure that ensures resource security, powers sustainable economic diversification and provides seamless connectivity to regional and global markets," he said.

Mr Salakae said the focus during NDP 12 would be to enhance monitoring and evaluation, which has been lagging and therefore affecting service delivery. *BOPA*

Rail freight declines

GABORONE - Botswana Railways is experiencing a decline in rail freight volumes, which is driven by reduced trade and rising road transport competition.

"Since 2015, imports and exports declined from their peak volumes of 843 000 tonnes and 738 000 tonnes respectively," Minister of Transport and Infrastructure Mr Noah Salakae said in Parliament on Thursday presenting the Transport and Infrastructure chapter of the draft National Development Plan 12 (NDP 12).

This, he said was driven mainly by reduced trade, rail infrastructure limitations and rising road transport competition.

Minister Salakae further said the railway line, which ran from Ramatlabama to Varakaranga Border in Zimbabwe has been deteriorating overtime, resulting in increased maintenance costs.

As part of the government's goal of expanding the rail network and enhancing connections with countries in the region, Minister Salakae noted that several infrastructure projects would be undertaken during NDP 12.

He said most of the said projects that would be implemented through

Public Private Partnerships (PPPs) included Mmamabula-Lephalale rail link, which would connect Botswana to the South African rail networks at Lephalale.

He said the project represented a crucial step in unlocking Botswana's coal export potential through Richards Bay port in South Africa.

He said the Mosetse-Kazungula-Livingstone rail link was also planned to facilitate efficient movement of goods between Botswana and Zambia by reducing transit times and improving logistics efficiency along the North-South Corridor.

Mr Salakae also highlighted that the Trans Kalahari Rail (TKR) line, which was expected to bring significant economic benefits to Botswana and Namibia and the whole of SADC was also expected to be implemented.

He also indicated that priority will be given to upgrading of the Ramatlabama-Varakaranga border line and the rehabilitation of the Zimbabwe rail line to allow for higher axle loads, improved turnaround times and greater efficiency in freight movements.

The implementation of these projects, he said would strengthen economic ties and trade integration,


thereby positioning Botswana as a competitive regional player.

Similiarly, he said there was a pressing need for reforms to separate rail infrastructure management from rail operations as the Act only allowed Botswana Railways to be the sole rail operator.

"This will enable Botswana Railways to retain ownership of infrastructure while allowing multiple operators to provide rail services. The separation will lead to improved efficiency through competition and attract investment into both infrastructure and rolling stock," he said.

In addition, he noted that in an effort to improve operational efficiency and in line with SADC Protocol on Transport, Communications and Meteorology of 1996, the Public Roads Act would be revised to introduce the National Roads Agency and National Road Fund. This, Minister Salakae said would allow for improved management of roads and their funding in a more commercial and market-oriented way.

He also cited that a new National Integrated Transport Policy would be introduced as a blueprint to guide on the development and management of a sustainable transport system. *BOPA*

Digital platform key driver in innovation

GABORONE - The unified government e-services platform, which is currently being implemented, is expected to enhance the digitalisation drive across all sectors of the economy and offer an efficient and convenient way of accessing public services.

Through its associated infrastructure and initiatives, the project will also stimulate research and innovation, thereby realising the government's aspirations of creating 100 000 decent Information and Communication Technology (ICT) jobs by 2030.

Presenting the Digitalisation chapter of the draft National Development Plan 12 (NDP 12), the Minister of Communications and Innovation, Mr David Tshere said the situation called for adequate capacity building and investing in enabling infrastructure to create a digital economy.

He said plans were underway

to connect government services through modern technologies and capacitate employees to close service delivery gaps.

"This will include hosting capability, connecting of government sites and offices through modern technologies, addressing obsolete systems and applications and capacity and capability of IT employees of government. This will address the perennial system down issue that has caused poor service delivery over time," he said.

He said government will explore the Public Private Partnerships (PPPs) and transaction based cost models to drive the digital services.

In an endeavour to expand access to broadband internet services, the minister noted that resilient network routes would be built during NDP 12 to connect various parts of the country to the internet.

He also said enhancing internet services availability and accessibility would be achieved by replacing obsolete components and upgrading the networks.

He also said his ministry will spearhead public campaigns to promote the use of digital services and enhance local solution in the digital space.

"To ensure widespread adoption, my ministry will launch awareness campaigns with the introduction of annual Digital Citizens Forums and incentives that promote digital service usage, especially among marginalised communities.

He said innovation hubs, incubators, digital sandboxes and digital service centres would be established in collaboration with the private sector to foster local tech talent and develop home-grown solutions to Botswana's context.

Mr Tshere said government has developed the one-Gov one-Citizen platform and its associated services, which was achieved through an open source based approach led by a local developer.

He said his ministry would make

use of the internal processes for project formulation, contacting and management to improve the service to local companies.

He said in addition to being aligned with the national development goals, the monitoring and evaluation mechanisms would be sustainable and cost-effective.

Additionally, Mr Tshere said investing in research and development was essential for creating a digital economy.

Consequently, he said the government was committed to establishing a National Research and Innovation Council aimed at overseeing funding and promoting collaboration between public and private research and innovation stakeholders.

He underscored the need for research collaborations with regional and international partners to augment the government's efforts.

Minister Tshere noted that while the newly approved Digital Services

and Cyber Security Bills were the lead legal statutes in establishing structures for implementing the sector's digitalisation drive, plans were underway for the development and immediate implementation of the digitalisation instruments.

"Specifically, holistic national digitalisation instruments are planned for development and implementation effective immediately. These measures are intended to catalyse innovation, enhance service delivery and expand citizen access to safe and secure, efficient digital services in line with government's vision of building a digitally empowered knowledge-based economy," he said.

Furthermore, the Minister said the implementation of the Artificial Intelligence (AI), in conjunction with the ICT Roadmap will improve access to government services to rural and marginalised communities, in the process closing the distance gap. *BOPA*

Dwindling revenue strains fiscal policy

GABORONE - Acting President Ndaba Gaolathe has indicated that Botswana's fiscal policy is under considerable strain due to declining government revenues, persistently high public expenditure and widening fiscal deficits.

Mr Gaolathe made the remarks in Parliament on Friday, saying the situation presented a macro-fiscal challenge as the country continued to require substantial investment toward key enabling sectors.

He said leveraging Public-Partnerships promised to be an important part of mobilising the resources needed to accelerate the government's transformation agenda and deliver

Government, he said was at an advanced stage of creating a legal framework for better management of PPP projects to reduce the strain on the budget and improve growthinvestment nexus.

"We are in the process of finalising the draft Bill on PPP for consideration by Parliament. This is an essential tool to foster a strong private sector partnership and provide a platform for domestic and international consortia to optimise the full benefit of the PPP delivery model," he said.

He said government was also considering alternative and innovative financing solutions.

"These include asset recycling, blended finance, green bonds and asset-backed securitisation during the NDP 12. Such approaches combine public and private capital to monetise existing assets and reinvest the proceeds into new projects, often leveraging private sector expertise and risk-sharing mechanisms," he said.

stated government determination to transform the nation's mindset to transition from a consumption mindset to a longterm wealth creation one.

The Acting President said this meant a more intentional way of saving some of the revenues, particularly mineral revenues towards investment in sustainable domestic and foreign assets across various industries and transforming resource wealth into financial wealth.

"We have started putting in place a Sovereign Wealth Fund mechanism whose components should take shape towards this aspiration. This model should create long-term macroeconomic stability, fostering generational equity by preserving sufficient assets and wealth for future generations," he said.

He said government would explore the possibility of creating a National Fund of Funds mechanism, which would enable the design of modernised and high-impact investment models to allocate resources strategically, targeting priority sectors in line with the national development objectives and also allowing disruptors and innovators including the creative industry to access funding.

Also, he cited government intent to empower citizens, particularly women and vouth.

Through this approach, he said government was keen to create an environment where entrepreneurship thrived communities prospered and national investments deliver maximum returns in jobs, growth and innovation.

He noted that to create a supportive and modern financial environment during NDP 12 government would thus introduce several key policy and legal reforms as part of the plan to strengthen the financial sector, promote innovation, enhance consumer protection and align Botswana's financial systems with international best practices. Financial sector contribution to GDP increases

GABORONE - The Financial services sector's contribution to GDP increased from 4.7 per cent in 2017 to 6.5 percent in 2024, an upward trend reflecting an expanding role of financial intermediation and the mobilisation of long-term savings.

Presenting the proposed priorities for the Financial Services Sector under the National Development Plan 12 (NDP 12), together with its Indicator Framework for performance monitoring and evaluation, Vice President, Mr Ndaba Gaolathe said the size and composition of Botswana's financial system continued to evolve, with Non-Financial Institutions (NBFis) now accounting for a larger share of total financial assets than the banking sector.

Mr Gaolathe, who is also the Minister of Finance said as at the end of 2023, total assets held by NBFis stood at P160.6 billion, surpassing the P133.6 billion quantum of the banking sector.

He said digital financial services were also gaining momentum, adding that in 2024, the total value of mobile and internet banking transactions reached P85.6 billion, reflecting growing consumer adoption of digital platforms.

"As of March 2025, the value of mobile money transactions alone reached P42.3 billion, underscoring the increasing role of mobile-based financial services in enhancing access and convenience," he said.

He indicated that several recent policy and legal reforms presented a solid foundation for progress, including the re-enactment of the Banking Act, (which commenced in August 2025), the Medical Aid Bill of 2025 and the Value Added Tax (Amendment) Bill, 2025 which were passed during the July 2025 Parliament session.

This, he said marked key legislative milestones in the financial sector reform agenda, adding that these milestones demonstrated government's commitment to modernising the sector, enhancing inclusivity and embracing transformation.

Although financial system remained safe, sound and instrumental in supporting economic activity, Mr Gaolathe cautioned that the sector continued to face challenges.

"These challenges include, among others, the high cost of infrastructure deployment, which hampers the expansion of financial services, elevated transaction costs that undermine efforts to promote financial inclusion, lack of interoperability within the financial ecosystem, which limits the seamless flow of data and of transactions across platforms and institutions," he said.

He stated that weaknesses such as the under performance of most SOEs, governance gaps and fiscal pressures further constrained sectoral performance.

Furthermore, he said access to finance for MSMEs remained limited by informality, lack of collateral and cautious lending practices, adding that the banking sector's reliance on short-term deposits from Non-Banking Financial Institutions presented liquidity risks, while global uncertainties and subdued capital markets had dampened investor confidence.

Thus, he highlighted the need to address these constraints in an effort to build a more inclusive, innovative and resilient financial system under NDP 12.

Mr Gaolathe stated that one of the focus areas for the financial services sector under the Botswana Economic Transformation Programme (BETP) was the development of a comprehensive reinsurance ecosystem.

"Africa's reinsurance market is valued at over US\$5.7 billion, yet Botswana contributes only 1.5 per cent of Africa's total reinsurance pool, leaving substantial room for growth," he said.

To that end, Mr Gaolathe stated that Africa's reinsurance market presented an opportunity anchored by Botswana's investment-grade sovereign credit rating, sound regulation and trusted governance.

He said government remained steadfast to position Botswana as Africa's most secure and competitive reinsurance hub that created high-value jobs, attracted global investment and provided greater protection for the people and businesses. **BOPA**

MPs request briefing on boards dissolution

GABORONE - MPs have requested the Minister of Transport and Infrastructure to urgently apprise them of the recent dissolution of both Air Botswana and Botswana Railways board of directors.

Debating Infrastructure chapter in the draft National Development Plan 12 (NDP 12), Selebi Phikwe East MP, Mr Kgoberego Nkawana decried that the frequent dissolution of the two boards was a worrying factor, which impacted service delivery at the two State Owned Enterprises

"It is disappointing that the minister has since his appointment dissolved the boards of the two SOEs more than once in a space of 12 months and yet Parliament is kept in the dark as to the reasons behind any of the dissolutions," decried Mr Nkawana.

Cognisant of the fact that the appointment of the board members reflected government's commitment to ensuring that Air

Botswana was well positioned to deliver on its mandate, Mr Nkawana likewise called on the minister for transparency in the appointment process.

He also expressed disappointment on the exclusion from the NDP 12 of the proposed development and construction of an international cargo and passenger airport and a state-of-the-art industrial plus township in the Selebi Phikwe area.

The project, he said sought to develop a state-of-the-art air cargo and passenger aviation hubs that do not only address the current logistical challenges in the region but also significantly contributed to the economic development of Botswana and the SADC.

Similarly, with a strong focus on governance, accountability and transparency regarding board members appointments, Tonota MP, Mr Gaefele Sedombo pleaded with the minister to exercise transparency through gazetting an expression of interest when appointing the board.

government for the projected expansion of the Maun airport, citing that the new airport infrastructure should nonetheless match its status as the second busiest airport in the region.

He said it was also important for government to promptly process the compensations payments for recidente who were relocated, giving way for the expansion of the

Responding the MP's, Minister of Transport and Infrastructure, Mr Noah Salakae highlighted that the national airline had not been performing well, affecting its financial situation, hence the need to appoint a new board of directors with a clear instruction to provide a turnaround strategy.

Mr Salakae stated that out of the four international airports, Maun was the most active, accounting for 67 per cent of all aircraft movements in 2023.

"As part of our objective of unlocking the high value export economy and establishing a regional logistics hub, the airpe has been identified as a critical gateway to enhancing global connectivity across continents, further increasing traffic into Botswana," he said.

He said they were finalising the feasibility study, which would guide implementation of the airport development project and also indicated that the development of the Sir Seretse Khama International Airport into a multimodal air cargo and logistics hub was also on the cards, adding that the cargo facility will be upgraded to enhance Botswana's appeal as an international distribution hub through enabling local logistics firms and exporters to scale their operations and compete on a global

'Promote food sovereignty'

KANYE - Farmers have been implored to promote food sovereignty by ensuring sufficient food supply and reduction of the food import bill.

Speaking at a kgotla meeting held to review the 1991 Agricultural Development policy in Kanye on Friday, chief policy and research officer at the Ministry of Lands and Agriculture, Ms Lerato Sello urged farmers to transition from subsistence farming to maximising commodity production and profit.

Ms Sello stated that in the endeavour to achieve food sovereignty, it was critical to ensure a farm was a productive investment through practising meticulous care for both fields and livestock.

She said farmers should be able to shape their food systems and define their food policies.

Ms Sello stated that farming should be able to support and enhance economic growth.

She called on farmers to value land, expressing concern that the youth sell land while they should instead lease it out in the event that they do not use it.

She said agriculture used to be the backbone of the local economy and contributed 40 per cent to the GDP, while the sector now contributes 1.7 per cent to the GDP.

She said performance declined since 1987, which had necessitated the review of the policy to establish factors that could have contributed to such a development.

She stated that with ideas gathered from Batswana, the Agricultural Development Policy of 1991 was established and programmes such as ALDEP, ARAP, ISPAAD and Temo Letlotlo were developed in alignment with the policy.

She stated that the policy had since been obsolete, hence the need to review it as it has failed to address some of the challenges that came with global warming.

She also expressed concern at the low participation of the youth in the sector, observing that farmers were mostly cases elderly members of society.

Ms Sello implored farmers to shift from food self-sufficiency to food security, raising concern that local farmers produced food locally but were not able to produce sufficient supply, compelling government to import.

She said the import bill bruised government coffers, adding that the idea therefore, was to

ensure sufficient supply without importing.

When commenting, one of the farmers Mr Albert Lebalesirele proposed that government should divert funds which were being spent on seeds supplied to farmers to the Botswana Agricultural Marketing Board, and then increase the buying price for grains bought from farmers.

That he said, would empower farmers financially and put them in a position to improve agricultural production.

Mr Kentsenao Rutwane said crime escalation had defied their efforts to intensify agricultural production.

He also attributed poor output in agricultural production to lack of good roads and mobile networks connectivity.

Ms Joyce Goletlegwang proposed that government should supply seeds only to farmers who produced high yields.

Member of Parliament for Kanye East Mr Mogorosi Mosanana informed farmers that with the financial constraints that government was faced with, the idea was to empower farmers and nudge them towards self-reliance. **ROPA**

Drug shortage crisis eases - minister

GABORONE - Botswana is beginning to recover from the severe shortage of medicines and medical commodities that prompted the declaration of a State of Public Health Emergency in August this year.

Giving an update on Friday, Minister of Health Dr Stephen Modise said the availability of essential medicines and medical supplies across public health facilities has improved from 17 per cent in August to 36 per cent by early October 2025.

Dr Modise assured the nation that government was working tirelessly to restore full supply levels and prevent a recurrence of the crisis.

"We are not out of the woods yet, but we are on a rebound mode, our target is to reach 97 per cent availability and maintain at least a three-month stock at Central Medical Stores (CMS) by December," said Dr Modise.

Giving a background to the situation, he said President Advocate Duma Boko declared a State of Public Health Emergency on August 25, following widespread medicine shortages that crippled service delivery in hospitals and clinics.

He mentioned that the shortages affected key areas such as theatre, imaging, laboratory, intensive care units (ICUs) and emergency departments.

"To address the crisis, the President appointed a National Steering Committee and Task Force comprising experts from government and the private sector."

Dr Modise revealed that the Health Task Force reached out to international partners for urgent support, adding that Cyprus and the United Arab Emirates were among the first to donate medicines and commodities, while local entities such as HB Botswana, Cospharm Investments, Maun Private Hospital and La Grace Medical Centre also contributed.

He highlighted that the World Health Organization (WHO) and other development partners continued to provide assistance, with additional consignments expected from the Antwerp Diamond Centre and other friendly nations.

He further said the Global Fund, European Union, United Kingdom, South Africa, China, India, Turkey, United States of America and Zimbabwe have also pledged support.

Dr Modise said the ministry planned to implement permanent structural reforms to prevent future crises, saying those included pooled procurement strategies, innovative financing models and the development of local pharmaceutical manufacturing.

"Our long-term goal is to ensure Botswana is never this vulnerable again, we will not rest until the situation is fully resolved," he affirmed. Dr Modise thanked Batswana for their patience and partners for their continued solidarity. Meanwhile, the minister explained that the declaration of a state of emergency on medical supplies allowed government to save hundreds of millions of Pula by purchasing directly from international manufacturers.

He said that without the emergency powers, the ministry would have been "forced" to procure locally through middlemen, a process that would have cost nearly P250 million.

"Imagine getting a procurement locally at close to P250 million, which is what you have in the pocket and not being able to go straight to the manufacturer to get that at about P30 million," he said.

He further explained that many local suppliers sourced their products from the same international manufacturers that the ministry had now been able to approach directly, adding that the state of emergency, was designed to ensure that government "gets the best bang out of the buck" by cutting out intermediaries.

He highlighted that the savings realised through the direct procurement approach had enabled government to expand its purchasing power, adding that it would ensure that no gaps would arise in the nation's medicine supply chain.

On the Health Task Force, permanent secretary in the Ministry of Health, Prof.essor Oathokwa Nkomazana said the ministry had effectively managed the distribution of medicines to hospitals and clinics nationwide following the allocation of P250 million Pula for medical supplies.

"We have been allocated P250 million to source medicines and we have managed the process of delivery to hospitals and clinics across the country," Prof. Nkomazana said, adding that the ministry had spent nearly all of the funds, with less than P60 million remaining.

She highlighted that shipments of medicines already purchased from Canada, Germany and other international suppliers were currently enroute, adding that their arrival would significantly boost the country's stock levels and ease the shortage of essential drugs in various health facilities.



A P43 million medicine consignment arriving at Sir Seretse Khama International Airport in September. The consignment, sourced through BDC and Ministry of Health, was to address critical medicine shortages in the country. Minister of Health, Dr Stephen Modise, said the availability of essential medicines and medical supplies across public health facilities had improved from 17 per cent in August to 36 per cent by early October.

Prof.. Nkomazana acknowledged that the procurement process for medical supplies remained "complex and highly regulated," emphasising that the procedures were in place to safeguard the integrity and quality of the products entering the country.

However, she assured the public that the ministry continued to monitor medicine supply

levels closely and remained in communication with suppliers and partners to maintain a steady flow of essential drugs throughout the country

Sharing the same sentiments, also in the Task Force, Prof.essor Mogomotsi Matshaba stressed that the focus was not merely on the quantity of medicines procured but on maintaining strict quality

standards throughout the process.

"We are not looking at quantity but at quality when purchasing medicines," said Prof. Matshaba, emphasising that the health and safety of Batswana remained top priority.

He explained that the Botswana Medicines Regulatory Authority (BoMRA) continued to play a crucial role in verifying the quality of all imported medical supplies. "BoMRA has been involved

to ensure that every batch of medicines that arrives in the country is of good quality," he noted.

Prof. Matshaba said the Task Force and the ministry were determined to protect the lives of Batswana, ensuring that no shortcuts were taken during the procurement and approval processes.


"We did not cut any corners, the quality of the medicines was thoroughly ensured before they were approved for use," he affirmed.

The Botswana Defence Force (BDF) has been instrumental in expediting the delivery of essential medicines across the country, ensuring that no medical supplies remained idle at CMS, said Brigadier Thomas Masunga.

He revealed that to expedite procurement and delivery, the BDF was assigned to work with CMS and Botswana Post in distributing supplies across the country.

He explained that the teams worked tirelessly to ensure that all medicines were dispatched to health facilities without delay.

"We made sure that no medicines were stocked at CMS. As soon as they arrived, they were immediately sent out to the respective health facilities," he added. Brig Masunga commended the collaborative effort of the various agencies, noting that the partnership had greatly improved the efficiency of the medicine supply chain. BOPA

UB murder accused cries prejudice

GABORONE - A lawyer representing Bantshuti Nkgarapi, charged with the murder of a University of Botswana (UB) employee, has accused the state of prejudicing his client's bail application.

The attorney, Mr Tiroyaone Sedimo told Chief Magistrate Kamogelo Mmesi of Extension II Magistrate Court on Thursday that the state had withheld the psychiatric assessment report, which is crucial to the bail application.

Mr Sedimo said that when his client was denied bail, the court had made it clear that it would consider the bail issue once it had been furnished with the psychiatric report.

"We are here in court without having been served with the report and our hands are tied when we are not furnished with the psychiatric report," Mr Sedimo said, adding that the lack of the report was prejudicial to the defense team's bail application.

Mr Sedimo clarified that the defense would not be making a fresh bail application but would rather ask the court to reconsider his client's bail, as the report had been made available to the court.

The prosecutor, Mr Pascal Mhandu, when asked by Magistrate Mmesi to explain why the defense was not served with the report despite it having been filed with the court in September, said that he was not aware that the defense had not been served.

He told the magistrate that his office was served by the police and he had assumed that they had been served as well.

Thus, Magistrate Mmesi postponed the case to November 12 for a bail hearing and ordered that the defense be served with the report.

The 37-year-old Nkgarapi, a traditional healer, was previously denied bail by the same court on grounds that the matter was still new and investigations were ongoing.

He is charged with the murder of his 47-year-old girlfriend, Magadi Mokganelwa, a University of Botswana employee, who was stabbed to death in broad daylight earlier this year. He has

been further remanded in custody pending his bail application.

Prior to the murder incident, Nkgarapi was on bail for threat to kill, having threatened to kill deceased. *BOPA*

Court denies quartet bail for unlawful dagga possession

SEROWE - Four men, three Batswana and an eSwatini national, appeared before Serowe Magistrates Court on Friday on charged of unlawful possession of a substance suspected to be dagga.

The quartet, Kgomotso Nthela (25), Goarabile Samson (25), Thato Mosinyi (33) and Thembinkosi Mnisi (37) of eSwatini were arrested during a Stop-and-Search operation mounted by officers from Serowe Police Station along the Thabala-Mogorosi road on Thursday night.

Appearing before Magistrate Onneile Ntwayapelo, the four men asked to be granted bail after the charge sheet was read to them.

However, the investigating officer, Assistant Superintendent Eric Dambe of Serowe police, requested the court to deny them bail as the matter was still fresh and investigations were yet to be concluded.

He said if granted bail, they could interfere with witnesses and could also skip the country because of the severity of the offence and the possible stiff sentences that would result in the event they got convicted.

ASP Dambe further told the court that there was uncertainty regarding the permanent physical addresses of the accused persons, hence granting them bail would likely result in them absconding and therefore missing future court appearances.

He said the police were also still on the trail of others suspected to be working with the four accused persons, adding that there were allegations that the four men were part of a larger syndicate.

The eSwatini national, Mnisi will be arraigned separately on October 28 as the charge sheet could not be read to him on

Friday as he had indicated that he required a Zulu interpreter.

The other accused persons will appear for mention on November 6. The four accused remain in custody. *BOPA*

New narration throws spanner in the works

MOCHUDI - Rape accused pastor, Goitsekgosi Mojadigo of The Divine Anointing Church International has somersaulted on the version of events that his lawyer, Mr Olehile Manchwe presented before court in previous appearances.

Appearing before Magistrate Queen Moanga of Mochudi Magistrate Court on Friday, Mojadigo threw a spanner in the works, denying Mr Manchwe's version that the sexual encounter between him (the accused) and the complainant followed the duo's consent to engage in a sexual exorcism.

Instead, Mojadigo claimed that he had agreed with the complainant to engage in a transactional sexual encounter, for which he had offered to pay the victim P1,000.

Recounting the chronology of the events leading up to the sexual act in relation to which he is being tried, he explained that the victim had contacted him via Facebook in 2023, requesting prayer, and that he had provided his phone number.

During examination by his attorney, Mojadigo admitted to meeting the victim two days after their initial contact, and that their conversations then shifted from prayer to flirtation, leading to him arranging a lunch date, which however never happened.

He said when the victim disclosed during their conversation that she was unemployed and therefore in need of money, they agreed to exchange money for sex and drove to his home in Morwa.

There, they watched a movie - The Intruder, and he admitted to caressing the victim, who did not resist. He said he had a condom and that they had sex until she complained that he was taking too long and that he had pleaded with her to allow him to at least ejaculate.

Afterwards, they showered and headed back to Gaborone. Mojadigo told court that they stopped at an ATM for him to withdraw P1,000 to pay for the sexual act but he could only access P400 via ewallet as it turned out that he had reached his daily withdrawal limit.

He said the victim agreed to take P200, with the remaining P800 to be paid later. Thereafter, he said he dropped her off in Gaborone before heading to Thamaga for a church service.

The accused said although he suggested a second encounter the following day, a call he made to check if the complainant was home safe was met with an accusation of rape.

Mojadigo, who has yet to settle the remaining P800 said the victim then involved her former boyfriend, leading to a conference call where both parties recounted their versions.

Later, Mojadigo said he travelled to Zimbabwe but never reached his

destination as he had to abort the trip after receiving a call from a Mochudi police officer, one Lesole, who informed him of an ongoing rape investigation.

During court proceedings, a prosecutor from the Directorate of Public Prosecutions, Ms Seeletso Ookeditse questioned Mojadigo about the inconsistencies in his account of events.

He struggled to answer, citing overwhelm from the multiple cases he is facing. Ms Ookeditse also asked why Mojadigo had not disclosed the alleged love relationship earlier, noting that some evidence, such as prayer requests to get a job at BDF, sprinkling water in her private parts and the victim's questions about sexual cleansing, were not explored in cross examination.

Despite the defence's protests to the line of questioning, the magistrate allowed the prosecution's questions, stressing that the defence should have questioned the victim on the points that were being raised.

Mojadigo's lawyer had also expressed frustration that key witnesses in the case remain in custody for an unrelated matter, which complicates the defence case. Magistrate Moanga however stated that it was the defence's responsibility to secure the appearance of its witnesses in court.

Mojadigo, who will be back in court on November 12 for delivery of judgment, will prior to that date on November 7, appear for a different cse relating to a defilement charge. **BOPA**





NMCB, BQA cement partnership

GABORONE - The Nursing and Midwifery Council of Botswana (NMCB) together with the Botswana Qualifications Authority (BQA) have signed a Memorandum of Understanding (MoU) to enhance collaboration and ensure the highest standards in nursing and midwifery training.

Speaking at the ceremony that marked a significant milestone in the regulation and development of Botswana's healthcare educatio in Gaborone on Thursday, the Registrar of NMCB, Ms Opelo Rankopo expressed deep gratitude and optimism for the partnership, describing the occasion as signifying shared journey with BQA to ensure that nursing and midwifery education in Botswana remained of the highest quality, relevance and integrity.

She highlighted that while both NMCB and BQA operated mandates, distinct under responsibilities their were closely aligned in maintaining standards and educational ensuring that Botswana produced competent, ethical and professional healthcare graduates.

"We regulate education and practice, ensuring that nursing and midwifery programmes meet the highest standards, by doing so, we are not overstepping BQA's mandate, rather, we are complementing each other in a shared responsibility," explained.

She noted that Botswana's nursing and midwifery qualifications were recognised globally, with graduates successfully working in countries such as Australia, Ireland and the United States as a testament.

Tracing the history of nursing regulation in Botswana, she reflected on the council's deep roots saying, "our regulation dates as far back as 1949, before Botswana's independence, when nursing and midwifery in Bechuanaland, Basutoland, and Swaziland were jointly regulated. Over time, this evolved into the establishment of the Nursing and Midwifery Council of Botswana in 1995."

Outlining council's the regulatory work, Ms Rankopo explained that NMCB evaluated nursing and midwifery curricula, inspects training institutions and ensured that teaching staff and clinical practice sites met the required standards.

The newly signed MoU, she said, was intended to bring clarity, quality efficiency, improvement and accountability to the regulatory environment.

"This collaboration will harmonise processes and reduce duplication of effort, it will bring clarity to our respective

ensure quality improvement through joint reviews and promote accountability by maintaining national and international standards," she said.

Ms Rankopo also reassured stakeholders that continuous professional development (CPD) remained mandatory for all nurses and midwives in Botswana.

"Nurses renew their licenses annually and they cannot do without providing proof ongoing professional she affirmed, development," adding that healthcare was constantly evolving.

Sharing the same sentiments, the acting CEO of BQA, Ms Boitumelo Watlhaga reiterated that the partnership aimed at strengthening the quality global competitiveness of nursing and midwifery training and practice. Ms Watlhaga said the partnership represented the beginning of a transformative alliance grounded in a shared vision of equality, professionalism and integrity within Botswana's midwifery and nursing professions.

"Through this partnership, both institutions aim to align nursing and midwifery qualifications and professional standards with Botswana's National Credit and Qualifications Framework (NCQF). The alignment will strengthen joint quality assurance mechanisms and promote mutual recognition of qualifications both nationally and internationally," she said.

Beyond academic alignment, Watlhaga said collaboration will also foster joint research, policy engagement, data sharing, workforce planning and accreditation, adding it will support recognition of prior learning and the development of credit accumulation and transfer systems to enhance professional

"These initiatives demonstrate our shared commitment to an education system that not only meets national standards but also aligns with regional and global benchmarks," she said.

She said they are laying the foundation for a qualification system that empowered healthcare professionals, strengthenend the integrity of the education system and enhanced the quality of healthcare delivered.

Ms Watlhaga said healthcare was not a field where people can be treated as mere subjects of technical training.

"We must produce graduates who are job-ready, compassionate and capable of delivering," she



Enhance Mmakgodumo tourism potential

KANYE - Dikgosi have been encouraged to be vision bearers for their communities, a role they are empowered to fulfill through Bogosi Act.

This was said by Mr Tumelo Seboko, Acting Deputy Director in Tribal Administration, during his address at the Mmakgodumo Festival on Saturday.

Mr Seboko referenced Kgosi Malope II's visionary statement expressing his desire to see the Mmakgodumo area fenced and for wildlife to be introduced within this secured environment to enhance the region's tourism

He said maximising the area could help Bangwaketse generate income through lease rentals and other activities.

Mr Seboko noted that the current government encouraged councils to self-finance, thereby creating their own revenue streams.

He urged Bangwaketse to recognise that this principle was not limited to councils; communities can also adopt it.

Mr Seboko praised the business community for giving back to the areas in which they operated, noting that the community expected businesses to contribute similarly to cultural initiatives.

He described the festival as a return to the roots and heartbeat of Batswana, explaining that the Mmakgodumo site was sacred as it carried the stories of Bangwaketse ancestors, tales of courage, wisdom and unity that continued to shape both Bangwaketse and Batswana.

The festival's theme, 'Ngwao Lore, Seikokotlelo' (My Culture, My Pride), celebrated heritage, creativity, sustainable growth, and the importance of harnessing culture for Botswana.

It served as a reminder that identity was a greatest asset.

He stated that through cultural tourism, Botswana was unlocking new opportunities and attracting visitors to its rich heritage, diverse landscapes and warm hospitality.

According to him, the festival's diverse programme showcased vision in action, including traditional games, cultural music and dance, poetry recitals and exhibitions of crafts and heritage cuisine.

"Each activity rekindles Botswana's cultural flame while creating new pathways for entrepreneurship, tourism and social inclusion," he said.

Mr Seboko said that the government was inspired by the Mmakgodumo initiative, which alignsed with broader development goals outlined in the National Development Plan 12 and the Botswana Economic Transformation Plan (BETP).

Furthermore, he noted that

these frameworks recognised the creative economy and cultural industries as powerful engines of transformation that created jobs, attracted investment and strengthened social cohesion while preserving Botswana's heritage.

He pleaded with Debswana, who have always been supportive from the past year, to consider Kgosi Malope II 's request; to fence the bird sanctuary and stock





He said that participation has increased since the inaugural event last year, with more people eager to get involved.

as Kasane and Francistown expressing interest in participating, but lack of sponsorship often prevented potential participants from attending due to lack of finances to cover transportation, accommodation and food costs.

He lamented the reluctance of many companies to proactively support such initiatives.

Nevertheless, Nkobolo has established regional groups aimed at providing motivation and ensuring a wider reach, visiting places like Moroka and Ramotswa to promote inclusion.

Sitale promises swift action

GABORONE - Newly-elected Botswana National Olympic Committee (BNOC) president has promised to hit the ground running as there are major events coming which the country has to earnestly prepare for.

In an interview, Sitale cited the Africa Youth Games scheduled for December in Angola and the Commonwealth Games billed for Scotland in July 2026, highlighting that Botswana was already late into the preparations for the former.

He said other countries were currently in camp in preparations for the Africa Youth Games; games that he said Botswana had to equally prepare for fully as they were a building block that ensured, among other things, that athletes were competitive.

Sitale, who disclosed that they currently have at their disposal P2 million to prepare for the games, explained that they have requested for a budget of P9 million from government.

"We currently have P2 million, and we need to identify strategic and innovative ways of using these limited funds to prepare the team while still waiting for more funds to be availed," he said, noting that they were alive to the budgetary constraints that government was faced with.

Regarding the Commonwealth Games, he said Botswana was still yet to start preparations while other countries had already started their training regimes for the games.

This he said, was despite the fact that the games were just nine months away. In that regard, Sitale said they needed to have a conversation with the relevant stakeholders so that preparations could start right away.

"We are aware that on the athletics side, they were still on their off season, but we need to come in as BNOC to look at our elite athletes and see how best

they can prepare," he said.

On other issues, Sitale expressed excitement that parliament had passed the National Anti-Doping bill, saying once signed into law, it would go a long way in addressing doping, which was quickly becoming a national crisis.

"I believe it will be signed into law soon so that it gives lawful provision to legally institute appropriate measures to encounter incidents relating to doping," he said

Furthermore, he rallied all stakeholders to actively contributes to efforts aimed at fighting doping, an enemy that threatened to undo the gains that had been made in developing sport.

Meanwhile, Sitale clinched the BNOC presidency after being voted by 20 delegates and Yarona Sharp on the other hand received nine votes while Ookeditse Malesu secured a solitary vote.

For the senior vice president position, Michael Moroka got 23 votes, with Moagi Sharp amassing seven.

For the first vice president position, Tebo Segaise ran unopposed in the second round after Oaitse Thipe and Bob Lekan were eliminated in order to allow her to satisfy the BNOC Constitution, which requires a candidate to have garnered votes in excess of 50 per cent in order to

be deemed to have won.

In the second round, Segaise got 19 votes, while for the first round she received 10 votes against nine each for Lekan and Thipe, respectively.

Game Mompe became the new BNOC second vice president after beating Unaswi Matebu by 15-14, while additional members are Boikobo Gaolebalwe, Kebalebile Ramontsho and Ofentse Bakwadi. *BOPA*
