GABORONE- Vice President and Minister of Finance, Ndaba Gaolathe has underscored the importance of expanding Botswana's capital markets and fostering a culture of listing among local enterprises.

Speaking during an engagement with prospective issuers in Gaborone yesterday, Mr Gaolathe said companies that go public do more than access capital as listing transforms a business from being privately managed to publicly accountable, bringing opportunity and discipline.

He said Botswana Stock Exchange (BSE) continued to lead in developing the country's capital markets and shaping the national conversation on inclusive, cost-effective capitalraising for all enterprises.

He said this event marked a renewed effort to strengthen dialogue between government and the private sector, particularly those considering listing on the BSE, adding that Botswana stood at a defining moment, as the global economic landscape was rapidly evolving with new technologies, market disruptions, and shifts in capital flows reshaping competitiveness.

Mr Gaolathe noted that the key challenge was to ensure the country's economy remained resilient, innovative, and futurefocused. Public investment alone, he stressed, would not suffice, hence the need for a strong, confident, and dynamic private sector to collaborate with the public sector in driving innovation, growth and job creation.

UK govt pledges support for BETP

MAUN - The United Kingdom (UK) government has pledged support to Botswana's Economic Transformation Programme (BETP) that aims to accelerate the country's growth and drive national development.

Through the programme, the government is promoting economic diversification which will eventually create new opportunities for investment.

The British high commissioner to Botswana, Mr Giles Enticknap

said in an interview during his visit to Maun, that the UK government and Botswana had a long standing relationship on various international matters hence the commitment to support transformation that the country endeavoured.

Following the Botswana's democratic transition, he said they were reviving and refining and willing to elevate the partnerships on various areas of science, innovation, education, security, energy and many more.

UK, he said was looking

forward to bring responsible investment to Botswana with a view to facilitating growth and diversifying the economy saying that the country's economy relied heavily on diamonds.

He however appreciated that other sectors like tourism and agriculture were emerging as potential investment areas.

For the second time this year, he said they had engaged the UK investors about how they could bring responsible green UK investment into Botswana to help diversify the economy

and stimulate employment opportunities.

He also appreciated that the vice president, Ndaba Gaolathe recently visited UK where he engaged with some high-level investors exploring partnerships opportunities in support of economic diversification.

"We are much willing to support the country's BETP which aims to reshape the economic landscape, attract investment and position the country as an economic hub. We believe that by bringing potential investors across Botswana including the northern side can help stimulate job creation, expand opportunities for Batswana as well as lead to mutual economic benefit to both nations," he added.

Mr Enticknap highlighted that Botswana was an attractive destination for foreign investment because of its stable political environment, vigorous incentives and strong governance.

Botswana, he said also had maintained peaceful

environment providing a conducive and secure setting for businesses to thrive.

"Navigating the business landscape in a foreign country can be a daunting task but here the country offered excellent opportunities for investment".

Mr Enticknap also noted that UK government was interested in supporting Botswana's energy transition specifically in renewable energy and green technologies to help meet its Vision 2036 goals.

The Botswana 'vision energy goals for 2036 include reaching 50 per cent of the energy mix from renewable sources and achieving universal access to electricity by 2030.

The UK private sector, he said, was also excited about how they could support the country renewable energy development to reach 50 per cent by 2030 through partnerships and financial initiatives to ensure energy reached the rest of the population who did not benefit from clean energy. **BOPA**

BIDPA plays crucial role towards Agenda 2063 journey

GABORONE - Botswana Institute for Development Policy Analysis (BIDPA) on Tuesday marked its 30th anniversary, celebrating three decades of providing research-based policy advice aimed at advancing the country's social and economic development.

In his keynote address, African Union Commission former deputy chairperson, Mr Erastus Mwencha, commended BIDPA for its commitment to providing evidence-based socio-economic policy advice and capacity building, noting that such dedication was key to building a prosperous Africa.

While acknowledging BIDPA's achievements, Mr Mwencha noted that Africa still had a long way to go, as it continued to grapple with persistent challenges such as uneven progress, capacity gaps, dependence on

external financing, limited domestic resource mobilisation, and ongoing threats such as pandemics, unresponsive governance and climate change, raising the question of what lies ahead for the continent.

"This is where Agenda 2063 comes in," said Mr Mwencha, explaining that Agenda 2063 served as a strategic framework for the socio-economic transformation of the continent over the next fifty years.

It builds on and seeks to accelerate the implementation of past and existing continental initiatives for growth and sustainable development," he added highlighting BIDPA as one of the key players in the journey to Agenda 2063.

Assistant Minister for State President, Ms Maipelo Mophuting, for her part, described BIDPA's 30 years as not only a celebration of longevity but also a milestone

that reflected the organisation's maturity.

"It represents a maturity born out of experience, perseverance, and, of course, service," she said, noting that the milestone comes at a providential moment when Botswana and many nations across the world face complex socio-economic challenges that demand renewed wisdom, courage, and innovation.

She emphasised the need for home-grown policies and solutions grounded in realities of Batswana and guided by robust evidence, especially in an era defined by uncertainty, technological disruption, shifting geopolitics, and global economic volatility.

Ms Mophuting affirmed that the government remained resolute in its conviction that Botswana could not achieve its economic transformation agenda without BIDPA's counsel and partnership. *BOPA*

High commissioner lauds Botswana conservation approach

MAUN - Partnerships are essential for supporting economic transformation, and Maun as a tourism hub can benefit greatly from them.

British High commissioner to Botswana, Mr Giles Enticknap, who shared this in an interview, commended Nkashi Trust for the work it was doing towards protecting the delta and its source, as well as supporting economic opportunities and sustainable livelihoods of the communities.

He said it was encouraging that the work was being carried out through partnerships, citing the partnership with National Geographic through the Okavango Eternal partnership with De Beers.

"I am impressed to learn that the trust and its partners have a series of projects supporting sustainable livelihoods of the communities, ensuring that conservation and livelihoods go hand in hand.

I have also learned about the beauty, the future and the potential that lies within the delta such as the potential for harnessing the green growth in Botswana which aims to support the government economic transformation agenda," he

Mr Enticknap, who has been on a three-day visit in Maun to learn and explore about the investment and partnerships opportunities the area could offer, appreciated the rich wealth of knowledge that exist within the communities living around the delta.

He said the communities' indigenous knowledge on conservation was invaluable, and that the United Kingdom and other countries could learn best practices from Botswana to enhance the way they had been doing things as far as conservation was concerned.

He also had the opportunity to visit a shopping complex where he interacted with small and medium entrepreneurs, whom he considers the face of economic transformation as they were primary drivers of job creation and inclusive growth.

Some, he said shared about the challenges they encountered in their entrepreneurship journey, while others recounted their success stories and how they benefited from Tokafala, an enterprise development programme helping entrepreneurs develop business, financial management and marketing skills in order to be able to build successful and sustainable businesses.

Mr Enticknap acknowledged that the programme, which was being implemented through partnership between Anglo American, De Beers and the Botswana government has benefited many businesses across the country, focusing on fostering growth by helping owners to overcome challenges in business.

He said he also learnt that the programme had also helped support thousands of jobs and created hundreds of new ones while also increasing access to commercial and formal financing for entrepreneurs. *BOPA*

Keorapetse urges establishment of **ESG** strategy

GABORONE - Advancing sustainability, climate action, and Environmental, Social and Governance (ESG) principles is central to national progress and economic resilience, says Speaker of the National Assembly, Mr Dithapelo Keorapetse

Speaking during the Botswana Sustainability Week Wednesday in Gaborone, Mr Keorapetse underscored the need for multilateralism, emphasising that global cooperation remained a vital platform for addressing cross-cutting challenges from environmental protection to climate adaptation.

Mr Keorapetse emphasised that climate change was a current and urgent challenge, directly threatening livelihoods, water security, agriculture, and energy.

It is for this reason, he said, that the government was committed to strengthening coordinated structures that would drive climate priorities from the highest level of policy.

"It is not just an environmental issue, but also governmental, security, and moral. Choices we make today will shape tomorrow," he said, adding that the are national priorities aligned with Vision 2036, National Development Plan 12, the African Union's Agenda 2063, and the UN SDGs.

Highlighting the urgency, Mr Keorapetse warned that climate change was a present and pressing challenge impacting livelihoods, water security, agriculture, and energy.

He said lack of a coherent governance framework for climate policy, along with outdated legislation, was a 'strategic vulnerability.'

He therefore specifically recommended establishing a national ESG strategy with clear steps and timelines, and urged Parliament to set an example by adopting sustainable practices in its own operations.

"Without the necessary policies and institutional commitment, we risk falling behind economically, environmentally, diplomatically," he said, urging comprehensive policy reform and a stronger governance framework. Outlining his vision for a high-

environmentally performing. conscious legislature, Keorapetse announced plans to transform Parliament into a 'Green Parliament.'

Drawing inspiration from Mauritius, he said the initiative will focus on digital transformation to reduce paper use, conduct carbon footprint audits, and embed sustainability across all parliamentary operations.

"In the next session of Parliament, I do not want to see stacks of notice papers and printed documents; we will distribute all materials electronically to reduce environmental impact," he said.

Mr Keorapetse emphasized that government action alone was not enough, urging the private sector to embed ESG and sustainability into their core business strategies before regulatory measures make it mandatory.

"Sustainability is not an obligation, it is an opportunity for innovation, competitiveness, and long-term profitability," he said.

He therefore called for business, academia, and civil society to collaborate specifically on developing training programs for ESG reporting, creating frameworks for impact measurement, and promoting responsible investment practices.

He described the Sustainability Week as a landmark platform for business beyond profit, adding that the discussions over two days would help shape the region's approach to sustainability.

Meanwhile, Mr Keorapetse applauded the Green Loop for creating a safe and inclusive space where policy meets practice and where transformation is driven through resilience, innovation, and vision.

He commended the founder and Managing Director, Ms Lindiwe Modise, for pioneering and setting "a powerful example of innovation, leadership, and national progress."

Also, he lauded the Green Loop for transforming Sustainability Week into 'an international and regional dialogue that connects governments, the private sector, academia, and civil society.'

The theme for the event was: Enhancing Sustainable Practices in Africa, Change is Here, Leaving No one Behind. BOPA

Botswana, Türkiye bolster relations

GABORONE - Minister for International Relations and Cooperation, Dr Phenyo Butale, says the relationship between Botswana and Türkiye is driven by shared values and mutual interests.

Dr Butale also expressed Botswana's appreciation for its ongoing collaboration with Türkiye and reaffirmed the government's commitment to deepening cooperation across various sectors to benefit both

"The bond between Botswana and Türkiye is built on common goals and a strong foundation of mutual respect.We value our partnership and are dedicated to working together to achieve shared progress, Dr Butale said.

Speaking during Türkiye's 102nd anniversary celebrations in Gaborone on Wednesday, Dr Butale said the recent bilateral agreements signed between the two countries, including the Visa Waiver Agreement for Diplomatic, Official, Service and Special Passports, the Memorandum of Understanding (MoU) on Political Consultations, and the Double Taxation Agreement would facilitate smooth travel for officials, promote economic collaboration Turkish

"This will also encourage deeper cultural understanding through increased people-topeople exchanges between our countries. Ultimately, this will be supported by Botswana opening an Embassy in Ankara," he said.

further commended Türkiye's continued support to Botswana, highlighting the provision of scholarships for Batswana students, humanitarian equipment donated in May 2025 to aid disaster response, and funding to train 50 small-scale horticulture farmers under the project Empowering Small-Scale Horticulture Farmers through Climate-Resilient Practices and Equipment Support.

He said the agricultural funding would strengthen the agricultural sector and ultimately enhance the country's food security.

For his part, Türkiye's Ambassador to Botswana, Mr Ahmet dem Akay, said the past year had seen notable developments in bilateral relations, adding that Türkiye stood ready to strengthen cooperation across all sectors on the basis of mutual partnership and benefit.

"Türkiye is here to collaborate with Botswana in over-coming the challenges she faces," Mr Akay

Akay highlighted that

Embassy, together with the Turkish Cooperation and Coordination Agency (TDKA), provided equipment worth P318,000 to support small-scale horticulture farmers in Shakawe.

In addition, he said, through the Turkish Disaster and Emergency Management Presidency (AFAD), materials worth P270 000 including generators, gas heaters, tents, sleeping bags and stretchers were donated following flood disasters experienced in February.

He also said several Turkish companies in sectors such as construction, mining and tourism had shown interest in Botswana, with one of them, Eksen Construction, signing an MoU with the Ministry of Transport and Infrastructure on the Mosetse-Kazungula-Livingstone Railway Project.

On education, Mr Akay said nine Batswana were awarded Türkiye Scholarships this year, with six currently studying in Türkiye. He noted that 33 Batswana students had benefited from the programme since its inception 13 years ago.

He added that Türkiye continued to promote cultural exchange through events such as the Turkish Cuisine Week luncheon and Ramadan celebrations aimed at bringing Turkish and Batswana culture closer together. BOPA

He pointed out that the future depended on collective capacity to diversify the economy, expand exports, and nurture globally competitive enterprises.

Gaolathe reaffirmed government's support for BSE initiatives encouraging listings by multinationals, state-owned enterprises, and small and mediumsized enterprises (SMEs). Among the intiatives, he highlighted the Tshipidi Mentorship Programme, which equips entrepreneurs with skills and governance frameworks necessary for listing readiness, expanding the pool of potential issuers and ensuring the capital market serves as a driver of inclusive

Embrace capital markets for grow

He further revealed that the BSE was strengthening its global partnerships through collaborations with the London Stock Exchange Group and the Luxembourg Stock Exchange partnerships aimed at connecting Botswana's capital markets to leading global financial ecosystems, enabling dual listings, sustainable finance, and digital innovation.

Mr Gaolathe said government was undertaking regulatory reforms, digital transformation, and policy adjustments to enhance the ease of doing business and ensure a robust, inclusive financial system.


A key focus, he said, was unlocking domestic capital. particularly from pension funds, which now exceed P150 billion in assets under management.

Despite this wealth, a significant portion was invested outside Botswana he said. While a significant portion is invested abroad, government is moving to balance investment ratios at 50:50 between onshore and offshore markets. However, he acknowledged the challenges faced by smaller enterprises, including fears of losing citizen ownership under the Public

Procurement Regulatory Authority and called for creative solutions to make listing a viable path to growth.

He urged the financial sector to consider greater allocations to emerging enterprises, emphasising that the country's development cannot rely solely on scale but must also recognise potential.

Mr Gaolathe also emphasised the need to reduce listing costs and compliance burdens for SMEs through proportionate solutions, simplified reporting, and targeted incentives as part of a broader effort to stimulate investment, productivity, and job creation.



GBV fight needs multisectoral approach

GABORONE - Combating gender-based violence (GBV) and promoting equality needs concerted efforts by all stakeholders across government, civil society organisations and the communities.

This therefore, challenges all stakeholders to unite and collectively commit to rebuilding a culture of respect and accountability in order to reclaim the moral strength of the society, says Minister of Youth and Gender Affairs, Ms Lesego Chombo.

Presenting Development and Gender Mainstreaming Chapter of the Draft National Plan 12 (NDP 12) to Parliament on Wednesday, Minister Chombo regretted that the loss of respect for humanity had resulted not only with many women and children living in fear, but in extension with broken families. Minister Chombo also noted that the rising number of GBV cases also called for targeted economic empowerment initiatives that would not only promote self-reliance for women, but also enable them to play a role in the country's economic transformation aspirations.

"Government will scale up women's economic empowerment initiatives by ensuring funding support, improved access to finance and developing modern market places for women entrepreneurs.

These interventions aim to promote fair access to economic opportunities to enable women to transition from informal to formal enterprises and to enhance their participation in productive sectors," she noted.

She attributed women's economic limitations to various factors including discrimination, low wages and cultural norms, among others.

Ms Chombo said these factors contributed to their vulnerability and susceptibility to violence from their male counterparts.

Furthermore, Minister Chombo noted that government would scale up gender responsive budgeting in an endeavour to ensure that various groups of society were accommodated in the national budget.

She said plans were underway to revive the National Gender Commission, which was mandated with the coordination, monitoring and accountability toward advancing gender equality.

Ms Chombo also said the rejuvenated commission would ensure gender mainstreaming in various national processes

including planning, budgeting and implementation in all sectors of the economy.

In addition to aligning Botswana's legal statutes with regional and international instruments, Ms Chombo said the envisioned gender equality legislation and national gender strategy were expected to drive gender equality to ensure an inclusive and just society.

"Government is advancing plans to develop gender equality legislation and a national gender strategy, both of which will serve as critical instruments in promoting gender equality, protecting rights and fostering a society that is just, inclusive and free from all forms of discrimination and violence," she said.

On political representation, the minister noted that gender biases, unequal access to resources and stereotypes contributed to the low number of women in political roles.

She said the NDP would create an inclusive environment where women, men and youth had equal opportunities to participate and benefit from the country's economic and political development. *BOPA*

Ipelegeng transition in full swing

GABORONE - The transformation of Ipelegeng programme from a purely welfare based intervention to promoting skills development is in full swing.

Minister of Local Government and Traditional Affairs, Mr Ketlhalefile Motshegwa said the transformation would be such that Ipelegeng evolved beyond short term relief in order to fully realise its potential as a tool for human development.

"The Ipelegeng programme remains one of the most recognisable pillars of our social protection system providing immediate relief and income support to vulnerable citizens across the country. To this end we are undertaking a comprehensive transformation of the program for it to promote productivity and pathways to sustainable livelihoods," he said when presenting the Social Protection Chapter of the draft National Development Plan 12 in Parliament.

He said under the transformation, participants would be equipped with employable skills, linked to community development projects and supported to transition into income generating opportunities.

These reforms, Minister Motshegwa said were about restoring dignity and enhancing self reliance as well as ensuring that public works contributed meaningful to both social protection and national development.

Similarly, Mr Motshegwa noted that government recognised the potential of rural industrialisation in transforming livelihoods of rural dwellers in order to reduce long term dependence on social protection.

"Successful and inclusive rural industrialisation creates non-agricultural jobs, boosts house hold income and revitalises local economic status," he said.

With the right the approach, he said rural industrialisation could become a pathway out of poverty through economic diversification and building a productive foundation for inclusive growth.

To unlock the fully potential of rural industrialisation, Mr Motshegwa said government would continue to prioritise investments in rural infrastructure, skills development and access to finance.

He said through these deliberate actions, rural industrialisation would not only create jobs and income but also lay the foundation for long term social and economic security hence enabling citizens to move from dependency to productivity and from vulnerability to dignity.

Furthermore, Motshegwa emphasised government's unwavering commitment to building a socially protected nation, one where citizens were empowered and equipped to thrive with dignity and purpose. Mr Motshegwa indicated that the True North for the social protection sector would be to create a socially protected community led Botswana, a vision which he said would be realised through economic empowerment and graduation as well as governance and sustainability.

He acknowledged that Botswana's social protection system had made significant progress in reducing vulnerabilities, yet persistent challenges such as fragmentation, weak coordination and unsustainable financing limited its overall effectiveness. **BOPA**

Youth Development Act on cards

GABORONE - Government intends to develop the Youth Development Act as part of the intervention strategy to address unemployment and guide youth mainstreaming in various sectors.

The Minister of Youth and Gender Affairs, Ms Lesego Chombo told Parliament that the legislation was expected to facilitate the formulation of the Youth Commission as well as strengthen the Botswana National Youth Council.

Presenting Youth and Gender Development Mainstreaming Chapter of the draft National Development Plan 12 (NDP 12) before Parliament on Wednesday, Ms Chombo noted that while unemployment hindered young people from participating in economic growth, the situation further resulted in the rise of anti-social behaviours such as high crime rate and alcohol and substance abuse.

Furthermore, she said the Youth Development Fund (YDF) was undergoing review to improve programming for the young people.

"In terms of programming for the youth, the Youth Development Fund is currently being reviewed and remodelled to address key issues that have constrained its impact over the years. These issues include analogue systems, inadequate post funding support and weak monitoring and evaluation mechanisms." she said.

Minister Chombo noted that YDF review was intended to enhance capacity building, adequate support and mentorship for youth businesses, as well as providing access to markets through a robust and more effective framework.

She also noted that the programme would strengthen partnerships with the private sector for financing, technology transfer and business growth.

These initiatives, she noted, would go a long way in creating more employment opportunities for young people and improve their economic and development contribution.

Ms Chombo further said the revamping of the Botswana National Service Programme would ensure improved coordination to promote youth empowerment and a conducive conduit into employment and the business world.

"The new model will emphasise skills development, civic engagement and transition pathways into employment or entrepreneurship. Our participants will gain training that allows them to later transition into structured opportunities through linkages with both public and private sector partners," she noted.

In order to create a sense of patriotism, service and active participation through structured placement in community and development partner projects, the minister said NDP 12 would see the introduction of the National Volunteer Movement targeting the youth

She said among other objectives, the initiative would reduce idleness of both in and out of school youth, while also creating a platform for employability and overall social interaction.

Ms Chombo said skills transfer, career guidance and personal growth would be addressed through the National Mentorship Programme. She said the latter was intended to bridge the gap between experienced mentors and less experienced young people in entrepreneurship and other ramifications.

In addition, she noted that her ministry would collaborate with strategic departments and organisations to avail youth-friendly facilities aimed at empowering youth. **BOPA**

Govt aligns policies for economic inclusion

PARLIAMENT - Efforts are under way to implement a unified social protection policy frame work designed to align with all related policies under one coherent umbrella.

Presenting the Social Protection Chapter of the draft National Development Plan 12 (NDP 12), the Minister of Local Government and Traditional Ketlhalefile Affairs, Mr Motshegwa said some of the policies that would be looked at included the Disability Policy, Revised Gender and Development Policy, Child Protection Policy, Development Policy, Rural Revised National Youth Policy, Social Security Policy and Housing Policy.

He said the alignment would eliminate overlaps and duplication as well as promote synergy among programmes while ensuring that interventions across sectors were coherent.

Motshegwa government would also review and consolidate all existing laws governing social protection into a single, coherent legal framework that reflects the country's constitutional principles and aligns with international and regional commitments including the Sustainable Development Goals (SDGs) and the African Union Agenda 2063. In line Economic with Botswana Transformation Programme (BETP), Minister Motshegwa said government also took deliberate steps toward the establishment of a semi-autonomous authority for social development aimed at consolidating all social protection programmes currently spread across various ministries under one institutional home to enhance efficiency, coordination and accountability.

"It is our ardent hope and belief that this reform will eliminate duplication of efforts, improve service delivery and ensure that resources are effectively targeted to those in need," he said.

He stated that building technical, financial and human resource capacity of the new authority would remain a priority to ensure that the institution was well equipped to manage progress effectively and coordinate the contributions of civil society organisation and private sector partners in advancing social development.

He said government through these concerted efforts, sought to establish a more responsive, accountable and inclusive social protection system that truly leaves no one behind.

With regard to decentralisation, Mr Motshegwa said government recognised that an effective system of social protection should be responsive to the unique circumstances of every community.

To that effect, he said government would continue to advance decentralisation as a strategic instrument for improving service delivery and deepening local governance.

"By strengthening the decision making authority and operational capacity of local authorities, social support programmes will be planned, targeted and implemented closer to the people who need them most," Minister Motshegwa said.

He further indicated that transforming social protection for inclusive growth involved shifting from a welfare based approach to one that drives economic inclusion and sustainable development.

He acknowledged the establishment of the Cabinet Sub-Commitee on Sustainability for Inclusive Growth and Justice citing that such committee was testament of government's commitment to aligning social protection with structural reforms in key sectors like mining and tourism.

He said such integrated

approach promoted local content, community enterprises and equitable benefit sharing thus moving citizens from dependency to self reliance.

Additionally, he highlighted that decentralisation ensured that interventions were area specific, timely and inclusive thus ultimately allowing government to build a social protection system that upholds dignity and empower communities while supporting vulnerable groups in every part of the country.

The approach, he said would not only enhance accountability but also promote community participation, ownership and innovation at the local level.

SELEBI PHIKWE - Nestled amidst the landscape of Selebi Phikwe, iconic chimney of BCL mine affectionately dubbed 'Chomela' by the locals, rises majestically against the skyline, a silent demonstration of the bustling energy of the copper smelter that once operated within its walls.

Though it now stands quiet, its presence is deeply ingrained in the community's identity, capturing the essence of a bygone era.

Chomela is more than just a relic, it embodies the town's rich industrial heritage and the spirited character that flourished during the golden age of mining, echoing the stories of hard work that once filled the air.

Endearingly, it earned the town a humorous moniker, "ko chomeleng," a playful nod to its significance.

Keith Stoffels elaborates, describing the chimney as a barometer of life within the mine; a robust plume of smoke would signify thriving operations, while a meagre trickle would send a ripple of concern through the community, alerting them to underlying production issues.

In these turbulent times, as the government endeavours to breathe new life into Selebi Phikwe, a flicker of hope shines brightly through the words of Mr Steven Tawana, a former Metallurgist Superintendent at With deep emotional ties to the area, he expresses optimism about the revival of the oncethriving smelting operations.

He emphasises the smelter's crucial role, not merely as a facility for processing copper but as a vital lifeline for the surrounding community.

"The state-of-the-art laboratory that the government is currently refurbishing at the old BCL mine can synergise beautifully with the smelter.

Once the minerals are analysed and their concentrations verified, we can process them right here in Selebi Phikwe, bringing back the spirit of Chomela," he said.

He spoke of the need to continue embracing innovative strategies to preserve the skills and expertise cultivated during BCL's operational years as the spirit of the Chomela might once again fill the air with promises of prosperity and community resilience. *BOPA*

Ministry predicts cereal deficit

KANYE - Crop Production for the 2024/25 ploughing season is not enough to sustain the national cereal demand, which calls for imports to augment deficit.

The Ministry of Lands and Agriculture Public Relations Officer Ms Neo Lenkopane said this when responding to BOPA questionnaire, stating that produced cereals accounted for 36.9 per cent of national cereal demand which was 300 000 tonnes.

reported production, The she said was mainly from Pandamatenga commercial farms contributing 81.2 per cent to the total production.

Ms Lenkopane stated that a total of 137 876.84 tonnes had been harvested from a total of 185 892.36 hectares by 45.779 farmers of all categories being commercial, emerging and subsistence farmers who contributed 77.58 per cent, 0.84 per cent and 21.58 percent respectively. The area planted during 2024/25 cropping season showed an increase by 41.42 per cent as compared to 130 533. 30 hectares planted by 27 808 farmers in 2023/24 season.

said it remained significantly lower than 272 803 hectares planted by 76 272 farmers during the 2022/2023 season, which was supported by exceptionally favourable rainfall conditions.

During the 2024/25 season, cereal crops dominated the planted area covering 122 701.,98 hectares, citing that maize was the most widely cultivated crop accounting 74 139.87 hectares or 40 per cent followed by sorghum at 39 568.28 hectares.

Ms Lenkopane stated that the country was facing a shortage in national grain supply therefore export of local produce was formal system. BOPA

restricted to protect food security in the country.

The country usually exported mung bean and chick peas because they have a high demand outside the country, fetches better prices and were not commonly consumed locally.

She appealed to the farming community to be prepared for the upcoming cropping season which was forecasted to receive normal to above normal rainfall country wide. Farmers, she said should be well prepared by having robust pests and weed control programme to deal with anticipated pests outbreaks and high weeds infestations.

She also implored farmers to uphold proper soil management practices such as ripping and maintaning drainage systems to drain excess water from the fields. Ms Lenkopane advised farmers to have effective soil fertilisation to be able to replenish nutrient loss expected from excessive moisture.

For her part, the Chief Executive of Pandamatenga Commercial Farmers Association Ms Lilian Costa Scheepers said there was limited export access and processing capacity, saying Botswana lacked streamlined export procedures, bilateral protocols and agro-processing infrastructure which reduced income potential.

Ms Costa Scheepers proposed for fast tracking of regional trade agreements, and empower associations to coordinate exports and invest in agro-processing zones to support local value addition.

She said the continued grain imports during bumper harvest seasons destabilised the local farmers market. Millers and traders, she noted, exploited the vacuum, manipulating prices and eroding farmers' confidence in

Inclusion of indigenous languages commendable

On the eve of Botswana's 59th
Independence celebration, President
Advocate Duma Boko launched the
indigenous language news bulletins on
the national broadcasters; Botswana
Television and Radio Botswana. This
milestone ensured that Batswana across
different communities have access to news
in their mother tongue. Some Batswana,
interviewed by BOPA had this to say:

Merapelo Tshweneyagae commended the inclusion of indigenous languages in the national news bulletins.

He applauded the introduction of indigenous languages from different tribes in Botswana Television (Btv) and Radio Botswana news bulletins, describing the initiative as a shining example of unity in diversity and a significant milestone in cultural inclusion.

Speaking in an interview with BOPA, Kgosi Tshweneyagae said the initiative demonstrated the country's continued commitment to promoting national inclusivity and recognising Botswana's rich linguistic and cultural heritage. He noted that for many years, some tribes, including the Bakgalagadi, had been reluctant to freely express their language in public due to societal perceptions that undermined its use.

Kgosi Tshweneyagae the inclusion various indigenous languages national broadcasts would long way restoring pride among speakers of such languages and promote a sense of

belonging among all Batswana. "For us to all have a sense of belonging as Batswana, it is crucial that we see ourselves being embraced and considered as one people, despite our different tribes," he said.

He explained that showcasing the linguistic diversity of Botswana on national platforms would also strengthen peace and harmony, as it encouraged mutual respect and friendship among citizens, regardless of ethnic background.

"It is pleasing to see indigenous languages being recognised in our national news bulletins. This gives us pride and ownership, we can now proudly see that our language is being represented," he said.

Reflecting on the Sekgalagadi language, Kgosi Tshweneyagae highlighted its diversity and widespread use across several districts, including Kweneng, Kgalagadi, and Ghanzi. He explained that this geographical spread has led to the development of distinct dialects spoken in areas such as Letlhakeng, Tsabong, Kang, and Hukuntsi.

"I have observed that the Sekgalagadi spoken in areas near Setswana-speaking communities such as Letlhakeng and Sekoma

is more influenced Setswana, while that one spoken in central Kgalagadi areas such as Hukuntsi and Macheng is purer and less mixed," he said. urged the Bakgalagadi not to criticise presenters who speak in dialects different from their own, stressing that such variations

"What is important is that we all understand what is being said, despite the differences. We should not worry when presenters speak in the dialect from their area of origin. After all, it is our language, which has unique differences as a result of our diversity," he said.

advised that as the initiative progresses, attention should be given to training news presenters to ensure consistency and quality in language delivery. He further suggested that consideration should be made in adopting a standardised Sekgalagadi dialect for use in broadcasting, guided by

linguistic experts. K g o s i Tshweneyagae further proposed that the inclusion indigenous languages should extend beyond radio and television to Government print media, namely Botswana DailyNews newspaper. He said involving language experts would develop help standardised

written forms for indigenous languages to preserve and promote them for future generations.

He emphasised that recognising and celebrating all indigenous languages had the potential to strengthen social cohesion, national pride, and a shared sense of identity. "Recognising

our languages makes us all feel seen and valued. It fosters peace and harmony among us as Batswana," he said.

of indigenous dialects on Radio Botswana and Btv. She said the initiative reflected government's recognition of the country's linguistic diversity and a step forward in preserving Botswana's indigenous languages.

She noted that for many years, communities such as the Bakgalagadi had longed to hear their language spoken on national platforms. "We have been waiting for a long time to hear our language being aired on national radio. It makes us proud to know that our voices and identity are being recognised," she said.

However, Ms Kgomo expressed a concern that the Sekgalagadi currently being broadcast did not fully reflect the indigenous dialect spoken by the majority of Bakgalagadi. She explained that while the effort was appreciated, there remained a need to ensure authenticity and inclusiveness in the representation of the language.

She also suggested that presenters should receive additional training to enhance their proficiency and accuracy in delivering news in indigenous languages. "Our presenters need more polishing to ensure that they can fully carry out their work and reflect the language in its purest form," she said.

Acknowledging the cultural diversity within the Bakgalagadi, Ms Kgomo pointed out that the community comprised several sub-groups, including the Bashaga and Bangologa, among others. She emphasised that as the initiative developed, future considerations should be made to cater for the various Sekgalagadi dialects spoken across different Furthermore. regions. expressed hope that government would extend the inclusion of indigenous languages to print media, particularly the DailyNews newspaper.

"It would be wonderful to also see the DailyNews, publishing articles in our native dialects, so that more people can read and identify with their heritage," she added.

Ms Kgomo also welcomed government's decision to establish community radio stations in all villages, noting that such platforms will play a critical role in promoting local languages and empowering communities to share their stories in their own values.

She applauded the initiative as an important step toward unity and cultural preservation.

"This development shows that our government values every tribe and every language. It encourages pride, inclusivity, and national harmony," she concluded.

Tsabong, Naomi Leepile reports that the introduction of Sekgalagadi news bulletin has been met with enthusiastic approval by Bakgalagadi community, who see the initiative as a major step toward tribal equality and recognition.

However, some concerns have emerged regarding the accuracy and purity of the Sekgalagadi language being used by news readers.

The initiative is already transforming the way many citizens interact with national media. A 71-year-old Ms Kobamelo Motate, a Bakgalagadi native who hails from Tsabong, warmly applauded the President's efforts. "It has made it easier for us to listen to the news, and we are even enjoying watching television," she shared in an interview.

For Ms Motate, the policy is more than just about accessibility; it's a profound political statement. She stressed that the move demonstrated the President's commitment to taking all tribes equally, with "no discrimination."

Ms Motate recounted a long history of marginalisation felt by the Bakgalagadi due to their language. She noted that for a very long time, the Kgalagadi natives were belittled and undermined because of their dialect.

"We used to shy away or get embarrassed to speak our language at school because the Tswana-speaking students used to mock us," she revealed, detailing how this environment made their learning very difficult. She firmly believed the introduction of Sekgalagadi and other languages would now "set them free" and ensure they were recognised like other tribes.

Despite this overwhelmingly positive response, Ms Motate raised an important practical concern; highlighting that the news readers were not speaking pure Sekgalagadi, which she said made the broadcasts confusing and difficult to understand.

She offered specific examples of words being mispronounced or substituted.

For the word knife, she explained that the authentic Sekgalagadi term is "mohagha," but the news readers sometimes use "khipa." Similarly, for rubbish or litter, the correct term is "maghaghala," while the readers are heard saying "madaghala."

To resolve this issue and ensure the initiative achieves its full potential, Ms Motate offered a clear suggestion, that news readers should be pure Bakgalagadi who know how to speak Sekgalagadi authentically.

While the President's initiative is signaled as a monumental victory for tribal inclusion, the feedback from Ms Motate highlights the critical need for linguistic accuracy to ensure the broadcasts are not just inclusive, but genuinely comprehensible and respectful of the language's

authentic form.

From New Xade, some residents said the introduction of Naro dialect on television and radio news had made a huge significance in enhancing the dignity of the Naro community.

This emerged through a telephone interview with Mr Tshotlego Digotlhong of New Xade, who stated that the introduction of the dialect in news bulletins had brought a lot of excitement among members of the community in New Xade in the Ghanzi district.

Thandy Tebogo indicated that Mr Digotlhong said the use of Naro dialect meant that their language was recognised as much as their existence as a tribe in Botswana.

"The mood is usually high as the elderly people look forward to the Naro news bulletin in the Radio. The youngsters would be requested to lower their voices when time for news at half past eight in the evening arrived, just after Sekgalagadi news," narrated Mr Digotlhong

He said there were people who did not have a deeper understanding of Setswana language in New Xade more especially the elders, therefore the introduction of the Naro news received a warm welcome. Mr Digotlhong called for the same to happen in government offices such as social welfare, tribal administration and district administration offices, such that people could be assisted through communication in their languages, for better understanding.

For his part, 66-year old Mr Daoqoo Xukuri, also New Xade resident, said since some did not have television sets they listen to Radio Botswana news, saying that they understood the dialect used. Xukuri expressed delight as he mentioned that one of the news anchor reading the news in Naro on Botswana Television was from New Xade.

Mr Xukuri said the promotion of their language to that level had fostered a sense of identity and empowered them as a community.

He said the development had also promoted access to information as previously they could not understand some of the issues communicated in Setswana news bulletins. Mr Xukuri called for the introduction of news in another dialect of Basarwa such as Dxanakhoi.

Additionally, Mr Johannes Tshara, 47-years old, said they were proud and felt they had a sense of belonging. Mr Tshara said the use of their dialect in news has enabled them to understand complex issues and had increased community engagement on issues of national interest.

Though he said they understood it, he highlighted that it differed with the one they used on a daily basis.

Mr Tshara said their wish was that it could also be introduced

in schools. He also proposed that the language should also be introduced in other radio programmes such as agricultural programmes.

Mr Tshara said the usage of the dialect would go a long way in preservation of their culture and language.

He said its usage would help maintain the vitality and continuous use of the dialect which could have been at the risk of disappearing.

Kelebogile Taolo reports that this development has been deemed, by Bakalaka community, as a move in the right direction which fosters an inclusive nation.

A senior citizen from Kalanga tribe, Ms Priscilla Motsu expressed happiness to such development which she said had now made it easier for them to understand what was happening in the country in terms of development and other important issues.

Speaking in an interview, the 71-year old Motsu who is a street vendor in the city, said the development meant that no one would be left out in current affairs and other important matters of this nation. She said

for the longest time she missed on important topics on the news due to language barrier.

"As old as I am, I do not understand Setswana that much and not even conversant with it. At times I struggled to hear about the plans and ideas concerning our country as news were only read in two languages, now I am very happy as I am able to choose to listen to the news bulletins in my mother tongue, the language I understand so well," explained Ms Motsu.

She further noted that the development was long overdue since some Bakalanga who did not know either Setswana or English really lagged behind in terms of information sharing through news.

A fellow Kalanga in his midyears, also a business man in Francistown, Mr Gaone Baoleni applauded the government for approving the use of other languages on the National television and radio.

He said as Kalanga man, this on its own gave him pride knowing that his mother language was well recognised.

He said this also would serve as language exchange since other people would want to learn any language of their choice through news.

"These are our indigenous languages, we have to embrace and be proud of them as different as they are, and also be flexible to learn them. For those who do not know Setswana and English, they now have a choice as they can switch to listen to the news in Kalanga or any other language of choice," Baoleni said.

He added that the introduction of indigenous language in news broadcast meant there would be no language barrier, citing that all Batswana would be now up to date in terms of news and current affairs.

In response to the introduction of Shiyeyi as another language in the national broadcast news bulletins, Ms Matshidiso Gantsi of Gumare expressed happiness for such initiative, which she said was a welcome development.

Ms Gantsi said the move would help young children to have interest in their mother tongues.

Another Gumare resident, a youth Mr Mpho Mokomoto also hailed the development saying it would help preserve languages such as Shiyeyi adding that it would open employment opportunities for youth who were well vested in those languages.

Ms Tangee Korujezu of Qangwa said she was happy about the introduction of indigenous languages in news broadcasts.

The youthful Ms Korujezu said it would help especially Bayei elders who were not conversant in Setswana and English as they would be able to get information directly from the news anchors. **BOPA**

BTC Champions a Greener Future Through Copper Recycling



In Gaborone, a quiet but powerful shift is underway. What was once seen as waste, copper cables buried underground and replaced by fibre, is now being reborn into new products and opportunities as well as a renewed vision for sustainability. At the heart of this transformation is BTC, Botswana's leading telecommunications company, working hand in hand with Sindawonye Granulators and Processors Pty Ltd, a regional leader in copper recycling with operations in South Africa, Zimbabwe, and now Botswana.

BTC continues its ambitious de-coppering programme, replacing legacy copper with faster, more reliable fibre, the question of what to do with thousands of tonnes of old copper cables naturally arose. Instead of allowing this legacy infrastructure to become waste, BTC made a bold choice to transform it into a sustainability success story. The company's partnership with Sindawonye Granulators and Processors Pty Ltd ensures that the shift to fibre is also a shift toward environmental and economic value creation. This partnership is the first of its kind in Botswana, positioning BTC at the forefront of circular economy leadership.

Between 2021 and 2025, BTC's de-coppering initiative tells a powerful story of financial turnaround and strategic foresight. In 2021, BTC spent P10 million

replacing stolen copper, a costly start that underscored the urgency for change. By 2022, losses from theft had doubled to P20.1 million, even as the first signs of revenue emerged, with P2.6 million generated through copper disposal. The year 2023 brought the worst theft on record, costing BTC P57.2 million, despite an increase in disposal revenue to P6.4 million

Then came 2024, the breakthrough year: losses dropped to P6.6 million, while revenue soared to P31.8 million, thanks to the operational partnership with Sindawonye and rapid fibre deployment that reduced theft opportunities. In 2025, BTC reached a milestone, generating P38.8 million in copper disposal revenue while losses fell dramatically to just P582,000. This transformation highlights how strategic partnerships and sustainability initiatives can convert operational risks into long-term value.

The Sindawonye facility in Gaborone, which became fully operational in September 2025, is already making measurable impact. The plant processes 30 to 50 tons of BTC copper every week, using an advanced granulation process that produces no emissions, no water pollution, and no air contamination. All 22 employees are Batswana, trained in specialised recycling methods that uphold both efficiency and environmental safety. The

facility's closed-loop water system ensures a zero-footprint operation, making it one of the cleanest copper recycling facilities in Southern Africa.

Copper is among the world's most recyclable materials and also one of the most targeted for theft. BTC and Sindawonye are tackling this challenge head-on by creating secure, transparent, and traceable recycling channels. Each tonne of recovered copper is documented from collection to processing, preventing leakage into the informal scrap market. Once separated from its plastic casing, the copper re-enters global supply chains, while the plastic is repurposed into durable fencing droppers that are termite- and rot-resistant, demonstrating a true circular economy in action

BTC's sustainability agenda aligns closely with its digital transformation investments. Between 2021 and 2025, the company invested over P100 million in fibre and Wideband Digital Subscriber Line (WDSL) technology to modernise Botswana's connectivity. From an initial P20.98 million investment in 2021, building the national digital backbone, to a P48.28 million allocation in 2025 to achieve near-universal access, BTC's infrastructure growth mirrors its sustainability journey: bold, consistent, and nation-driven. These investments support Botswana's Vision 2036 and its commitment to a green, digitally empowered economy.

BTC's de-coppering project has evolved from a cost-saving measure into a revenue-generating sustainability model. What once drained millions in replacement costs is now a profitable and environmentally responsible enterprise, with cumulative copper disposal revenue projected to exceed P80 million by 2026 if current trends continue. Beyond the financials, the project demonstrates how innovation and sustainability can coexist and lead to creating jobs, reducing theft, and contributing to Botswana's circular economy vision.

Sindawonye's expansion into Botswana represents a regional leap forward in sustainable industrial collaboration. With BTC as its first local partner, the company aims to turn Botswana into a Southern African recycling hub, driving economic diversification and environmental stewardship. This partnership redefines what legacy means: old cables once destined for landfills now symbolize opportunity and national pride.

Letsididi declines to show missing finger

GABORONE - Serving rape and double murder accused, Tshepiso Letsididi, on Tuesday declined to show the court his missing finger after being identified by a state witness as the man seen driving the deceased's vehicle in Gakuto a day after the alleged murder. Letsididi (37) refused to display his hand in court after the prosecutor, Ms Seeletso Ookeditse of the Directorate of Public Prosecutions (DPP), applied before Justice Oteng Motlhala of the Gaborone High Court that the accused show his hands for identification purposes.

"The issue is not examination, but identification," Ms Ookeditse submitted, requesting the court to direct the accused to raise his hand so that the state witness, Ms Janet Basole, could confirm the missing

finger she mentioned in her earlier testimony.

However, Letsididi's attorney, Mr Michael Itumeleng, objected to the application, arguing that compelling the accused to show his hands would amount to a violation of his client's rights.

He said such an act would constitute an intrusive exercise that should only be carried out by a qualified medical officer, health practitioner, or crime scene investigator.

Ms Ookeditse countered that the request was purely for identification and not examination, and that the defence had not demonstrated how it would prejudice the accused.

Justice Motlhala ruled that it was up to the accused to consent or refuse, and Letsididi opted not to raise his hands.

Earlier, witness Ms Basole had testified that on November 12, 2022, she met a man driving a silver-grey Toyota Camry who claimed to have

hit a road sign on his way to Gakuto.

She said the man later invited her to accompany him, and they proceeded to Dacrozing Tavern. She further told the court that while she did not know the man's name, she observed that he had a missing

finger and a tattoo on his face.

Letsididi faces charges of murdering Penekane Mhaladi and her grandchild, Laofa Mamorebo, on November 11, 2022, Magokotswane in Molepolole.

He is also accused of stealing

items valued at approximately P5,000, including a Toyota Camry, and raping the minor.

During Tuesday's proceedings, the accused, through his attorney, admitted to the forensic evidence report of the deceased. BOPA

Inmate appears for murder of another inmate

LOBATSE - Murder accused, Ogona Tlhabologang, 23, of Gumare was remanded further in custody pending investigations to determine the cause of death of a 31-year-old Zimbabwean prison inmate at Sbrana Psychiatric Hospital in Lobatse on May 17.

Extending his remand on Tuesday, chief magistrate Ms Magistrate Court, said this would allow investigations to continue.

The two inmates; Tlhabologang and the deceased were incarcerated at Maun Prison, and were referred to Sbrana Psychiatric Hospital for forensic psychiatric examination as part of the criminal procedure when the ordeal happened. At the time, Tlhabologang who was incarcerated for a threat to kill offence, shared

the cell with the deceased inmate at Sbrana. According to the police report, the deceased had sustained serious injuries, bodily harm and beatings and was taken to Athlone Hospital where he was certified dead. Tlhabologang pleaded with the court to grant him bail promising that he shall follow all bail conditions to the latter. He is expected to appear again in court on November 28. BOPA

More charges for Mokomeng

LOBATSE - Kgomokasitwa triple murder accused Moagi Mokomeng's count of offences are likely to increase to 10 after state prosecutor Mr Modibedi Tladi indicated the state's intentions to file an amended charge sheet.

Mr Tladi told senior magistrate Tshoganetso Atamelang of Lobatse Magistrate Court on Monday that the offence would be disclosed in the next court sitting scheduled for December 9.

He apprised the court that committal documents on the case were ready to facilitate the matter to move to the High Court.

He stated that in the next court sitting, they would be ready to serve the accused with the final documents.

Senior magistrate Atamelang further remanded in custody Mokomeng pending committal of the case to the High Court.

Mokomeng is charged with nine counts of offences, which include murder, attempted murder, arson and malicious damage to property committed on February 25, 2025.

The accused murdered Elizabeth Ramolala, Alefha Ramolala, and Katlego Ramolala. He also attempted to murder Happy Ramolala by burning the house he was occupying and a police officer Sergeant Thabo Dibotelo by shooting him with a service

Additionally, the accused is charged for causing malicious damage to property by smashing windows of a dwelling house used by Wathapelo Tiro with a gun. He is further charged with firing gun shots thereby damaging the load bin, dash board, bonnet, right front bumper and ignition chamber of a white Toyota Hilux, which belonged to the deceased Elizabeth Ramolala.

Mokomeng's murder case runs parallel to his rape case committed between December 26 and 27, 2022 at Borite Ward, in Kgomokasitwa.

He is accused of having unlawful carnal knowledge of a minor.

The trial for the rape case is scheduled for December 2 to 3. **BOPA**

Chinese, African experts join forces

ADDIS ABABA - The 2025 General Assembly of the China-Africa Agricultural Science and Technology Innovation Alliance (CAASTIA) kicked off on Monday in Addis Ababa, Ethiopia's capital, with a focus on cooperation for Africa's food security and agricultural modernisation.

President of the African Academy of Sciences Lise Korsten said China's journey in agricultural modernisation, marked by intensive cultivation, developed value chains and breakthroughs in digital agriculture, provides invaluable experience to Africa.

According to the president, China exemplifies mastery in high-yield, technology-driven agriculture, feeding nearly 20 per cent of the global population with less than 9 per cent of the world's arable land.

Meanwhile, Africa faces food insecurity despite being home to 60 per cent of the world's uncultivated arable land.

"This paradox of land and people underscores the need for a balanced partnership: one that marries Africa's untapped potential with China's proven innovations to build a resilient global food system," said Korsten.

Jiang Feng, head of the Chinese Mission to the African Union (AU), said China stands ready to share its experience in agriculture development and rural poverty reduction with African countries to achieve common development.

He highlighted that the current agricultural technological revolution, driven by biotechnology, digital technology, and intelligent equipment, offers new opportunities for China and Africa to improve agricultural productivity and strengthen their response to global challenges.

"China-Africa agricultural cooperation is evolving from traditional aid-based assistance to sustainable, capacity-building partnerships.

This year, the Chinese government announced a zero-tariff policy covering all tariff items for 53 African countries with diplomatic relations with China.

This will significantly enhance the access of African agricultural products to the Chinese market," Jiang added.

Gaspard Banyankimbona, AU commissioner for education, science, technology and innovation, said China and Africa can jointly develop climateresilient crops, sustainable soil and water management systems, early warning tools of pests and extreme weather, and a digital platform that empowers smallholder farmers across the continent.

"The China-Africa alliance provides the ideal vehicle to mobilise collective force to promote joint research in climate-smart agriculture, animal and plant

health, agro-ecology and food safety, technology transfer and localisation, capacity development through scholarship and innovation ecosystem," Banyankimbona emphasised.

The three-day event, coorganised by the Chinese Academy of Agricultural Sciences, African Academy of Sciences, and the Mission of China to the AU, brought together over 200 scientists, policymakers, and representatives from agricultural institutions across China and Africa. *Xinhua*

Egypt, Sudan ministers discuss situation in El Fasher

CAIRO - Egyptian Foreign Minister Badr Abdelatty met his Sudanese counterpart Mohieldin Salim on Wednesday to discuss the critical humanitarian and security situation in Sudan's El Fasher, which was captured by the paramilitary Rapid Support Forces (RSF) over the weekend.

During their meeting in Cairo, Abdelatty reaffirmed Egypt's full support for the Sudanese people and its commitment to ongoing efforts aimed at achieving stability and peace in Sudan, according to a statement by the Egyptian Foreign Ministry.

He reiterated Egypt's commitment to Sudan's unity, sovereignty, and territorial integrity, noting that Sudan's

stability is vital to the region.

The two ministers agreed to maintain coordination to support both nations' aspirations for peace and development.

On Sunday, the RSF claimed control of the western Sudanese city of El Fasher, the last stronghold of the Sudanese Armed Forces (SAF) in the Darfur region.

The next day, SAF Commander Abdel Fattah Al-Burhan acknowledged the army's pullout, saying it was to protect its citizens, and vowed to retake the city.

The war between the SAF and the RSF, now in its third year, has killed tens of thousands, displaced millions, and left much of the country on the brink of famine. *Xinhua*

Government honours Basarwa

GHANZI - As a testimony to and respect human rights, especially the rights of the deemed marginalised Basarwa, government has swiftly moved to construct a Basarwa human rights monument, in the Central

Kalahari Game Reserve (CKGR) at Metsiamanong settlement.

The monument is said to its committed effort to protect be dedicated to promoting, commemorating and reflecting on the struggle for human rights experienced by the Basarwa community.

The project, estimated to cost P15 million comprises of two main components being the Basarwa Human rights monument and improvement of the late Gaoberekwe Pitseng's burial site.

Apprising the Ghanzi District councillors during a special full council recently, the project manager, Tiisang Thokweng, explained that given the current economic and fiscal constraints, the ministry has resolved to implement the project in phases.

He alluded that phase one would be the Pitseng Burial site that would be undertaken inhouse using available government resources and skilled personnel.

Thokweng said the second phase would be the construction of the Basarwa Human rights monument to be advanced as resources permits and through partnerships with the business community and other stakeholders.

He however stated that, the project status update details that concept design has been completed awaiting to be presented to the architect and the next stage would be consultations with other stakeholders on the refinement of designs and phased implementation in alignment with available resources.

He emphasised that, the Basarwa communities residing in CKGR would also be fully consulted and all other relevant stakeholders as a way of developing social ownership and promoting active participation.

Meanwhile, the erection of the human rights monument in the CKGR comes to life after two historical events that befell upon the Basarwa community, being the alleged forced 1990's relocation from the CKGR and the 2021 prolonged and contentious battle between the state and the Gaoberekwe family over the burial of Mr Pitseng Gaoberekwe.

The 2021 clash emerged after the Basarwa descendant, Mr Gaoberekwe was denied burial right at his ancestral land in CKGR on the basis that he was a resident of New Xade.

The late Gaoberekwe, passed away on December 21, 2021 and government had argued that his relocation to New Xade guaranteed it as his appropriate burial site.

However, his family opposed the court ruling and insisted on honouring the late Gaoberekwe's wish to be buried in the game reserve.

The disagreements complicated burial arrangements until in 2024, when President Advocate Duma Boko was elevated to the helm of government. During his maiden State of Nation Address speech, he announced that government had taken a decision to honour the late Gaoberekwe's wishes, by burying him in the CKGR at his ancestral land, Metsiamanong.

The state burial was eventually conducted alongside the 2024 commemoration of International

GABORONE - Visual artist Kentse Bogatsu has taken centre stage at the Thapong Visual Arts Centre with a captivating solo exhibition that reflects years of creative mastery and introspection.

In an interview, Bogatsu described art as an outlet for internal expression "a Pandora's Box unleashed in art form."

"I want to share with people the drama and excitement that's inside of me," he said. "I put so much energy into what I do, and I want to share that energy with everyone."

He revealed that the key to his artistry lies in channelling emotions into his work, adding

that true art is about expressing what is within, much like Japanese Haiku poetry, where a poet captures emotion in a single moment using only three lines.

"To me, that is the greatest poetry, and I get to do something similar through art," he said.

Though abstract, Bogatsu's artworks tell stories of selfacceptance. Some pieces pay tribute to those who battle selfdoubt, while others celebrate cultural festivities such as Legwetla.

Veteran artist Veryan Edwards commended Bogatsu for his exceptional weaving of patterns and motifs, describing his work as clever and deeply thoughtful. She highlighted the Primordial Universe series as a standout, noting how it draws viewers into an alternate reality and elevates their imagination to the heavens.

The Primordial Universe series, she said, presented a synthesis of authentic nature and fantasy, a celestial creation that feels both ethereal and dramatically composed.

Bogatsu's works will remain on display at Thapong Visual Arts Centre until November 20.

He said the initiative would support Botswana's commitment to inclusivity, recognition and cultural heritage preservations.

Furthermore, Mojalemotho said the monument would stand as a national symbol of recognition and respect for the Basarwa and all communities whose rights and dignity form the foundation of Botswana democracy. Moreover, he said it would also represent a commitment to equality, inclusion

and justice, values enshrined in both national and international human rights principles.

For his part, the technical officer, Kabo Sepato also underscored that the proposed monument would serve as a symbolic icon, tourist attraction and a cultural centre.

He emphasised that the human rights monument would be designed in a manner that would influence an economic value through the development of a heritage trail. The heritage trail, he said, would connect with all gazetted park entries and would also recognise all the settlements around CKGR, where Basarwa are currently living.

Sepato said the proposed heritage trail would consist of an open-air museum at Old Xade, the 189 monument at Molapo; which will display the names of 189 people who signed the petition against the relocation, the human rights monument at Metsiamanong, cultural village at Metsiamanong, the burial site monument at Metsiamanong, the origins/Interpretations Monument at Mothomelo and CKGR museum at a place to be identified. **BOPA**
